Dog Show Sniffs Out Top Obedience Performers

ST. CHARLES -- Throughout a cold, slushy Sunday morning, hundreds inside the cavernous exhibit hall at the Kane County Fairgrounds were reminded of one of life's fundamental principles:

"If there is to be a winner, there must also be a loser."

And so it went as The Fox Valley Dog Training Club -- which is certified by the American Kennel Club (AKC) -- hosted its 48th annual Obedience Trial, with 272 dogs of all breeds competing in novice and open classes. There were prizes to be awarded for high marks in agility, directed jumping, obedience, retrieving and scent discrimination.

"Hunter has titles from several shows," said Lee Melka of Wood Dale, twisting at the waist to give her cheerful 8-year-old golden retriever a biscuit.

"But we're not here to talk big about our past success. We're here for another first-place finish," she said.

Scoring is based on how man's best friend measures up to each judge's image of the perfect dog as determined by documented AKC regulations. The dogs also are compared to one another.

Most dogs are competing for points toward their overall championship, which then entitles the owner to use "Ch" before the dog's name.

William Short, trial chairman at the Kane County show, said that these points are essentially based upon the number of dogs in actual competition -- the more dogs, the more points. However, the number of dogs required for points varies with the breed, the sex and the geographical location of a particular show in accordance with AKC designations to help equalize competition from breed to breed and area to area.

"There's a lot to learn about these events," said Cindi Green of Keeneyville, who was at the crowded exhibit hall with Harley, her frisky 4-year-old Australian shepherd.

"Some of these people are really into it," Green said while motioning in the direction of several intense-looking matriarchs who were waiting with their dogs to enter the "sits and downs" rectangular trial ring, where even the most spirited puppy is expected to remain in position until released by its handler. It doesn't matter if a hissing black cat passes by or if a can of gourmet canine chow is placed only a few inches away.

"Stay" means STAY.

Green, who has three young children and a husband at home, said that her time "is at a premium." Still, she decided that "this training club would make Harley a better companion for all of us. He can heel, stay on command, stand for examination and come when called. So now I'm working him on a more difficult format," she said.

Green shared a laugh when she remembered how her "Aussie" became overly excited during a recent show and "really blew it by fooling around."

In that case, it's best to smile and remember that patience often differentiates a good sport from a sore loser.

St. Charles Hosts Dog Obedience Trial

Linda Benson was greeted with plenty of high fives and back slaps Sunday from fellow dog owners.

She deserved the accolades.

You see, her countless hours of training Tygr finally paid off.

Benson's African-hunting dog, a basenji breed, captured a Utility Ring, the most advanced degree in Sunday's 47th annual Obedience Trial for the Fox Valley Dog Training Club Inc.

About 230 dogs, their owners and that infamous musty dog smell were prevalent at the Kane County Fairgrounds in St. Charles.

For Benson, Sunday's triumph for Tygr was no small feat.

To win a Utility Ring, the dog must come, heel and sit based on an owner's hand signals. There is also a jump, item retrieval and scent discrimination.

In the latter, the dog must find an owner's scent on metal articles.

Basenjies are known for stubbornness and a lack of motivation to work for humans. That made Tygr's victory more gratifying.

"They work with man rather than for man," said Benson, a Kaneville resident. "It's hard keeping their attention. They like looking around. I use food to train him, and he has a fuzzy ball."

Everyone who owns a dog should enroll the animal in an obedience class, [Jinny Addington of Riverwoods] said.

"Dogs enjoy it," Addington said. "They are never too young or too old to start."

How to Photograph a Puppy

1. Remove film from box and load camera.
2. Remove film box from puppy's mouth and throw in trash.
3. Remove puppy from trash and brush coffee grounds from muzzle.
4. Choose a suitable background for photo.
5. Mount camera on tripod and focus.
6. Find puppy and take dirty sock from mouth.
7. Place puppy in pre-focused spot and return to camera.
8. Forget about spot and crawl after puppy on knees.
9. Focus with one hand and fend off puppy with other hand.
10. Get tissue and clean nose print from lens.
11. Take flash cube from puppy's mouth and throw in trash.
12. Put cat outside and put peroxide on the scratch on puppy's nose.
13. Put magazines back on coffee table.
14. Try to get puppy's attention by squeaking toy over your head.
15. Replace your glasses and check camera for damage.
16. Jump up in time to grab puppy and say, "No, outside! No, outside!"
17. Call spouse to clean up mess.
18. Fix a drink.
19. Sit back in Lazy Boy with drink and resolve to teach puppy "sit/stand" and "stay" the first thing in the morning.
20. Consider buying "older, trained" dog.

Membership Meeting Highlights November 4, 1998

Meeting brought to order at 7:45 p.m.

Carolyn Pearson (Secretary) - The October Meeting minutes were approved as published.

Cheryl Lewis (Director of Training) reported that two Puppy classes (at 7:00 and 8:00 p.m.) began on October 29th. The four Beginner's classes (at 6:00, 7:00, 8:00 and 9:00 p.m.) began on October 22nd. Cheryl announced that several of the Beginner's classes had to be declared closed prior to the reaching the maximum number of students allowed because there were not enough assistant instructors. Cheryl does not feel that it is fair to the primary instructor (or to the students) to have more students per instructor that can be comfortably taught by one person. This shortage of assistant instructors will need to be resolved before the next session begins in January. Marietta Huber stated that she would like to help instruct, however it is difficult to commit when the training nights are switched to Tuesday nights. It was explained that the club has no say when the training nights are changed by the fairgrounds events coordinators. Cheryl stated that any club members who would like to help but has a similar problem with switching to Tuesdays, should let Cheryl know. She will do her best to accommodate your schedule.

Will Short (Trial Chairperson) announced that stewards need to be at the trial at 7:30 a.m. on Sunday, November 8th. Mike and Debbie Kovacevich reported that they have enough stewards.

He also stated that there is enough help for kitchen and they need to be at the trial at 7:00 a.m.. In order

order to prevent the problems that occurred last year (stewards did not receive any food because their rings did not take a lunch break), a lunch order form has been created for the stewards and judges. The food will be reserved for whenever the ring breaks for lunch. Anyone donating baked goods are asked to be individually wrapped.

Debbie James has volunteered to be the Grounds Chairperson. Ed Herdes stated that there is enough help for take-down after the trial. Carolyn Pearson, Hospitality Chairperson, announced that the Judges dinner has been set for 6:00 p.m. at Erik & Me. Any club members who are not showing are invited to attend. There are 10 booths in the

vendor/kitchen area. Anyone who still might have raffle items should contact Georgia Fiorito. Judy Anderson will be the photographer at the trial.

Taffy Wille (Trial Secretary) reported that she has created a small advertisement for the trial. Anyone who knew of a location to display them should pick one up from Taffy.

She found perforated sheets of paper for the breakdown sheets. She printed the sheets with the class and judge information for each class. Rather than having the table stewards fill out a separate form, she will use the judges books to determine award winners. This will eliminate double work for the table stewards.

Helen Castellano stated that she had a newspaper article announcing our trial that featured Linda Benson.

The stewards are asked to come to the trophy tables prior to the end of the class to pick-up the special awards. The special trophies MUST be handed out in the ring at the conclusion of the class.

Dave Lewis (Waggin' Tales Editor), Carolyn reported for Dave that the next deadline is Tuesday, November 10, 1998.

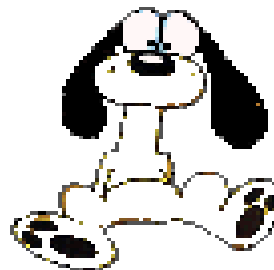

Remembrances of 1998

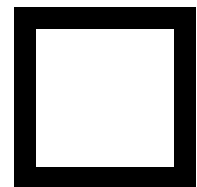
The year 1998 is just about gone by and it is time for me to reflect on the good and sad times the year had in store for us.

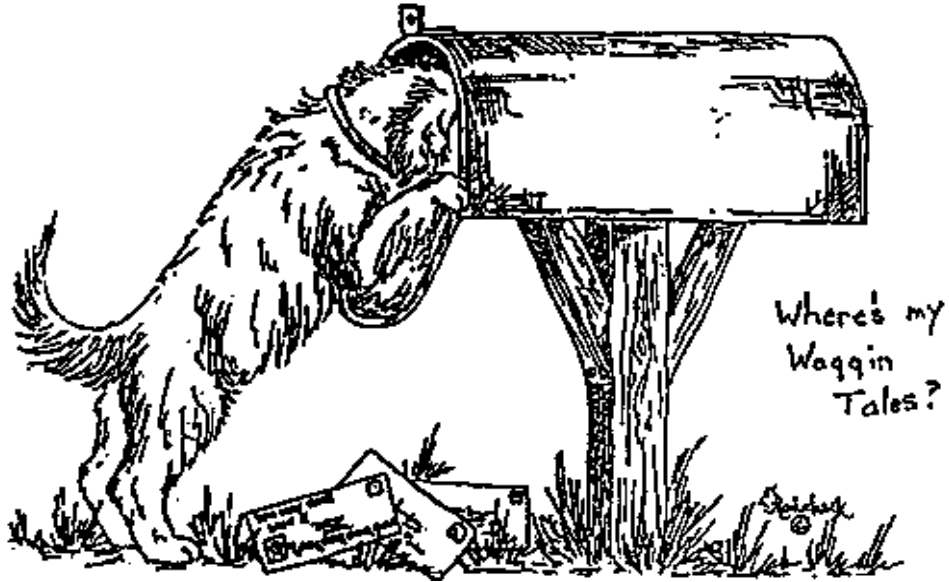
