A special thank you goes to Penny for hosting the meeting in her lovely home. It certainly was more elegant & comfortable than a public place! Gratitude is also extended to Loretta & Marian Lazzara for assisting Penny in this endeavor. It was encouraging to spend time with members who are enthusiastic & dedicated to enhancing the lives of dogs & their people.

As fall & a full calendar of obedience trials approaches, the training floor will become busier. Someone to staff the entrance table is badly needed. It would be greatly appreciated if members would help remind

guest trainers about the \$5 fee & ring procedures. Guest trainers may be directed to any board members who will gladly accept their money.

Due to a number of questions the following is a clarification of training opportunities beyond advanced beginners' class. The ring ready class provides polishing for the novice exercises as well as instruction regarding AKC rules. It is discouraging to have your dog do well in the ring only to lose points or be disqualified because of handler error. This class meets at 7 p.m. The open class at 8 p.m. is for handlers who would like to introduce the behaviors necessary to achieve a CDX title or whose dogs are not yet ready to enter open classes. The 7 p.m. open run-throughs are for dogs who are currently

competing in the open class or just about ready to enter. There is not time to teach or perfect open behaviors during the run-throughs. The 7 p.m. utility class is for handlers & dogs in the learning phase of utility exercises. The 7 p.m. utility run-throughs are for dog/handler teams who are currently competing in utility or just about ready to enter. Again time is not available to teach utility behaviors. Long sits & downs are done at 7 p.m. & 8 p.m.

Anyone interested in becoming part of the instructional staff especially as substitute instructor on Tues. nights may contact Penny or myself. Your help would be greatly appreciated.

ASPCA Animal Poison Control Center Responds to Swiffer Wet Jet Rumor
Veterinary Toxicologists regard allegations of liver failure and death from household cleaner as unfounded.

Friday May 7, 2004

(Urbana, IL) May 6, 2004 -- Veterinary toxicologists at the ASPCA Animal Poison Control Center have reviewed the claim described in a widely distributed email alleging a relationship between the use of Swiffer Wet Jet and liver failure in a dog. The email alleges that exposure to the ingredients in Swiffer Wet Jet caused a dog's death.

The Swiffer Wet Jet system contains water (90-100%), propylene glycol n-propyl ether or propylene glycol n-butyl ether and isopropyl alcohol (1-4%). These ingredients are safe to use around pets when used according to label directions and would not cause liver damage at product concentrations. Propylene glycol n-butyl/propyl ether differs significantly from ethylene glycol, the potentially toxic ingredient present in most antifreeze products. Ethylene glycol is frequently implicated in causing renal failure in dogs following antifreeze ingestion. Propylene glycol n-propyl ether and propylene glycol n-butyl ether are very safe ingredients at levels used in cleaning products and do not cause kidney or liver failure.

Frozen Treats

- 1 ripe banana
- 1/2 cup peanut butter
- 1/4 cup wheat germ
- 1/4 cup chopped unsalted peanuts

In a small bowl, mash banana and peanut butter together using a fork. Mix in wheat germ. Place in refrigerator for about an hour until firm. With your hands, roll rounded teaspoonfuls of mixture into balls. Roll balls in peanuts, coating them evenly. Place on cookie sheet in freezer.

When completely frozen, pack into airtight containers and store in freezer.

**ASPCA Animal Poison Control Center Alert Veterinary Staff and Pet Owners:
Products Sweetened With Xylitol Can Be Toxic to Dogs**
Wednesday July 28, 2004

Since July 2003, the Center managed approximately 45 cases of dogs ingesting xylitol-containing products. (NEW YORK, NY) July 29, 2004 -- The ASPCA Animal Poison Control Center cautions animal owners that xylitol, a sweetener found in certain sugar-free chewing gums, candies and other products can potentially cause serious and even life-threatening problems for pets.

According to Dr. Eric Dunayer, Consulting Veterinarian in Clinical Toxicology for the ASPCA Animal Poison Control Center, dogs ingesting significant amounts of gum or candies solely or largely sweetened with xylitol may develop a fairly sudden drop in blood sugar, resulting in depression, loss of coordination and seizures. "These signs can develop quite rapidly, at times less than 30 minutes after ingestion of the product. Therefore, it is important that pet owners seek veterinary treatment immediately." Dr. Dunayer also stated that some data appears to point to a possible link between xylitol ingestions and the development of liver failure in dogs. However, he cautions "as there is not yet enough solid information pertaining to the relationship between xylitol and liver failure, it would not be appropriate at this point to draw any firm conclusions."

The ASPCA Animal Poison Control Center advises pet owners avoid offering their animals food meant for human consumption, and to be especially diligent in keeping candy, gum or other foods containing xylitol out of the reach of pets. "Typically the main concerns are with products that contain xylitol as one of the first ingredients," advises Dr. Dunayer. As with any potentially toxic substance, should accidental exposures occur, it is important to contact your local veterinarian or the ASPCA Animal Poison Control Center for immediate assistance.

Gentle Reminder to All

PLEASE do not place any garbage, aside from cigarette butts, in the cigarette ash buckets outside of the doors at training. IF there is no garbage can or dumpster available outside to dispose of poop-bags, just put the bags in the inside garbage can closest to the main entrance door.

Instructors, please remind your students of this housekeeping request.

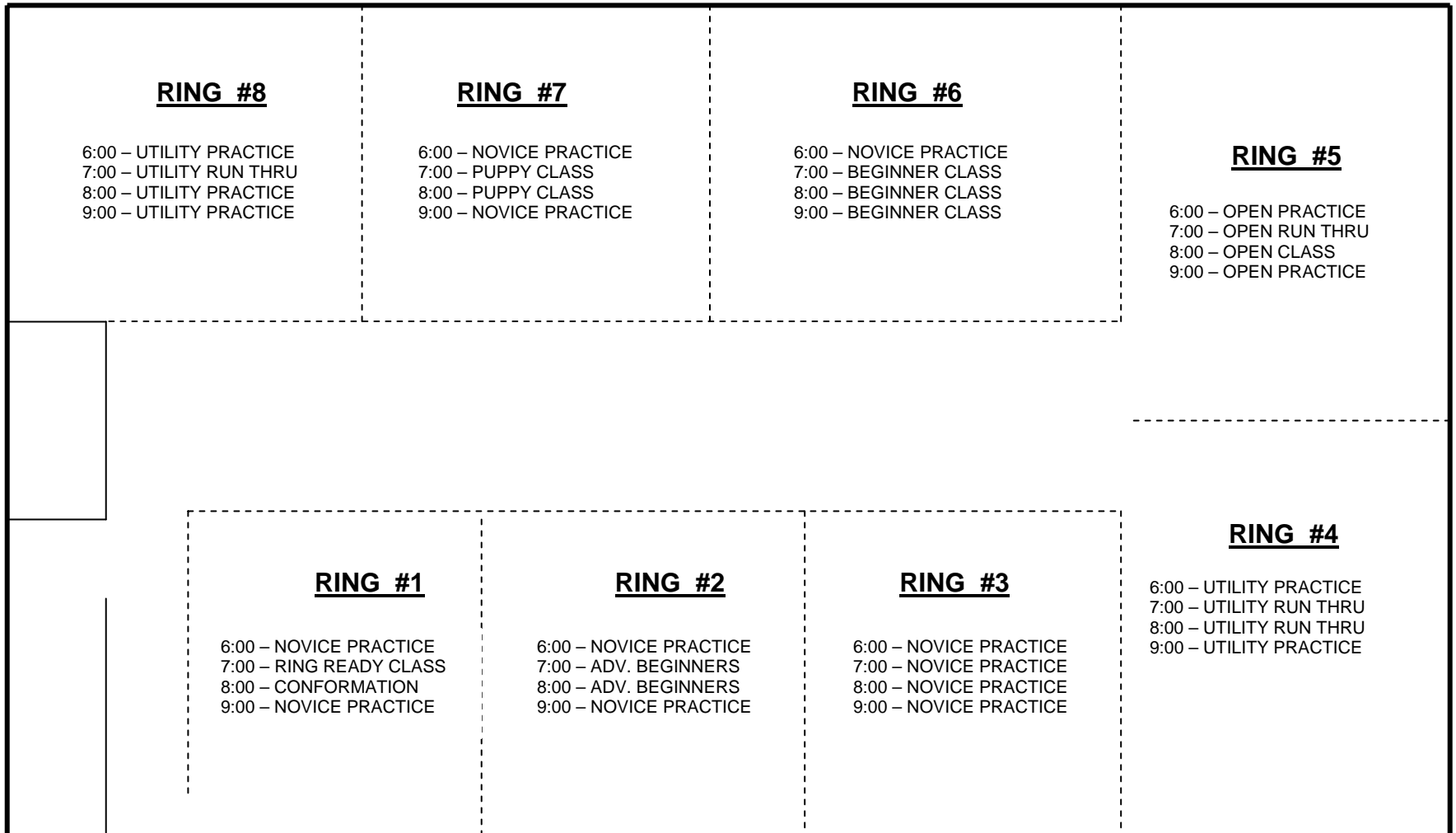

This page is yours to keep, and to help you prepare for the test!

AKC Canine Good Citizen Test Items:

1. Accepting a friendly stranger: Evaluator greets Handler.
2. Sitting politely for petting: Evaluator pets dog, dog must show no signs of shyness or resentment.
3. Appearance & grooming: Evaluator inspects dog, combs or brushes lightly, examines ears and each front foot.
4. Out for a walk: Handler takes dog for a short walk including right turn, left turn, about turn and stop.
5. Walking through a crowd: dog and Handler walk close to several people; dog may show casual interest but not jump up.
6. Sit & down on command/Staying in place: Handler shows dog can do a sit and a down, then chooses either position, leaves dog and goes to the end of a 20 ft. line and returns immediately.
7. Coming when called: with dog still on 20 ft. line, handler walks out 10 ft. and calls the dog.
8. Reaction to another dog: two handlers and dogs approach, shake hands, exchange pleasantries, move on; dogs can show casual interest to either the Handler or the other dog.
9. Reaction to distractions: distractions are presented; dog may not panic or show aggression.
10. Supervised Separation: Handler goes out of sight for 3 minutes. Dog is held on 6ft. lead by Evaluator's assistant. The dog may not display any signs of stress.

IMPORTANT NOTES:

1. Treats and toys are not allowed, but verbal praise and petting is encouraged.
2. Acceptable Collars for the test: leather buckle, nylon buckle, slip chain, or martingale **(pinch/prong, head halters and Gentle Leader are unacceptable)**
3. Acceptable Leads: leather or nylon, up to 6 feet **(flexi, chain and any line longer than 6 feet is not allowed).**
4. You may wish to bring your dog's own brush to the evaluation. You are also allowed to lift your dog's paws for the evaluator in item 3.
5. Exercise your dog just prior to the test and between exercises if necessary. A dog that eliminates during the test is dismissed.
6. As the handler, you can really only test one dog at a time. If you want to test more than one dog, please sign up for more than one testing time.

No dog ever "fails" this test, however some items may require further training. A dog that shows signs of aggression may be dismissed at the Evaluator's discretion.

Please show up 10-15 minutes prior to your testing time, as the test will begin promptly. You must be ready to go at your indicated time! If for some reason you find you are unable to attend your confirmed test time, please contact Barb Misch at 630-761-0823 as early as possible. It is very likely that others would like to take your place.

Checkout Procedure

1. Ask for the cabinet key from person at the Information Table. It is in the lime-green pencil pouch.
2. Retrieve the book that you want to read.
3. Remove the checkout card from the front of the book.
4. On the checkout card, fill in your Name, Phone number, the date you are borrowing the book.
5. The book is due back to the cabinet in 3 weeks.
6. Return the key and the checkout card to the person at the Information Table. Both items will be placed in the lime-green pencil pouch.
7. Take home and enjoy your reading.

Return Procedure

1. Ask for the cabinet key and the checkout card from the person at the Information Table. Both items are in the lime-green pencil pouch.
2. Fill in the Return Date on the checkout card.
3. Return the checkout card to the pouch in the book.
4. Return the book to the cabinet.
5. Return the key to the person at the Information Table.

4. Take home and enjoy your viewing.

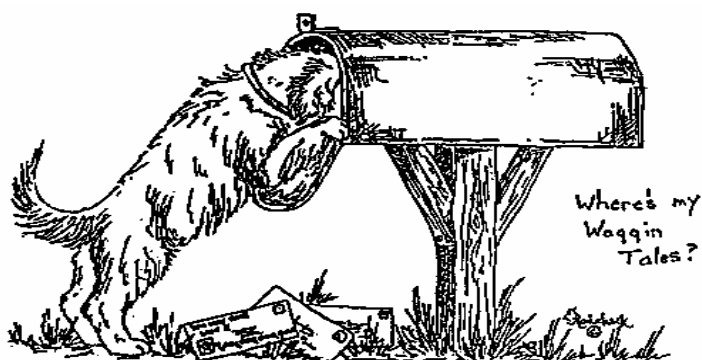
