Meeting brought to order at 7:43 p.m. Carolyn Pearson (Secretary). April Meeting Minutes approved as published.

Assistant Instructors are still needed, anyone interested should contact Priscilla. Front table help would also be appreciated. Cindy also extended her thanks to all those who are continuing as instructors and assistants for Session 3. The effort and time are very much appreciated.

Priscilla Pisarski (Assistant Director of Training) reported that she needs a Primary Instructor for the 8:00 Beginners class.

Sandy Davis (Waggin' Tales Editor) was not in attendance, but sent the following report: The next deadline is Sunday, June 5th.

Will Short (Obedience Trial Chairperson) reported that the following are the judges for the 2006 Obedience trial.

Will also reported that Tammy Fanter is the photographer for the 2005 Obedience trial and that a catalog ad person is still needed. The Trophy Committee chairs have agreed to use four of the existing awards for Novice A for the First through Fourth placements and to use eight of the items for each of the highest scoring in each group. Additionally, in an effort to earn some money for the club, some will be offered to the Raffle Committee Chair. Secretary's Note: As of June 7, Will reported that all the committee chairs have been filled. Julie Dorsey has agreed to chair the Catalog Ad committee.

Barb Misch (Public Education Coordinator) reported that the May 12th CGC Test went quite well. The 6:00 p.m. test was cancelled due to lack of entries, however the evaluator had a last-minute conflict anyway, so things worked out. Becky Jankowski was the evaluator for the 8:00 p.m. test, and six of the eight dogs passed. Barb stated that Becky was a wonderful evaluator and hopes that she is considered again in the future. The representatives from Midwest Therapy Dogs showed a lot of interest and they should be kept up-to-date for future tests. Barb also stated that Margi Stuessy and all the others who

helped that night were invaluable to her.

Barb also reported about a minor incident between a Correction Clinic participant and a CGC test participant. As the CGC participant entered the building for the first time, a Correction Clinic participant harshly informed her that they "had better keep their dog away from hers because they just don't need that tonight." Unfortunately, Barb was unable to determine who the Correction Clinic participant was to discuss it with them at the time. However, she wanted to remind everyone who does any training at Fox Valley that we do have visitors all the time, and aside from patience being a quality that conveys good manners, it is also expected of anyone who could be perceived as representing this club. She also stated that she would have preferred that the person direct harsh words to her, rather than to our CGC Test participants, to allow her to deal with her concerns. The CGC Test participant's dog was young and a little jumpy; there was no attack, no growl, and no contact. The Correction Clinic participant saw the participant headed her direction and tossed this comment at her.

The Rover Rescue Pet Dog Show was a lot of fun! Jan Schomer and Camper, Suzan Scott and Rico, Cheryl Hettinger and I talked with lots of dog lovers and shared a good deal of information.

Next on Barb's to-do list is to begin planning Responsible Dog Owner's (RDO) week in September. Anyone with ideas for any events that should be considered for the week, such as demos to crazy things...like, well, anything, should let Barb know by mid-July.

Did You Know...from the ASPCA



Did You Know...the arrival of Spring and Summer brings lots of fresh oranges, grapefruits, peaches, cherries, apples and many other delectable fruits. However, certain parts of these fruits can be potentially irritating - or even occasionally toxic in some situations- to our companion animals.

The peels, fruit and seeds of citrus plants such as lemons, oranges, limes and grapefruits contain varying amounts of citric acid, limonin and volatile oils that can cause gastrointestinal irritation such as vomiting or diarrhea if ingested. In some cases, exposures to high concentrations of these substances (such as those found in certain citrus-based cleaners) could possibly result in central nervous system depression as well. The stems, leaves and seeds of apples, cherries, peaches, apricots and certain other fruit trees contain cyanogenic glycosides that have the potential to cause vomiting and loss of appetite, and in severe cases weakness, incoordination, difficulty in breathing, hyperventilation, shock, coma and even death could occur.

Typically, these severe effects develop from very large ingestions of plant material that are more likely to occur with grazing animals such as horses or other livestock. The consumption of a few segments of citrus fruit, an apple or two or a few cherries would usually not be expected to cause serious problems beyond perhaps minor stomach upset. However, it is important for animal owners to be aware of the potential for problems that these fruit trees can produce.

Companion animal owners should try to become familiar with the different types of plants in and around their home, and make sure that the plant material of potentially poisonous species are not accessible to pets. If you suspect that your pet may have ingested a poisonous plant, contact your local veterinarian or the ASPCA Animal Poison Control Center (1-888-426-4435) for immediate assistance.



Did you know that depending on the form, iron is not only potentially toxic to pets, but can be found in a variety of forms and in many different products and substances?

Iron poisoning is the number one toxic fatality in children, and pets can be susceptible to iron poisoning as well. Some vitamin formulations are chewable and may be eaten in large amounts. Depending on the brand and formulation, as little as 2 prenatal vitamin tablets with iron can cause stomach upset in a 20 lb dog, whereas as few as 6 tablets can potentially cause more serious problems.

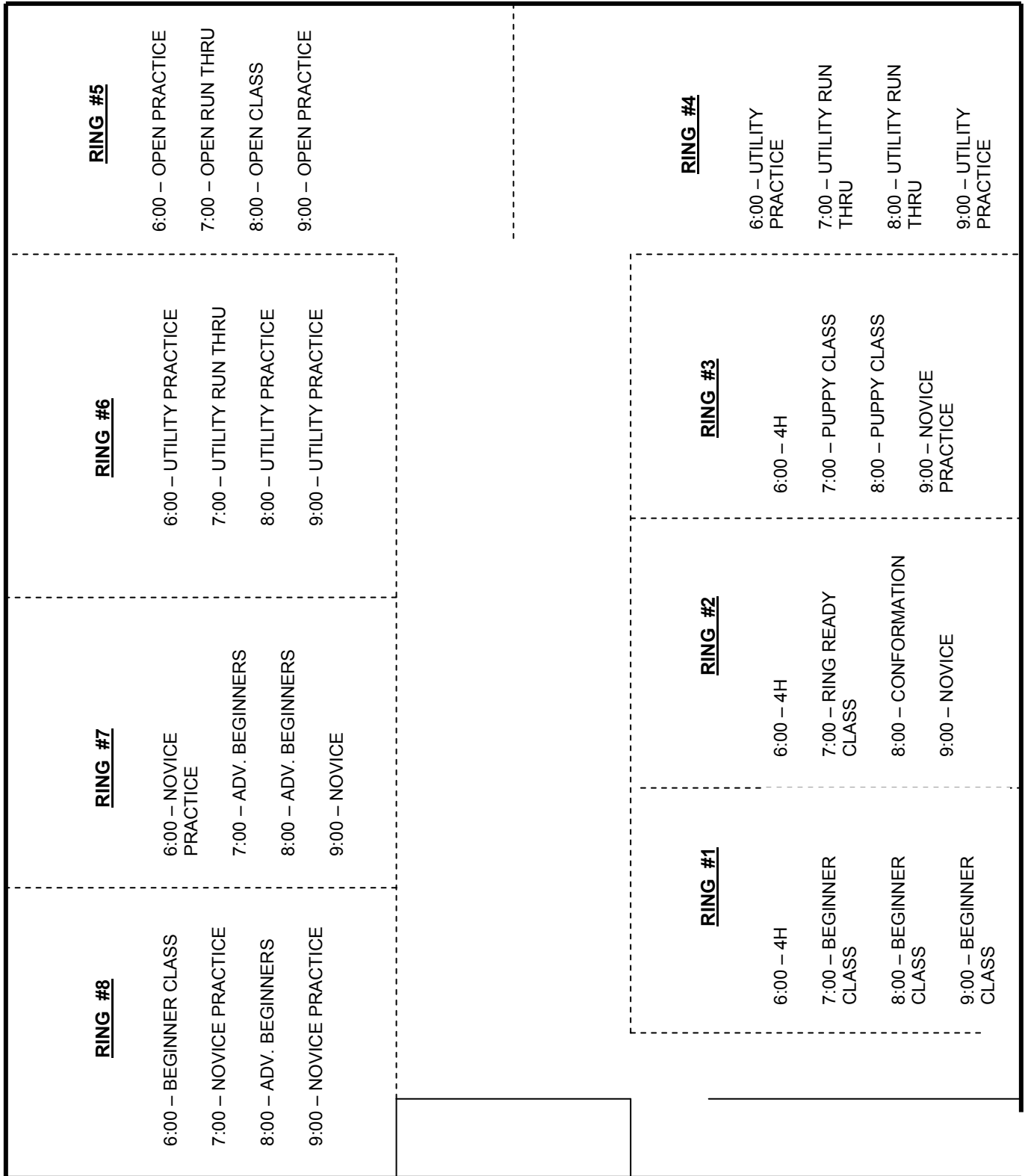
Depending on the form of iron and amount ingested, within the first few hours animals may initially exhibit signs of significant gastrointestinal irritation and pain, including vomiting and diarrhea which can be bloody. Subsequently, the pet may appear to recover, but approximately 12 - 24 hours following ingestion, gastrointestinal signs may reappear, along with severe depression, shock, low blood sugar, seizures, hemorrhage from blood clotting problems, fluid accumulation in the lungs, liver damage with jaundice, and possibly even kidney failure.

If you suspect that your pet may have ingested a product or substance containing iron, contact your local veterinarian or the ASPCA Animal Poison Control Center (1-888-426-4435) for immediate assistance.

she believes the foreclosure price is \$180,000 for 18 acres; however that information must be confirmed with Dennis, who was going to do a title search today. It is believed that the property includes a house (Dennis thought that it could be used as a club house), a pole barn, a two car garage, approximately 30' x 50' and nursery stock that would need to be moved. Peggy stated that she knows of an auction house in Woodstock that can handle a sale of the nursery stock.

The foreclosure date is tentatively June 16<sup>th</sup>. With that very tight timeframe, Dennis stated that he was considering purchasing the property himself and that he would offer one of the following three options to FVDTC.

- we could purchase the property outright from him
- we could purchase the property on contract from him (the Board preferred method)
- we could rent a building at the same price that we currently pay for the fairgrounds

In addition to Francene, Helen, Peggy and Taffy also looked at the property. According to their evaluation of the exterior of the building, it appears that the pole building can be used immediately for training. However, the floor may not be solid. Concrete and asphalt were several of the flooring options that were briefly discussed. Taffy asked whether a purchase on contract might also include the financing. If that were true, that would be an ideal situation for FVDTC.

It was agreed that we would definitely like to be kept abreast of this situation. We would like to learn whether the entire property could be sub-divided, according to the Kane County 2030 Land Use Plan. Francene stated that she will send an e-mail message to Dennis with these questions. She will forward his response to the Board members when it is received.

#### **Lifetime Members and Membership Renewal Forms**

During the February 2, 2005 Board meeting, Sue MacPherson asked the Board to consider whether the club should require all lifetime members to submit membership renewal applications every year. Will Short stated that as long as the by-laws do not specifically state that the lifetime members do not need to submit membership renewal applications every year, then we should require the lifetime members to do so. Will Short made a motion that we require lifetime members to submit the renewals applications annually. Sue MacPherson seconded the motion. During the discussion, it was asked what would happen to the non-complying lifetime members. Although they would continue to remain in the membership database, would they continue receiving the Waggin' Tales newsletters and still have their name included in the roster? The motion to require lifetime members to submit the renewals applications annually passed with the following results, six approved, five opposed and no abstentions.

Cindy stated that if we did not continue providing the Waggin' Tales and inclusion in the roster, to the lifetime members who failed to submit an application, the by-laws would need to be

changed. Dean Connolly made a motion to table the discussion of the non-compliance until next Board meeting. Will Short seconded the motion. All Board members approved the motion to table the discussion of the non-compliance until next Board meeting.

Barb Misch made a motion take the discussion of the non-compliance off the table. Peggy suggested that we change the by-laws so that the requirement to submit a renewal form would be effective at a certain date in the future. Francene asked whether the lifetime club members who were unwilling to return the form would be willing to be active in the club in other ways. Taffy stated that we currently have a procedure in the by-laws that allows any member may be dismissed and his/her rights cancelled for a good cause. The member's name and information would be removed from the roster, but not removed from the membership database and the member would no longer receive the Waggin' Tales.

Barb made the following motion.

Any lifetime member, who fails to send in a membership renewal form, would be sent a return receipt request letter pursuant to by-law section 4.2.2, which states *[Any member may be dismissed and his/her rights cancelled for a good cause, after said cause having first been reviewed by the Board of Directors and, if necessary by the membership-at-large, by a two-thirds majority vote of the members present and voting. However, no member shall be dismissed for any cause until he/she has been notified by the Secretary of the charges made and shall have an opportunity to reply in his/her defense, either in writing or in person, at the next regular meeting.]*, asking that the lifetime member comply with the requirement or he/she will be dropped from the membership roster. A letter would be sent by the secretary to notify the member that his/her membership would be cancelled unless a response is received from the member prior to or presented at the October Membership meeting.

Priscilla seconded the motion. During the discussion, Peggy asked why we do not simply contact the lifetime members who do not submit their membership renewal form. However attempts such as that which were made in the past were not successful. Sue reported that approximately fifteen to twenty lifetime club members do not return a membership renewal form. There are currently several lifetime members listed in the roster that Sue does not have a valid address in the membership database. The motion passed with the following results, nine approved, one opposed and one abstention.

#### **Obedience Trial Trophies**

Will stated that he passed the information that Peggy sent to him about her sponsorship of all of the High Scoring Group trophies to the trophy committee. Peggy stated that she asked because she had not heard anything from the Trophy Committee. Will reported that the Trophy Committee agreed that using some of the trophies that last year's trophy committee purchased from Peggy Sue Seehafer would be a good idea. A total of twelve of those items would be used, eight would be used for the Group

trophies and then four for the Novice A placements.

Dave told Will that the Board's approval of the trophy had been skipped this year, and that we need to make sure that the problem does not recur next year. Carolyn reminded Will that in the past, the Trophy Committee presented a list of the trophies to the Board for review and approval prior to the list being presented as finalized. Will stated that he did let the committee know, but was not aware that the committee had not done so. Carolyn reminded Will that as the Trial Chair, he was responsible for coordinated all committee activities. Next year the Trophy committee must present the trophy list to the board for review and approval. Dave stated that Penny Breich will bring the remaining items to him for use by other committees. Francene stated that she would like to review the items for possible use by the Tracking Test Committee. Any other committee chairs that might be interested in using any of the many items should contact Dave Lewis.

### New Business

#### **Purchase of Electronic Timers for Agility Tests**

Helen made a motion that FVDTC purchase two sets of electronic timers (e-timers) as soon as practicable with rechargeable battery packs to be used at our annual agility trials. The amount is not to exceed \$3,400 plus the shipping costs. Peggy Sue seconded the motion. Helen stated that the majority of the Agility Trial Committee Chairs agreed that using the e-timers would be beneficial to use at the agility trial for the following reasons.

- It would be easier to get individuals to act as Timers, because the job is easier.
- Trials run smoother and are finished quicker.
- Human error is eliminated, which is important for the individuals competing in the Excellent classes.

Helen stated that she considered the following two options prior to making her motion to purchase the e-timers.

- Option 1 - Rent e-timers from Agility Ability. The cost would be \$300 for both days, plus a \$250 damage deposit, plus a free entry to one person/dog each day of trial, plus supply the batteries needed to operate the e-timers. Additionally if the e-timers were damaged, we would be responsible for the cost of repairs or \$1,600 per set for replacement.
- Option 2 - Purchase two sets of e-timers. The cost would be \$1,600 per set, plus \$45 per battery recharger (a highly recommended item). That total is \$3,290 plus the cost of the shipping. The shipping cost was not known at this time. These prices are from the Signature Gear company.

Helen proposed that we increase the entry fees for next year's trials to help offset this purchase. Additionally, she stated that in the past three years, the agility trials' total profit was \$13,883 and the committee has never requested to purchase any agility equipment until now.

During the discussion, Dean stated that purchasing the e-timers demonstrates the club's commitment to improving the overall quality of our trials and eliminate human error. Francene stated that the agility trial committee deserves to work with equipment appropriate for the times and in line with what is used throughout the agility trial world. Barb and Taffy both agreed that making this financial commitment to such an important club event was logical. Cindy stated that after observing the use of the electronic timers at a recent agility trial, she saw their value and also some problems.

The following questions were raised.

- *Who would maintain the units?* - Unknown
- *Who would store the units?* - Helen volunteered at this time. However anyone doing it in the future would have to be "board-approved".
- *Who would set-up and service the units at trials?* - Helen stated that we have at least three current club members who can operate the units. The individual would also have to agree to train people at the trials so that the units can be restarted should they stop working.
- *Would the timers be rented out to other clubs?* - It is possible to lease the units. However, Peggy suggested that we do not lease them out initially.
- *Would the timers be covered by insurance?* - Need to check with Amy to see if the club's insurance policy would extend to the timers? Or would the individual, who is storing the timers, insurance cover the timers?
- *Can other types of timers be used for timing?* - Francene and Peggy Sue volunteered to investigate the possibility of using timers such as those used at equine events.

Helen also noted that we did not fill our entries at the 2004 Agility Trial. However, any or all of the following factors could have caused that.

- The club did not use the e-timers
- Exhibitors do not like Mike Bond or his facility
- Exhibitors did not like the equipment, which is currently in the process of being replaced

The Board approved the use the e-timers for the 2005 Agility Trials. That information will be placed on the front page of the Premium List. The e-timers used will either be rented from Agility Ability or purchased by the club.

A motion was made, seconded and approved to adjourn the meeting at 9:18 p.m.

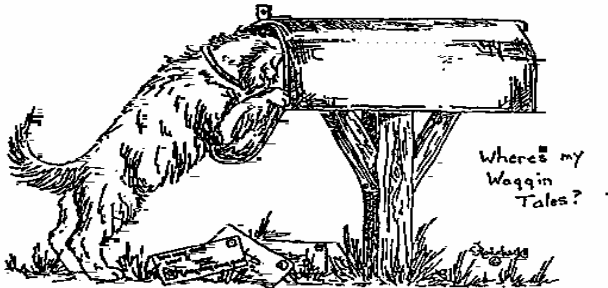
