#### **AGILITY**

Club Member, Marietta Huber, is very proud to announce the results of the World Tournament held in Denmark on Oct 4-5. The USA/AKC sent 4 dogs/handlers to compete on the Standard Team and 4 dogs/handlers to compete on the Mini dog Team. Each dog competed in two runs in a team event and 2 runs for individual scoring. With 2 border collies, a golden and a malinois, the USA Standard team placed 11th, and the 3 shelties and SQUIGGLES (beagle) also placed 11th in the Mini division! Running 4 perfect rounds, SQUIGGLES placed 13th on an individual basis!

All the dogs worked to their very best and only when pushed for speed on the last round, did they go off course or miss a contact! The competition was very tough, with the European dogs pumped for speed! But the new president of the AKC, Al & his wife - Patricia, the Captain - Sharon Anderson and Coach - Dan Dege, were very proud and supportive of their "all girl" teams!

The fans were as crazy as our
football fans, ringing cow bells &
blowing air horns! Many of the
cheering fans had painted their
faces in the colors of their national
flags! No wonder why two of our
shelties froze in fear!

Switzerland, Netherlands and Denmark placed 1st, 2nd, 3rd in the Standard division, while Denmark, Finland, Norway placed 1st, 2nd, 3rd in the Mini division. In the individual standings, two border collies placed 1st & 3rd, and a Beauceron \*\* placed 2nd for the Standard dogs, while a mini schnauzer and 2 shelties placed 1st, 2nd & 3rd for the Mini dogs.

The 3rd place sheltie was run by a 13 year old girl in her 1st major competition! Unlike the dog shows here at home, 90% of the handlers in this event were young, athletic men!

Marietta was happy to discover another beagle was competing and was able to converse with his handler on the Belgium team! The feelings at this event was that most Europeans favored having the American team there, and they were eager to trade agility t-shirts and national pins with us! While all of the European dogs ,...,ere much faster then our dogs here in the States, the general consensus was that most of the European dogs were very aggressive and not at all socialized as our dogs!

For Marietta, being selected to run on the World Team was truly a wonderful experience, and undoubtedly the highlight of her career!

\*\* A Beauceron is a French dog that looks like a cross between a rottweiler & a doberman! This one was very fast & very aggressive, wearing a prong collar & muzzle when not competing! Will this breed now become a the "new" agility dog for us? Wait & see! There are 2 adults & 11 puppies now members of the Animal Inn in Minnesota!

On the weekend following her return from Denmark, Marietta competed in another big agility AKC event - the National Championship event held McCormick Place! Not having recovered from the time change yet, Marietta & SQUIGGLES were understandably "off a beat", turning in 2 perfect rounds & 2 rounds with off courses, putting **SQUIGGLES** in 15th place. However, the big placement went to her chocolate lab, RAINBOW who was "flying high" and placed 5th among the country's top agility dogs, clocking in times much faster than the beagle! According to Marietta, this is usually the case, however who bothers to watch a "brown" dog run, where your eyes are caught by a flashy beagle!

#### Holiday classic

Those of you who missed attending the classic held 11/29 and 11/30 at the Odeum missed a chance to see the top handlers in the country and their dogs.

I worked as a steward in one of the novice rings on Saturday. There were two Fox Valley members in the class - Mike K and Cathy Fluery. Each had a little trouble along the way, but I give them much credit for getting out there and competing in such a stressful setting. Poor Cathy had everything happen in about half an hour - one heeling pattern, sits and downs, another heeling pattern in the other ring and sits and downs again. Chance and Cathy were a little stressed. (Chance was the high scoring rott in novice)

I saw other Fox Valley members who were entered, Bridget Carlson and Sue Maybourne. Former member Bonnie Barry was in from out of town. I wasn't there on Sunday due to other commitments, so I can't give you a run down on who won what.

I did see a handful of members either working or watching, but our newer members lost out on a golden opportunity to see the best working their dogs. I was inspired to go home and work my dogs and just like W.C. Fields, took to bed until it passed.

Seriously, if the opportunity comes up again for a regional or the classic to be in our area, cancel your other plans and get there, no matter what. I've worked at a regional previously and am glad that I was able to help with the classic.

#### From the Editor:

I was at a couple trials in November and had a couple conversations with spectators and Novice A people. Some of these conversations made me think about the image these people are getting. One lady who was there observing, asked me how a dog got a ribbon. I explained to her what it takes to get a title and what it takes to qualify. When I told her a score of 170 or better out of 200 was required she said, "That's a lot". She was right, a 170 is 85%, which would be a "B" at most Most people never achieve perfect or near perfect grades, yet we expect that of our dogs. One Novice A person after watching Open A and Novice classes said, "I feel much better, I think my dog can do that." She was not referring to those dogs who had high scores or placed, she was referring to dogs that were 'just like hers', made mistakes, but still qualified.

At that same trial I overheard several people remarking how their dog could do so much better than the dog currently in the ring and commenting on all the mistakes they could see. I hoped none of those 'newcomers' heard those conversations and were too discouraged from entering any trials because their dogs were not perfect.

My dog Holli did N.Q. at that trial, and I did see the looks on some faces as I happily left the ring. I'm sure some thought I was insane and should have been embarrassed Some probably thought my dog wasn't ready to enter a trial.

Actually, I was very pleased with Holli's performance and anyone who had seen Holli at training would know she is ready for trials. Holli is my only dog who loves to heel. Much to the disgust of my other dogs who figure she is not smart enough to figure out that heeling has no practical purpose. Unfortunately, Holli is also extremely aware of her surroundings. The tension at a trial between the dogs and handlers is much too much for Holli. She can't figure out why everyone is so scared, she thinks this should be fun. But there must be a good she becomes reason, so progressively more scared and tense the longer she exposed to this tension. Once in the ring, Holli is so scared she can no longer sit. When she gets off lead, she may decide she has to go home and tries to leave the ring.

I have learned to bring Holli directly into the ring from the car. This way, by the time she realizes what is going on, it's over.

Holli is also taking a Bach flower 'potion', which is supposed to counter stress. It seems to be working.

So when I take Holli in the ring now, she heels, happily. She sits most every time. She stays with me off lead. And if she blows the recall, I am still happy that she has come so far.

Soon I will try to show Holli in Agility and she will be taking her potion - at least at first. She is a much happier dog now and I expect she will earn several titles next year.

CH Heather Glen As Handsome Does, Am. Can. UDT. He also won about 20 HIT's.

I won't go into all the other dogs I trained at Fox Valley - I think about 40 titles - conformation, obedience and tracking. I went to a lot of shows with Debbie Orr, Jane Wiedel, Mary Bradley, Janie Feuerborn and Dorothy Vettel - we had a lot of fun! Serving as Assistant Director of Training with Dorothy for 7 years, I saw many changes and watched the club grow into one of the biggest and BEST - all the Members worked so hard! Edith Blase was always there to help. Sally Compton, Ed Kneip, Alice Larson - I can't name them all!

#### Board Meeting Highlights December 3, 1997

Meeting brought to order at 7:45 p.m.

August Meeting Minutes were approved as published. Several items of correspondence read.

Cindy Pakenas (Second Vice-President) briefly discussed the demonstration at the YMCA on December 5<sup>th</sup>. The club members involved would be bringing their own jumps. Cindy would like to be able to encourage others to get more involved with dog training to demonstrate that competition obedience is not the only thing that the puppy and beginners' classes can lead to. The mats are to be picked up by individuals from the YMCA. Cindy announced that there are 6 to 8 club members involved in the demonstration.

Penny Legner (Treasurer) reported that she has not received the November bank statements. Once that information has been received the final financial information for the November Obedience trial will be released. Penny stated that she would like to send out information on the club finance's to all club members once the books have been reconciled after the end of the year. This information would include a comparison for the last three years. Penny made a motion to be allowed to spend \$70.00 to send out to the information to the club members as a special mailing. Judy Anderson seconded the motion, all members approved the motion.

Penny also stated that she is investigating the possibility of obtaining a "secured" credit card. A credit card is secured by the fact that a certain balance is maintained in the savings account to which it is attached. This card would be used for large purchases, i.e. ordering collars for the beginner's classes, and would prevent club members from having to use personal cards to make approved purchases for the club.

Cheryl Lewis (Director of Training) reported that she is looking for volunteers for the next session which begins on January 8<sup>th</sup>. Current instructors will have a one week break during the holidays. Cheryl will put up a sign for looking volunteers for the December 30<sup>th</sup> Christmas party. It was suggested that perhaps a freestyle demonstration can be done at the Christmas party.

Cheryl reported that the building officially opens at 6:00 p.m. for training. Judy Anderson stated that when she was Director of Training (DOT), our insurance policy required that a DOT or a DOT appointed club member must be on the premises prior to allowing usage of the building. We will ask Penny Legner to verify if this clause is still in our insurance policy.

### Waggin' Tales

Cheryl will post signs notifying that <u>all</u> quest trainers are required to pay regardless of what time they arrive.

Will Short (Trial Chairperson) reported for Trial Chairperson and Secretary. He stated that the AKC Representative had positive comments regarding the Obedience trial, as well as some suggestions for changes to the ring layout for next year. Those suggestions will be researched for feasibility.

The contracts for the judges for the 1998 trial were mailed on December 2, 1997. Once they have been confirmed and signed, the judges and their classes will be announced.

Kay Weber (Waggin' Tales Editor) stated that the next deadline will be the Monday, December 15th. Kay reported that she is checking into a non-profit stamp from the post office for the Waggin' Tales mailing to determine if we can save any money when mailing out the Waggin' Tales. The information will be sent to her.

Peggy Sue Seehafer (Graduation Chairperson) announced that the final graduation for 1997 will be held on TUESDAY, December 23<sup>rd</sup>. She has all volunteers necessary for this Graduation. Cathy Fleury and Rick Cox are judging the 7:00 p.m. Beginner's classes, Shirley Short will judge the 8:00 p.m. class and Will Short will do the 9:00 p.m..

Judy Anderson (Membership Chairperson) reported that will be at least seven membership applications to be voted on at the January Membership Meeting. The prorated monthly amount for membership application is \$7.50.

Tracey Mohr (Public Education Liaison) announced that the AKC Stewards book arrived two days after the trial. She will distribute them to the necessary individuals. Anyone that needs a copy should contact Tracey.

Kay handed out a letter from the awards committee regarding the reasons for the "recommended changes to the Awards program".

There were several club members present at the Board Meeting who wished to express their concerns regarding the direction that the current Awards' Committee had gone with the 1997 Awards Package. Several Board members stated that they were confused by the awards form as it was published. Kay Weber explained that the document had been created with "shading" that did not copy well when the Waggin' Tales was assembled at the printer. She stated that she would redo the form and have it available at training for club members to pickup.

Much of the discussion entailed whether or not the awards structure could be changed at this time for titles that were earned during the past year. The majority of the Board member present felt that it would be unfair to change the awards structure at the end of year - rather than the beginning of the year. The club members should be aware at the beginning of the year of how the awards will be handled for the year, not the end of the year.

Cheryl Lewis reminded the members present that the survey done by the awards committee was to be for information purposes to initiate discussion regarding the present awards structure, NOT to be considered as a vote.

The other item discussed at length was the combination of the CKC Awards into the "Non-AKC Titles" grouping. During the September 4, 1996 Membership meeting, it was voted that the "Canadian awards be maintained as they currently stand". This vote was taken after a great deal of discussion regarding the

financial aspects (how they might be financially supported for the future) and whether this was entirely necessary given that fact that club morale seemed to be low - don't add to the sliding morale by "taking away" things from the club members. - The motion was approved by 40 members and opposed by two. Given this membership vote, the Board did not feel that the combination of CKC awards with the other non-AKC awards was appropriate.

Cindy Pakenas stated that determining a club "mission statement" would help to decide the purpose of the awards. We should define "why we offer the awards".

Kay stated that there is a need to order the round FVDTC patches for: AKC-UD, CKC-OTCH, AKC-UDX, VST. After a brief discussion, it was decided that the order should contain 25 of each. Will Short made a motion to spend the money necessary to replenish our supply of club patches. Cheryl Lewis seconded the motion. It was approved by all Board members present.

Peggy Sue Seehafer made a motion that the awards for 1997 be left as they have been in the past year. The motion was seconded by Will Short and approved by Cindy Pakenas, Carolyn Pearson, Cheryl Lewis, Will Short and Tracey Mohr. Kay Weber abstained. No one opposed.

A motion was made, seconded and approved to adjourn the meeting at 10:20 p.m..


