#### IN MEMORY OF DOROTHY VETTEL

On August 3rd the dog world lost a dedicated friend: Dorothy Vettel died in Harrison, Arkansas at the age of 78. Dorothy started in obedience in 1952 after the breeder of her cocker puppy told her that the puppy should have dog training. (The breeder just happened to be Aldythe Comstock, one of the founders of our club.) Dorothy obviously enjoyed training enough to devote nearly 50 years of her life to it.

Fox Valley trained at the bird house in Phillips Park until 1961, when they moved to the Armory in downtown Aurora. In 1968 the Armory burned down and we moved to our present location at the Kane County Fairgrounds. Dorothy served two terms as president of the club from 1955 to 1957. At one time or another she held every office except treasurer. She was a board member for many years. She was Waggin' Tales editor from 1973 - 1978 and served on many different committees. She received the Dog World Award For Outstanding Service in 1961.

Another of Dorothy's loves was 4H dog training. She tutored classes for 4-H for many years and helped write the 4H Dog Training Manual. In 1968 Dorothy started judging Novice; in '69 she judged Open and in '71 Utility for AKC. She also helped many of

THAT is what we are training our dogs, communication. Them understanding us and us listening to them. If a command is too harsh (which may be verbal as well as contact) then the results may backfire on us.

The use of electric collars is nothing new. The same with prong or choke collars. The handler is the one that controls those tools. In the educated hands these tools can prove to be very effective and kind. Such collars have approximately the same effect on dogs as electric fences. Why are electric fences not up for debate? Is it not better to try to communicate with the dog in the teaching process to let them know through your supervision rather than letting the fence do the teaching?

**New Business** 

#### Use of electric/stimulator training collars at training

This special meeting was held to discuss a series of emails, phone calls and personal comments regarding the use of electric/stimulator training collars at training during the June correction clinic. The correction clinic committee asked the Board to make a policy prior to the August 17<sup>th</sup> correction clinic regarding the use of the collars rather than "leaving it to the discretion of the clinic judge". The correction clinic committee members felt that it was too open for confusion – the exhibitors would not know from one judge to another whether a stimulator collar was allowed in the ring or not. The communication was from

members as well as non-members. The majority of the communication supported the ban of the stimulator collars. Each concern was addressed and discussed. Several of the board members also asked questions regarding the proper use of the collars. Issues and concerns that were addressed and played a part in the decision were:

- Use of many collars in the building. For instance, without a large selection of frequencies available, it is possible to correct a dog other than your own.
- The perception of people coming in to observe our training methods and perceiving that we are "electrocuting" our dogs. This perception can also occur with the use of the citronella anti-bark collars because their design is similar to the stimulator training collar. Unfortunately, not every person walking in to observe our training methods can be educated immediately, should they view someone using a "collar with a box". This can be damaging to the image that Fox Valley strives to achieve to the

general dog-owning public, that we are a great place to bring your dog to train. Our bylaws state "3.11 To provide training to other community organizations, such as 4H, Girl Scouts, Boy Scouts, or others who desire to have such training services provided to them on an organizational basis." Looking at that from a business standpoint, we cannot afford to "push" the community away from us, before we've had a chance to properly educate them about our training methods and the use of appropriate training tools. Any person seeking to learn about our club (whether to take a puppy or beginner classes, etc.) is strongly ENCOURAGED to drop by and see what we are all about. It is not always possible to greet those individuals visiting us for the first time.

- The discussion also entailed the many positive aspects of using the stimulator collar to correct a specific training problem. The stimulator collars can be used to effectively and quickly correct problems that have eluded other training corrections.
- Several of the board members also discussed the misuse of more standard training methods. It is possible to incorrectly use ANY training tool, one board member discussed the permanent esophageal damage done to their dog on a nylon slip collar.
- It is possible to misuse ANY training tool, and cause discomfort to the dog. Even a poorly timed "look" can cause a dog to be uncomfortable.

The board members want the membership to clearly understand that we take our responsibility very seriously of making decisions regarding all aspects of our club (By-laws section 5.3.1 - The duties of the Board shall be to determine policies of the Club and to make all necessary decisions not covered by these By-Laws. A quorum shall consist of at least five (5) members excluding the President.). This means we must find the balance of satisfying our club members and satisfying the general community members' needs by providing an educated and kind training facility. It is through the community members that we welcome new club members into our club.

After a very difficult discussion, the board members felt that as a business decision, it was best to set a policy to ban the use of the collars on the training grounds. The discussion looked at both sides of the issue: allowing our members to use their training tools, as well as maintain our responsibility to the general petowning public. We also stated that after the policy was publicized, that any and all club members would be strongly encouraged to present their opinions to the board regarding this policy. Judy Anderson made a motion to ban the use of stimulator collars at the Fox Valley training site. Will Short seconded the motion, the motion was approved by four and opposed by three Board members. There were no abstentions.

#### Graduation

It was suggested by several Board members to change the current format of the Beginner's class Graduation. Currently the 10<sup>th</sup> week of class is devoted to the beginner's students "performing" what they have learned in the past nine weeks in front of a "judge". This is similar to a novice run-through at a pre-novice level. Many of the Board members expressed concern about the stress level that the students experience during the run-through. It was felt by many Board members that due to the stress, many students may not be exhibiting the true extent of their training improvements. During the discussion, it was suggested that perhaps the most accurate method of evaluating a beginner's student progress would be the observations of the instructors over the 10 weeks of class. The final evening of class would be changed from a night of unnecessary stress to a celebration of all that the students have accomplished. The responsibilities of the Graduation Chairperson would change to more of a "celebration coordinator". The instructors would then be responsible for providing feedback to each student whether they should continue to the Advanced Beginners classes or whether they would benefit from repeating the Beginner's class. After the discussion, Will Short made a motion to eliminate the current format of Beginner's class Graduation. Dave Lewis seconded the motion. The motion was approved by all members present, without any abstentions.


#### Awards for the November Obedience Trial
