#### **AIRLINE EMBARGO UPDATE**

During the summer months numerous airlines instituted embargoes on shipping dogs as excess baggage. In spite of AKC meetings with airline officials, pressure from the dog-owning public and ... letters from AKC President Al Cheauré to airlines' executives, several airlines have decided to continue these embargoes indefinitely.

United Airlines [and] TWA and Continental confirmed that they ... are extending their embargoes indefinitely. Small dogs may travel in the cabin of the plane but larger pets must travel as cargo. Continental offers a "Quik Pak" excess baggage express service but at a high cost to the shipper. All other major airlines have told us they are not extending their summer embargo policies.

AKC urges fanciers to contact the airlines directly for updates on their policies. Travelers should make arrangements well in advance and confirm their plans shortly before departure date. Also, we encourage you to contact the airlines imposing embargoes to express your opposition to these policies. Please see former postings on our web site for names and addresses of airlines' executives and a sample opposition letter.

# NOTES FROM THE MEMBERSHIP MEETING

#### Membership Meeting Highlights October 4, 2000

Meeting brought to order at 7:50 p.m.

Prior to start of the regular club business, as published in the September Waggin' Tales, a vote was taken to determine whether the membership wished to approve or not approve the policy recently announced by the Board. Prior to the initiation of the voting, Francene Andresen questioned whether our by-laws allowed for the use of "absentee ballots". She stated that according to Robert's Rules, the bylaws must include for that method if they are to be used. Our by-laws only specify a method for the voting for the board members, new members, the bylaws and club dissolution. Although there is nothing specific about absentee ballots in our by-laws, the procedure was published well in advance of the meeting to allow sufficient notification time. Carolyn Pearson stated that the reason that the method was offered for this issue is that in the past, many club members have expressed disappointment about being unable to attend meetings when an issue was being voted on.

Peggy Sue reviewed the procedures and re-read the policy as it was published. When it was assured that all members present understood what was being voted on, the following was read and a hand count was done. The number of votes is in parenthesis following the statement. The number of votes also includes the absentee ballots. There were 26 voting members present plus 10 write-in votes sent via mail.

Yes, I approve the current policy to ban the use of stimulator collars at Fox Valley. (received 22 votes) - OR -

No, I do not approve the current policy to ban the use of stimulator collars at Fox Valley. (received 14 votes)

The final outcome of the voting was the desire of the members to continue the policy prohibiting stimulator collars at Fox Valley training site. A club member asked whether this policy could ever be changed in the future, to which Peggy Sue Seehafer stated that policies are always available to be re-addressed.

Carolyn Pearson (Secretary). The September meeting minutes were approved with the following correction: Carol Cook stated that she wanted to correct

the comment attributed to her in the September membership meeting minutes. She stated that the stimulator collars should be used in a life or death situation.

Several items of correspondence were read.

Judy Anderson (First Vice-President) was not feeling well and sent her report with Peggy Sue Seehafer. She reported that she has received a \$225 check from the Siberian Husky Club of Greater Chicago and the signed contract for the rent of our equipment for their show to be at the Kane County Fairgrounds on October 14<sup>th</sup>.

Taffy Wille and Carolyn Pearson (Acting Directors of Training). Carolyn reported that the current session ends on Tuesday, October 10<sup>th</sup>. Primary and Assistant Instructors are needed for the final session which begins on Thursday, October 19th. Please contact Carolyn Pearson (630-231-5658 or secretary@fvdtc.org) or Taffy Wille (630-365-0423 or trialsecretary@fvdtc.org) at training, via telephone or e-mail if you are interested.

Nadine Conner and Jerry D'Aprile volunteered to help where needed.

Will Short (Trial Chairperson) stated that stewards are still needed and that he had the steward sign-up board at the meeting for the trial. After the meeting, it would be available at training, please sign up. Nadine Conner (Trial Kitchen) also stated that she is seeking volunteers to sign-up to work in the kitchen as well as provide baked goods. In order to prevent an over-abundance of one particular type of dessert, she would like the volunteer bakers to please specify what they are donating. If you would like to volunteer your time in the kitchen or donating baked goods, she can be reached at 630-365-1396 or nadine5544@aol.com.

Bill Clarke (Trial Booths) stated that due to the lack of utilization by the judges and stewards of designated dining tables, they will be eliminated this year. That space will be used to allow for two more booth spaces, which already have been rented. Bill also stated that it is possible to add even one more space, but will measure the space on October 10<sup>th</sup> to confirm that. If it is possible to add an additional space, Peggy Sue stated that she knows of a possible "renter".

This will allow the acknowledgements to be sent earlier than usual.

Taffy stated that she has not yet set a date to do the catalog information proofreading. Once that has been set, she will let members know.

Dave Lewis (Waggin' Tales Editor) reported that the next deadline is Sunday, October 8<sup>th</sup>. By receiving it via e-mail, it saves the club approximately \$1.00 per issue for printing and postage.

Cathy Fleury (Treasurer) reported that we are current on our bills. She stated that she will have numbers from the September 16<sup>th</sup> Agility Trial at the November 1<sup>st</sup> Membership meeting.

Kathy Hubbard (Membership Chairperson) was unable to attend the meeting due to work and sent her report with Carolyn Pearson. Carolyn read a list of five new applicants for membership. Ingrid Hamburger made a motion to accept the list as read. Trudi Kimm seconded the motion. Without any discussion, the motion was approved by all, without any opposition or abstentions. Tracy McMahon was the only new applicant present. Welcome to all our new members. J

Cathy Fleury reported that all of the checks received by Kathy Hubbard for membership renewals had

been deposited today, October 4th.

Ingrid Hamburger (Match Steward Chairperson) stated that she is in need of stewards for the October 19<sup>th</sup> and the November 30<sup>th</sup> correction clinics. She asked that club members NOT sign up to judge and steward- as much as we like to think we can "do it all", being in two places at the same time is simply not possible by mere mortals.

It was stated that Jan Schomer and Ingrid Hamburger only keep track of the correction clinic stewards and the information is communicated to Suzan following each clinic.

Cindee Ehrhart-Malnar (Annual Dinner Chairperson) was not in attendance. Peggy Sue Seehafer stated that the Annual Dinner will be at Fisherman's Inn, Elburn, on March 10, 2001. 
