Old Business

Peggy Sue reported on the continued search for our own building and the review of different sites. She stated that ideally we would like to own the building that we use at the fairgrounds. HOWEVER, that is an option that we cannot afford. The Building Committee (Peggy Sue Seehafer, Barb Misch and Francene Andresen) continues to investigate different properties to build our own place, which are for sale.

The Kane County Forest Preserve District has approached us about using the Schweitzer property in Sleepy Hollow, but most of the Board Members felt that for the majority of our current club members and community members taking our classes, the distance to the Sleepy Hollow is too far. Peggy Sue stated that the property is too good to let go unused. She has contacted AKC about creating a satellite building, perhaps like the

St. Louis Art Museum. The property has a fabulous home and kennel and was deeded to the forest preserve to be used for dog activities. Peggy Sue will continue to explore this possibility with the AKC.

Peggy Sue also reported that the requirements for buildings on the Keslinger and Peck property, we probably could not afford. Will Short asked whether we have contacted any of the other local clubs to combine to form a coalition. Peggy Sue stated that without a firmer idea of what the property

can evolve into, it was not a good time to involve other clubs. The maintenance for the property would be VERY costly might be more than we can handle. Priscilla Pisarski asked whether could use the Schweitzer property on another night. Cindy Pakenas asked whether it could be used as an outside

Trudi Kimm reminded club members to pay attention to the amount of parking available, as is it a huge concern.

New Business

- Trudi Kimm stated that during recent matches, the Sit/Stays and Down/Stays were conducted after all of the dogs did their run-throughs. Due to Trudi's schedule, she had to leave prior to doing any Stay exercises. She stated that she feels that Stays should not be done after all the dogs are run-through, rather they should be done back-to-back after twelve dogs. Cindy Pakenas stated that other clubs do their Stays prior to the judging of the individual run-throughs. Carolyn stated that at a minimum, the Stays should be done as in a trial, after a group of twelve dogs.
- Special Election for Director of Training. As stated in the August Waggin' Tales, a special election would be conducted for the DOT position. Helen Castellano made a motion to elect Cindy Pakenas as DOT. Vera Nyberg seconded the motion. There was no discussion. The motion was approved by all without any opposed or abstentions.

Cindy stated that she plans to observe all classes to get acquainted with the classes and the instructors, NOT to evaluate or critique. Cindy also stated that she would like to improve the individual runthroughs to allow members opportunity to get in a run-through. She will be looking for ideas about any other clubs have a successful method for runthroughs. Cindy appointed Penny Breich as the Assistant DOT.

 Carolyn Pearson also reminded everyone to please quiet your dog or dogs when it barks constantly. It is difficult to hear instructors when a dog is barking for any length of time. Cheryl Hettinger stated that is asked by many beginners' students for a trick to quiet a noisy dog. Anyone with the magic "formula" is encouraged to share. Brenda Rivera also reminded everyone that when approaching someone with a noisy dog to PLEASE BE KIND when choosing your words. We cannot help someone quiet a barking dog when they feel insulted or hurt.

A motion was made, seconded and approved to adjourn the meeting at 8:50 p.m.


