Membership Meeting Highlights—November 3, 2004

Meeting brought to order at 7:35 p.m. Carolyn Pearson (Secretary). The October Meeting minutes were approved as published.

Cheryl Hettinger (First Vice-President) reported that the new jumps would be re-evaluated after the trial. She asked the stewards to report to Will Short, Ed Herdes, Carolyn Pearson or herself regarding any problems with the jumps. She also reported that one of the bar jump's base was cracked. She had not yet contacted J& J regarding its replacement.

Cindy Pakenas (Director of Training) thanked all instructors for the last session. She stated that Rick Cox is returning as the instructor for the 8:00 p.m. Open class. She reported that this session is all set and going well. Cindy reported the following two seminars: Glenbard is hosting a Diane Baumann seminar on January 29 and 30, 2005, at DuPage County Fairgrounds. The cost is \$150.00, before December 1st or \$175.00 after December 1st.

Stone City Kennel Club is hosting an Adele Yunck seminar on May 14 and 15, 2005 at Stone City Kennel building. The cost is \$125.00 for working teams and \$85.00 to audit. Cindy stated that both women are well respected in the dog world, not just in obedience. Taffy Wille asked what the policy was for seminar reimbursements for instructors. Carolyn stated that she would look up the policy in the past meeting minutes and report on it.

Note from Secretary: During the February 4, 2004 Board Meeting, the following policy for instructor seminar reimbursement was approved. Instructors will receive a reimbursement of 50% of the cost for one seminar annually up to a limit of \$100.00.

Will Short (Trial Chairperson) reported that Helen asked him to remind club members who were donating a specific prize to the obedience trial to please bring them to her at training. Additionally, Will also reported for Helen that any club member who was providing cash for a trophy should pay her immediately. Ed reported that a complete breakdown is necessary for Sunday, not just a clean up of the building. Will reported that volunteers are welcome for the set-up for awards beginning at 6:00 p.m.

Nadine reported that she is setting-up the kitchen from 6:00 p.m. until 7:00 p.m. on Saturday, although she does have enough help for set-up and during the trial. However, she needs uncut baked goods. Ed Herdes reported that since Car-Dun-Al is paying for the use of the fairgrounds on Friday night for their set-up, they

have asked us not to allow any of our club members to set up crates on Friday.



Property Search Report

Francene provided the following update on properties discussed at previous membership meetings.

Franks Nursery and Craft, St. Charles—There are 3 acres of land with a building that is 38,000 square foot. Going on auction with an anticipated price of \$1.6 million - puts us out of the mix.

Rentals—Land/Property Rentals are jumping in price because of the Elgin expansion attempts. Can expect to lease properties for around \$36/square foot.

Burlington Rd & Rt. 47, Lily Lake—Unable to get any further information from the owner. There are buildings in place but they cannot be used as anticipated.

<u>Lake St. & Randall Rd.</u>, <u>Elgin</u>—behind the Mall on the West side of the street; 3.5 acres of land that is far out of our range

Beith Rd. & Anderson Rd., Campton Township—12 acres, but the price is more than \$700,000, which is well out of our price range.

Steben Farm Rt. 64 west of Wasco—60 acres; 2 entrances - (1) off Rt. 64 the other off Merri Lane No price is currently available, the current owner wants interested parties to make an offer. NOTE: Horse farm just west for 32 acres sold for \$1.2 million. Dennis expects this to go for \$1.3 million

Wenmoth Rd, Batavia—17 acres; Wedge piece at south end is the only buildable area Kane County has again told Dennis that a retention pond will help to enable us to build up more area and use the whole lower area for outdoor trials. Significant earth moving is needed.

Ramm Rd., Lily Lake, West of Rt. 47-13 acres parcel, near the Serengeti Restaurant. Peggy Sue Seehafer stated that the Waukesha Kennel Club built their training

building on 3 acres. However, we feel that we need no less than 7 acres for hosting outdoor agility trials and parking. Has a small house or some type of building that could be used for clubhouse type activity; 450 Ft. well, which would definitely require careful review, because it may be too shallow; Asking price is \$495,000 Because it has been on the market for 130 days, Dennis felt that we could make an Barb pointed out that as we move forward towards offer of about \$300,000. > The following is the discussion about the properties in general.

Anne White asked about the West Chicago industrial parks, but Francene stated that they usually want about \$36 sq. ft. to lease. Barb agreed that heading east would be more expensive. Francene also stated that because we need to be considered a kennel, many municipalities would not allow us to open a training center.

Marietta Huber stated that Car-Dun-Al is also looking for a new place, perhaps we should consider joining forces. Francene stated that we could consider offering to lease a building to them. However, Barb said that we would not be in a position to lease a place any time soon.

Tim White also asked whether we had checked with AKC to determine what the location restrictions were. stated that once we have a more definitive location, we had already put contacting AKC on the "to-do" list. Francene stated that during the last attempt to purchase the land on Route 38, we had all sorts of contingencies in the contract, including meeting AKC rules, the Kane County rules, etc. In response to Tim's question about removing the multiple contingencies prior to entering in a contract, Barb stated that none of the approvals by the county, etc. could be addressed until there is a valid contract.

New Business

Priscilla Pisarki asked whether there were any club rules about kids eating in the training building, outside of the rings. Priscilla stated that she had a student in her last class who brought her kids and their dinners to training, despite being asked twice by Priscilla that she not allow her kids to eat ringside.

Taffy stated that food is food regardless if it's used for treats or human food. She suggested that the dog gets moved or move the chair back from the ringside. Taffy also suggested that instructors remind their students that adult supervision is required for children, especially if the



IT'S A WARDS TIME 2004!!

It is the policy of FVDTC to give awards for AKC, CKC and UKC titles earned at trials, tests or shows each year. Below is a list of the awards that are offered and a copy of the forms we will be using this year. Each form must contain all the information for eligibility. Please submit one handler form and a separate form for each dog.

To receive a club award, you must have a total of 10 works credits for the year and be listed as a Regular Training Member in the Roster. If for some reason you have not met **ALL** your requirements and can justify the reason, your eligibility will be reviewed by the Board of Directors.

Awards are given for titles earned in 2004 (i.e., a dog may have earned two "legs" toward a title prior to 2004, but if the third "leg" was earned in 2004, the title is earned in 2004). However, all scores for any of the "Special Club Awards" must have been earned in 2004.

Members owning mixed breed dogs are eligible for a Certificate of Merit for the equivalent of AKC titles earned at **MATCHES**. Submit at least 3 qualifying score sheets signed by three different judges. This also applies to purebred dogs that are not registered by the AKC.

Any award that states "Personalized" will be engraved with the dog's name, title and year. PLEASE NOTE: All items by C. Rodeback and P. Seehafer require a photo of your dog to be submitted with your forms. All items by B. McGuffy require an article of clothing (50% to 100% cotton and washed at least once) and a photo of your dog to be submitted with your award forms. All submitted pictures **MUST** be <u>clear</u>, <u>close-up photos</u> for best reproduction. Our artists need time to work on these, so please be considerate and get everything in as early as possible.

Front and Finish is now offering the "Front and Finish Excellent (FFX) Obedience Platinum Award". The requirements are that the obedience title must be completed in three trials with scores of 195 or better. If you are eligible for this award, **you must also submit the FFX Application with the rest of your forms**. For more information about this and other Front and Finish awards as well as a copy of the FFX Application, go to www.frontandfinish.com.

SPECIAL CLUB AWARDS

ALL scores for special awards must have been earned in the current year and must have been earned at AKC trials unless otherwise specified.

NOVICE A - HIGH QUALIFYING AVERAGE AWARD - must have a minimum of 3 scores from AKC trials submitted.

NOVICE B - HIGH QUALIFYING AVERAGE AWARD - must have a minimum of 3 scores from AKC trials submitted.

<u>OPEN - HIGH QUALIFYING AVERAGE AWARD</u> - must have a minimum of 3 scores from AKC trials submitted.

<u>UTILITY - HIGH QUALIFYING AVERAGE AWARD</u> - must have a minimum of 3 scores from AKC trials submitted.

NOTE: ALL qualifying AND non-qualifying scores must be submitted if you are applying for one of the following special awards that refer to an "average" score. If you do not know your NQ score, list it as 165. Remember, obedience is a sport guided by the principles of good sportsmanship. Each of you is on the "honor system" in submitting your scores.

<u>DOROTHY DIMOND MEMORIAL TROPHY</u> - given to the member whose dog was trained & shown by the member & receives the highest average score in regular classes in at least three AKC trials. All scores must be included. NQ's, unless higher, will be 165.

<u>DEBBIE ORR MEMORIAL AWARD</u> - goes to the member whose dog or dogs earned the most AKC titles or international equivalents during the year. For this award, AKC, UKC and CKC titles are counted.

<u>HEATHER MEMORIAL AWARD</u> - offered by Nancy Gillum, in memory of Briarwood's Heather Miss AM/CAN CD. It is given to the handler whose dog earned the 3 highest scores in Novice A at AKC trials.

FOUNDERS AWARD - offered by Fox Valley Dog Training Club, Inc. in memory of the founders of FVDTC. It is given to the handler whose dog earned the 3 highest scores in regular classes at AKC trials.

ED KNEIP AWARD - given to the handler whose dog earned the highest combined score in Open B and Utility A or B at same AKC trial.

<u>KANOSAK KENNEL AWARD</u> - given to the handler whose dog earned the 3 highest Utility A scores at AKC trials with at least 5 scores being submitted.

SALLY COMPTON OUTSTANDING SERVICE TO THE CLUB AWARD - given to a club member to acknowledge them and their contributions to the club. This award is especially significant because it offers you the opportunity to nominate a fellow club member for their efforts. Because the nominations are reviewed by the Board to determine the winner, no current Board member is eligible.

THE ABOVE SPECIAL AWARDS WILL BE KEPT FOR ONE YEAR BY THE WINNER AND REPLACED BY A PERMANENT REPLICA.


