Yes Rover, you can teach an old handler new tricks

Sandi Stephenson, Director of Training

I would encourage anyone who is training a dog, and especially anyone who trains dogs for other people, to attend as many seminars as possible. They are one of the best educational tools available. You can find a list of area seminars in the AKC Gazette, and on the website, and a few others are listed in this issue of Waggin' Tales. With this issue, WT will begin publishing such events as a regular feature.

On August 26th and 27th, obedience judge Bernie Brown will offer a seminar in New Lenox, IL. Bernie was a well-known top competitor in this area in years past, and he is the author of the "NO-FORCE" book series. Check the Stone City Kennel Club website for more up-to-date info.

I was fortunate to have the opportunity to attend Ceasar Milan's (The Dog Whisperer) seminar in June. While not a true dog trainer or behaviorist, Ceasar uses common sense and an ability to read dogs' body language to solve problems. His latest book has been on the top ten best seller's list for some time, and I would recommend it to anyone, especially new dog owners. I'll write more about this seminar next month.

Ancient breed finally eligible for AKC registration

The **Tibetan Mastiff** becomes eligible for American Kennel Club® registration on September 1, 2006 and will compete in the Working Group as of January 1, 2007. One of the oldest

breeds in existence, the Tibetan Mastiff is considered by many to be the stock from which most modern large working breeds developed.

AKC, there is little recorded about the genetic heritage of the breed and much of their history is described only in legend. It's believed that these dogs remained isolated on the high plateaus and valleys of the Himalayas, developing into the magnificent animal that has been highly prized by the people of Tibet throughout history and today.

With a powerful, muscled body and solemn yet kindly appearance, this dog is both regal and imposing. He is aloof, watchful of strangers and protective of its people and property.

Plott moves to Hound Group

On January 1, the distinctive and rare **Plott**, which currently competes in the Miscellaneous class, will begin competing in the Hound Group. The **Plott** is unique among Coonhounds because it descends from Germanic stock rather than English foxhounds. The history of the Plott began when a young German immigrant, Johannes



Plott, landed in the United States with five hunting dogs. His son later made a conscientious effort to establish a big-game dog and eventually developed a pack of 'mountain' dogs.

raised and trained to hunt such animals as bear and wild boar. The breed is intelligent, alert and confident, and an excellent hunter, capable of traversing diverse terrain in all seasons.

June Board of Directors Highlights

Meeting brought to order at 7:40 p.m., June 9, 2006.

Carolyn Pearson, Secretary. The April meeting minutes were approved as published.

Ed Herdes, First Vice-President, reported that all ring gates have been repainted. Ed agreed to set out the extra ring gates to block the building doors that are open during warmer weather. Ed also requested that a small committee of board members determine what equipment in the shed should be kept or not.

Dale Swanson, Treasurer, distributed the year-to-date financial statement.

Sandi Stephenson, Director of Training, will ask the primary instructors of the Puppy and Beginner classes to provide to her the names of their assistant instructors. Sandi also stated that FVDTC instructors should not feel obligated to dog owners that seek specialized help outside of the group classes.

Sandi reported that **Nancy Pederson's** idea to stagger the starting dates for the Puppy classes would be implemented as of the third session of classes. It was suggested that the Board and Nancy meet to discuss the initiative, either at a regularly scheduled Board meeting or a special meeting.

It was suggested that local seminars be published in Waggin' Tales and on the Club's website. Sandi stated that we should seek a volunteer to keep track of local seminars and keep the club members informed.

Ingrid Hamburger, Tracking Test Chairperson, presented a budget for the 2006 Tracking Test. During the discussion, Ingrid stated that approximately 15 entries were returned for the eight TD and TDX tests. Helen Castellano made a motion to accept the budget as presented. Terri Byerly seconded the motion. The motion passed with the following results: all approved, none opposed and no abstentions.

Nadine Conner, Public Education Coordinator, reported that the Girls Scouts in Elburn raised \$120 for the Paws With A Cause organization from their May 7th first (annual) pet parade. Nadine stated that **Helen** and **Samantha Castellano** attended with her and it was extremely hot, but fun.

Helen Castellano, Agility Trial Chairperson, stated that the last volunteer she needs for the September Agility Trials is the Hospitality Chair. The hospitality job at the Agility trials is a lot of work and would be best handled by a committee. Anyone who would like to volunteer for Hospitality Chair should contact her at agility@fvdtc.org. Product Sweetener Xylitol Can Be Toxic To Dogs

The ASPCA Animal Poison Control Center is warning that the sweetener xylitol, found in some sugar-free candies, baked goods and other products, can potentially cause serious and even life-threatening problems for pets.

According to Dr. Eric Dunayer, veterinarian and toxicologist for the Poison Control Center, a dog that ingests a significant amount of a product sweetened with xylitol could develop a fairly sudden drop in blood sugar, resulting in depression, loss of coordination and seizures. "These signs can develop quite rapidly, at times less than 30 minutes after ingestion of the product. Therefore, it is crucial that pet owners seek veterinary treatment immediately." He also said there appears to be a strong link between xylitol and the development of liver failure in dogs.

While it was previously thought that only

large concentrations of xylitol could result in problems, this no longer appears to be true. "We seem to be learning new information with each subsequent case we manage," says Dr. Dunayer. "...we have begun to see problems developing from ingestions of products with lesser amounts of this sweetener." He also says that with smaller concentrations of xylitol, the onset of clinical signs could be delayed as much as 12 hours after ingestion. "Therefore, it is important to keep in mind that even if your pet does not develop signs right away, it does not mean that problems won't develop later on."

As with any potentially toxic substance, should accidental exposures occur, it is important to contact your local veterinarian or the ASPCA Animal Poison Control Center for immediate assistance.

Old Business

Streamlining Board Meetings

Dave Lewis reminded everybody that providing reports via e-mail prior to each Board meeting, and limiting agenda items to those things that need discussion, will make meetings briefer and more efficient.

AKC Companion Animal Recovery (CAR)

Helen stated that she found the following information on the AKC CAR website.

AKC CAR was founded in 1995 to help reunite lost pets with their owners. With this goal in mind, AKC CAR provides 24-hour recovery services for pets that are identified with a microchip, tattoo, or AKC CAR collar tag. AKC CAR, located in Raleigh, NC, is an affiliate of the American Kennel Club and is the nation's largest nonprofit recovery service provider.

As a demonstration of our ongoing commitment to the companion animal community, AKC CAR is offering a rebate for every enrollment received. Additionally, we will continue to offer our half price \$6.25 enrollment fee for non-profits.

A motion was made and seconded on-line to participate in this program. During the discussion at the meeting, Helen stated that she would attempt to determine whether FVDTC qualifies as a non-profit organization for the purpose of the CAR program. The motion was approved by all, without any opposed or abstentions. Helen volunteered to register the club for the program.

4H Instructor Credit

Terri Byerly's request for clarification of the work credits for the Instructors was addressed in the on-line Board forum.

Waggin' Tales Censoring Issue

Terri Byerly presented a concern to the Board about the Waggin' Tales Editor rejecting an article. After examination of the article, explanation and a very lengthy discussion, the Board reached a consensus that the Editor was correct in all her actions and had the full support of the Board for her decision.

New Business

2006 Obedience Trial Trophy Report

Peggy Sue Seehafer, Obedience Trial Trophy Chair, attended the meeting to present the following information for Board consideration and approval. Peggy Sue requested that the Board review and approve the following awards for the 2006 Obedience Trial.

Taffy Wille made a motion to accept the budget as presented. Helen Castellano seconded the motion. During the discussion, Sandi suggested that we increase the HIT award value to \$100, the HC award value to \$75 and decrease the Second HIT award value to \$25. Helen stated that to achieve the HC award generally required more effort on the part of the handler. Taffy agreed with that assessment and suggested that we leave the HIT award value as \$75 and increase the HC award value to \$75 and leave the Second HIT award value as \$50. This would acknowledge the effort required to achieve the HC award.

The scenario of the same dog and handler earning both the HIT and the HC awards would only be eligible to receive the higher valued award. Taffy withdrew her motion to accept the budget as presented following the discussion. Helen made a motion that the dog and handler who earns the HIT award would not be eligible to earn the HC award at the 2006 Obedience Trial. Taffy seconded the motion. The motion was approved by all, without any opposed or abstentions.

Sandi Stephenson made a motion to offer an award value of \$100 for the HIT, an award value of \$75 for the HC award and an award value of \$25 for the Second HIT award. The motion failed for lack of a second.

Helen made a motion to offer an award value of \$75 for the HIT, an award value of \$75 for the HC award and an award value of \$50 for the Second HIT award. Nadine Conner seconded the motion. The motion was approved by all, without any opposed or abstentions.

be comparable to the rosettes offer for the HIT and the HC awards. Sandi Stephenson seconded the motion. The motion passed with the following results.

Approved—6; Opposed—1; Abstained—2 Sandi Stephenson stated that she will verify with Ronnie Bizer whether we could change the name from Second High in Trial to Reserve High in Trial.

Everyone agreed that Peggy Sue Seehafer has done a fabulous job thus far and we were confident that she would continue to do so.

August Board of Directors Highlights

The meeting was brought to order at 7:48 p.m.

Carolyn Pearson, Secretary. The June Meeting minutes could be not reviewed or approved as they had not yet been distributed. One item of correspondence was read.

Ed Herdes, First Vice-President, reported that the inventory of the equipment in the shed still needed to be done. Ed said that he would bring in a couple of extra gates to block the open overhead doors during the warmer weather.

Terri Byerly, Second Vice-President, was not in attendance but sent the following report via e-mail which was read by Dave Lewis.

It has been brought to Terri's attention that the Club members (despite the Board's best efforts) are getting mixed signals and information about the possibility that the Club will not have awards this year. According to the announcement made at the June 9th Board meeting, if we do not have a volunteer for the Award Chair and Annual Dinner Chair by the August 4 Board meeting, we will not have awards or a dinner next year. The work involved will not 'magically' get done without volunteers to do it.

Terri asked that the Club's bulletin board get hung by the door and not rested on a table. It is much more noticeable when it is hanging. She also reported that the hooks she provided to hang the board must be replaced each week.

Terri reminded Sandi Stephenson or Loretta Lazzara to send her the wording for the Rally run-through bulletin board sign.

Sandi Stephenson, Director of Training, reported on the following items.

Training Issues

Sandi stated that things are going pretty well at training, though two incidents recently occurred with minor injuries to one person and one puppy. Sandi stated that she believes both incidents could have been avoided if the owners had just a little more "education" on dogs and dog behavior.

 The puppy incident occurred when the owner brought the puppy for socialization, and then let him wander all around other dogs and their crates. He was severely "scolded" when he wandered into the crate of the wrong dog.

Possible Solutions:

- No longer allow socialization for untrained dogs/ untrained owners? (This owner honestly believed she and her pup did nothing wrong.)
- The person at the table must explain all do's and don'ts to new people? (Obvious why this would seldom work).
- Yet one more sign at the sign-up table, explaining "rules"? Discuss just what the sign would need to say.
- Yet one more sign insisting that all dogs be kept on a very short leash?
- 2. The second incident happened in Carolyn's class between two Bernese Mountain Dogs and their owners. One handler offered to hold the leash of another handler's dog for a recall, while still holding her own dog's leash. The 'held' dog broke and bounded to the other dog and handler. The dogs did not connect, however the 'held' dog's tooth punctured the calf of the handler. Big thanks to Sandy Davis and her medical skills for all her help. Carolyn has instituted the necessary steps to avoid more situations.

Volunteer Issues

On a happier note, Sandi reported that with the exception of the 9 p.m. Beginner's Class, there are enough assistant instructors. Please keep looking for a warm and kind-hearted body for Ed!

The lack of a regular Information Table volunteer still plagues us, though Cheryl Hettinger has been great about stepping in. Thanks, Cheryl! **Correction Clinics**

Sandi said that she and Loretta would like to start offering Rally Run-Through on the same nights as the obedience correction clinics starting as early as the September 14th Correction Clinic, as there is extra ring space. This would be contingent on getting enough stewards and judges. Sandi asked Terri to make (yet another!) sign to announce these. Additionally, there needs to be a method to have the following additional volunteers to sign-up to work:

- Timer
- Table Steward
- Judge
- Honor dog

Staggered Puppy Classes

The puppy class change in schedule has worked out very well so far. In fact, the next puppy class filled weeks ago, though the beginner classes are not filling as rapidly. Perhaps we should add another puppy class? Sandi asked whether anyone (while looking directly at Taffy) would be able to volunteer to teach a one-time puppy class as we have so many who are

waiting. Taffy said that she could not instruct until October.

Instructors

Sandi stated that she would like to get some background information from primary and assistant instructors, such as the following.

- A brief history of their dog training experience, whether they have canine behavioral background
- Attendance at seminars, such as seminars presented by Patricia McConnell or Ian Dunbar.
- A history of titles, if any, earned on their dogs.

It was suggested that this information could be obtained by completing a survey form developed by Sandi.

Sandi asked whether an instructor's meeting should be scheduled for the near future and asked for ideas on potential topics. Taffy and Carolyn recommended holding a hands-on discussion regarding reading "canine body language" with actual dogs. Carolyn said that while she learned things during the Becky Jankowski discussion during a meeting program, she found it difficult to look at a drawing of a dog face, rather than an actual photograph or the real thing. Taffy and Carolyn both recommended Ronnie Bizer as an individual who is very experienced in reading canine body language. It was suggested that at least a month's notice should be given for the next instructors' meeting to allow individuals ample to time incorporate it within their schedule.

Ronnie Bizer, Obedience Trial Chairperson, reported on the following items.

Ring Layout

Roni presented and received approval for a modified ring layout for the 2006 Obedience Trial from the Trial Committee chairs. She also received support from Jean Munger, Trial Chair for Car-Dun-Al, for a modified ring layout. This modification was designed to alleviate ring gate congestion and received Board approval. The

crating area will be identified by placing tape on the floor and will be done during Car-Dun-Al's Friday night set-up.

Trial Judges

Ronnie announced that written confirmation has been received by the Judges Panel for the 2007 Obedience Trial. Once the 2006 trial event has concluded, contracts will be sent to all judges on the panel. The premium list was currently being proofread. Taffy stated that she would need assistance getting the premium list mailed once they were printed.

AKC News

Although AKC has announced changes effective September 1st, Ronnie stated that she is unaware of any impacts to Obedience or Agility rules.

Ingrid Hamburger, Tracking Test Chairperson, was not in attendance but sent the following report via e-mail:

Ed Herdes reported that he was informed by the fairgrounds that it is possible, that at some time in the future, the entrance regularly used on training nights might be closed due to the Randall Road construction project. Neither are crayons or pens, especially not the red ones, or my people will think I am hemorrhaging.


