COYOTE ALERT

Dog owners in the Fox Valley and surrounding areas need to take caution with their small dogs and cats, which can become a food source for coyotes. This is especially true during the

cold snaps when their food supply is limited. There have been numerous reports lately of small dogs being attacked, taken, and killed by a single coyote or pair of coyotes. They have been known to scale fences and remove small dogs from yards. This seems to be happening in sub-divisions not out in the country. The latest incident that I have heard of was in Mill Creek subdivision.

Cold weather, the mating season, and increased familiarity with humans have been suggested as possible reasons why coyotes have attacked four dogs in three weeks.

Coyotes have also been reported to lurk in brush or bushes and stalk walkers with small dogs. They have been seen in daylight hours boldly walking down neighborhood streets. Do not leave small dogs unattended even in fenced areas if you believe this could be a concern for your area.


Brags and Other Good Stuff
