## Board Meeting Highlights June 15, 2007

Meeting brought to order at 7:40 p.m.

Carolyn Pearson (Secretary). The April Meeting minutes were approved as read.

Ed Herdes (First Vice-President) stated that the process of the equipment sale was defined as the following.

Requests for equipment can be made no earlier than the Opening date, September 17.

The final request will be accepted on the Closing date, September 26.

The equipment must be picked up at training on October 4, between 6:30 p.m. and 9:00 p.m.

It was also agreed that at this time, there would not be any limits set, however, depending on the requests received, it may become necessary to set limits. The prices will be published with the items for sale. Additionally, in response to Carolyn's question, it was decided that some of the items from the Lost-and-Found will also be available for purchase.

In response to Terri Byerly's (Second Vice-President) request for a clarification, the current policy regarding the reduction in membership dues for Primary Instructors and Assistant Instructors was explained. When an Assistant Instructor is qualified to act as a Primary Instructor, they are generally offered the same benefits as a Primary Instructor in the reduction of membership dues. The DOT determines the current qualifications of an Assistant Instructor after discussions with the Primary Instructor(s) who worked with the Assistant Instructors.

Terri reported that she scheduled a Pet First Aid Class to be conducted by the Fox River Chapter of the American Red Cross for August 4<sup>th</sup>. However, she was awaiting final confirmation from Red Cross.

Dale Swanson (Treasurer) reported that he will provide the current Income and Expense Report within the next couple of weeks.

Dale also stated that because former Treasurer, Amy Ford, completed our tax forms last year, he did not feel comfortable attempting the form completion and club member, Ingrid Weihe CPA, prepared our tax forms for this year. During the process, Ingrid offered invaluable assistance in updating the accounts. Dale stated that he and Ingrid determined that a couple of accounts needed to be updated, as they still indicated Cathy Fleury as the signatory. Dale stated that he has sent written requests to all our account institutions requesting account history, signatory of record, etc. However as of this time, only Old Second, has responded to his request. He also reported that he and Ingrid will be meeting shortly to complete the taxes and finalize account updates. Dale stated that Ingrid has been a great help with this process.

Sandi also extended a big thank you to Carolyn, for keeping track of the ring set ups and telling us all "where to go". Additionally, Sandi apologized for not scheduling an Instructors' meeting as originally planned, due to babysitting her sweet but extremely active 13-month old granddaughter and caring for her 7-week old puppies. Sand stated that IF she and Tom remain "strong" and NOT keep one of the puppies, she will get caught up in the near future, assuming that Teah does not hit the terrible twos.....

Sue MacPherson (Membership Chairperson) stated that she is still receiving membership renewal applications.

Ingrid Hamburger (Tracking Test Chairperson) stated that she is currently updating the TD/TDX Test Premium list with the AKC logo as required. Ingrid also reported that John Goreth from the Kane County Forest Preserve District has assured her that the gate at the forest preserve entrance will be opened no later than 6:00 a.m. on Saturday, but will probably not be locked after Friday night. Ingrid also stated Sue MacPherson is the Hospitality Chair for the 2007 Tracking Test.

Helen Castellano (Agility Trial Chairperson) reported that the AKC applications for the indoor Spring 2008 Agility trial to be held on March 29 and 30 at the Sports-Plex were submitted and approved. The Judges are Tavonda Herring, from New York, and Monica Tand, from Connecticut. Helen also reported that the AKC applications for the outdoor Fall 2008 Agility trial to be held on September 13 and 14 in the Plato Township Park. The Judges are Kera Holm, from California, and Sally Dickner, from New Jersey.

Because AKC goes by the Julian weeks to determine when events are held, Ingrid stated that she will verify that the dates for the 2008 Fall Agility Trials and Tracking Test do not overlap.

#### • No Sniff Bandanas

Carolyn stated that she contacted Vicki Wild regarding making more No Sniff bandanas.

#### • New Awards Structure

Taffy reported that the Award Restructuring Committee met and has successfully restructured awards for Fox Valley Dog Training Club in a fair and cost efficient way. The committee has added the Rally titles and the new Agility FAST titles to the awards offered.

Awards will continue to be offered similar to the past

except that Rally and Agility FAST titles will be added to appropriate levels, and Canadian titles will be removed. Canadian titles will now be recognized with a title plate. All titles earned by a working, training member will be acknowledged with engraved titles plates for a plaque; this includes titles earned in other registries. All AKC titles will receive a patch. Both the title plates and patches are optional and should be requested specifically. A blank plaque for the title plates per dog will be provided as needed for those members that fill one up.

A member will now be limited to receiving one award (picture, wood item, etc.) per level of titles received. The exception to this will be anyone who receives a title at the highest level in the same year (for example, OTCH and a MACH).

The following is the example of the levels and the corresponding titles.

Level 1 – AKC Champion, RN

Level 2 – CD, NA, NAJ, NAP, NJP, NF, NFP, RA

Level 3 – CDX, TD, OA, OAJ, OAP, OJP, OF, OFP, RE

Level 4 – UD, TDX, AX, AXJ, AXP, AJP, XF, XFP, RAE

Level 5 – UDX, VST, MX, MXJ, MXP, MJP, MXF, MFP

Level 6 - OTCH, MACH, FTC, FTCP

Sue MacPherson made a motion that the Board recommend to the membership that the club approve this new awards structure effective for titles earned in 2007. Helen seconded the motion. Without further discussion, the motion was accepted by all Board members present with no one opposed or abstaining.

#### • Title Patches Purchases

Taffy made a motion to allow the Statistician to order the necessary patches up to \$600. Board agreed with the Award Restructuring Committee recommendation that patches for the new Rally titles offered should be ordered from our existing embroiderer. Jan Schomer recommended that the Agility titles patches continue to be ordered from J & J due to the smaller minimum quantity required for ordering. The motion was accepted by all Board members present with no one opposed or abstaining.

#### **New Business**

The following report was published in the August Waggin' Tales and read by Dave. The Award Restructuring Committee has met and has successfully restructured awards for Fox Valley Dog Training Club in a fair and cost efficient way. The committee has added the Rally titles and the new Agility FAST titles to the awards offered.

Awards will continue to be offered similar to the past except that Rally and Agility FAST (FTC, FTCP) titles will be added to appropriate levels, and Canadian titles will be removed. Canadian titles will now be recognized with a title plate. All titles earned by a working, training member will be acknowledged with engraved titles plates for a plaque; this includes titles earned in other registries. All AKC titles will receive a patch. Both the title plates and patches are optional and should be requested specifically. A blank plaque for the title plates per dog will be provided as needed for those members that fill one up.

A member will now be limited to receiving one award (picture, wood item, etc.) per level of titles received. The exception to this will be anyone who receives a title at the highest level in the same year (for example, an OTCH and a MACH).

Dave also stated that the Board recommends that this revised structure be adopted PLUS include the addition of the statement "maximum of one title earned for the OTCH/UDX/MACH level" can be earned per dog. This addition was included due to the two new AKC obedience titles being added as of January, 2009. These new titles will be based on the score not the placement. These titles will probably be in the OTCH/UDX level and can be earned in multiples such as the UDX can be.

Brenda Rivera stated that we should wait to add awards for the new titles until next year because the new awards have not been clearly defined. Jan Schomer stated that we should wait until at least January, 2010 before offering awards for the new titles. Selena Larmon suggested that we define the awards before the title is offered to allow awards to be offered in the same timeframe that the titles are available. Will Short stated that we should wait until a later time before deciding for the new titles.

Following this discussion, it was agreed that the motion would stand as published without the addition of the Board's recommended statement.

The motion was approved by all, without any opposed or abstentions.

Francene made a motion that the awards restructuring become effective for titles earned as of January 1, 2008. The motion was seconded by Selena Larmon. The motion was approved by all, without any opposed or abstentions.

Below is a reprint outlining the **New Awards Structure** that was printed in the June/July/ August, 2007 issue of WagginTales. The New Structure will take affect on January 1, 2008 and will not affect titles earned this year. **All titles earned starting January 1, 2008 will be under the new awards structuring system.** 

## **NEW AWARDS STRUCTURE**

The Award Restructuring Committee has met and has successfully restructured awards for Fox Valley Dog Training Club in a fair and cost efficient way. The committee has added the Rally titles and the new Agility FAST titles to the awards offered.

Awards will continue to be offered similar to the past except that Rally and Agility FAST titles will be added to appropriate levels, and Canadian titles will be removed. Canadian titles will now be recognized with a title plate. All titles earned by a working, training member will be acknowledged with engraved titles plates for a plaque; this includes titles earned in other registries. All AKC titles will receive a patch. Both the title plates and patches are optional and should be requested specifically. A blank plaque for the title plates per dog will be provided as needed for those members that fill one up.

A member will now be limited to receiving one award (picture, wood item, etc) per level of titles received. The exception to this will be anyone who receives a title at the highest level in the same year (for example, OTCH and a MACH).

An example of the levels and their corresponding titles is as follows:

Level 1 -

#### **Effective Date of Award's Restructure**

Taffy made a motion that the date for the new awards structure become effective January 1, 2007 for titles earned in 2007. Francene Andresen seconded the motion. During the discussion Brenda stated that she is very much against the effective date of 01/01/2007, due to the fact that it is already October 2007.

Taffy read the following prepared statement:

"Eleven months ago, a motion was made at a membership meeting which drastically increased costs to the club in regards to awards. The motion was seconded and approved by members present with the promise that a restructuring committee would be formed to design a new structure for awards that would continue to honor those who put titles on their dogs, vet would be more fiscally responsible. The motion that was voted on went into effect immediately and for the current year's awards. The restructuring committee met in the spring of this year to complete the task started at the November, 2006 membership meeting. The committee was successful and presented a proposal to the Board for a restructure of the awards to be effective for 2007. The Board approved the proposal and at the next membership meeting, which happened to be September, the proposal from the committee was presented to the membership to be voted on. The membership approved the new structure; however, the effective date was incorrect. The effective date of the new award structure should have been 1/1/07."

Taffy said that the addition of the agility awards was done late in the year. Taffy stated that we should get titles for the titles, NOT to get an award. Brenda stated that she likens this change to changing canoes while still in the middle of the river.

Jan expressed concern that we are trying to set limits for the few club members who take advantage of the club's generous awards. Jan stated that those club members who took advantage will probably be unable to collect awards for titles earned in 2007 due to lack of sufficient work credits.

Dave stated that during the discussion at the September 5 membership meeting the majority of the discussion was about the effective date, not the actual awards restructuring efforts. Heidy stated that she is also disappointed with the awards offered for earning CKC titles.

The following are the results of the voting of the club members present.

In response to the concern that Rally titles were not able to be submitted for an award, Carolyn stated that all AKC titles not specifically listed on the Awards form could submit a request for a title plaque and the title plates.

Peggy also suggested that the board reevaluate the total amount of money spent on awards at some time in the future.

A motion was made, seconded and approved to adjourn the meeting at 8:53 p.m.

Congratulations to Terri Sidell on the arrival of her new litter.


