Therefore, they will be hosting their Fall 2010 Obedience/Rally Trial in their training facility and NOT at the Kane County Fairgrounds. They are currently planning to have 4 rings set up and some crating space. The facility does not have a kitchen, so food would be an issue. Jean reported that the very front of the building is regular matting, and the rest will be in 3/4" agility mats.

Jean also stated that CDA would consider renting the building to FV for future obedience trials. She stated that the rental fees would be negotiable. Carolyn stated that just a couple of minor concerns used for the demonstrations we are presenting. must be addressed with this change. She will contact the past CDA Booth Chairperson to get the list of past booth participants. Additionally, she will contact Sharon Hodges-Woods, who is the only judge that is shared between CDA and FVDTC, about lodging accommodations.

raffle prize to the Libertyville's "Dog Days of Summer" event. Barb Runkle seconded the motion. The motion passed by majority vote.


A motion was made, seconded and approved to adjourn the meeting at 9:26 p.m.


