## **Board Meeting Highlights: April 26, 2017**

Meeting brought to order at 7:43 p.m.

**Carolyn Pearson (Secretary)** did not have the February Board meeting available for review.

**Peggy Sue Seehafer (Second Vice-President)** was not in attendance, however she sent the following report:

- Bonnie Gutzwiler, owner of the Barn Hunt training facility "Hide and Squeaks" and Barn Hunt judge will explain this fun activity at the May Membership meeting starting at 7:00 p.m.
- The next membership meeting will have a great tracking teacher and judge. Peggy asked for confirmation of whether or not dogs are allowed in the Extension Center for demonstration purposes. Carolyn stated that she will verify that with the Extension Center.
- The following membership meeting will have a program on NoseWork.

It was also suggested that Peggy Sue be contacted to determine whether one of the upcoming membership meeting programs could be rescheduled to allow for a discussion of the upcoming Rally changes. This would also require a dog to be allowed in the Extension Center for demonstration purposes. Another

suggestion to accommodate both program and meeting times was to start the programs at 6:45 p.m.

**Phil Nuger (Treasurer)** distributed a year-to-date statement of activity comparison for review. After a brief discussion, Will Short made a motion to accept the financial reports as presented. Sue MacPherson seconded the motion. The motion was approved by all members present, with no one opposed or abstaining.

Phil stated that he has not yet moved the money into an investment account. He also stated that once he has completed the next account reconciliation, in the very near future, Ingrid Weihe will be able to do our taxes. In response to a suggestion, Phil stated that he will look into the possibility of getting the bank to waive some or all of the service charges that we pay to them.

Will Short (Director of Training) reported that we have the following upcoming workshops scheduled.

- TDI Workshop June 22, 29, July 6 and 11 at 6:00 p.m. This workshop will be presented by Jan Winters and John Grosse.
- Rally Workshop (Five weeks for the Novice and Advanced Classes) – Limited to 10 teams

- per workshop, cost is free for members and \$25.00 for non-members.
- Rally Workshop (Five weeks for the Excellent and Master Classes) – Limited to 10 teams per workshop, cost is free for members and \$25.00 for non-members.

Additionally, it was agreed that during the next full breakdown, we would perform a 'test' of the space required to store mats rolled end-to-end as opposed to the current method of folded over and then rolled. The first three of the five total layers of mats, would be rolled end-to-end before placing in the storage cabinet and the total height of each layer would be measured. Due to the weight and lengths, the lower shelf of the storage cabinet must be used to store all of the mats and all of the jumps. Carolyn stated that she would work with the breakdown person and report back with the findings.

**Pat Senne (Obedience Trial Chairperson)** reported that she has confirmed that Kathy Sweet, the 2017 Rally judge, will be able to judge the two new rally classes.

Ingrid Hamburger (Tracking Test Chairperson) was not in attendance, but reported that the TD/TDX tracking tests are approved and announced in AKC's Event Calendar!!! She reported that once the premium list is completed, she will forward it to Dave Lewis to post on the club's website.

Cathy Fleury (Agility Trial Chairperson) was not in attendance and did not send a report. However, Will Short stated that he recently sent an email to Cathy regarding the possibility of having the agility trial at Dash in Geneva, as they appear to be expanding their facility.

### Old Business

Dave Lewis and Wendy Waddick are working on setting up the club to be able to use Pay Pal to accept payment for entering our correction clinics. The process is being done in incremental steps; Dave is currently working on the online forms.

### **New Business**

- In response to Carolyn's question about starting the June 21st Board meeting at 8:00 p.m. to accommodate the 4-H show that day, it was stated that the meeting start time would remain at 7:30 p.m.
- Awards Wendy presented the following report from the Awards Committee.
  - The Awards Committee is recommending that the club retire the Dorothy Dimond award, due to its poor physical condition and that the requirements for earning it are very similar to the Founders award.
  - DOROTHY DIMOND MEMORIAL TROPHY given for the highest average score in AKC Regular classes, in at least three AKC obedience trials.
  - FOUNDERS AWARD given to the handler whose dog earned the 3 highest scores in Regular AKC classes.

Phil Nuger made a motion to immediately retire the Dorothy Dimond Memorial Trophy. Pat Senne seconded the motion. The motion was approved by all members present, with no one opposed or abstaining.

Additionally, Wendy reported that Donna Bihner confirmed that the slight confusion during the award's presentation at the dinner for the Debbie Orr Memorial award was correct. It was earned by Cathy Fleury AND Francene Andresen. The confusion was due to inaccurate information displayed on the presentation slide. Previously the award requirements stated "dogs", now it is a singular "dog". The presentation slide has already been updated for next year's dinner.

Training Night Bite Incident - The Board discussed a recent bite incident between two club member's
dogs. It was agreed that the dog who bit will be asked to wear a muzzle whenever it is not training in a
ring. It must wear a muzzle when walking in and out of the training building. It was reported that the dog
that was bit did not suffer severe injury.

A motion was made, seconded and approved to adjourn the meeting at 9:14 p.m.

**Phil Nuger (Treasurer)** was not in attendance, but did report that there were no material changes in our financial position. He stated that he will present an upto-date report at the next meeting.

In response to Will Short's (Director of Training) question, Barb Runkle stated that she would be a beginner instructor for the next session of classes.

Sue MacPherson (Membership Chairperson). In response to a suggestion from Will Short regarding allowing workshop participants to use attendance at our workshops towards membership training requirements, Dave Lewis made a motion that workshop participants can earn one (1) training-class-credit towards membership, per week of a workshop that is attended. Will Short seconded the motion. The motion was approved by all members present, with no one opposed or abstaining.

### Barb Runkle (Public Education Coordinator).

Peggy stated that our club has been invited to participate with a display and with demo dogs at the 200-acre Gray Willows Farm Dog Days Second Annual event on August 19th. Barb stated that she will contact them to get details and will determine how many volunteers she will need for the event.

Ingrid Hamburger (Tracking Test Chairperson) stated that she is in need of one more experienced tracklayer for the September 9th and 10th Tracking Test.

Cathy Fleury (Agility Trial Chairperson). Will Short suggested that Cathy Fleury investigate having the Spring Agility Trial at the "Agility at the Farm" facility on Burlington Road in Campton Hills, rather than at the Car-Dun-Al training facility in Huntley.

Will also reported that the **Dash K9 Sports** facility in **Geneva** has been pre-approved by AKC to host Excellent courses based on the size the facility will be after the future renovations have been made.

**Dave Lewis (Director at Large)** announced that the club's website was down for several hours due to a cable being cut by construction workers near the hosting center. He has also set up a service so he gets notified if the site is down for more than 10 minutes.

Dave stated that he recently received a limited-time offer for a toll-free telephone number. After discussion, it was agreed that we do not have a need for toll-free calling.

### **Old Business**

## **Rule Changes from the AKC:**

### **Obedience & Rally Regulation Changes**

Transfer of entries in obedience and rally. The regulations will allow a transfer of an entry from one class to another (rally class to rally class; obedience class to obedience class) at the request of the exhibitor after the closing date for entries, regardless of when the dog earned the title, provided the club allows transfers and only if the class and judge are available. Transfers in both Obedience and Rally were amended and are effective July 1, 2017.

- The club will clearly state in its premium list whether transfers will or will not be allowed. If no statement is provided in the premium list the default is to allow transfers.
- A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers.
- Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. (When a club does not allow transfers, refer to Section 16b. Entry of Ineligible Dog.)
- The request for a transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial.
- Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list.
- Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

Rally Regulations – Chapter 1, Section 13. Transfers.

- The club will clearly state in its premium list whether transfers will or will not be allowed. If no statement is provided in the premium list the default is to allow transfers.
- A transfer from a rally class to a rally class may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers.
- Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. (When a club does not allow transfers, refer to Section 14. Entry of Ineligible Dog.)
- The request for a transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial.
- Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list.
- Transfers may be approved provided the class and judge is available, and the class has not reached its limit.
