Heart Clinic

Fox Valley Dog Training Club is happy to host a heart clinic in conjunction with our fall Obedience and Rally Trials. Dr. Heidi Kellihan, DVM, DACVIM – a Clinical Associate Professor of Cardiology, Board Certified Cardiologist at the University of Wisconsin-Madison – will be performing the following exams:

- AUSCULTATIONS EXAM ALONG WITH A DOPPLER ECHOCARDIOGRAM, which is an Ultrasound of your dog's heart. This exam has no expiration date for certification needs.
- AUSCULTATIONS EXAM, which is listening to your dogs heart. This exam is good for one year.

WHEN: In conjunction with our trial on Saturday November 20th, 2021 starting at 8:00 am

WHERE: At our trial site at the Kane County Fairgrounds

COSTS: Echocardiogram exam, which includes an auscultation exam, \$250.00 per dog.

Auscultation exam only \$50.00 per dog.

**Along with your payment; please include the preferred time you would like for your arrival; plus your dog's name and breed; along with your preferred contact information. The eye exam will be performed approximately a half hour after your arrival. You need to arrive a half hour before the exam time in order to get eye drops placed in your dog's eyes so they are dilated for the exam, and to fill out paperwork. Bring your dog's AKC registration information; if it's AKC registered; the night of exams to make filling out paperwork easier.

Please indicate the preferred time that you would like to arrive, I will do my best to fulfill your request. Get your reservations and fees in early to get your preferred time slot! There maybe limited night of testing exams available at a cost of \$40 per dog, however, night of examination spots are not guaranteed.

There will be no refunds of examination fees starting two weeks prior to the examine date. IMPORTANT, please include your email address and preferred telephone number so I can contact you!

If you are bringing more then one dog, please bring a helper, if possible, to hold your extra dog/dogs while the other dog is being examined

Membership Meeting Highlights September 08, 2021

Meeting brought to order at 7:38 p.m.

Bob Boeke (First Vice-President) was not in attendance, but Carolyn reported that the August 28th Mat Cleaning was successful and that the mats are now ready for another trial and another year of training. She stated that she is working with both St. Charles High Schools to get on the list of organizations that offer activities that can be used by the students to accumulate service hours.

He reported that payments are all timely, but he is a little behind on deposits. Additionally, there are no updates to financial statements to report.

Pat Senne volunteered to assist Cheryl Hettinger in hanging the window coverings on Friday, November 19th. Cheryl asked that she be told what windows do not need paper coverings because of the special window coverings that Nancy Lee usually provides for the weekend of the trial.

Wendy will discuss with Taffy what food / services can be provided for judges, workers and exhibitors due to COVID restrictions.

Sue MacPherson (Membership Chairperson) read the name of one new applicant, who was published in the Waggin' Tales. Will Short made a motion to accept the list as published and read. Barb Runkle seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to our newest member.

Ingrid Hamburger (Tracking Test Chairperson) was not in attendance, but Cheryl Hettinger reported that Kent Hildebrand needs drivers for Saturday and Sunday. Volunteers are needed starting at 8:00 am and until approximately 4:00 or 5:00 pm.

Gina Post (Public Education Coordinator) reported that AKC has cancelled all previously scheduled "Meet the Breeds" events throughout the country due to COVID.

Cathy Fleury (Agility Trial Chairperson) was not in attendance, but reported that the Worker's Sign-up link for the upcoming Agility trials has been posted for members needing work credits to volunteer.

Candy Ellis (Annual Dinner Chairperson) will contact Riverside Receptions very shortly to verify that our deposit is still holding a date for our next Annual Dinner.

Sally Boeke (Awards Co-Chair) reported that on Thursday, September 23rd, the awards earned last year will be available for pickup at the fairgrounds. There will be an online signup link for club members to sign up for a

specific pickup time. Times will be available from 5:30 pm until 7:30 pm, in 5-minute increments. If anyone is unable to pick-up their awards on that date, please make other arrangements directly with Sally Boeke. Additionally, if a club member has not signed up for a pickup time or made arrangement for some one else to pick up the award(s) on that night, the awards will not be brought to the fairgrounds.

Cris Ballenger (CGC Test Coordinator) reported that she sent her report for the August CGC Test to the Board with a recommendation to raise the entry fees for participants and the evaluator's fee. This will be discussed during the October Board Meeting.

Cris stated that the last test was held with only four dogs, however she is anticipating a larger turnout for the March 2022 test.

Pat Senne (Match Chair-Coordinator) reported that the Match Committee has determined that the option of signing up on-line for a timeslot caused more confusion then expected and therefore the option is being discontinued. People sent their payment and entry to Lori Delk but then did not sign up for a timeslot online; which caused the entries to be out of sync. For the people who travel long distances this caused timing issues. Additionally, Pat reported that although we are now allowing gate entries there have been little to none during the last couple of matches.

There were some issues with people who sent checks to Lori and were not on the entry list. Although the entry forms do display Lori's new address, apparently entries are still being submitted on old forms, using Lori's old address.

Barb Misch volunteered to sit at the table for gate entries, etc. to enable Pat Senne to volunteer to judge the Rally class.

Lori Delk (Match Chair-Entries) was not in attendance, but reminded everyone to use the updated Fun Match Entries forms.

Barb Misch (Match Chair-Stewards) reported that there are still two stewards needed for an Open class and two stewards for the Graduate Open class.

Therapy Dog Evaluation – Tentatively scheduling a testing date for January or February 2022.

Dave Lewis (Waggin' Tales Editor) reported that the deadline is "real soon."

• Wendy reported that the timeslots between 4:30 pm and 6:00 pm are filled for the October 7th eye clinic with Dr. Lindley. 
