Mexican Pinwheels

3 pkgs flour tortillas (2 pkgs if they're large size)
1 can diced black olives
2 cans diced green chiles
1 4-oz. jar pimentos
2 packets Hidden Valley Ranch mix (original flavor)
1 8-oz. container sour cream
2 8-oz. packages cream cheese
salsa

Soften cream cheese. Drain pimentos and green chiles. If desired, run olives, chiles and pimentos through food processor to make it less chunky. Mix everything except the tortillas and the salsa together. Spread the mixture on the tortillas (it helps if you cut off the edges so that they are more or less square). Roll the tortillas tightly, wrap individually in plastic wrap, and refrigerate overnight. Slice and serve with salsa.

(Note: If you're worried about "fat grams", I did use reduced-fat sour cream and cream cheese, and that didn't hurt it at all!)

January Membership Meeting

Membership Meeting Highlights January 13, 1999

Meeting brought to order at 7:48 p.m.

Carolyn Pearson (Secretary) - The November Meeting minutes were approved as published. Several items of correspondence were read.

Cindy Pakenas (Second Vice-President) reported that on Saturday, April 17th, the Anderson Animal Shelter will be hosting their annual Canines, Crafts and Critters show (formerly the Dog Expo). There are Puppy classes at 7:00 p.m. and 8:00 p.m.. Cheryl announced that the CGC test listed in the Waggin' Tales calendar was not correct - that test was from 1998 - not 1999. She also stated that HELP is still needed for several classes. Anyone interested in (or even just considering) acting as a primary or assistant instructor should see Cheryl. All talents are welcome and encouraged.

Cheryl stated that anyone who would like to volunteer to instruct 4-H Club members should contact her or Trudi Kimm. The 4-H program will begin their training some time in March. The 4-H class is conducted between 6:00 p.m. and 7:00 p.m..

A Little of This & A Little of That

1999 Fitness Program

Your dog is not just a wonderful companion. Your canine friend is also a valuable fitness tool. You've seen those ads on TV promising amazing results from all sorts of contraptions. Well there's no need to invest in fancy equipment. If you have (or can borrow) a dog, you have everything you need.

Inner thighs:

Place the dog's favorite toy between thighs. Press tighter than the dog can pull. Do not attempt barelegged - dogs who favor shortcuts to success will just dig the toy out. You could be damaged.

Upper body strength:

Lift the dog - off the couch, off the bed. Repeat. Repeat. Repeat. As the dog ages, the process is reversed - onto the couch, onto the bed and so on...

Balance and coordination:

Exercise 1. Remove your puppy from unsuitable tight places. If they're too small for him, they're certainly too small for you. Do it anyway. Repeat. Repeat. Repeat.

Exercise 2. Practice not falling when your dog bounds across the full length of the room, sails through the air and slams both paws into the back of your knees.

Upper arms:

Throw the ball.

Throw the squeaky toy.

Throw the Frisbee.

Repeat till nauseous.

Hand coordination:

Remove foreign object from locked jaw. This exercise is especially popular with puppy owners. Repeat. Repeat. Repeat. Remember, this is a timed exercise. Movements must be quick and precise (think concert pianist) to prevent trips to the vet which only offer the minimal exercise benefit of jaw firming clenches.

Calves:

After the dog has worn out the rest of your body, hang a circular toy on your ankle and let the dog tug while you tug back. Warning: this is feasible only for those with strong bones and small dogs. Have you taken your calcium supplement today?

Calves - Alternate:

Run after the dog - pick any reason, there are plenty.

Dogs of any size can be used for this exercise.

Greyhounds are inadvisable.

Neck Muscles:

Attempt to outmaneuver the canine tongue headed for your ear, mouth or eyeball. This is a lifelong fitness program. A dog is never too old or feeble to lick the inside of your nostril when you least expect it.


10 Commandments for Having/Loving a Dog

10. Go with me on difficult journeys. Never say "I can't bear to watch it" or "Let it happen in my absence." Everything is easier for me if you are there.
