REMEMBERING LINDA

To Linda and Jim's sons, daughters-in-law, grandchildren, and family,

I can't remember exactly when I first met Linda and Jim. They were almost a fixture on training nights at Fox Valley. Jim helping with the crates and getting dinner. Linda chatting up a storm on any subject, training her dogs and teaching her class.

We probably started talking when we realized how very much alike her Dyna and my Jena were. Both dominant black and white bitches with lots of attitude which they directed at any other dog who invaded their space.

I know that I was a student in Linda's Open class for sometime and enjoyed her class very much. Particularly, the very physical workout she gave each of us with her requirement that we heel for what seemed like an eternity. It was worth the effort.

Somehow, Linda talked me into volunteering to take over the work for Match Nights from her. At the time, this included getting the judges, taking the entries and being there on Match Night. I also remember somehow volunteering to help Linda with the Obedience Trial Trophies one year. Well guess what, that stuck! I took over from Linda and have been the Trophy Chairperson for Fox Valley's Obedience Trial ever since. I will remember her for getting me involved.

Linda and I attended many of the same dog shows and always watched, supported, congratulated, and offered advice to each other on our training. But we were more than fellow dog club members. Linda attended my bridal shower and also the baby shower for my daughter, Samantha. We were friends.

It was a sad day when I heard that Jim had passed away. It was so sudden and unexpected. And then when Linda finally found something to put her heart into again, agility teaching, I heard the sad news of her cancer. The last time I spoke to Linda, she was planning to go home the next day from St. Joseph's Hospital. I called to tell her how everyone loved the Agility Trial trophies which she had picked out for Fox Valley's Agility Trial and how our trial had gone the first day.

I know what it is like to lose a parent as I lost both of mine within a short time of each other. It has been many years since then but I look at my daughter, Samantha, and realize what they, and I have missed.

Fortunately for Linda it was a fairly short time until the end. Unfortunately for her you, her sons, daughters-in-law, grandchildren, and family, you wanted and needed her here much longer than was given.

I have made some wonderful friends through my dogs and Fox Valley. Linda and Jim were among them. My memories of them and the Basenjis will remain forever.

MEMBERSHIP MEETING HIGHLIGHTS

Membership Meeting Highlights November 7, 2001

Meeting brought to order at 7:40 p.m. by Carolyn Pearson. Tracey Mohr was out of town on a required business trip. The October meeting minutes were approved as published. Several items of correspondence were read.

Judy Anderson (First Vice-President) was not in attendance. However, Will Short reported that she is slowly recovering from her liver transplant.

Carolyn Pearson (Assistant Director of Training) reported for Trudi Kimm, that we desperately need primary and assistant instructors. We also need to have a list of individuals who would be willing to substitute teach for any classes, especially on short notice - flu and cold season is here.

The Rally cards have been ordered, but not yet received. A book on the rules and regulations for Rally Obedience was given to Ginger for the club's library.

Carolyn also reported that she and Ed Herdes are still trying to find a date to clean our mats at the fairgrounds. However, it does not appear as if it will occur prior to the end of the year because the fairgrounds are booked most weekends. We need to have a weekend date that we do not have to breakdown the equipment and we would be able to gain access to the fairgrounds on a Saturday.

Will Short (Trial Chairperson) reported the following:

- All trial workers should be at the fairgrounds between 7:15 a.m. and 7:30 a.m. on Sunday, November 11th.
- No Fox Valley club members should place crates or other personal equipment at the fairgrounds Friday night while Car-Dun-AI is setting up.
- The trial will begin at 8:00 a.m. with the Pledge of Allegiance, followed by the National Anthem. Judging will begin immediately after that.
- Taffy has the gold dollar coin to be given to an individual for each entry. The distribution will be done by Vera Nyberg or Cathy Fleury.
- Anyone witnessing a problem should seek Will out immediately.
- Anyone noticing a reporter from the local newspaper should see Kent Hildebrand or Will.
- Cindy Pakenas is the grounds chairperson and could

use some help.

- The raffle is still in need of donated items. They can either be brought on Saturday night or Sunday morning.
- The set-up is scheduled to begin at 5:00 p.m. on Saturday.
- There will not be any non-regular classes offered in 2002.
- ALL chairpeople should provide a list of workers to Will following the trial.

Bill Clarke reported that all thirteen booth spaces are filled. He also stated that several booth occupants are new this year. Booth set-up begins at 6:00 p.m. on Friday. Dean Connolly reported that help is needed to do the clean-up on Sunday afternoon for equipment and the kitchen.

Dave Lewis (Waggin' Tales Editor) reported that the deadline is Sunday, November 18th. This is one week later than usual to allow for trial reports to be included in the November issue. The website is up-to-date and receiving visitors regularly.

Dean Connolly (Graduation Chairperson) reported that the Graduation certificate supply needs to be replenished. He will obtain prices from several places.


