## MEMBERSHIP MEETING HIGHLIGHTS - JANUARY 16, 2013

Meeting brought to order at 7:53 p.m.

**Carolyn Pearson (Secretary)**. The November Meeting minutes were approved as published. Several items of correspondence were read.

**Dana Weller (Treasurer)** distributed a preliminary year-end financial report for review.

**Will Short (Obedience Trial Chairperson)** reported that all judges for the 2014 Obedience trial have been secured, but contracts have not been signed. Additionally, one judge for the 2015 Obedience trial has been secured.

**Sue MacPherson (Membership Chairperson)** read the list of the 13 new member applicants who have been published in recent Waggin' Tales. None of the applicants were present at the meeting. Candy Ellis made a motion to accept the list as read. Paul Rogers seconded the motion. The list was accepted by all members present, with no one opposed or abstaining. Welcome to all new members!

**Ingrid Hamburger (Tracking Test Chairperson)** reported that the pavilion at the Burnidge Forest Preserve has been reserved for the Tracking Test on September 15. Ingrid also reported that she has signed contracts for the 2014 Tracking Test judges.

**Cheryl Hettinger (Annual Dinner Chairperson)** stated that the annual dinner will be on April 13, 2013 at the Brewster Creek Lodge. Cheryl reported that reservations and money are being collected by Candy Ellis and are due by April 4th. Cheryl reminded club members paying by check, that the checks will not be deposited until after the dinner.

**Carol Nightingale and Nancy Einwich (Awards Chairs)**, Carol reported that the form to apply for the Volunteer Recognition award has been updated on the website. The form was modified with additional awards from which to select. Additionally, photos of those choices are now on the website to view. Carol stated that this year the photographer will take all the pictures during two scheduled events. The first event is scheduled for Thursday, March 28th at training and the second event is scheduled for Saturday, March 30th at another location. Club members who have selected photos for their awards will be provided the times available.

Terri Byerly thanked Carol and Nancy for the nice selection of awards for the new Volunteer Recognition award.

### Old Business

- **Web Site Redesign**

Peggy Sue Seehafer stated that updated website was fantastic and thanked Dave Lewis for the great job and his hard work. Terri Byerly also thanked Donna Bihner for her effort in the redesign.

- **Christmas Party 2012**

Donna Bihner thanked Candy Ellis for the wonderful job she did organizing the 2012 Christmas party, she was definitely "the holiday hostess with the mostest". Cheryl Hettinger also praised Candy for the fun everyone had at the party. Nancy Pederson did an awesome job of taking the pictures of the dogs with

- **Puppy Mill Project Update**

Peggy Sue Seehafer stated that as a result of many anti-puppy mill groups, many pet stores are no longer selling puppies obtained from puppy mills. Additionally, she spoke with Critters Pet Store in St. Charles, who said they no longer sell dogs, they are only offering rescue dogs for adoption.

- **On-Site Canine Chiropractor**

Donna Bihner reported that she has confirmed February 28th as the date for Dr. O'Conner, certified animal chiropractor from Vitality Chiropractic Center, to offer her services at training. Donna stated that appointments can be set up on the website. New clients will be charged \$45.00 for their first appointment, returning clients pay \$40.00.

Sue MacPherson reported that she had contacted another canine chiropractor who confirmed that they are interested, however was unable to discuss details at that particular time. Sue will contact the chiropractor again and confirmation of participation.

### Voting for 2013 Board of Directors

Prior to distributing the ballots, Terri thanked the nominating committee for their hard work obtaining the slate of Board of Directors and chairs for committees. ### New Business

- **4-H Assistants**

Terri Byerly reported that she is in need of assistants for the upcoming 4-H classes. No prior experience is necessary; on the job training is provided. The 4-H classes begin on Thursday, April 4th and conclude with the show on Wednesday, June 26th.

- **Pet Emergency Resuscitation Masks**

Peggy Sue reported that 40,000 animals annually die in fires due to their susceptibility to smoke inhalation. With that statistic in mind, she contacted the Fox River and Countyside Fire Protection District located in Campton Hills and discovered that none of their five emergency vehicles were equipped with pet emergency resuscitation masks. Peggy Sue stated that a set includes three different sizes (to account for size variations), an instructional DVD for a cost of \$95.00 per set of masks. Peggy Sue asked whether the club would be interested in providing two sets to the Fox River and Countyside Fire Protection District. Francene Andresen made a motion to purchase two

sets of three masks to be donated to the Fox River and Countyside Fire Protection District. Joyce Conway seconded the motion.

During the discussion, Peggy Sue said that she would volunteer to coordinate the purchase and distribution of the two mask sets. She also encouraged the other club members to verify that their local fire stations have the mask sets on their emergency vehicles, and if they do not, to consider donating the set, perhaps as a way of memorializing the death of a pet or pets. Additionally, any club members who wish to donate any amount can see Cheryl Hettinger at the front information table or Carolyn Pearson at training. She was hoping that if enough individuals donated additional money, we would collect enough extra to provide the additional three sets to fully equip all vehicles. Any club members, who wished to donate a full set to their own local fire stations, should contact Peggy Sue in an effort to coordinate the additional purchase to the club's sets. Peggy Sue said that she had not yet determined which vendor to purchase the masks. However, as soon as she had the finalized

information, she would share it with club members in the Waggin' Tales, Constant Contact messages and on the club's website. The motion was approved by all members present, with no one opposed or abstaining.

• **Updates to the By-Laws**

Members must be notified of the date(s) of the meeting and proposed changes in the By-Laws at least (10) days prior to the date of the meeting.
- The proposed changes were announced at the November meeting, published in the December Waggin' Tales and distributed at the meeting.

Donna thanked Terri Byerly for her time since 2008 as the President. Donna stated that she hopes to continue the past efforts to improve avenues of communication. • **Award Nominations**


