**MOVE UP REGULATIONS**

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing via postal mail or e-mail to the trial secretary only. Move ups for Saturday September 18th must be received by 6 pm Monday September 13, 2010. Day to day move ups will be accepted and must be received by the awarding of the last ribbon of the day. Dogs so moved up will be entered at the end of the running order, and every effort will be made to accommodate handlers running multiple dogs in the same class. *Move ups are not allowed from Novice A to Novice B after the closing date*

**Dogs Eligible To Enter:** This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance are not eligible for entry. Refer to chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

Each dog must be entered in ONLY Regular classes OR Preferred classes for the show. Each dog must be entered in only one height division for this show.

**Height Divisions:** Owners are responsible for entering the proper height division as shown in the table below. Handlers may opt to run in a higher height division for regular classes ONLY but not in a division lower than their proper height division. Dogs entered in Preferred MUST run in their correct height division; they may not run at a higher or lower height. Dogs shall be moved down to the proper jump height if entered in the incorrect Preferred class jump height only if measured by Volunteer Measuring Official, AKC Agility Field Representative or Judges of Record.

Dogs that run in a regular height division lower than their proper division or in a preferred height division at other than their proper division will be eliminated. **In no case may a dog be moved down in height after closing, whether due to an exhibitor entry error or due to a judge's measurement.** The secretary is not responsible for ensuring that a dog is entered in the proper height division. Any and all errors in height division entered are solely the responsibility of the exhibitor.

**Height Cards:** All dogs competing in agility must possess an official AKC jump height card. An official jump height card is defined as either a permanent jump height card or valid temporary jump height form copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. **Jump Height cards (including copies) do not have to be submitted to the trial secretary nor are jump height cards required to be shown during check-in.** If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running. The secretary is not responsible for providing proof that a dog is in the correct height division.

**Incomplete entries will be returned.**

**Prizes & Awards:** Dogs must qualify to receive awards. Qualifying ribbons and prizes will be awarded to all dogs receiving a qualifying score. Placement rosettes and toys (\$1—\$3) will be awarded for 1st through 4th place in each class in each height division. New title Ribbons will be awarded to those dogs completing a title at this show. All prizes must be claimed at the trial, none will be mailed. Any dog achieving a MACH title at this show will be presented with a ribbon and a decorated bar.

**Catalogs:** Catalogs will be available for presale. If you would like a catalog please include \$12.00 in addition to your entry fees. A limited number will be available the weekend of the trial for \$15.00 each.

**Warm Up Area:** A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors. Exhibitors may not use the warm-up area to relieve their dogs. Consideration should be given to those teams who are due in the ring prior to other teams wishing to use the jump.

**Collars & Leashes:** Dogs may run with or without collars. If collars are worn they must be flat buckle collars with no attachments. Martingale collars & choke collars are not allowed.

**Pinch collars are not allowed on the show site. Flexi Leads are not allowed inside the building. Exhibitors are responsible for keeping dogs under control.**

**Classes Offered:** Standard (Novice A & B, Open, Excellent A & B), Jumpers with Weaves (Novice A & B, Open, Excellent A & B), Standard Preferred (Novice A & B, Open, Excellent A & B), Jumpers with Weaves Preferred (Novice A & B, Open, Excellent A & B).

**Obstacles:** Obstacles will conform to the requirements in the current edition of the regulations for AKC Agility Trials.

**Course Familiarization:** Handlers are permitted to walk the course, without a dog prior to the start of the class. The walk-through allows handlers to plan their strategy for running the course. A walk-through period will be held prior to each class following the judges' briefing. The walk-through may be split at the judge's discretion. The judge's briefing will outline the course and answer handler questions. There will be no contact familiarization for Novice dogs at either trial.

**Crating:** Indoor crating is allowed, crate mats or other ground cover must be used underneath all crates. Unentered dogs not allowed on show site.

**Entry Acceptance Methods:** No more than ten (10) dogs are allowed in each envelope submitted to the trial secretary. Envelopes with more than ten (10) entries will be returned to the sender. All entries must be delivered to the show secretary's address.

### Notice to Exhibitors

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and of AKC and their dogs are familiar with and are able to perform all obstacles safely. Single copies of the latest edition of the rules may be obtained without charge from the AKC" 8051 Arco Corporate Drive, Raleigh, NC 27617-3390. Also available online at [www.akc.org](http://www.akc.org). Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, and communicable diseases, and have appropriate vaccinations. Proof of current vaccinations, including rabies, must be available at the trial if requested.

All dogs must be held on leash or crated at all times except when in the ring or in the designated agility warm up area.

Dogs are not required to be at the trial until the scheduled time of judging. Exhibitors are responsible for being at ringside when it is their turn to run. Judges need not wait for dogs who are holding up the class.

An exercise area will be provided. All handlers must pick up after their dogs. Please don't allow dogs to use the shrubbery or landscaping to relieve themselves. **Anyone not cleaning up after their dogs or exercising in prohibited areas will be asked to leave. In such case, no refund of any fees paid will be made.**

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor who's dogs and/or children create unnecessary disturbances or engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

The Trial Giving Club assumes NO responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and further assumes no responsibility for injury to children. Owners/handlers enter at their own risk and agree to assume responsibility for any damage caused by them, their dogs, or their children.

The club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending this agility trial hereby waive any claim for damages against the club for such removal.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the Trial Committee. No refund for bitches in season. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire or act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

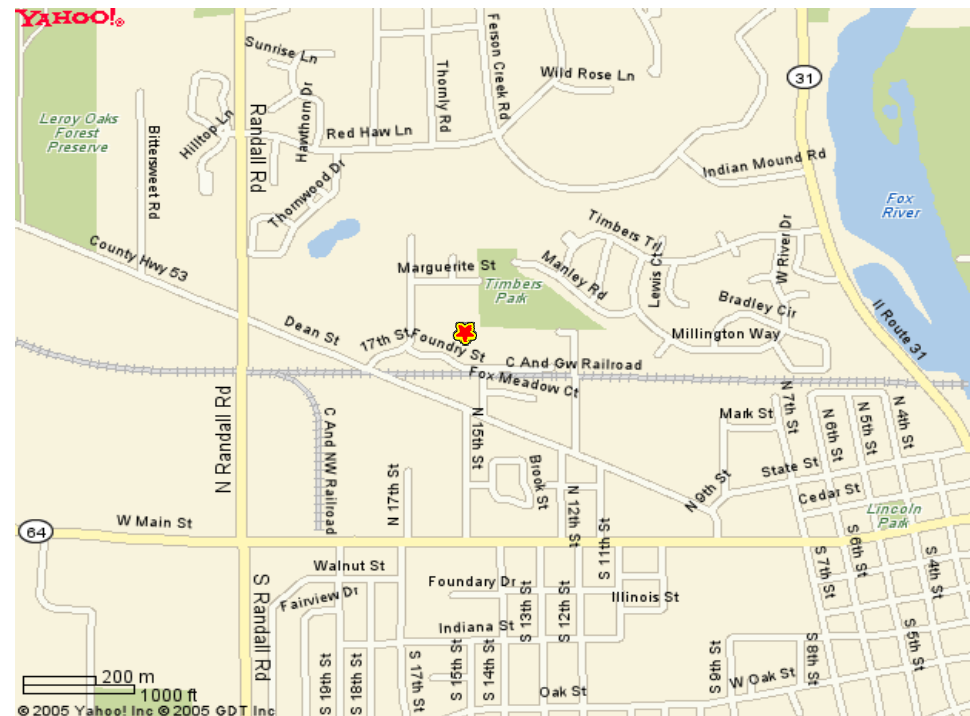

**INSTRUCTIONS**

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

**Mixed breed classes** may only be offered at standalone all-breed AKC agility trials. A standalone agility event is defined as an agility trial that is not held on the same date and show site as an AKC All-Breed Dog Show or Independent Specialty for conformation.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 816-3776. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship is the Junior Handler to the Owner?

**INSTRUCTIONS**

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

**Mixed breed classes** may only be offered at standalone all-breed AKC agility trials. A standalone agility event is defined as an agility trial that is not held on the same date and show site as an AKC All-Breed Dog Show or Independent Specialty for conformation.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 816-3776. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship is the Junior Handler to the Owner?
