The Tracking Test is for dogs not less than six months of age. With the entry form for the TD test of a dog, which has not passed a "Tracking Test", there must be filed a written statement by a person who is accredited by the American Kennel Club to judge a "Tracking Test", that the dog is considered by the judge to be ready for such a test. An exhibitor may enter more than one dog. The holding of other titles including "TD" shall not bar the dog from competition in the TD test. Entries without a Tracking Degree (TD) will be accepted first. There will be no actual scores for the TD or the TDX Test, but the dog will be rated "Passed" or "Failed" and a TD or TDX certificate will be issued by the American Kennel Club confirming all dogs rated "Passed".

Telegraph, telephone, e-mail, and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of *entry forms without the NEW Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.* Check your old photocopied forms and update.
