Classes: Novice, Open, Utility, Rally, Beginner Novice, Graduate Novice, Graduate Open

Location: Kane County Fairgrounds – St. Charles IL
 Randall Road between Roosevelt Road (Rt. 38) and North Avenue (Rt. 64)
Enter in the back gate from Oak Street and proceed to training building

Time: Doors open at 6:00 p.m. Judging begins at 7:00 p.m.
No Gate entries until further notice, due to Covid restrictions.
 PLEASE check-in prior to 8:00 p.m., if you have pre-entered.

Fees: Non-FVDTC Member \$6.00/dog; additional entry of the same dog \$4.00.
 FVDTC Member \$4.00/dog; additional entry of the same dog \$2.00.

Entry Rules: Pre-entries are by mail only, no e-mail or phone calls accepted.
 Pre-entries must be received/changed/cancelled at least 24 hours prior to the clinic.
Complete one (1) entry form for each dog.
