Fox Valley Dog Training Club Covid 19 Rules

Subject to State of Illinois mandates at time of trial.

Fully vaccinated exhibitors have the option of not wearing a mask; otherwise masks are required. If required to wear a mask, it is to be worn properly (covering nose and mouth) including when running your dog.

Please DO NOT COME to our trial if you:

- feel sick,
- have been exposed to COVID-19 in the last 14 days,
- are concerned about being exposed to the Coronavirus,
- are not willing to follow the rules.

We have put together these rules and guidelines based on government and AKC suggestions. Read the judging program thoroughly for any updates to these guidelines that occurred between now and the trial.

Indoor crating will be allowed. First come, first serve.

At the time of the premium publication, no kitchen services will be available. Food will be provided to judges and full day workers. This could change prior to the trial.

NOTICE TO EXHIBITORS

Transfers (move-ups) in Obedience and Rally will be accepted provided the next level class and judge is available, and the class has not reached its limit. The request for a transfer must be made in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial.

All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's Breed should be entered as "All American Dog." The dog's listing number must be entered on the entry form and the AKC number checked.

Conditional, unsigned, incomplete, telephoned, faxed, or emailed entries cannot be accepted. Entries without fees cannot be accepted. Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. Changes which are received on the telephone are unacceptable.

Entries mailed overnight must waive recipient signature, or they will be returned. Entries will not be accepted without fees. Returned checks do not constitute valid entry fees and are subject to an additional service charge. All entries must be on a signed AKC form with the AKC agreement on the back. Entries on an invalid form will be returned.

Refunds of \$3.00 or less will not be issued, due to the cost of processing. Entry fees will not be refunded after the closing date or when classes close, whichever comes first, for any reason but the following: **Bitches who come into season, after the closing date or when classes close; may receive a refund of entry fees less a \$5.00 administrative fee by sending a signed statement from a veterinarian, to the Trial Secretary by 8:30 a.m. the day of the Trial.**

There will be a limited number of catalogs available at the trial. If you would like a catalog, please pre-order a catalog by checking the box on your entry form and including an additional \$4.00 with your entry and fee.

Please be respectful to others and turn cell phones off or put them on vibrate/silent. No use of a flash is permitted, if taking photos during the judging of any dog.

NOTICE TO EXHIBITORS

Entries will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, barred from competition by action of the Trial Committee or, if because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete this trial.

The Fox Valley Dog Training Club and their Trial Secretary assume no responsibility for a wrong entry. Exhibitors are advised to print or type all unusual words when filling in entry forms. No dog wrongly entered in a class may be transferred to another class after the closing date, except as provided for in Chapter 11, Section 6 of the AKC Rules and Regulations. No entry may be cancelled unless notice of the change or cancellation is received in writing by the Trial Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such error.

Pursuant to Chapter 1, Section 3, entries will not be accepted unless submitted with the required entry fee, be on an official American Kennel Club entry form, be signed by the owner or his/her duly authorized agent and must have the required information - name of trial giving club, date of trial, breed, sex, name of class(es) entered, full/registered name of dog, name of owner(s)/co-owner(s), address of owner, one of the following – AKC registration number or ILP/PAL number; if known the following – date of birth, place of birth, name of breeder(s), name of sire and dam. Entries must be submitted on approved entry forms with the agreement printed on the reverse side.

Entries will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, barred from competition by action of the Trial Committee or, if because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete this trial.

NOTICE TO EXHIBITORS

The show giving club, the Trial Secretary, their agents, etc. assume no responsibility for any loss, damage or injury sustained by the exhibitors, handlers, or to any of their dogs or property and assume no responsibility for injury to children, who must be under the control of their parents or guardians.

For awards in both Obedience and Rally, there will be only ribbon prizes. The exception for this, is a gift to be presented to all Rally Novice A exhibitors and to all Obedience Beginner Novice A and Novice A exhibitors.

Dogs are not required to be at the trial until the scheduled time of judging and may leave immediately thereafter unless required for further judging. The owner/handler is solely responsible for having the dog ready at ringside when the class is to be judged. Conflicts between rings should be discussed with the judge prior to the start of the class.

JUMP HEIGHT

All classes requiring jumps will be arranged in jump height order (low to high, beginning with lowest jump). Entries will be run in catalog order on Saturday and on Sunday.

SUNDAY ONLY - TEAM RALLY NOVICE CLASS

TRIAL LOCATION - The Kane County Fairgrounds is located at 525 S. Randall Road, 40 miles west of Chicago and midway between IL Route 64 (North Avenue) and Route 38 (Roosevelt Road). Randall Road has exits from I-90 (north of the fairgrounds).

From I-88 (south of the fairgrounds), exit at Orchard Road and head North. Follow Orchard Road for 2.4 miles and turn left (north) on Randall Road.

No left turn into the fairgrounds coming from the south on Randall Rd. You must continue to the light after the entrance and turn around and come back.

There is no charge for parking. No overnight parking will be allowed. No dogs except those properly entered at this trial will be allowed within the trial precincts.

All dogs must be on leash or crated at all times. Warm-up must be done on leash.

It is understood that exhibitors alone are responsible for the behavior of their dogs. Any exhibitor whose dogs creates unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are expected to keep the show grounds clean. **Please pick up after your dogs.**
