Also a BIG THANK YOU to Taffy Wille and new member Carol Swenson who saw the need and volunteered to act as stewards. THANKS also has to go to our signed-in stewards who showed up to steward, Marietta Huber,

Shirley Short, Jan Schomer (table) and Don Kloss (table) and to our volunteer "floaters" Ingrid Hamburger, Jim Benson, Suzan Scott and Cathy Fleury (who volunteered to help out once her 7:00 p.m. beginner class had ended). Thank you for caring enough about FVDTC to help out a very frazzled Match Committee. We had a most successful match and only had to turn away two entries due to the limitations we had placed on the January match. We made a profit of \$275.00. And, last but not least a big THANK YOU to our judges, Joan Payne, Mike Kovacevich, Sandy Stephenson and Will Short for handling a full load assignment.

Perhaps some clarification as to what helping at a match entails may spur some of you to volunteer your time and talents. Actually, as to the "talent" part...all that is required is a warm body with attached smile

(and, in some cases patience) willing to learn "on the job". Each steward (and judge) get two (maximum) free

entries. We ask, where possible, that stewards and judges who wish to be put through would come at 6:30. Mary Bradley and Suzan Scott are available to

at 6:30. Mary Bradley and Suzan Scott are available to put people through Utility and Open. And, I am sure we can find someone to put people through Novice.

Oftentimes we encourage those entered in Novice to steward in Novice, those entered in Open to steward in Open and those entered in Utility to steward in Utility so that they can easily be assimilated into the class and into sits and downs (where required). We also try to obtain floater stewards who can step into a ring and allow the full-time steward to go work their dog in another class. All judges and stewards should be at their rings and ready to work by 6:55 p.m. so that we can start regular "judging" "runthroughs" at 7:00 p.m. Please also remember that

- 1. The dog is not allowed in the house.
- 2. OK, the dog can come into the house but only with certain rules.
- 3. The dog is allowed in all rooms but has to stay off the furniture.
- 4. The dog can get on the old furniture.
- 5. Fine. The dog is allowed on all furniture but is not allowed to sleep with the humans on the bed.
- 6. OK, the dog is allowed to sleep on the bed but only by invitation.
- 7. The dog can sleep on the bed whenever it wants but not under the covers.
- 8. The dog can sleep under the covers by invitation only.
- 9. The dog can sleep under the covers every night.
- 10. Humans must ask permission to sleep under the covers with the dog.

## **New AKC Tracking Regulations**

(The following is excerpted from the AKC web site. The full text is at http://www.akc.org/)



he Board of Directors approved the following changes to the Tracking Regulations effective February 1, 1998.

Chapter 5 Tracking Test/VST Section 4. Variable Surface Tracking Test Requirements.

- F. Line 7: At least one 90 degree turn shall be in an area devoid of vegetation and plotted to allow at least thirty (30) yards before a change in surface. Acute angle turns are to be avoided.
- F. Line 7:At least one (1) 90 degree turn

The Board of Directors of the American Kennel Club approved a voluntary "DNA Certification Program" at its January 1998 meeting. shall be in an area devoid of vegetation and plotted to allow at least thirty (30) yards before crossing or returning to a vegetated surface.

G. No part of the track shall be within fifty (50) yards of any other track.
G. No part of the track shall be within fifty (50) yards of any other track. No part of the track may be within thirty (30) yards of any other

part of thesame track.

- H. Delete entire letter paragraph.
- H. All tracks shall be laid utilizing buildings and the diverse scenting conditions created by being in close proximity to such buildings. Tracks shall also utilize any and/all other structures such as fences. breezeways, ramps, stairs, bridges, shelters, roofed parking garages, through courtyards and buildings with two or more openings and/or open buildings. The intent of Variable Surface Tracking stresses that dogs shall be able to handle the diffusion of scent created by these structures. Tracks shall be as equal in complexity as possible in this regard. Tracks may not enter a building with closed doors and sides.

## Chapter 5 Tracking Test/VST Section 7. General Requirements

- F. Delete entire letter F requirement. Add new letter F requirement so that it now reads:
- F. A Variable Surface Tracking site totally or partially covered in snow would not meet the criteria of three (3) different surfaces including vegetated and non-vegetated surfaces and snow covered portions of a Variable Surface Tracking site may seriously affect the proper utilization of the site as a whole.
- G. (NEW) All other general Tracking Regulations apply to the Variable Surface Tracking Test.

#### **GUIDELINES FOR TRACKING TESTS**

Add the following new paragraph to the beginning of the Guidelines:

These guidelines reflect the policies and practices set forth by the Board of Directors of the American Kennel Club. Judges are expected to conduct themselves in accordance with the guidelines. Failure to comply with these guidelines subjects a Judge to disciplinary action.

Delete paragraphs 1 and 2 and add the following so that the new paragraphs in their entirety now read:

Tracking is a team sport in the truest sense. In true team effort, a handler working as a team with his or her dog, exhibits a real understanding of the dog's motivation and commitment to the task at hand. The handler is able to read his or her dog and communicate with it to accomplish their goal. It is the responsibility of the Judges to differentiate between team cooperation and guiding by the handler and to determine when the

handler is no longer a supporting member of that team and is attempting to guide the dog. In Variable Surface Tracking, team effort becomes even more critical due to the nature of the test. The objective of a Variable Surface Tracking Test is proving credibility in following a scent in an urban locale. The dog works for the sheer love of scenting.

The tracking fraternity is known for it's

friendliness, hospitality, and encouragement of all participants. Tracking Judges are members of a very select group. Each Judge represents the American Kennel Club at Tracking Tests. Judges are expected to maintain the high standards that have been set for holders of the titles "TD", "TDX", and "VST". At the same time, a Judge should endeavor to make the Tracking Test itself a pleasurable event for dogs, handlers, spectators and the club sponsoring the event. Adherence to the principles provided in the Tracking Regulations and the Guidelines will enable Judges to achieve these goals.

#### Section 1. Assignments.

The AKC also made changes to Obedience Regulations, effective February 1, 1998. These changes were excerpted in the January *Waggin' Tales*, or you can see the full text at the AKC web site (http://www.akc.org/).

**New Obedience Regs** 

Line 5. A Tracking assignment entails a two (2) day commitment by the Judges. Acceptance of an assignment means that if the test is on a Saturday, the Judges will be available to plot tracks the day before. Similarly, a Sunday test will involve the Judge for both days of the weekend. No Judge shall accept an assignment that requires more in one day than he or she is physically and mentally able to accomplish. No Judge shall exhibit in any

event or competition until completion of their two day assignment.

#### Section 3. Physical Fitness.

Paragraph 1 Line 2 after the words "physically fit" add: "Variable Surface Tracking may not require

as much physical effort as TD or TDX tracking, but may require more consideration of complex scenting conditions in an area containing buildings and/or other large physical structures, as well as a variety of tracking surfaces other than vegetation"

#### Section 6. Visible Tracks.

Paragraph 1 Snow, frost, dew on the fields, plowed ground, or on any other vegetated or non-vegetated surface such as in a VST test, creates the possibility that the path of the tracklayer may be evident to the dog and handler. Judges must consider whether awarding a title to a dog under these circumstances would render a disservice to all previous title holders who have truly earned their titles. If the Judges decide to proceed on any field or variable surface tracking area where the track is visible, they must be alert to any attempt by a handler to lead his dog. Any indication of guidance by the handler shall cause the dog to fail. It is especially critical in VST that there are three (3) different surfaces available and that these surfaces are not obscured by a covering such as snow, otherwise the intent of VST will not be met.

#### Section 7. Use of Tracking Area.

Paragraph 1 Line 6 after the words "this one field " add the words " or variable surface tracking area".

Paragraph 2 add new paragraph " In Variable Surface Tracking, Judges,

exhibitors, spectators and test giving clubs should be aware that these areas may be heavily used by the general public and accordingly, must make every effort to cooperate with these public areas and the people who use them in order to ensure that these variable surface tracking sites will continue to be available for future tests. Clubs and exhibitors alike must try to confine "exercise areas" for dogs to a small designated area and be sure that those areas are cleaned up before the test is over and the area is left in the same condition as it was at the start of the test, not only to promote responsible dog ownership but to promote good relations with the general public."

Paragraph 4 line 1 prior to the words "A complete report" add the words "In the case of Variable Surface Tracking, for the safety of the dog and handler, Judges must be cognizant of surface temperatures in hot weather, especially on asphalt and concrete. Tracks shall not be run on surfaces where the judges and/or tracking committee have knowledge of recent treatment with chemicals that might cause an injury to the dog or handler. If conditions are such as to be unsafe for the dog or handler, the test shall be delayed, postponed or canceled." so the paragraph in its entirety now reads:

In the case of Variable Surface Tracking, for the safety of the dog and handler, Judges must be cognizant of surface temperatures in hot weather, especially on asphalt and concrete. Tracks shall not be run on surfaces where the Judges and/or tracking committee have knowledge of recent treatment with chemicals

that might cause an injury to the dog and handler. If conditions are such as to be unsafe for the dog and handler, the test shall be delayed, postponed or canceled. A complete report of unsuitable grounds or lack of sufficient areas in which to plot the tracks shall be made to the American Kennel Club by the Judges in the Judges books.

#### Section 8. Club Responsibilities.

Number 2 Line 8 after the words "into the ground." add the following sentence "This provision shall not be applicable to variable surface tracking since only a starting flag is to be used

Number 4 Line 4 after the word "terrain." change the period to a comma and add the following " keeping in mind the requirement for nonvegetated surfaces in Variable Surface Tracking." so that the entire Number 4 now reads:

#### Section 9. Length of Stride.

Line 6 after the word "tracks" add the following sentence "Judges should be aware that there can be a difference in depth perception in Variable Surface Tracking Vs TD/TDX plotting because of developed areas rather than natural areas." so that Section 9 in its entirety now reads:

#### Section 10. Handler's Responsibility.

1st paragraph Line 7 after the word "difficulty." add the following new paragraph " In Variable Surface Tracking, although there are no physical obstacles as found in TDX, handlers must train for all types of conditions and surfaces that might commonly be found in a variable surface tracking

area, such as soft and hard dirt, blacktop, concrete, paving materials, sand, gravel, wood chips or metal stairs and to train for the diverse scenting conditions that exist in variable surface tracking."

## Section 10a. Judges Responsibility and Plotting.

To further establish credibility, articles used in Variable Surface Tracking represent items made of substances used in everyday life that an average child or adult might carry and drop.

After the starting article of leather or fabric. Judges should make every effort to place the remaining articles in varying random order on all tracks. Judges should not use standardized articles so handlers are not looking for only certain articles or a definite sequence of articles. Article drop 2 or 3 should be on a non-vegetated surface. This does not preclude the track from ending on a non-vegetated surface and the final article also being on a non-vegetated surface.

The last article should be temporarily marked with the number 4, such as with a small post it note cut down in size, but NOT WITH any permanent markers or grease type pencils. Articles should not have any rough edges or any protruding parts that might cause injury to the dog.

When determining the placement of articles on the track, Judges should keep in mind the possibility that under certain wind conditions and circumstances, if an article is placed on a

minimum length leg (30 yards) connecting two parallel legs, the dog might easily bypass that minimum leg and article, thereby failing. Judges are discouraged from placing articles in such fashion as to fail dogs. Judges should also use caution in

placing articles in or near buildings and structures when there is a strong possibility that the dog might cut off that portion of the leg that the article is on.

Judges should keep in mind that Variable Surface Tracking does not contain obstacles and no non-vegetated surface in itself, should constitute an obstacle for a dog. Anything on the track that prohibits all AKC breeds of dogs and handlers of all ages to participate might be construed as an obstacle.

Tracks shall be laid utilizing any and all structures located on site and the diverse scenting conditions provided by such structures, such as buildings, fences, breezeways, ramps, stairs, bridges, shelters, roofed parking garages, through courtyards and buildings with two or more openings and/or open sided buildings. The intent of Variable Surface Tracking stresses that dogs shall be able to handle the diffusion of scent

created by these structures. Tracks shall be as equal in complexity as possible in this regard. Judges shall not avoid plotting tracks in close proximity to buildings when they are available, it is feasible to do so and it will ensure a track that meets the intent of Variable Surface Tracking. Judges shall not plot tracks utilizing only one small shed type building or single fence line when the above options are available to plot fair but challenging tracks.

Judges shall not use the 90 degree non-vegetated turn in such a way as to be influenced by vegetation, but in fact said turn shall be a true moment of truth non-vegetated turn.

Judges are to avoid plotting tracks in just open areas thereby preventing VST tracks from becoming elongated TD tracks. For safety purposes, Judges are prohibited from crossing heavily traveled roads.

Variable Surface tracks should be as realistic as possible, keeping in mind that most people will follow the path of least resistance. Lost adults are drawn to buildings to seek help, while lost children may be drawn to playgrounds.

Only contamination of a track by a hazardous material, or a large portion of a track being rendered unusable, will warrant another track being laid. People, animals, or vehicles crossing a track shall not invalidate that track.

Judges should be aware of the fact that in a variable surface tracking area there may be an over abundance of similar landmarks such as grassy islands that look the same, yellow line dividers in parking lots, and other repetitive land marks that can easily cause confusion since no flags are used in Variable Surface Tracking.

It is not necessary that the Judges charts be drawn to scale, however, every effort should be made to indicate the location of buildings, structures, etc., in relation to the general area so as to provide a complete picture of the track in question. Judges are not expected to be artists

when indicating buildings and/or structures in the preparation of their charts.

Section 11. Position of the Judges during the test.

After the last paragraph of the section add the following new paragraphs:

In Variable Surface Tracking, the scent cone widely varies from those in TD or TDX due to buildings, structures, etc., therefore, it is imperative that when judging, the Judges follow the dog at a distance so as to be able to observe the dog tracking, but not too close as to interfere with the dog while working and to allow the dog adequate time and distance to work out scenting problems and only fail the dog when it can no longer recover.

It is imperative that the Judges not allow the

tracklayer to follow too closely so as to interfere with the dog and handler and create scenting problems such as causing the dog to turn and go directly to the tracklayer; however, the tracklayer should be in an area easily accessible to the Judges, if and when needed.

### Section 12. Evaluation of the Tracking Performance.

Line 12 after the words: "before failing the performance." add the following sentence:" However, if the dog has stopped working, the dog must be failed."

#### Section 13. Judges Qualifications.

After the last line of the section add the following paragraph:

A VST Judge should be familiar with scenting conditions in an area consisting of more than just vegetation. Buildings, miscellaneous other structures and a variety of surfaces can affect the scent.

## Minutes from the February Board Meeting

**F** ebruary 4, 1998

Meeting brought to order at 7:45 p.m..

Drew Graham (President) welcomed the new board members.

Kay Weber

Kay Weber announced that there were nominees for the Sally Compton Service Award. Following a very difficult decision by all of the board members, the winner was chosen. (you'll have to come to the Award's dinner to find out first hand who got it.)

Kay Weber also stated that the vendor supplying the round F.V.D.T.C. patches requires a minimum order of 50 patches per type. Kay asked for board approval to increase the maximum allowed amount to purchase the new patches. The order will consist of 50 patches each of: AKC-UDX and AKC-VST and 25 patches each of AKC-UD and CKC-UD. The anticipated cost for the entire order is expected to be approximately \$465.00, which would be a difference of about \$150.00 from the original order. A motion was made by Will Short, seconded by Judy Anderson and approved by all members present to allow the additional patches to be ordered.

The December meeting minutes were approved as published without any corrections. Several items of correspondence were read.

Michelle Richter-Farrell (First Vice-President) stated that Trudi Kimm (conformation instructor) has requested that a new grooming table be purchased for the class. The current table is old and has been fixed multiple times in the past. After researching the prices in a selection of catalogs, it was determined that the least inexpensive 30" table is \$64.00 and the 36" table is \$73.00. Peggy Sue Seehafer made a motion to authorize the purchase of a new table for a maximum of \$100.00. The motion was seconded by Will Short and approved by all members present. Michelle will also ask if any club members might be able to donate a table that they are no longer utilizing. The possibility of asking a club member to build a table was also discussed, but it was decided not to pursue that idea due to possible liability problems should the table ever fail while being used.

Michelle also asked for feedback from the board members regarding the possibility of ordering leashes with the intent of having them available for purchase by students. The leashes will be available on a preordered basis. Michelle will put an order form in the Waggin' Tales, any interested students should submit the order form to Sandy Walsh at the information table with the payment. The leash(es) will be ordered and available for pick-up at training the following week.

Peggy Sue Seehafer suggested that we should consider having other types of club merchandise available for sale at training.

Cindy Pakenas (Second Vice-President) requested feedback to determine whether a program would be needed for the March membership meeting, or would the business portion of the meeting preclude the time

for a program. One of her thoughts would be a panel of experienced exhibitors and trainers for a Q & A session.

Cindy also stated that several club members had mentioned to her that they would like to know how the board members voted on motions. All of the board members present agreed to that suggestion (it'll be done starting with this meeting).

Cathy Fleury (Treasurer) and Penny Legner (as former Treasurer) reported that 1997 was a better year than past years. The club showed a profit of slightly more than \$5,000.00.

Penny distributed the 1997 financial statement which includes a three year comparison for the individual categories. She reviewed the "big ticket items" of the trial:

- Visitors totaled 104 (just due to the marquee on Randall Road)
- Kitchen showed a profit Many thanks to Susan Yee (Trial Kitchen Chairperson) for a great year!!

Penny mentioned the phenomenal work done by Jean Airey (Publicity), Cheryl Lewis (DOT) and the many instructors who increased the revenue of our puppy and beginner classes.

Due to the excess in revenue this year, Penny recommended that the board begin to consider ways of "returning to the community" some of our excess. According to our non-profit status, we need to be careful with retaining a large sum of cash on hand. In Penny's opinion, with the recent history of ending past years "in the red", our non-profit status should not be challenged at this time. However, should this financial history continue (and we hope that it does), we should consider ways to benefit the community in a monetary fashion. Peggy Sue Seehafer suggested that we could consider offering a class

scholarship to a member of the community. Although many other ideas were mentioned during the meeting, it was decided not make any final decisions at this time due to the fact, that any monetary gift would be reflected in year 1998 - not 1997. We will need to keep careful watch of the situation in future years.

Penny stated that the tax return due to be filed by May 15th will be completed by the end of February. Penny announced that she will continue to complete the tax returns while Cathy Fleury is handling other functions of the office.

With the financial statements for past three years, it is obvious that our club has begun the swing back to the positive. All of the volunteers who have worked and continued to work extremely hard should take a minute to "pat yourselves on the back".

The Board members extended a huge thank-you to Penny for her spectacular job as Treasurer (and Board member) in the past and for her continued assistance in the future.

Cheryl Lewis (Director of Training) reported that we currently have four beginner's classes: one at 7:00 p.m., two at 8:00 p.m. and one at 9:00 p.m. and one puppy class 7:00 p.m.. Assistance instructors are still needed both of the 8:00 p.m. beginner's classes.

A Canine Good Citizen's (CGC) test has been scheduled for February 19th, Alice Seymore will be the judge. This test will only be offered on a pre-entry basis, no drop-ins will be allow to enter. Entries and payment should be made to Cheryl Lewis. The fees are \$4.00 for a member and \$6.00 for a non-member. It was also announced that the Anderson Animal Shelter Dog Expo will conduct a CGC test, either on April 18th or April 19th. A question was posed as to why we do not host a more "regularly" scheduled CGC

test. Cheryl explained that we simply do not have enough space to hold the CGC test. For this CGC test, one of the novice rings will not be available for the February correction clinic. At this time of the year, it is "easier" to remove a ring without dramatically impacting the time and space requirements of the correction clinic.

Cheryl reiterated that the non-member guest training fee is \$5.00 PER dog, not per person. This is stated in the "Fee" section of the red binder at the information table. Taffy asked for a clarification of what constitutes fulfilling the membership application requirement. She used an example of a potential member paying to train two dogs on one night (i.e. the trainer would be in possession of two receipts with the same date). According to that part of the definition in the red binder, the statement reads "Come as a Guest Trainer a minimum of five (5) times". consensus of the board members was that it could also be stated as 'five (5) NIGHTS'. Cheryl reminded the Board that the purpose of that policy was to enable the current club members to get to know an individual (and allow the individual an opportunity to get to know the club) prior to accepting them as a member during the membership vote.

Another item of discussion was whether to continue placing advertisements in the local newspapers. Gerry Erskine (Class Coordinator) was asked to keep a record of how our students learn of our classes, via a question on our class applications. It has been determined that for the last two sessions of classes, most of the students have heard about us through local veterinarians or other club members. According to the 1997 financial report, a total of \$637.17 was spent per session for the three or four days of local newspaper advertising for classes in 1997. Additionally, approximately 600 flyers and mailings were distributed in 1997.

Judy Anderson made a motion that we do not place the newspaper ads for the next two sessions of classes. Peggy Sue Seehafer seconded the motion, all members present approved it (with the exception of Cindy Pakenas, who left the meeting prior to the vote). It was felt that after two sessions of classes, a fair determination could be made whether this action had a positive or negative impact to the club's class enrollments.

We discussed alternative methods of advertising. Jean Airey has submitted press releases to local newspapers for our class graduations. However to date, none of them have been printed. We have had one "human interest story" printed at the time of our trial.

Additionally, we also discussed different ideas of how we can show our appreciation to the local veterinarian offices that are currently recommending our club to their clients. One idea discussed was the possibility of offering them a full page ad in our trial catalog for the price of a half page ad. Taffy Wille suggested that we offer a vet who refers five students that type of discount. No final decision was made at this time to allow for exploration of other possibilities.

Cheryl Lewis made a motion that the next item in her report be moved to an Executive Session of the board. Dave Lewis seconded the motion, the motion was approved by all members present.

Sandy Walsh has been appointed as the Assistant Director of Training by Cheryl Lewis.

Taffy Wille (Trial Secretary) reported that in order to complete the AKC paperwork, she needed to determine the entry fee for the trial. She was told by Car-Dun-Al, that their entry fee would be \$18.00 for the first dog and \$12.00 for the same dog entering a

different class. Taffy Wille recommended that we also charge \$18.00 and \$12.00. We would then be consistent with Car-Dun-Al fees and would be the same as last year's trial.

Taffy asked for Board feedback regarding the possibility of having a "special attraction" at the trial. An example of special attraction would be hosting an eye or tattoo clinic after the trial and before the awards are handed out. Although, by AKC definition it is not considered a special attraction, Will Short suggested that we do a heel-down as we have done in the past. It was determined that we would not include a special attraction in our AKC application, however the possibility of conducting the heel-down would be discussed in the future with respect to the timing of the trial completion time and time necessary to determine the awards' winners.

Taffy also mentioned that she would like to determine the price of our catalog ads. Our ads are more expensive than what Car-Dun-Al charges. They charge \$35.00 for a full page ad, while we charge \$50.00. In spite of the price difference, our 1997 catalog contained more ads than the Car-Dun-Al catalog. With that background information, it was decided that our prices would remain the same for the 1998 trial catalog. Taffy also explained that she handles the inside covers of the catalog on a first-come/first-serve basis - they are not sold at a higher price (like other clubs charge).

Taffy reported that she is asking for volunteers to be trial committee chairpeople, she wants to begin updating the premium list with that information. Any club members wishing to serve as a trial committee chairperson should contact Taffy Wille or Will Short.

Prior to continuing with the regular committee reports, it was announced that due to the time of the night, and that we voted to discuss the issue from Cheryl Lewis in an Executive Session, we went directly to Old Business to allow Kay Weber to provide an update to the Dr. P. McConnell seminar prior to adjourning the regular session.

#### **Old Business**

Kay Weber stated that all the "spots" had been filled. She had received all the necessary volunteers to work for the weekend.

\*\*\*\*\*

At this time of the meeting, Will Short made motion to adjourn the regular Board meeting and go to an Executive Session. The motion was seconded by Dave Lewis. During the discussion, it was determined that the regular Board meeting would be continued on February 18th at 7:30 p.m. at Peggy Sue Seehafer's studio. The motion to go to an Executive Session was approved by all members present.

The outcome of the Executive Session of the Board is as follows:

Cheryl Lewis reported that Wally O'Brien (who had resigned his and Gail's membership, prior to the end of the membership year) has asked her how they would re-apply to F.V.D.T.C. for membership. Given that there are currently no specific procedures in place, the board set about to determine an overall solution for this type of situation for now and in the future.

After much discussion among the Board members present, Dave Lewis made a motion that an individual who has resigned within the fiscal year of membership follow the normal new member application procedure, with the exception that the following requirement would be waived by the club:

Prospective member(s) must:

• Come as a Guest Trainer a minimum of five (5) times

or

Attend a Beginner class

The motion was seconded by Judy Anderson, and approved by all members present with the exception of Will Short.

A motion was made, seconded and approved to adjourn the Executive Session meeting at 10:40 p.m..

## Letter to the Membership

We have rules, called by-laws. Our by-laws say that where not specifically covered by the by-laws we are bound by Roberts Rules of Order. These procedures have not always been followed, but the members are more aware of the rules now and want them to be followed. Perhaps members want to make sure that no policies are added, changed, deleted without following these rules. In the past, some policies have been changed without membership approval.

Regarding the September meeting: There was no motion and vote to suspend Roberts Rules of Order for this meeting. Therefore any motions made and votes taken were perfectly in order.

In October, a member tried to make a motion to disregard (or throw out) the vote taken in September. Another member stated that this cannot be done and the motion died. There is a section in Roberts Rules that states that a motion cannot be made to 'throw out' a motion that has already passed. Neither can a motion be made which directly opposes a policy put in place by a vote. Presumably this is to prevent opposing factions from throwing out each other's votes at every other meeting. A motion which has passed must be rescinded by a motion and vote to rescind the original motion. In October, a vote was taken to continue discussion. Discussion can take place at any time for any length of time (unless a motion is passed to end discussion) but no amount of discussion can change a previously voted on motion. In order to rescind a previous motion that was passed, prior notice must be given, or else the motion to rescind must pass by a 2/3 majority. Prior notice means, it must stated that a vote to rescind a specific motion will be taken as part of the business agenda at a meeting. Notice of this meeting and the specific motion to be considered for rescinding must be given to all members prior to the meeting. Since no notice was given to members regarding a vote to rescind the September motion prior to the January meeting, the motion to rescind had to have a 2/3 majority to pass. This did not happen and policy passed in September remains in place. It doesn't matter how many members voted or how they voted at any given meeting - the rules still apply.

The question was asked why everyone is so upset about this issue. One reason might be that the training policy was changed without a membership vote. Alice Larson said at the January meeting that this is all about awards. She was right. The topic of discussion in September was to define a training member with respect to eligibility for awards. The current policy (passed in Sept.) does not require any member to attend training - unless they apply for an award. The alternate proposal up for consideration in September was that the member only had to be listed as a training member in the roster. If the 'listed only' policy were to be adopted members might be afraid of what abuse of the policy we would be leaving ourselves open for. Let me propose the following scenario: I am a training member. There is another member of my family who is also a training member. We have one membership. The other member of my family teaches classes and may be on the board. Anyway, because of the other person's work, we pay no dues - I do not pay any dues - I get the benefit of the work done by the other family member. I still need my 6 credits to get an award. I decide to work at 6 or more of the 10 matches held during the year. If I steward I get one credit per match. I also get to run 2 dogs through for free for every match I work at. I am saving as much as \$48. to \$80. on match fees, depending on how many times I work. If I judge at matches instead of stewarding, in addition to all the above mentioned benefits, I also am paid \$15 in cash for every match. I may be paid up to \$150, depending again on how many times I judge. So, for a best case scenario, I could earn my credits, save myself \$80. in match fees, and earn \$150 cash. Then all I have to do is attend the picnic and two meetings and show up to collect my award(s)! This may not ever happen, but everything outlined above is perfectly 'legal' under the 'listed only' proposal. I would not even be subject to review at awards time (the board only reviews cases where requirements are not met). In this case all requirements would be met under the 'listed only' proposed policy. It seems a lot of members do have a problem with this.


