I will communicate through Waggin' Tails and on training nights. You can respond in writing, by telephone, and through discussions. I invite and will present as many sides to an issue as I can. For instance, one question is what titles should receive an award? Choices range from doing away with all awards to giving awards for all canine titles by all titling organizations. By narrowing choices through discussion, not a vote, those who would have voted for none or all awards still have a voice. I want to eliminate the extremes and least favorable selections and discover what most club members believe to be the wisest choice of awards for FVDTC.

The first focus will be on which obedience titles should be given awards. What will not discussed at this time, are awards for conformation, tracking, other titles or awards value. Currently we give awards for all AKC and Canadian obedience titles. There is much discuss: about whether to eliminate the Canadian awards or add UKC (United Kennel Club) recognition. Our choice is to give awards for one of the following:

- 1. AKC Obedience titles only
- 2. AKC, CKC awards of equal value (our current policy)
- 3. AKC, CKC, UKC with equal value awards
- 4. AKC, CKC, UKC, SKC (States Kennel Club) with equal value awards
- 5. AKC and one choice from another obedience titling organization for equal value awards
- AKC and one choice from another obedience titling organization for equal awards and recognition of a lesser value from other obedience

The following are some expressed views for and against various title recognition

- We are an obedience club, therefore we should recognition all obedience titles.

From the Editor

E-Mail Waggin' Tales

n January and February we asked you if you would be interested in receiving your copy of *Waggin' Tales* via e-mail. There has been a lot of positive response, and a lot of questions. Here's my best effort at answering those questions. If you want more information, or want to receive *Waggin' Tales* via e-mail, contact Dave Lewis at 630/897-4267 or dclewis@inil.com.

♦ What does it cost?

It costs you nothing. The club will purchase the software necessary to produce the newsletter, and you use free software to read it.

What's the benefit?

It will save the club almost the entire cost of producing the newsletter -- about \$1 per person per month.

- How does the newsletter get to me? It will be sent as a "binary attachment" to your regular e-mail. That means your e-mail software must support attachments. Juno (the free e-mail system) does not work. Netscape, Microsoft Mail, Microsoft Exchange, Pegasus, Eudora Light, Eudora Pro, AOL and many others will work fine.
- Can I print the newsletter?
 Yes. Just like anything else, you can print the whole newsletter, or page by page.
- Can the contents of the newsletter be changed?

No. The newsletter will be in "Adobe Acrobat" format, which means you can read, search and print, but not change the contents. It will look identical to the printed copy.

How big is the file? How long will it take to download?

It depends. The size of the file will be directly dependent on the number of pages in the newsletter, how many pictures there are and several other factors. A sample 12-page newsletter is 280Kb. Time to download depends on your modem, your

computer and your e-mail provider. It shouldn't take more than a few minutes.

Will it be compatible with DOS,
 Windows 3.1, Windows 95,
 Macintosh, Unix?

Yes. One of the reasons for choosing Acrobat is its extreme portability. You can find a reader that will work on any platform.

 Can the newsletter be forwarded to non-members?

> Yes. There's no way to prevent members from forwarding the e-mail to non-members. (Of course, there's no way to prevent members from passing or copying the printed version, either)

- Is this going to replace the printed version of Waggin' Tales?
 Only for those members who want to.
 A paper copy of Waggin' Tales will be provided to any member who wants
- What do I need to do to get the email Waggin' Tales?

Send e-mail to Dave Lewis at dclewis@inil.com, download and install the free Acrobat Reader (don't worry, I'll send you complete instructions) and wait for your first copy of e-mail Waggin' Tales.

Minutes for the February 18 Board Meeting



eeting brought to order at 7:45 p.m..

Will Short made a motion to conclude the meeting by 9:30 p.m.. The motion was seconded by Cindy Pakenas and approved by all members present.

Dave Lewis (Waggin' Tales Editor) gave a demonstration of what the Waggin' Tales would look like electronically. In order to receive the electronic Waggin' Tales, the software application Acrobat reader is necessary. For those utilizing Windows version 3.11, the Acrobat reader necessary is version 3.9. Your e-mail provider must be able to support attachments. Currently, Juno free e-mail does not. The newsletter would be sent out as read-only to prevent anyone other than the editor from modifying the contents.

To purchase the software necessary to create the electronic document, the cost is \$179.00. Dave asked everyone to please respond to survey published in the last issue, in order to determine an accurate account of those members who would prefer to receive the newsletter electronically. He stated that if there were as few as 12 members receiving the newsletter electronically, the development software would "pay for itself" after one year. The payback would be fewer copies made at the printer and less postage to mail out the copies. Dave also stated that the paper copy would still be available to those members who prefer to receive it that way or who do not have internet access.

Those who receive the electronic newsletter would be able to see color pictures. Non-members would also be able to receive the newsletter, as is currently done.

Judy Anderson stated that she will attempt to modify the membership database to allow a place to store email addresses. It was felt by the board that a decision could not be made until we had least 12 club members who wanted to get the newsletter electronically.

Dave also announced that he continued the investigation (started by Kay Weber) into using the U.S. Postal Services special handling of non-profit postage. In order to receive that lowered postage rate, we would have the following restrictions:

- only be allowed to print our club information (i.e. no AKC information could be printed)
- we would need to mail out a minimum of 200 copies
- it could take between one to four weeks to receive the mail.

Dave had been approached by a non club member who wished to advertise a litter of puppies in the newsletter. It was decided after some discussion that it would not be appropriate to accept an advertisement from a non club member.

Tracey Mohr (Public Education Liaison) reported that the Anderson Animal Shelter's Canines, Crafts and Critters show (formerly known as the Dog Expo) will be on April 18th and 19th. Cindy Pakenas stated that Linda Castle from the Anderson Animal Shelter has contacted Toni Sikorcin regarding the demonstration. Michelle Richter-Farrell will need to work Toni to determine what equipment will be needed.

Tracey will be asking for volunteers to sit at the club's booth during the day at the next

that if the club did have a booth at the show, the hours would be approximately 12 hours each day on Saturday and Sunday. Tracey learned that a 8' x 10' booth would cost \$150 for a non-profit organization. This show generates a lot of public interest. Cindy Pakenas stated that she had also been contacted by the coordinator who indicated the cost of the booth might be negotiable. Tracey felt that the type of club literature she would like to present to the public cannot be created in the five weeks remaining until the show. She feels that the club should consider a more polished and professional appearing presentation for public events. Peggy Sue Seehafer suggested that we should have a small "gift" to maintain our presence in the minds of the general public. During the brief discussion, magnets and keychains were suggested.

"connected" website would mean that the club's website would be available through a club member's personal page. A disadvantage to that type of website is volatility of club members and the lack of ease of searches for the public.

If the club does pursue the website, our flyers could state "visit us at the web-site". Questions regarding the future maintenance and other long-term issues were briefly discussed. Dave Lewis stated that he would be available to maintain the site as the club's webmaster. It was also suggested that perhaps we could consider a site sponsorship by ?? (i.e. Dog World), although it was thought that perhaps that could be construed as "advertising by a non-member". Dave stated that he will put some more information in the next issue of Waggin' Tales. Cindy Pakenas stated that since the seminar did return a nice profit to the club, perhaps it would be a worthwhile way of advertising.

New Business

Kay Weber reported that the seminar made a profit of approximately \$2,200. She stated that the room was professionally maintained and set-up. There were 79 individuals on Saturday and 102 people on Sunday. In spite of the large number of people, the subject dogs handled the situation fine. seminar was video-taped by 4 different club members. She stated that to create a complete set of tapes (by editing of the tapes created), she received a price of \$50/hour to edit by a local tape editor. She and other club members would determine the contents of the final set of tapes. A "super master" would be created from all of the video tapes created at the seminar. The super master would be utilized to make other copies. The editor requires a purchase order minimum of 5 sets. It was his opinion that the final set of the seminar would be approximately 6 or 7 tapes. The reproduction cost would be \$10.00 per tape. It was suggested that the club purchase six sets of tapes to be distributed in the following manner:

- One set each for the four club members who did the actual taping
- One set for the library
- One set for Dr. P. McConnell.

Bob Nicholson had been asked, but he felt that he would not be the appropriate individual to decide what was kept for the final draft. He would be contacted again to let him know that he would not have to decide what gets taped. It was stated that the tapes created on Sunday tape would be ideal for instructors to view for dealing with aggressive dogs. Cindy Pakenas stated that Kay did a wonderful job, creating a low-labor money making situation for the club.

Peggy Sue Seehafer made a motion to get the tapes edited and seven sets made (keeping two in the library) and not to spend more than \$1100. The motion was seconded by Will Short. During the discussion, Taffy Wille stated that she felt that the amount was too high, she thought an amount closer to \$750 would be a more reasonable. Cheryl suggested that we encourage club members to obtain copies via a pre-ordering process after advertising in Waggin' Tales and at the membership meetings. After the discussion concluded, Peggy Sue Seehafer amended the motion to not exceed \$800. The motion as it was voted on: to get the tapes edited and seven sets made (keeping two in the library) and to not spend more than \$800. The motion was seconded by Will Short and approved by all. No one opposed and there were no abstentions.

Will Short made a motion to go to Executive Session at 9:00 p.m. The motion was seconded by Cathy Fleury and approved by all.

She witnessed a non club member physically kick her dog in the chest and use a rag that had Tabasco sauce on it as a training tool. Additionally, this women was rude to Anne and Kay Gianos. Prior to the match, judges had been told not to interfere with handlers in the ring. There had been prior complaints that judges were "telling me how to train" to the handlers and they had been asked not to extend that information to the handlers. Cheryl was informed of the women's behavior. Cheryl approached the woman, identified herself as the Director of Training, and let her know that her treatment of her dog was not acceptable at our training facility. The women responded by demonstrating how she "plays" with her dog by kicking it and stated that she "has to" train her dog very roughly. The training techniques that she was using was recommended to her by her professional trainer. Cheryl stated that during the "play" demonstration, she asked the woman several different time to discontinue that type of behavior. When she would not cease the behavior and told Cheryl to mind her own business, Cheryl asked her to leave the building. Cheryl felt that the woman will probably NOT show up again.

A discussion entailed on whether we need to communicate "that abusive training will not be allowed on the grounds". We could post a sign regarding this. Nick Trnka suggested that we put something on our correction clinic entry form. Joan Payne suggested that we should not call attention to the situation. Cathy Fleury suggested that we do not create a blanket definition of "abusive training", rather that it be dealt with on Anyone witnessing a an individual basis. behavior should immediately contact the DOT to address the issue. Please do not attempt to address the situation without Cheryl. Joan Payne asked if Cheryl felt she needed any additional support to handle that situation. Cheryl reported that she did not for that situation. Ronnie Bizer stated that she knows who the professional trainer. Ronnie also volunteered to call the trainer to let her know that her students will not be allowed to use some of her training techniques while at our training facility.

FVDTC on the Web??



bout a year ago the FVDTC Board began exploring the option of creating a site on the World Wide Web. Although the benefits were clear, we were very concerned about the cost of creating and maintaining such a site, along with the logistics of keeping the information fresh and current. At the February 18 Board Meeting (see p. 8), we continued our discussion and I was asked to present the different options to the membership.

Benefits of a WWW Site

The World Wide Web is an excellent means of providing information. FVDTC has a wealth of information to provide to members, potential members, and dog-lovers. Using the internet, we can advertise events like the McConnell seminar and the November trial nationwide for a fraction of the cost of printing and mailing fliers. When training is canceled because of the weather, we can put a notice on the web site and notify any member who has web access. The club calendar can be posted, or past issues of Waggin' Tales, the club roster, or any number of other pieces of information that is of importance to the membership. Any or all of these items can be protected so that only club members can see them.

With some of the hosting options, the club would get multiple e-mail accounts. For example, we could have a "DOT@fvdtc.org" assigned to the Director of Training. Then, when a new DOT is elected, there is no change to the address you send your e-mail to. It just gets routed to a new person.

Drawbacks of a WWW Site

The most obvious drawback is that a site will cost money over a long term. Secondly, the site must be maintained. Right now we have the skill and the willingness within the club to maintain the site, but if that person leaves the club will have to find somebody else or abandon the site.

"Static" and "Interactive" Pages

Throughout this list of "Hosting Options" you will see the terms "Static" and "Interactive" pages. A static page is one that presents information with little or no user input. An interactive page gives you the option to enter information and get something back based on what you entered. For example, filling in a form with your name, and having the web returns your address and phone number. Pages that have been customized to fit specific input are more effective.

Hosting Options (where do we put our web page?)

The first option is to get a personal account for the club (eg. "www.inil.com/~fvdtc/"). This is the same kind of account you would get from your local Internet Service Provider if you wanted to get internet access for your family. This option gives the club 3 e-mails (like fvdtc@inil.com), space for WWW pages, and costs \$179/year. The only option is for static web pages. To get interactive pages with this account would cost an extra \$30/month for an annual cost of \$539.

The second option is a business account (eg. "www.fvdtc.org"). The cost structure is more complex:

Year 1: Registration and Setup fees \$200 + Hosting Fees \$600 = \$800

Year 2: Hosting Fees \$600 = \$600

Year 3: Registration Fee \$50 + Hosting Fees \$600 = \$650

What we get for the money:

10 Email accounts (eg DOT@FVDTC.org)

30 megabytes of space for your web page

Access to the CGI directory (This lets us do interactive pages)

FVDTC on the WWW

The third alternative is to wait until I get my site set up and put the club's pages in a place like

"www.davesplace.com/fvdtc/". The club would get one email (eg fvdtc@davesplace.com), and the cost would be \$200/year. We would be able to have interactive pages, but the space limit would be somewhat less than 30Mb.

Paying for the Site

There are several options for paying for the site. The first, most obvious, option is for the club to pay the entire cost. The second is to find a sponsor, like Dog World magazine or Front and Finish. This might be seen as advertising from a non-member. A third option is to share a site with another club or another organization in a similar field.


