

Board Meeting Highlights August 21, 1998

Meeting brought to order at 7:43 p.m.

Carolyn Pearson (Secretary) - The June Meeting Minutes were approved as published. Several items of correspondence read.

Dog Dictionary



Awards Report

To the FVDTC members,

I wish to apologize for the delay in receiving the 1998 awards information. I agreed to be the awards committee chairman hoping to expedite information and recommendations. A family crisis delayed the process.

The board informed the committee that we could make suggestions but we could not make decisions without board, and in some cases, membership approval. The board did receive the committee's report in early June. We believe it is up to the board and the members to make the final decisions. Our recommendations remain the same.

It was my personal goal to try to reconcile members who had opposite views. While I never found agreement between any two members, I did discover hopes of compromise among many. If you can approach the following information with the attitude, "I may not like this, but I am willing to work for a compromise (whatever that may be)", instead of, "if it isn't my way, it's no way," we will reach *compromised agreements*. The following are the committee's recommendations for the 1998 awards followed by the board's suggestions.

Obedience

As an AKC club, AKC titles should receive our premium awards. Since we are an obedience club, we strongly recommend awarding AKC and CKC titles with the addition of UKC titles.

Recommendation: UKC titles be awarded on the same level as Canadian titles (one level lower than AKC).

Board recommendations: Keep the AKC and CKC titles the same as last year AND recognize obedience titles offered by other registries with a 5" x 7" plaque with room for additional

Board's Comments

Board's comments regarding the Award's Committee's Report.

First - a HUGE thank-you to all of the committee members for all of the time and effort that went into their recommendations. This was put together in spite of several catastrophic events occurring recently to the various committee members. Although there has been a "delay" in the publication of the report, it has not due to lack of action by the Award's committee or the Board. It has been a result of the complex and sensitive issues that needed to be addressed

A lot of heart and soul went into the report - between the work that the Award's committee did and the discussions by the Board. After the Board received the commutice's recommendations at the beginning of June, several weeks were spent communicating between the board members regarding our opinions and thoughts. It was finally decided that everyone's opinions had been heard via non-face-to-face communication (i.e. e-mails, fax's and telephone calls). The "conversations" were compiled into one document and then the final Board recommendations were compiled at a face-to-face get together. This "final" recommendation was then turned back to the Award's committee for further action - i.e. membership decisions.

As you will notice in some of the recommendations, Joan Payne is correct agreement between club members is not always possible, but compromises can and should be made. Joan's report lists the Award's committee's recommendations, as well as the Board's recommendations. In most cases, they are one in the same - differences have been noted as such.

Please read the report very carefully (and with the mindset that compromise is not a "bad word").

name plates. Club members would also need to fulfill the other award requirements. This recommendation was arrived at after much discussion between <u>what</u> should be recognized and <u>how</u> it should be recognized. It was finally agreed that a nice award should be offered, but still attempt to keep the long-term cost fairly reasonable.

Committee comment: we strongly disagree with not awarding UKC titles at the same level as CKC.

Awards Report

Tracking

The recommendations are an attempt to avoid duplication of awards for the same title and continue to honor the memory of Aldythe Comstock and Ruth Anderson. Currently, the TD earners select one of five awards and the Aldythe Comstock Memorial Award. A dispute over money caused this award to be suspended, but it was reinstated last year. The committee wants to insure both memorial awards are secure now and for the future.

1. Tracking Dog (TD) and Tracking Dog Excellent (TDX)

Currently, TD earners receive one of five awards AND the Aldythe Comstock Memorial Award.

Recommendation: The TD award would <u>BE</u> the Aldythe Comstock Memorial Award with selection from the list of awards or an 8" x 10" picture with an engraved plaque affixed to the frame stating it is the Aldythe Comstock Memorial Award.

Board Recommendation: Agreement for the TD.

Currently, TDX earners receive one of five awards <u>AND</u> the Ruth Anderson Memorial TDX Award which is a large plaque with engraved name plates that is passed on from year to year and a small replacement plaque kept by the previous year's winner.

Recommendation: The traveling plaque stays the same. In place of the small commemorative plaque, an 11" x 14" picture (currently one of the five choices) and an engraved plaque affixed to the frame stating it to be the Ruth Anderson Memorial TDX Award, will be awarded.

Board Recommendation: Agreement for the TDX - recipient has a choice of five awards including the picture (committee agrees).

2. Variable Surface Tracking (VST)

Currently offered at the AKC - UDX level

Recommendation: Stay the same.

Board Recommendation: VST title to be offered at the same monetary value as the UDX.

3. Champion Tracker (CT)

Currently not recognized.

Board Recommendation: Agreement for the CT, recognized but not given a special award.

<u>Agility</u>

This is a complex and controversial issue that needs more discussion and a cost projection study.

Recommendation: FVDTC continue to recognize agility titles with certificates. We also recommend a recipient have the choice of a patch.

Board recommendation: Continue with the certificates. Do not offer patches at this time.

Breed (Bench) Champion Awards

Recommendation: No change, award at the CKC - CD level

Board recommendation: Agreement with the Award's committee.

Other Awards

Needs more time, discussion, and cost projections.

Title Recognition

While attention will be paid to those who have "earned" an award through their club involvement, ALL club members who earn any title should be recognized. Recognition does not mean earning an award.

Recommendation: ALL titles earned by ALL FVDTC members should be recognized in the following ways:

- **1.** January or February issue of Waggin' Tales (does not have to fulfill other award requirements).
- **2**. June Front and Finish ad (current policy, does not have to fulfill other award requirements).
- **3.** Annual Dinner Banquet program (does not have to fulfill other award requirements).

4 . Certificates (must fulfill all other award requirements).

Board recommendations:

- 1. The board agrees with the Award committee's recommendation to recognize ALL title earners in the Waggin' Tales.
- 2. The board agrees with the Award committee's recommendation to recognize ALL title earners in the Front and Finish ad.
- **3.** A great deal of discussion went into the Award's committee's recommendation to list ALL title earners in the Annual Dinner Banquet's program. After listening to all opinions about this topic, it was agreed that the program should be reserved to give **special** recognition to those individuals who put forth the extra effort necessary to be eligible for a club award. This recommendation does not agree with the Award committee's recommendation.
- **4** . The board also agrees with the recommendation of the Award committee to offer Certificates to all title earners who have fulfilled all other award requirements.

Committee comments: We believe the Annual Banquet is a celebration of a member's total accomplishments including recognizing the hard work of many members who do not earn titles and all title holders. For various reasons, some members earning titles do not fulfill the award requirements. The Annual Banquets is a night of inclusion not exclusion, of patting ourselves on the back and saying what a great year, and of looking at the positive with an eye to the future on how we can improve. It is a night to put aside our differences and celebrate our sameness. It is a night to not only honor our dogs, but to also honor ourselves, all of us that make up the membership of FVDTC.


