## **Juniors in Performance Events**

From: Mari-Beth O'Neill, Director of Judges Education and Liaison National Junior Organization



ffective January 1, 1999, Juniors will be recognized for participating in obedience, agility, earthdog, lure coursing and herding events. The Junior will enter the dog in the class in which it would normally compete for the event. In each of these events the dogs are scored individually on their performance. The individual handling the dog in these events must have worked with their dog to train them to participate successfully. The dog's score in these events will be

linked to the Junior Handler's number through the use of the Junior Handler Certification Form (see enclosure). The American Kennel Club is planning to acknowledge the Junior for each title that their dog successfully earns. The Junior must have been the handler for all qualifying scores leading to the title in that event. Unfortunately, we can not acknowledge qualifying scores or titles prior to January of 1999.

We are hoping that this will encourage Juniors to participate in different AKC events in which their dog may be eligible to compete. We hope clubs holding these events will find ways to recognize the Junior and encourage their participation.

To record wins in these events, the Junior Handler is responsible for the completion of the Junior Handler Certification Form. These forms will be supplied to all Show Superintendents, Field Representatives, and to each Club upon approval of their event. The Junior can also obtain these forms by calling the Judges Education Department, (919) 854-0195. The form must be filled out completely and signed by the judge on the day of the event. The original copy is sent to the American Kennel Club with the judges book while the other copy is given back to the Junior Handler to maintain their records.

The ownership requirements are the same as for participating in Junior Showmanship, the dog must be owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather, or grandmother, including corresponding step and half relations, or by a member of the Junior Handler's household. ## Board Meeting Highlights February 3, 1999

Meeting brought to order at 7:45 p.m..



arolyn Pearson (Secretary) - The December Board Meeting minutes were approved as published, without any corrections or additions. Several items of correspondence were read.

Cindy Pakenas (Second Vice-President) sent her report with Carolyn Pearson. She would like to have a Panel Discussion for the March Membership meeting program to allow individuals the opportunity to ask questions regarding obedience competition. All of the Board members present at the meeting felt that this would be an excellent program and it should be heavily publicized at the all of the beginning level classes (beginners through novice ring-ready). Judy Anderson stated that she would put together a little "poster" to be displayed at training. The discussion would be held for a maximum of 30 minutes and be the first item on the agenda.

Cathy Fleury (Treasurer) reported that all bills that have been received have been paid. The tax returns are being prepared by Penny Legner (our registered agent).

**Director of Training** - Carolyn Pearson suggested that in lieu of a current Director of Training (DOT), that an acting DOT be utilized. The acting DOT would be available on training nights for any questions or problems that might arise. During the hours of 7:00 to 8:00 p.m., the acting DOT will be Sandy Walsh, at the front table. After 8:00 p.m., Carolyn Pearson will be the contact.

Taffy Wille volunteered to assist Carolyn Pearson in obtaining instructors for the next session, which begins on March 18th for Beginners' classes and March 25th for Puppy classes.

Will Short (Trial Chairperson) was home ill, but had sent his report. Will reported that the rent of the fairgrounds for the 1999 Obedience Trial has increased. Due to the increase, he would like to raise our trial entry fees to \$19.00 for the first entry and \$13.00 for the additional entry of the same dog.

Prior to the Board meeting, Taffy unsuccessfully attempted to contact Car-Dun-Al to determine what they were planning to assess for their entry fees. Taffy felt that we might loose prospective exhibitors if our fees were higher than Car-Dun-Al's fees. She stated that for those competitors who had to decide on only one show for the weekend, they might choose Car-Dun-Al simply for the lower entry fee. After the discussion, it was decided that we would re-contact Car-Dun-Al to determine what their entry fee would be and to adjust our fees accordingly.

Taffy Wille (Trial Secretary) reported that all judges' contracts have been signed and returned. She is currently waiting to receive the AKC forms to be completed and submitted.

Dave Lewis (Waggin' Tales Editor) reported that the Acrobat software purchased to allow the Waggin' Tales to be distributed via e-mail has more than paid for itself at this point. He is also investigating the cost of upgrading to the Windows/95/98 version for Acrobat.

The distribution of the February newsletter will be delayed due to a business trip.


