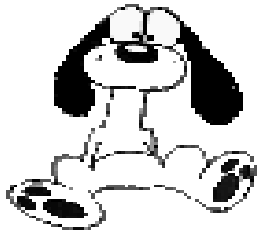

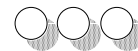

Membership Meeting Highlights May 5, 1999

Meeting brought to order at 8:03 p.m.

Helen Castellano discussed "What help is needed for an agility match" as the program, prior to the business meeting. Helen reported that the current status of the sanctioned match approval process is: AKC is requiring a change to the by-laws to include "agility" or a letter of intent to amend the by-laws. The courses set-up by the judges are currently being reviewed by the AKC.

There are currently four members on the agility match committee: Deb Simmons and Cathy Fleury are coordinating the stewards and Suzan Scott is the match secretary.

It is expected that approximately fifteen to twenty volunteers will be necessary. Volunteers will be rotated through the different positions, if they wish to do so. The amount of work credits to be earned has not currently been determined - that will be discussed at the June Board meeting and announced in the June Waggin' Tales.

The following positions are needed to have a successfully organized agility event:

- Scribes - keeps score for the judge
- Timers (two) - keeps the time of the dog running the course
- Check-in
- Line-up
- Runners - take a leash from the start line to the end
- Course "fixers" - resets the jump and jump heights, resets the chute, moves equipment when the course is changed between the different courses, etc.
- Table assistants - helps Suzan (match secretary)

Carolyn Pearson (Secretary) - The March Meeting minutes were approved as published. Several items of correspondence were read.

Cindy Pakenas (Second Vice-President) announced that the Annual Picnic/Membership Meeting will be on July 18th at Creekwood Meadows (Mike Bond's Agility Training Facility in Plano). The agility match will be held in the morning with the picnic following in the afternoon. The club will pay for the food and drinks for the judges and workers. A sign-up sheet will be available at training for club members to sign-up to bring a dish to pass and/or donate money to purchase the other food and drinks. The tentative order of events for the day are as follows: 1) agility match, 2) lunch, 3) meeting and (the best part) 4) the games. Please contact Cindy at (630) 377-6250 if you would be able to volunteer to assist in the planning and the execution of the games for the afternoon.

The AKC Obedience Rule books are now available for sale at the Information Table on training nights. The cost is \$1.00.

Cindy also reported that the club has received an invitation, through Kay Weber, to participate in the St. Charles Scarecrow Festival on October 9th and 10th. The club has been asked to provide a total of six hours of demonstrations. Each demonstration will be for one hour each at 11:00 a.m., 1:00 p.m. and 3:00

Volunteers will be needed to participate in each demonstration and also to coordinate each demonstration. Cindy stated that she would do the overall coordination - but not for each demonstration.

How to Tell a Chihuahua From a Mastiff

As judges at dog shows well know, distinguishing between a chihuahua and a mastiff is a difficult, perplexing and confusing job. The tricky task is somewhat easier if the two animals are side by side, but with study and practice, the distinction can be made even when the dogs are viewed one by one.

There are two subtle points of distinction:

- 1) The nose. The mastiff's nose is blunt, while the chihuahua's is pointy.
- 2) The ears. The mastiff's ears are floppy. The chihuahua's are sharp,

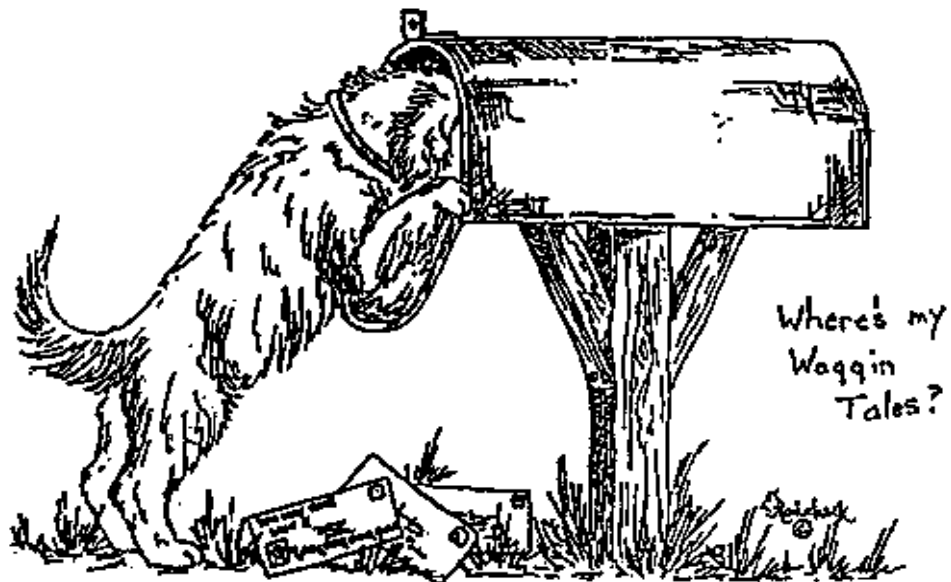
upright and pointy.

If, after examing ears and nose, you are still in doubt, there is yet another method of distinguishing between a mastiff and a chihuahua. This technique involves two steps.

- 1) Sit on the dog.
- 2) Arise and examine the dog.

If the animal is alive and well, you are dealing with a mastiff. If the dog is not, then what you had was a chihuahua.
