Halloween Safety Tips

Halloween is filled with goblin masks, chocolates and excited children. All three can pose a risk to your canine. The American Kennel Club offers the following safety tips to keep in mind on Halloween.



Walk your dog early on Halloween night - before the most active part of the evening, and grip the leash firmly. Your dog may be distracted or scared by children walking by in costume. If your dog is usually outside and is a "greeter," meaning he barks his welcome, you may want to consider bringing him inside. His potential barking at trick-ortreaters may scare them or bother the neighbors. Make sure your dog is secure either in the house or in the yard.

Caution adolescents in your neighborhood not to tease or "trick" your canine. Scared dogs may bite to protect their property.

Sweets are not healthy for your dog. Chocolate can act as a toxin in canines and can cause severe sickness or even fatality. Remind children never to feed a dog sweets, especially chocolate. If you'd like for your dog to have a treat, keep dog biscuits close by.

Be careful if you dress up your dog for Halloween. Make sure he can see, hear and breathe properly through the costume. Make sure the costume is flame retardant as well. Keep a close eye on the dog to ensure its safety. If at any time the dog looks uncomfortable or anxious, remove the costume.

Membership Meeting Highlights October 6, 1999


