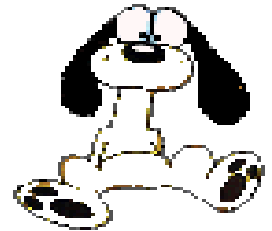

# Board Meeting Minutes

## *Board Meeting Highlights December 1, 1999*

Meeting brought to order at 7:43 p.m.

Agility Committee Members', Cathy Fleury and Vicky Hagens, presented the committee's proposal to the board. The date would be Saturday, September 16, 2000 (Lyons Dog Training Club would host their own agility trial on Sunday, September 17). Carolyn asked whether the club's Tracking Tests, scheduled to be held on September 17th would be a problem with AKC rules - that is not a problem. Will Short made a motion to accept the proposal as presented by the Agility Committee to host our first annual Agility Trial, Dave Lewis seconded the motion. The motion was approved by all present, without any opposition or abstentions.

Carolyn Pearson (Secretary). August Meeting Minutes were approved as published.

Cindy Pakenas (Second Vice-President) was not in attendance. Carolyn reported that Cindy has once again agreed to organize the games at the annual Christmas party on December 28th. Anyone wishing to help Cindy (as an assistant) should contact her at training or at (630) 377-6250. In addition to the games, party-goers are encouraged to bring a dish to share. Soda will be provided by the club.

Cathy Fleury (Treasurer) reported that the bills that have been received have been paid and we have money in the bank. The summary financial report for 1998 and one for the first six months of 1999 will be distributed at the January Membership meeting.

Taffy Wille and Carolyn Pearson (Acting Directors of Training), reported that they will be in search of Primary and Assistant Instructors for the first session of 2000. ANY current instructor wishing to continue for the next session is asked to please contact either Taffy at (630) 365-0423 or Carolyn at (630) 231-5658.

Cathy Fleury volunteered to be the Primary Instructor for the 7:00 p.m. Beginner's Class.

Taffy reported that anyone who might consider being a Primary Instructor for future Puppy classes should contact her. She would like to have any interested people work with her during the upcoming session.

## Sally's Cheese Veggie Soup

- lack of an 8" height on the bar jumps (the jumps were made prior to the rule change in which 8" is a valid jump height)
- inaccuracy of the actual height (a measurement with a revealed that the jump was not exactly correct)

Will Short and Judy Anderson volunteered to work with Ed Herdes and review ALL of the jumps that the club owns, over the Christmas holidays. The review will determine the condition of the jump and whether the measurements are accurate. Each jump will be categorized into four groups:

- Discard
- Keep for use only at the trial
- Keep for use at training
- Keep for use as rental

Following the review, it will be determined whether any jumps need to be replaced or whether we have sufficient sets to use for all our needs.

Taffy Wille (Trial Secretary) read the thank-you notes that she received from judges, Steve Pool and Diane Propst.

Taffy requested feedback from the board regarding our current policy to allow an individual to request a refund (even after entries have closed) when their bitch has come in season. Currently, the refunded amount is the entry fee less a service charge of \$2.00. Car-Dun-Al also allows their entrants to request a refund and they retain a service charge of \$3.00. Taffy verified the policy with AKC and determined that the refund is at the discretion of the club - it is not an AKC mandate. Taffy stated that when someone pulls their entry, it is administratively costly and also prevents other exhibitors from getting in the trial. After much discussion, the board felt that the ultimate decision should be made by the trial committee, however the consensus was that we should no longer allow a refund for exhibitors with bitches in season. The premium list will need to be modified should the trial committee approve this change.

## Skunk!!!!

**S**uch a lovely aroma - as we all know! BUT, thanks to Ginger Romano, I can actually live with Brady (the brat). A couple of weeks ago, he decided to investigate a black and white "cat" while out on our nightly walk and bam!

So I quickly called Ginger and she gave me the following recipe for a "de-skunking" solution. The full article was printed in The Whole Dog Journal and explained how a chemist named Paul Krebaum discovered the solution to neutralize the highly odorous compound in the skunk's spray called Thiols. He discovered that by making oxygen molecules bond with the thiols, the smelly substances were chemically altered into odor-free neutral substances.

Brady was not completely free of the skunk odor, but enough so he was allowed to sleep in our bedroom that very night. I can still smell the skunk a teeny-bit when Brady gets wet. BUT, compared to the initial aroma - this is a "bed of rose". So keep the following things (but not pre-mixed - loses the effectiveness over time) somewhere in your "doggy-supplies" for any accidental future encounters you might have.

1 quart 3% Hydrogen Peroxide  
1/4 cup Baking Soda  
1 teaspoon Liquid Dish Soap

Mix in a bucket or bowl: it will be fizzy. Don't put it in a sealed bottle, could "explode" the lid off. Thoroughly wet your dog with the solution. Knead it well into the coat, to chemically alter every bit of the thiols on the hair. Be careful to keep the solution out of the eyes, nose and mouth. Use a sponge to wipe it on the face. Follow the solution bath with a thorough rinse of clear water.

# Reflections of a Pet Store Puppy

I don't remember much from the place I was born. It was cramped and dark and were never played with by the humans. I remember Mom and her soft fur, but she was often sick and very thin. She had hardly any milk for me and my brothers and sisters. I remember many of them dying and I missed them so.

I do remember the day I was taken from Mom. I was so sad and scared. My milk teeth had only just come in and I really should have been with Mom still, but she was so sick and the humans kept saying that they wanted money and were sick of the "mess" that me and my sister made. So we were crated u and taken to a strange lace. Just the two of us. We huddled together and were scared, still no human hands came to pet or love us.

So many sights and sounds and smells! We are in a store where there are many different animals! Some that squawk! Some that meow! Some that peep! My sister and I are jammed into a small cage. I hear other puppies here. I see humans look at me. I like the 'little humans', the kids. They look so sweet and fun, like they would play with me! All day we stay in the small cage. Sometimes mean people will hit the glass and frighten us, and we always hear "Aw, they are so cute! I want one!" but we never get to go with any.

My sister died last night when the store was dark. I lay my head on her soft fur and felt the life leave her small, thin body. I had head them say she was sick and that I should be sold at a "discount price" so that I would quickly leave the store. I think my soft whine as the only one that mourned for her as her body was taken out of the cage in the morning and dumped.

Today a family came and bought me! Oh happy day! They are a nice family, they really, really wanted me! They had bought a dish and food and the little girl held me so tenderly in her arms. I love her so much! The mom and dad say what a sweet and good puppy I am! I am named Angel. I love to lick my new humans! The family takes such good care of me, they are loving and tender and sweet. They gently teach me right and wrong, give a good food and lots of love! I want only to please these wonderful people! I love the little girl and enjoy running and playing with her.

Today I went to the veterinarian. It was a strange place and I was frightened. I got some shots but my best friend, the little girl, held me softly and said it would be OK so I relaxed. The vet must have said sad word to my beloved family because they looked awfully sad. I heard severe hip dysplasia and something about my heart. I heard the Vet say something about backyard breeders and my parents not being tested. I know not what any of that means, just that it hurts me to see my family so sad. But they still love me and I still love them very much!

I am 6 months old now. Where most other puppies are robust and rowdy, it hurts me terribly just to move. The pain never lets up. It hurts to run and play with my beloved little girl and I find it hard to breathe. I keep trying my best to be the strong pup I know I am supposed to be but it's so hard.

It breaks my heart to see the little girl so sad and to hear the mom and dad talk about "it might now be the time". Several times I have gone to that veterinarian's place and the news is never good. Always talk about congenital problems. I just want to feel the warm sunshine and run and play and nuzzle with my family.

Last night was the worst. Pain has been my constant now, it even hurts to get up and get a drink. I try to get up but can only whine in pain. I am taken in the car one last time. Everyone is so sad and I don't know why. Have I been bad? I only try to be good and loving. What could I have done wrong? Oh if only this pain would be gone! If only I could soothe the tears of the little girl. I reach out my muzzle to lick her hand but I can only whine in pain.

The veterinarian's table is cold. I am so frightened. The humans all hug and love me. They cry into my soft fur. I can feel their

love and sadness. I manage to softly lick their hands. Even the vet doesn't see so scary today. He is gentle and I sense some kind of relief for my pain. The little girl holds me softly and I thank her for giving me all her love. I feel a soft pinch in my foreleg. The pain is beginning to lift. I am beginning to feel a peace descend upon me. I can now softly lick her hand. My vision is becoming dreamlike now and I see my mother and my brothers and sisters in a far off green place. They tell me there is no pain there, only peace and happiness. I tell the family good-bye in the only way I know how, a soft wag of my tail and a nuzzle of my nose.

I had hoped to spend many, many moons with them but it was not meant to be. "You see," said the veterinarian, "pet shop puppies do not come from ethical breeders." The pain ends now and I know it will be many years until I see my beloved family again. If only things could have been different.

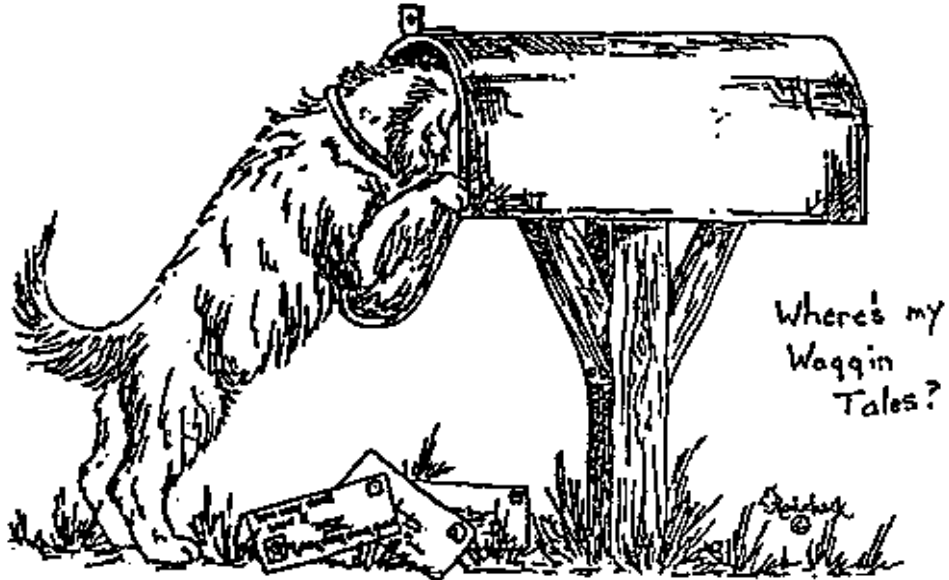
