## Member Spotlight — Brenda Rivera with OTCH Cosmo

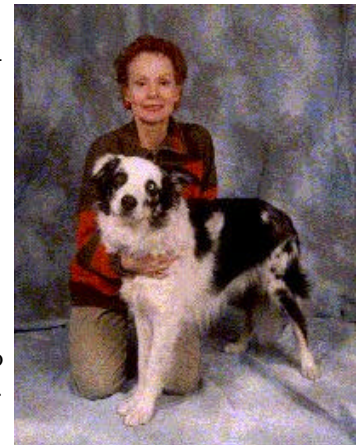
Brenda joined the FVDTC in 1983 with her Sheltie, Ajoy Tampico B. Gallant, a gift from a friend. Brenda's first instructor was Dudley Murray – the team took first place in his graduation class and she was hooked on obedience. Brenda followed up by attending Judy Anderson's class and then Ellen Sidwell's Ring Ready class. Within 6 months Brenda and Tamp were entered in their FVDTC Trial where they placed 6<sup>th</sup> in their class, thanks to good instructors. Tampico went on to become UUD Ajoy Tampico B. Gallant UD, C-UD, a triple utility dog. Sadly, she had to say "good bye" to him last January after 16 ½ years.

U-CDX Ajoy Pookala B. Gallant UD, C-CD or as she prefers Princess Pookala, also a sheltie, is the only female Brenda has trained. Pook always felt the "obedience thing" was a little beneath her. It took Tamp four shows to earn his UD, while Pook took 15. She is 15 years old and has mellowed a little.

OTCH Chad B. Gallant, Brenda's first border collie, was 3 ½ years old when she bought him from a friend in 1990. She finally had a dog who loved obedience. In fact, at trials, he sometimes had a much better time in the ring than she did! Brenda and Chad trained with Bernie Brown who was the best, and in 1994 received their OTCH. What a thrill that was for her. In 1997 Chad died from a freak accident. Brenda was devastated.

OTCH Cosmo FDCH, another border collie, is co-owned by Brenda, her daughter, and son-in-law. Cos lived with Brenda's daughter and son-in-law but since Brenda's house was his day care center Brenda trained him. Her daughter decided to show him through his utility degree, which was a real challenge because neither of them had been in a trial before. After her daughter finished his UD Brenda found herself with no dog to show, so Cos was elected to be her obedience teammate. He would rather have been competing in Frisbee or Flyball. Cos decided there was only one way out of this "obedience stuff", to get his OTCH which he did last year.



Brenda is currently showing her 3 ½ year old border collie, U-CD Kilt B. Gallant CD. After an eight-year absence, it's back to the novice ring. The team has recently earned 3 High in Trial awards, and the elusive perfect 200 score. Brenda gives a lot of the credit to Lynn Heidinger who is coaching her.

Brenda's training methods have changed a great deal over the past 16 ½ years, changing with each new dog. Brenda, most importantly, always wants to be fair to her teammate. After all, as she says, "it's tough to compete without him".

There is much confusion over this issue and it seems that clubs and trainers are not clear on it.

Entered her first 2 UKC-Agility trials on January 1st and 2nd and earned her first 2 agility legs

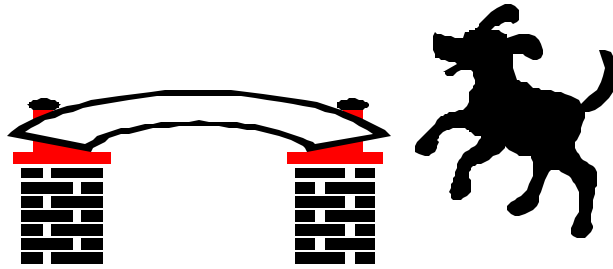

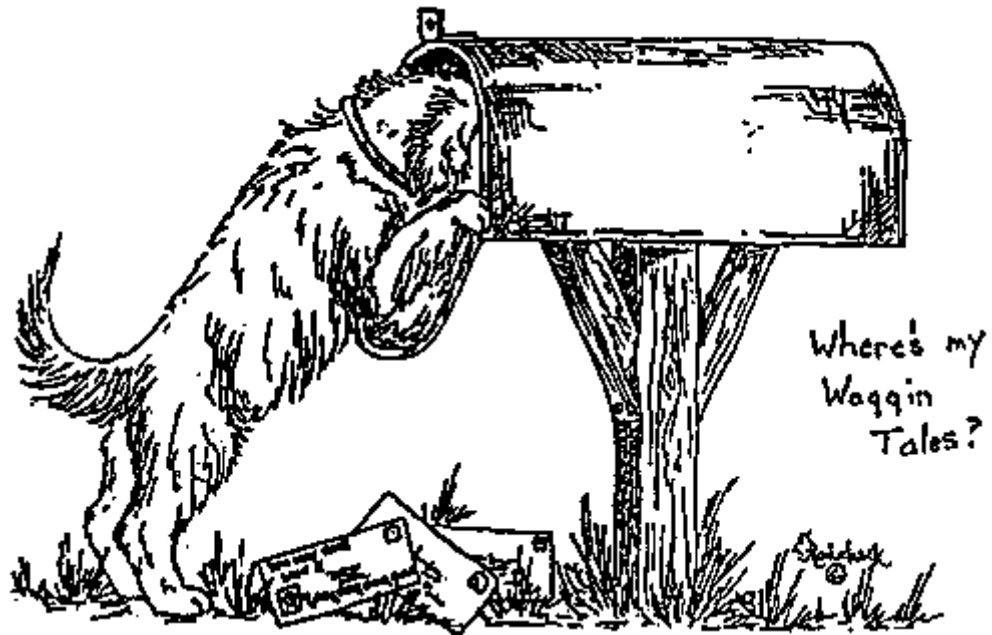
