To receive a club award, you must have:

- "Substitute" as an Instructor or an Assistant on 4 nights

**TWO credits:**

- Serve as Chairperson on a Committee
- Assistant Instructor for Puppy or Beginner Class
- Assistant Instructor per quarter for Advanced classes
- Serve as a Board Member
- Full day at the November Trial

**THREE credits:**

- Primary Instructor for Puppy or Beginner class
- Primary Instructor per quarter for Advanced classes
- Two day Tracking Test
- Serve as the Puppy/Beginner Class Coordinator

## NOTES FROM ALL OVER

### **Obedience Barbie:**

Barbie comes with a training bag full of gear, a set of utility articles, a full set of regulation obedience jumps, her own lawn chair, cooler, a subscription to Front and Finish, and her very own obedience Golden Retriever "OTCh Sparklepond's Shorestepper's Heelalong Fool" better known as "Two-hundred". Accessories such as HIT ribbons and high scoring club plaques can be purchased separately.

### **Tracking judge Barbie:**

Barbie comes with a polartec snowsuit, Gore-Tex rain-gear and boots, wool socks, leather tracking gloves, silk long underwear, sunscreen, bug spray, a baseball cap, a waterproof clipboard, mylar paper and space pens in three colors. She also comes with whistles in two different colors to match the snowsuit and rain

gear, a complete set of tracking flags, a compass, and a set of 12 different tracking articles. ## MEMBERSHIP MEETING MINUTES

### Membership Meeting Highlights March 1, 2000

The meeting began with a demonstration of Canine CPR and Rescue Breathing. Neil Dal Cerro, fireman and paramedic at Fermi Lab, demonstrated the techniques used. The Business meeting began at 8:00 p.m.

Carolyn Pearson (Secretary), the January Meeting minutes were approved as published. Several items of correspondence were read.

Taffy Wille and Carolyn Pearson (Acting Directors of Training). Carolyn reported that classes are wrapping up for session number one. Graduation is next Tuesday, March 7<sup>th</sup>. Session number 2 will begin on Tuesday, March 14<sup>th</sup>. Instructors are ALWAYS being sought for all levels of classes.

The 4H classes began on February 24<sup>th</sup>. There are three rings devoted to the 4H students, between 6:00 pm and 7:00 pm. There are 17 students signed up for the Beginners class, and 20 students signed up for the Advanced Beginners class. Trudi Kimm reported that these numbers also include those students who have only signed up for Dog Care, which is not an obedience class.

Will Short (Trial Chairperson) reported the process is moving along. Judges have been contacted.

Dave Lewis (Waggin' Tales Editor) sent his report with Carolyn. The deadline has been changed to Sunday, March 12 (not the 5<sup>th</sup>), due to a business trip.

Sandy Walsh (Graduation Chairperson) reported that she is still in need of two judges for the Tuesday, March 7<sup>th</sup> Graduation. A judge is needed for the 7:00 p.m. and the 9:00 p.m. Beginner's classes.

Kathy Hubbard (Membership Chairperson) read the names of two applicants, which were published in the February Waggin' Tales. Brenda Rivera made a motion to accept the list as published. The motion was seconded by Kathy Hubbard, approved by all, without any opposed or abstentions.

They will use the excursion to determine whether the club would benefit from attaining a booth at the 2001 show.

Ginger Romano (Librarian) stated that she has purchased a new enclosed and lockable cabinet to hold our library collection. She is in process of having the wheels installed. She will be implementing a new way of loaning the books, by putting cards in all of the books to be signed by the loaner and kept in the cabinet.

Ginger also stated that she will be publishing a list of the books that will remain in the library (the rest were destroyed when the former library cart got wet) AND a list of books that she thought would be good additions to our collection. Once the "wish list" is published in the Waggin' Tales, everyone is encouraged to peruse it and provide feedback to Ginger.

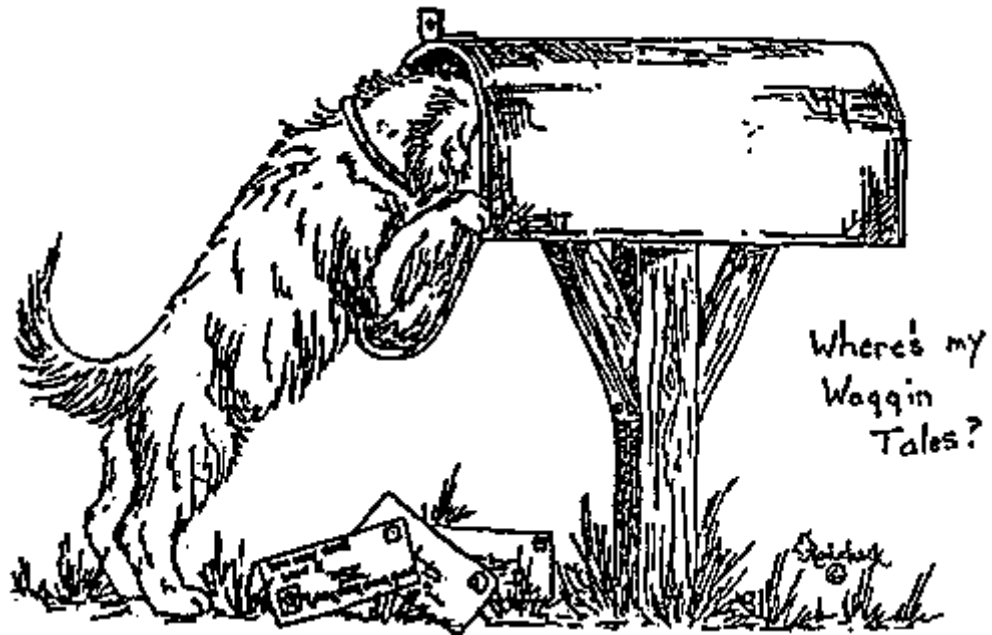
## What Gets Included
