What a guy! I dearly love this handsome, off the wall, loveable so smart GSD of mine.

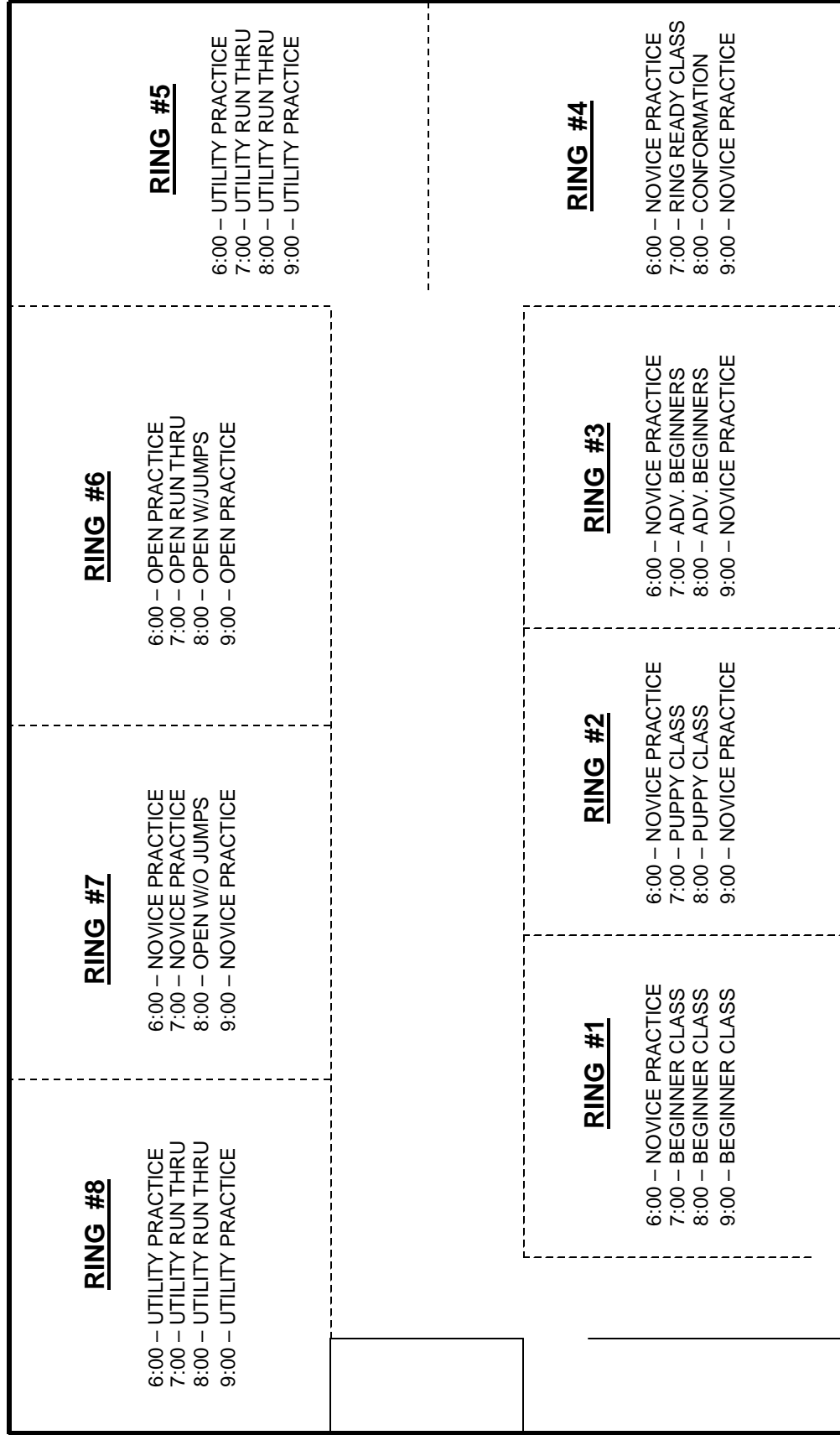

BOARD MEETING HIGHLIGHTS

Board Meeting Highlights December 5, 2001

Meeting brought to order at 7:38 p.m.

Carolyn Pearson (Secretary). June Meeting Minutes approved as published.

Will Short reported that Judy Anderson (First Vice-President) was back in the hospital to determine the cause of an infection. We all wished her a quick recovery and stated how nice it was to see her at the trial on November 11th.

Trudi Kimm (Director of Training) stated that we need instructors for all the next session of Puppy and Beginner classes. We ESPECIALLY need a primary and assistant instructor for a 7:00 p.m. Puppy class. Vicky Hagens and Paul Grosso are in need of a break, and will NOT be teaching that class. The only class that currently confirmed instructors is the 9:00 p.m. Beginner's class. The next session begins on January 3rd. Please contact either Trudi Kimm (dot@fvdtc.org or 630/673-0527) or Carolyn Pearson (secretary@fvdtc.org or 630/231-5658).

Trudi also discussed the possibility of reducing the number of class sessions in the Beginner's classes. Rather than having the Beginner's classes meet on the nights of our Correction Clinics, Trudi suggested that we could utilize that ring to have a Rally "course" set-up. The ring would be available for exhibitors to run through a rally course. The fee schedule would be the same as the obedience portion of the correction clinic. The number of dogs would be limited to 24 dogs per night. The rally match course would use two rings and need a judge. After discussion concerning the ability to teaching the student the same amount of in less physical hands-on time, it was felt that we should try this for two sessions and re-evaluate the Rally course match interest and the quality of our classes. Trudi made a motion that we eliminate the match night training for the Beginner's classes for sessions two and three. Peggy Sue Seehafer seconded the motion. The motion was approved by all present without any opposed or abstained.

We also discussed the amount that we charge for our Puppy and Beginner's classes. Kathy Hubbard reported that she just contacted a local Petco (or PetsMart, sorry I do not remember which one) and they charge \$99.00 for their beginner's class – which does not include a collar and is a shorter amount of time. During the discussion, we felt that it has been a significant amount of time since our last price increase AND we would not be out of line for charging more than \$50.00 for the Puppy

classes. Trudi Kimm made a motion that we increase the \$50.00 fee to \$60.00 beginning with the second session of the puppy class. Dean Connolly seconded the motion. The motion was approved by all present without any opposed or abstained. (Secretary's note: The last price increase was effective June 30th, 1994. Puppy class raised from \$35 to \$50. Beginner's class raised from \$50 to \$65.)

Will Short (Trial Chairperson) re-iterated that we will not offer non-regular classes at next year's Obedience trial. We will also increase the entry rates from \$19.00/\$13.00 to \$20.00/\$14.00. Car-Dun-AI will also be contacted regarding the amount they will charge for entry fees.

Dave Lewis (Waggin' Tales Editor) reported that the next deadline is Sunday, December 9, 2001. Once the new calendar has been confirmed with the fairgrounds schedule, it will be posted on the website calendar.

Dean Connolly (Graduation Chairperson) stated that we need new graduation certificates. Dean checked each of the following printers for a quantity of 2,500 and received the following quotes:

- Kwik Kopy - \$623
- Kon Printing - \$525
- Swifty Printing - \$298.40

Dave Lewis volunteered to work with Dean to get the artwork into a format that can be sent electronically to the printer. Peggy Sue Seehafer made a motion that we use Swifty Printing to print our graduation certificates. The motion was seconded by Dave Lewis. The motion was approved by all present without any opposed or abstained. Trudi also mentioned that the certificates that Nadine Conner made for the 4-H participants were very nice.

Kathy Hubbard (Membership Chairperson) reported that our current membership roster is at a greater number than we typically have at this time of the year. Kathy also stated that the new rosters will be available to pick-up at training, beginning on December 27th – just ANOTHER reason to come to the Holiday Party/ Membership Meeting.

Peggy Sue Seehafer (Director at Large) reported that she investigated various types of dog-related organizations. A list of the organizations was given to Carolyn Pearson. After discussion, it was decided that we SHOULD donate to a group in memory of the September 11th tragic events. It was also suggested that we look for a local

organization dealing with Search and Rescue (SAR) dogs. Several Board members stated that with the amount of money that was being sent to the East Coast, local organizations might be suffering the consequences of not getting their normal amount of donations. Peggy Sue volunteered to look for a local organization that meets our criteria. The amount of money to be donated was not discussed at this time.

Old Business

- Taffy Wille made a motion to allow her to spend a maximum of \$375.00 to pre-order a quantity of 25 (allows for a bulk order discount) of the book called "New Art of Dog Training" by Shelby Marlo. The motion was seconded by Carolyn Pearson and approved by all.

New Business

- Carolyn asked whether it would be possible to increase the amount paid to the Set-up and Break-down individuals. It was the consensus of the board members that we would offer the individuals an increase of \$5.00 per week, per event, effective January 1, 2002. The new fees are: set-up (non-match night) - \$40, set-up (match night) - \$45, break-down - \$45.00. The last time the amount was increased was in June, 1996.
- The General Policy contains descriptions of the board and committee position's job descriptions. It has long been a goal to update the list, since many of the jobs have evolved over the years. Carolyn stated that a new club member has volunteered to update it. Once it has been updated, it will be posted on the website.
- Suzan Scott (Statistician) requested, via email, that the board evaluate the following issues.

§ Offering a plaque for AKC agility titles.

It was the consensus of the board members that we **will** offer a plaque for AKC agility titles, similar to the one awarded for UKC obedience titles. Each plaque would be for the dog, with new title plates added as the titles are achieved. The titles listed would be ANY title that currently receives a title plate. For example, a UKC CD and an AKC NA title plates would be placed on the same plaque for the dog.

§ The re-evaluation of the award given for each title.

It was decided that this would be an appropriate time to do. It will be done, as early in the year as possible to avoid any confusion about what awards would be offered for titles earned in 2002.

§ Continuation of using the services of photographer, John Felix.

He has moved from St. Charles to DeKalb and is extremely difficult to communicate with, as he does not return phone calls. It was the consensus of the board that we would seek an alternate photographer. The John Felix photographs that had been offered as past awards, will be replaced by other awards. Those new awards will be published in the Awards Application in the December Waggin' Tales.

§ The Heather Memorial and the Founders Award traveling awards have been filled.

It was the consensus of the board that the individuals who originally offered the trophy should be contacted with the following questions:

- o Would they be interested in purchasing a new traveling trophy?
- o Would they be interested in holding the "filled" ones, until the club has some place to display on permanent basis

A motion was made, seconded, and approved to adjourn the meeting at 9:58 p.m.

IT'S AWARDS TIME!!

Below is a list of the awards that are offered and a copy of the forms we will be using this year. Each form must contain all the information for eligibility. A separate form must be used for each dog.

If for some reason you have not met **ALL** your requirements (i.e. attended three membership meetings, worked at what equals six work credits and actively participated in the training of dogs at the club) and can justify the reason, your eligibility will be reviewed by the Board of Directors. We highly suggest that if three meetings were not attended, that there is a compensating work effort shown.

It is the policy of FVDTC to give awards and/or patches for AKC and CKC titles earned at trials, tests or shows, where all AKC recognized breeds are able to participate such as Obedience, Tracking, Agility and Conformation. All other titles or degrees conferred by the AKC will receive a certificate of recognition. A plaque will be offered for obedience titles from other registries such as UKC.

Awards are given for titles earned in 2001 (i.e., a dog may have earned two "legs" toward a title prior to 2001, but if the third "leg" was earned in 2001, the title is earned in 2001). However, all scores for any of the "Special Club Awards" must have been earned in 2001.

Members owning mixed breed dogs are eligible for a Certificate of Merit for the equivalent of AKC titles earned at **MATCHES**. Submit at least 3 qualifying score sheets signed by three different judges. This also applies to purebred dogs that are not registered by the AKC.

Any award that states "Personalized" will be engraved with the dog's call name, title and year.

PLEASE NOTE: Anyone wishing to receive an award that requires your dog's picture or involves having your dog's photo taken or other personalized artwork produced - please get your pictures and/or eligibility information to me A.S.A.P. All submitted pictures **MUST** be clear, close-up photos for best reproduction. Our artists need time to work on these, so please be considerate.

If your dog received a Dog World Award, please give me the information as soon as possible. The Dog World Award's program has been moved from Chicago to New York so who knows how long it will now take to get the certificates.

ALL COMPLETED FORMS, PHOTOS AND CLOTHING (FOR AIRBRUSHING) SHOULD BE SUBMITTED TO:

SPECIAL CLUB AWARDS

ALL scores for special awards must have been earned in the current year and must have been earned at AKC trials unless otherwise specified.

NOVICE - HIGH QUALIFYING AVERAGE AWARD - must have a minimum of 3 scores from AKC trials submitted.

OPEN - HIGH QUALIFYING AVERAGE AWARD - must have a minimum of 3 scores from AKC trials submitted.

UTILITY - HIGH QUALIFYING AVERAGE AWARD, must have a minimum of 3 scores from AKC trials submitted.

NOTE: ALL qualifying AND non-qualifying scores must be submitted if you are applying for one of the following special awards that refer to an “average” score. If you do not know your NQ score, list it as 165. Remember, obedience is a sport guided by the principles of good sportsmanship. Each of you is on the “honor system” in submitting your scores.

DOROTHY DIMOND MEMORIAL TROPHY - given to the member whose dog was trained & shown by the member & receives the highest average score in regular classes in at least three AKC trials. All scores must be included. NQ's, unless higher, will be 165.

DEBBIE ORR MEMORIAL AWARD - goes to the member whose dog or dogs earned the most AKC titles or international equivalents during the year. For this award, AKC, UKC and CKC titles are counted.

HEATHER MEMORIAL AWARD - offered by Nancy Gillum, in memory of Briarwood's Heather Miss AM/CAN CD. It is given to the handler whose dog earned the 3 highest scores in Novice A at AKC trials.

FOUNDERS AWARD - offered by Bonnie Barry in memory of the founders of FVDTC. It is given to the handler whose dog earned the 3 highest scores in regular classes at AKC trials.

ED KNEIP AWARD - given to the handler whose dog earned the highest combined score in Open B and Utility A or B at same AKC trial.

KANOSAK KENNEL AWARD - given to the handler whose dog earned the 3 highest Utility A scores at AKC trials with at least 5 scores being submitted.

SALLY COMPTON OUTSTANDING SERVICE TO THE CLUB AWARD - given to a club member to acknowledge them and their contributions to the club. This award is especially significant because it offers you the opportunity to nominate a fellow club member for their efforts. Because the nominations are reviewed by the Board to determine the winner, no current Board member is eligible.

THE ABOVE SPECIAL AWARDS WILL BE KEPT FOR ONE YEAR BY THE WINNER AND REPLACED BY A PERMANENT REPLICA.

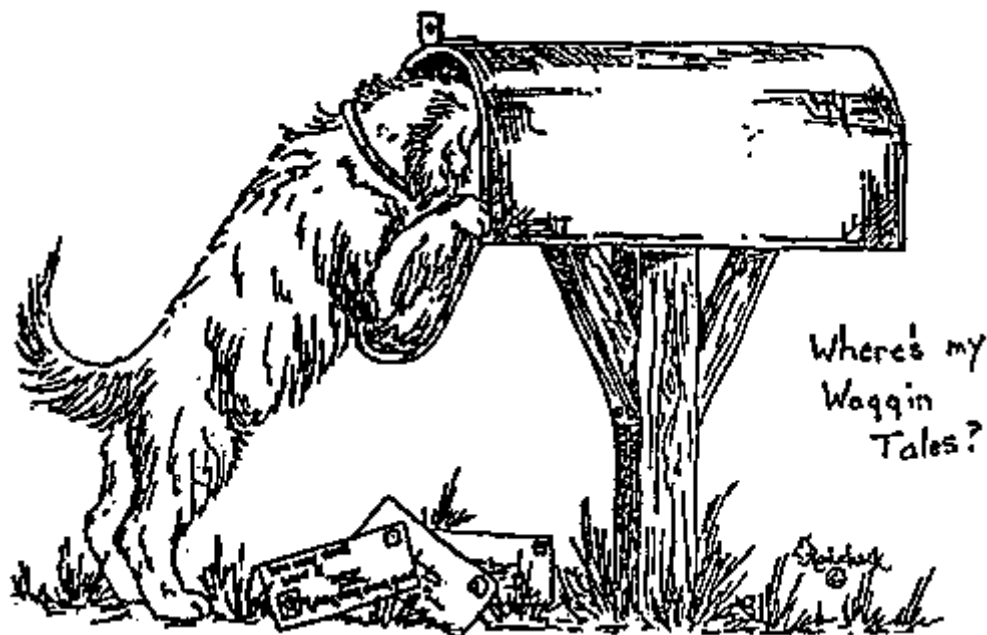
