### Membership Meeting Highlights January 8, 2003

Meeting brought to order at 7:45 p.m.

Carolyn Pearson (Secretary) the December Meeting minutes were approved as read. Several items of correspondence were read.

Vera Nyberg (Second Vice-President) announced that a short program about Paws for a Cause will be presented by Cindy Pakenas at the March 5<sup>th</sup> Membership meeting.

Session 1 of 2003 began on January 2<sup>nd</sup>. All three Beginner's classes are at the maximum number of students. There are two Puppy Classes - however they are not completely full. Still Will Short (Trial Chairperson) reported that a committee is curneed Assistant Instructors for the 7:00 p.m. Beginners class rently looking into selecting judges for the 2003 Obedience with Maxine Brinker. Cheryl Hettinger volunteered to assist trial. Maxine.

Carolyn also gave the following gentle reminder - PLAY NICE!!! She reminded everyone of the following standing rules.

- The following SHARING rules apply to practice rings:
  - Novice Shared by all.
  - Shared at the discretion of the han-Open dler who signed up for the ring use.
  - Shared at the discretion of the han-Utility dler who signed up for the ring use.
- Please be courteous to each other when using practice rings for individual training. Practice rings are not to be used as a private training ring. Any club member has the right to use those rings. If a club member wishes to use a ring, they should simply ask the individuals presently using the ring to share the space. Any club member who is denied access to a ring should notify a current Board Member immediately.
- Instructors should be given priority when ring time is required to train their dogs.
- Members ONLY have the right to use the 'sign-up' practice rings. Individuals who paid a Guest Training fee must defer to training members for the sign-up rings.
- Members may sign up for more than one ring time, but not consecutively, i.e. cannot sign up for 7:00 - 7:10 in the Utility ring and then 7:10 - 7:20 in the Open/

Utility ring.

- Ring Sign-Ups should only be made by the person wishing to train in the ring. No "save me a spot" allowed. ©
- If you change the layout of the Utility and Open rings - PLEASE return it to its original layout. The next person using the ring should NOT have to spend their training time to place the jumps in their appropriate positions.

Will Short asked if we could please post this information at Carolyn Pearson (Assistant Director of Training) reported that each ring with sign-up practicing. Carolyn stated that was a great idea and will make those signs.

Dave Lewis(Waggin' Tales Editor) was not in attendance, but Carolyn reminded everyone that the deadline was Sunday, January 12. Merry Lee Hritsuk stated that the calendar printed in the December Waggin' Tales did not match the dates in the calendar on the website. It was determined that the calendar in the December Waggin' Tales was the calendar with the errors and it would be reprinted in January.

Note from Secretary – the following is the report that was not received in time to present at the meeting.

- We have about 90% of the Waggin' Tales dating back to 1980, but very few prior to that. Copies have been made and originals will be returned shortly. Many thanks to those who have contributed to the collection and reproduction of these past issues. The complete collection from the last five years is available online at <a href="http://www.fvdtc.org/news">http://www.fvdtc.org/news</a>, and the rest is in process. If you have any older issues (prior to 1980) and would like to either donate them or loan them to the club, we'd like to hear from you.
- We have not been able to figure out exactly when Waggin' Tales started, so we do not know how many issues we are missing. Our best guess is 1964, but if anyone has a definitive answer, we would love to hear from you. The earliest issue we have is December, 1966 (Thank you Helen Hankes Pierce).
- The web site had some e-mail difficulties in December. First, it was not sending e-mail from the "Contact Us" page. Fortunately, since this happened last time

we have been archiving all the requests as they occur. We were able to recover all the missed messages (about 2-1/2 weeks' worth), and forward them to the appropriate people. Secondly, the e-mail server at the ISP was mistakenly rejecting e-mail from some of the larger local ISPs (Internet Illinois, CoreComm, Voyager). We worked with our ISP over a period of several weeks to correct the problem, and all is OK now.

Dave has been searching periodically for a more reliable host for the web site, and has found one that will give us newer technology and more reliable service at the same price. He will be working to move the web site to the new host over the next several weeks.

Amy Ford (Treasurer) announced that the transition from Cathy Fluery has been completed. As of today, all check requests should be made to her. She has created new forms which are available on the website, in the gray box or by getting a copy from her. She also reminded club members that any expenditures over \$50.00 must be pre-approved by the Board. Merry Lee Hritsuk asked about the audit. Amy replied that it was decided not to do it, so as not to delay the transition.

Sue MacPherson (Membership Chairperson) read a list of two applicants which were published in the December Waggin' Tales. Sue stated that she also had three applications, which were received after the December Waggin' Tales but prior to tonight's meeting. Taffy Wille made a motion to waive the requirement of pre-publication of those applications, Barb Misch seconded the motion. The motion was approved by all present. There were no opposing or abstaining votes. Sue then read the list of three applications.

Sue read the complete list of applicants, none were present at the meeting. Rick Cox made a motion to accept the list (published and un-published) of names as read. Francene Andresen seconded the motion. The motion was approved by all members present, with none opposed and one abstention. Welcome to ALL new members.

Sue also announced that the rosters are available to pick-up tonight, please print your name on pick-up sheet. They will also be available one last time for pick-up at training on January 9<sup>th</sup>, the rest would be mailed. Sue asked that everyone PLEASE check all your own information and to report any changes to her. A new database was created during the transition from Kathy Hubbard to Sue, so some information may have been lost or modified along the way. Sue also stated that due to the space limitations, all club members not shown as Lifetime are assumed to be Training. That issue will be resolved prior to the next printing of the roster.

Barb Misch (Public Education Coordinator) reported that the fundraiser at Barnes & Nobles netted the club a total of \$123.50. She also stated that Barnes & Nobles seemed impressed with us, as they asked us to fill in when other organizations did not show up at their allotted time. She also found out after she arrived that we could have brought our dogs.

Barb announced that thanks to the generosity of her company, Walsh Media, the club now has a phone number for public contact. The new number is (630) 575-WOOF (9663). This number is a voice mail system with the following "Press #" options.

Barb's co-worker, Michelle, did a great job programming the system for us. Barb announced that this system provides many ways of automatically contacting the club member who is to receive the voice message. The messages with specific date information, such as the next correction clinic will be updated with the new monthly information. Peggy Sue Seehafer suggested that we send a thank you to Barb's boss and company.

It was also suggested that we use the system to announce to club members an unexpected cancellation of an event – such as a night when training is cancelled due to a blizzard. Barb suggested that we could put that message at the very beginning of our message. She will check with Michelle about the method to use to program that into the phone system. Jan Schomer suggested that we give that number to the Puppy and Beginner's class students on the class information sheets. Once the system has been in use for a little bit of time, the class information will be updated with the phone number.

Ingrid Hamburger (Match Steward Chairperson) reported that she needs stewards for the January match. She will have the annual sheet available at training for signing up to work at all 2003 Correction Clinics. Ingrid received several volunteers at the meeting. Taffy Wille also reminded the club members that judges get paid AND receive work credits.

Cindee Erhart-Malnar (Demonstrations) reported that several club members went to the Holmsted for a demonstration and resident visits on November 18<sup>th</sup>. The Holmsted coordinator called and would like us to return soon. Cindee announced that Ed Herdes received a call from an individual looking for

Ginger Romano (Librarian) was not in attendance, sent the following report: all the Waggin' Tales that Dave Lewis has attained for electronic archival will soon be available in binders and put in the library cabinet.

Jean Airey (Publicity) was not in attendance, however Taffy reported that Jean is currently in warm and sunny Florida and practicing with her new digital camera. All club members who are receiving a photograph from Jean as their award must make arrangements with Jean to schedule a sitting. She will be returning from Florida in February and will have limited time to get pictures done prior to the Annual Banquet.

Jan Schomer (Statistician) asked that all club members who possess a traveling award should return them. All award forms must be submitted prior to the January 18<sup>th</sup> deadline.

Jacquie Kramer (Annual Dinner Chairperson) was not in attendance, but send the following report: the Annual Dinner is planned for Saturday, March 8<sup>th</sup> at Fisherman's Inn.

Francene Andresen (Tracking Secretary) reported that we would not host a March tracking test. She is currently looking into judges for the September 7<sup>th</sup> test. A location has not yet been determined, but it will not be at the McHenry location as it is not adequate for hosting TD and TDX tests.

### **Voting for 2003 Board Of Directors**

Carolyn Pearson read the names for each position. Tracey Mohr asked if there were any nominations from the floor. There were no additional nominations. Carolyn Pearson then re-read the slate. Brenda Rivera made a motion to accept the slate as read. Jan Schomer seconded the motion. The motion was approved by all without any opposition or abstentions.

Newly elected President, Peggy Sue Seehafer thanked Tracey Mohr for a wonderful job as President during a VERY difficult year.

Carolyn Pearson made the following brief announcements.

- The gray box at the Front Table has been updated for example pens and pencils are now in pencil cases not in the money envelope.
- A new First Aid Kit has been put together. It now contains supplies for people and pooch injuries. It is in a large gold/brown box band-aids are right on top on the lid.
- PLEASE do NOT park in such a way as to prohibit a large emergency vehicle (i.e. fire truck or ambulance) from getting access to the building.
- Equipment Repair Request Procedure.
  - Write it down on the Equipment Needing Repair log, which is in the gray box.
  - Or, tell Ed Herdes, Cheryl Hettinger or Carolyn Pearson
- Purchase of cleaning supplies will now be done by Cheryl Hettinger – if you notice something getting low (or completely empty) – please tell Cheryl so she can replace it.

Trudi Kimm asked whether any one knew about the status of the #11 fuse which blows all the time. Will check with Ed about the status.

Peggy Sue Seehafer asked the members if they are interested in approaching Kane County Animal Control (KCAC) about working together about the proposed new facility. Barb Misch stated that H.E.L.P. has also contacted KCAC and has offered to provide volunteers in the facility. Barb Misch stated that one of H.E.L.P.'s main objectives is provide an on-site surgery center. She stated that H.E.L.P has connections with the Shodeen family and could be considering some sort of partnership for a surgery center.

Peggy Sue asked what the club should offer to the KCAC. Trudi Kimm suggested that we offer a discount coupon for a class to individuals adopting dogs. Peggy Sue asked whether we were interested in the Elgin location or just Geneva location. The consensus was that we should not pursue the Elgin location. The question was asked whether we would want to own our building and enter into a land lease with KCAC. Susan Waterfall asked why KCAC would want to work with us. It was stated that FVDTC has been a respected community member for over 50 years, with every intention of continuing indefinitely.

Peggy Sue stated that as of the November election, there are

new County Board Members and she does not know what position they have about the proposed facility. Will Short suggested that we should own a building and enter into a 100-year land lease. If we owned the building, would we want to rent it back to animal control? Perhaps we should offer to rent a building owned by KCAC on the property.

Trudi stated that consideration should be made to the significant amount parking needed for hosting training and other events. Jan Schomer that in spite of the limited parking at the Northwest Obedience facility, they were still able to host an obedience trial in December. Taffy Wille asked about hosting the Obedience trial and perhaps an indoor agility trial. Peggy Sue also asked for club members to consider the maintenance issues of owning our own building – snow removal, grass mowing, and internal facility maintenance. Do we want to add the amount of maintenance necessary for our own building?

Taffy Wille said that a \$210,000 mortgage with a 6.5% interest rate would be \$2,400 monthly. Trudi stated that we should consider starting smaller, such as what Bridget Carlsen had done when she built a building, which can be ex-

panded in the future. Bridget's building currently has room for one agility ring or three obedience rings.

Francene Andresen stated that we could start with a smaller building because the utilization would be spread out throughout the week – not just trying to squeeze all activities into one night a week. Susan Waterfall stated that we should "do the numbers" first. Based on the comments made during the discussion, Peggy Sue stated that the club members believe we should continue pursuing the opportunity. Barb Misch and Peggy Sue Seehafer stated they would continue their work. Amy will work on determining what our finances would allow. Peggy Sue Seehafer stated that the next meeting of the Kane County Safety Committee is to determine which site to recommend to the county board. (Note from Secretary – Peggy Sue found out that the next meeting of the Safety Committee is January 15 at 9:00 a.m. in Building A. Club members are encouraged to attend.)

A motion was made, seconded and approved to adjourn the meeting at 9:12 p.m.


