### From the DOT

On Dec.12, 2003, FVDTC will be hosting a workshop for any members who have instructed classes, are currently instructing classes, or who are interested in instructing in the future. The purpose will be to review the current instructional program, discuss what is working and what isn't, and provide input for the homework sheets which are in the process of being revised. Bring dogs. We can train the first hour and talk the second. The time is from 7-9 p.m. and the place is Kay Weber's training rings at 205B Dempsey St. in Elburn. From RT 47 or Main St. in Elburn turn east on North Street. (Look for the library sign.) Go east approximately 3 blocks. Turn north (left) on Dempsey and go about half a block. The building is on the east side of the street just after the self-storage place. It is unit B and has a sign for Kay 9 Petiquette on the door.

Penny will be posting signs on various rings reminding members and informing guest trainers about the procedure for using the rings. We are continuing to use a random draw for individual 7 p.m. run-throughs. The draw is at 6:45 p.m. Utility will be drawn first so that Mary's instructional class may begin. The open draw will follow. Anyone not making the draw or who can't get there for the draw is welcome to request a runthrough at 8 p.m. with the DOT in the ring in which the utility run-throughs have been done.

Help is still needed for the table between 6:45 p.m. and 8:45 p.m. If anyone is interested in being part of the instructional staff for 2004, please contact either Penny or myself. Suggestions for seminar givers would also be welcome. Seminars are not only excellent learning opportunities but can also raise funds.

Instructors, please encourage students to attend, participate in, and assist with our correctional clinics. Not only do they provide handlers feedback on how their dog will perform in simulated trial conditions but by observing other handlers, training tips and techniques may be gained. Novice handlers will be able to observe the different levels of obedience and hopefully aspire to continue beyond the basic sit, down, come, or stay.

### Membership Meeting Highlights November 5, 2003

Meeting brought to order at 7:40 p.m.

Carolyn Pearson (Secretary). The October 1st Meeting minutes were approved as published.

Cindy Pakenas (Director of Training) reported that we recently completed Session 4 for 2003 and that Session 5 had begun. She stated that we do need someone willing to sit at the front table on training nights to greet people and take guest trainers' money. Cindy will put together a "want ad" for the Waggin' Tales. Cindy also asked for anyone who would like to be an instructor for 2004 should see Penny Brcich or Cindy.

Cindy also stated that she believed that the club had a policy for reimbursing any instructors a portion of the fees paid to attend a seminar. Carolyn stated that she would check the records to determine if that policy was defined and recorded.

Cindy reported that she would be conducting an Instructors workshop either on November  $18^{th}$  or December  $2^{nd}$ , from 7:00 p.m. until 9:00 p.m. She anticipates that the evening will begin with the instructors working with their dogs – perhaps demonstrating a training method that they have had success using, followed by a meeting. This first meeting will discuss the revamping of the current homework sheets that the Beginners' instructors hand out to their students. Cindy would like to conduct an Instructors' workshop once a quarter. The workshop will be at a facility in Elburn, which is rented for 2 hours at a cost of \$15.00.

Cindy also reported that Penny has put together a list of ring rules, which will be laminated and posted, at each ring. Cindy also stated that perhaps we could put up a sign on the rings that the Puppy and Beginner classes are meeting at for the first two weeks of each new session. Taffy asked whether we could use the signs that are used at the trial. Cindy will look at them when they are used on Sunday at the trial to determine the feasibility of their use.

Penny Brcich (Assistant Director of Training) stated that the Instructors workshop is open to all members who are currently teaching a class or who are considering becoming an instructor. Will Short (Trial Chairperson) communicated the following information from the trial committee chairpeople:

- Jacquie Kramer needs floating stewards, as she currently only has two floaters signed-up. Francene volunteered as a floating steward.
- Priscilla Pisarski needs raffle items.
- Nadine Conner needs baked goods, Carolyn passed around a sign-up sheet at the meeting.

#### **Old Business**

*Land Purchase Committee Report* Barb Misch reported the results of the Land Purchase Ballot. The following is the results of the vote:

Our next step is to establish a purchasing committee. The Board needs to determine how to proceed in the purchase procedure and to develop a plan of action. The entire Board will be involved in the process, as this is a significant decision-making process for the club and one or two people cannot handle the workload. The following are just a few of the areas that still need to be covered.

1. Obtain a farm real estate attorney or an attorney that has a solid understanding of the Kane County's requirements for a non-profit organization or operation such as ours. One that can be sure we are not overlooking important pitfalls or necessary documents that the county and/or the state needs.

We need to be sure that all contingencies are noted in the paperwork, that we have an attorney who understands the type of land acquisition we are seeking, and that we are soundly covered as a club and as Board members in the area of liability, etc. This list must be very detailed.

2. Develop a list of contingencies to be met prior to finalizing the purchase. For example: land use approval by County, the zoning, licensing for Special Use, building approval, soil testing, etc.

- 3. Develop a list of people and/or agencies necessary to complete each inspection, test, or contingency.
- 4. Develop a preliminary building plan for County approval, as necessary or appropriate.

We need to be sure, however, that our use plan does not meet serious blocks in the future, when we are actually ready to build and put our plans into action. The more obstacles we confront now, the better our success will be later.

Helen asked the attorney she is working with for an attorney's name to assist us in our project. She received the name of John Gosalin. Trudi Kimm volunteered to assist the Board during the land purchase process. It was agreed that the attorney should be secured prior to the Board meeting to dividing the workload. Helen will notify the Board once the attorney has been secured.

Will Short asked whether there was timeframe for the sale of the property. Francene Andresen said she did not know and was uncertain if anyone else has expressed any interest in the property. Cindy Pakenas asked whether we could start the process at this time. It was agreed that we must have an attorney and a list of the contingencies.

Barb also stated that given the number of yes responses on the ballots, that other properties continue to be sought.

Peggy Sue Seehafer thanked Barb Misch and Francene Andresen for all their hard work.

#### Eye CERF Clinic Report

Trudi Kimm reported that she continues to seek an animal eye doctor to perform an eye CERF clinic.

#### Spatial Dog Identifying Bandana

Will Short asked for a brief explanation about the orange "no sniff" bandanas. It was explained that the bandanas are to identify dogs that are spatial and do not want to be approached by other dogs. The bandanas are in the gray box and are available for sale for \$1.00. Will Short stated that he felt that the dogs wearing the bandanas will be perceived as aggressive. He felt that the dogs not wearing a bandana will be perceived as open to being freely approached by any dog or person.

Cindy Pakenas stated that the program is necessary because dogs that are spatial are not always aggressive and deserve the courtesy of space from other dogs and people. She also stated that spatial dogs should not have to be muzzled, as if it were an aggressive dog. Penny Brcich agreed that using the bandana should not be perceived as a bad thing by the public.

Jerry D'Aprile stated that he feels that this is another law that cannot be enforced. It was stated that this was not a law, rather a way of providing a little extra help to people who have spatial dogs to keep progressing forward in the work necessary to overcome the space issue. Tracey Mohr stated that this is should be looked upon as a tool to make more people aware of the situation – not as a license to be lax in our responsibility to pay attention to our dogs' position.

Trudi Kimm said that her dog was attacked four times in one evening for no reason. She stated that she is considering getting a bandana for her dog – to perhaps prevent further incidents.

Francene stated that we should use this as a training tool to increase our opportunities to inform the public of dogs that have space issues. Penny Brcich stated that horses that have a kicking problem are identified with a red ribbon on their tails. This is a visual reminder not to approach too closely to that particular horse. She also stated that information about the no sniff bandanas is included on the laminated ring rules.

A motion was made, seconded and approved to adjourn the meeting at 8:58 p.m.



### The "Puppy Protection Act" Introduced in the House

The so-called "Puppy Protection Act" (PPA) has been introduced in the House of Representatives by Rep. Ed Whitfield (R-KY) designated H.R. 3484. The AKC urges all fanciers to write or call your U.S. Representative asking him or her NOT TO CO-SPONSOR H.R. 3484.

The PPA is once again being promoted by the Humane Society of the United States (HSUS), a Washington-based animal rights organization that opposes all purposeful breeding of purebred dogs. The PPA would amend the federal Animal Welfare Act (AWA) to require the United States Department of Agriculture (USDA) to regulate the breeding practices of dog breeders covered by the Act, including the frequency and age at which bitches are bred.

In the 107th Congress the PPA was opposed by the AKC, the American Veterinary Medical Association, most other animal interest organizations, and even some animal welfare organizations.

The AKC strongly supports the Animal Welfare Act and has a longstanding history of opposing substandard kennel operations. The AKC maintains care and condition standards which it enforces through regular inspections of all breeding establishments. The AKC denies registration and other privileges to breeders who do not comply with the AKC's standards. Nevertheless, the AKC opposes H.R. 3484 because it is bad public policy and sets dangerous federal legislative precedents.

• The Animal Welfare Act currently does not regulate breeding practices of any species of animals. There is no scientific basis for the specific breeding restrictions included in H.R. 3484.

• The USDA's Animal Care regulations already require commercial dog breeders to follow a program of veterinary care developed and supervised by a licensed veterinarian to protect the health of all animals in commercial breeding facilities, including the breeding stock. Breeding decisions should be made by breeders and their veterinarians. H.R. 3484 would co-opt the judgment and discretion of breeders and veterinarians.

The AKC believes that what is needed to improve the welfare of dogs in substandard kennel operations is not legislation imposing new standards on dog breeders, but legislation that strengthens the USDA's tools for achieving compliance with the existing standards. The AKC is working with several members of Congress on the introduction of legislation that would strengthen enforcement of the Animal Welfare Act, and truly address the problems of commercial breeders who do not comply with the Act, without imposing additional restrictions on responsible breeders.

The AKC urges all fanciers to write or call their Representatives asking them not to co-sponsor H.R. 3484. The AKC has also sent letters to all members of the House of Representatives urging them not to cosponsor the bill.


