Board Meeting Highlights June 4, 2004

Meeting brought to order at 7:40 p.m.

Carolyn Pearson (Secretary). The April Meeting minutes were approved as published.

Cheryl Hettinger (First Vice-President) requested any feedback regarding the new jumps that were delivered and are in use. She also asked whether she could have Ed Herdes put screws in the broad jumps to reinforce the boards, as the jumps are only glued and stapled. Although this change would provide a more stable jump, it would void the one-year warranty. The guarantee provides for a replacement jump for a year, however Cheryl will check into whether J & J would also pay for the return shipping. Helen stated that she did not feel that we should void the warranty because the jumps should be able to withstand the normal use of people moving them. Cheryl will remind the club members that when the jumps are positioned, they should be pickedup and moved - not dragged. The Board agreed that we would wait until the August Board Meeting to see how the jumps are withstanding our usage before readdressing that decision about the broad jumps.

Cheryl also reported that the jumps are now numbered. The numbers should be used to identify any problems with the jump. Club members are asked to report any problems to Cheryl Hettinger, Ed Herdes, Carolyn Pearson or Steve Kleinheksel.

Cheryl stated that although the Annual Mat Cleaning has typically been done during May or June, she would like to do it at date closer to the trial. After much discussion about event and Attn: Waggin' Tales Contributors

Preventing Dog Bites

Information from AVMA & CDC Web Sites

Man and woman's best friend bites more than 4.7 million people a year, and key experts believe that public education can help prevent these bites. The American Veterinary Medical Association (AVMA), the United States Postal Service, and the Centers for Disease Control and Prevention are each working to educate Americans about dog bite prevention. Each year, 800,000 Americans seek medical attention for dog bites; half of these are children. Of those injured, 386,000 require treatment in an emergency department and about a dozen die. The rate of dog bite-related injuries is highest for children ages 5 to 9 years, and the rate decreases as children age. Almost two thirds of injuries among children ages four years and younger are to the head or neck region. Injury rates in children are significantly higher for boys than for girls.

Teach children basic safety around dogs and review regularly:

- Do not approach an unfamiliar dog.
- Do not run from a dog and scream.
- Remain motionless (e.g., "be still like a tree") when approached by an unfamiliar dog.
- If knocked over by a dog, roll into a ball and lie still (e.g., "be still like a log").
- Do not play with a dog unless supervised by an adult.
- Immediately report stray dogs or dogs displaying unusual behavior to an adult.
- Avoid direct eye contact with a dog.
- Do not disturb a dog who is sleeping, eating, or caring for puppies.
- Do not pet a dog without allowing it to see and sniff you first.
- If bitten, immediately report the bite to an adult.

<u>Veggie Bones</u>

3 cups minced parsley
1/4 cup carrots -- chopped very fine
1/4 cup shredded mozzarella cheese - or parmesan
cheese

2 tablespoons olive oil
2 3/4 cups whole wheat flour
2 tablespoons bran
2 teaspoons baking powder
1/2 cup water -- (1/2 to 1)

Preheat oven to 350 degrees, rack on middle level. Lightly grease a large baking sheet. Stir together parsley, carrots, cheese, and oil. Combine all the dry ingredients and add to veggies. Gradually add 1/2 cup of water, mixing well. Make a moist but not wet dough. If needed, add a little more water. Knead for one minute. Roll dough out to 1/2 inch thickness. Using cookie cutter or a glass cut out the shapes and transfer them to the baking sheet. Gather the scraps, re-roll, and cut. Bake for 20-30 minutes until biscuits have browned and hardened slightly. (They will harden more as they cool.) Speed cooling by placing them on wire racks. Store in airtight tin.

Bacon Bites

1 egg
1/2 cups nonfat milk
1/4 cups bacon fat
4 slices bacon (cooked, drained and crumbled)
1/2 cups beef or chicken broth
3 cups whole wheat flour

Preheat oven to 325°F. In a large bowl, combine the egg, milk, bacon fat, cooked bacon and broth. Mix well. Gradually add flour. Roll out on floured

surface to 1/2 inch thickness. Use bone shaped cookie cutters and place on lightly greased cookie sheets about 1/4 inch apart. Bake for 40 minutes. Let cool. Can be frozen in freezer bags.

EPA orders retailers to stop sales of counterfeit flea and tick products for pets - April 1, 2004

The Environmental Protection Agency is acting to disrupt an 11556-120), Advantage 100 for Dogs (EPA Reg. No. 11556effort to distribute counterfeit products for controlling fleas and ticks on dogs and cats. The agency has ordered pesticide distributors and retailers in a number of states to stop selling counterfeit products that contain false EPA registration numbers and labeling for Advantage and Frontline brands of pesticides.

The orders prohibit retailers and distributors from distributing or selling the counterfeit products and make them responsible for their proper disposal.

The counterfeit pesticides appear to have been unlawfully imported and packaged in retail cartons designed to look similar to legitimately registered pesticides sold in the United States. The EPA investigation is ongoing and, so far, it appears that the counterfeit products have been sold to distributors and retailers throughout the country.

"We strongly applaud the EPA's recent actions and their notification of their efforts pertaining to counterfeit pet products. This supports Bayer's efforts to take a strong stand against counterfeit products within the industry," said Bob Walker, communications director for Bayer Corp., which markets Advantage for cats and dogs.

Legitimate Advantage and Frontline products that have been through the EPA's review process are registered for use in the United States, and are not affected by this action. Pet owners who are concerned their pet may be affected by counterfeit products should contact their veterinarian.

"A good safeguard to ensure the integrity of products such as these is to purchase them from a reputable source. The best way to be confident about the source of Frontline products is to purchase through your veterinarian," said Dr. Zachary Mills, executive director of veterinary services for Merial.

Counterfeit products should be disposed of according to local accepted procedures for other household chemicals. Many communities and municipalities have local resources to dispose of household chemicals, and consumers encouraged to contact their local solid waste authority for more information on disposal programs for chemicals.

The EPA has identified counterfeit versions of the following products: Frontline Top Spot for Cats (EPA Reg. No. 65331-2), Frontline Top Spot for Dogs (EPA Reg. No. 65331-3), Frontline Plus for Cats (EPA Reg. No. 65331-4), Frontline Plus for Dogs (EPA Reg. No. 65331-5), Advantage 10 for Dogs (EPA Reg. No. 11556-117), Advantage 20 for Dogs (EPA Reg. No. 11556-119), Advantage 55 for Dogs (EPA Reg. No.

122), Advantage 9 for Cats (EPA Reg. No. 11556-116), and Advantage 18 for Cats (EPA Reg. No. 11556-118).

The EPA regulates all pesticides used in the United States. Before a pesticide can be marketed in this country, the agency performs a rigorous scientific review to ensure that use of the product is not likely to cause harmful effects on people, pets or the environment. According to EPA spokesman David Deegan, "We cannot make any assurances to the public that these counterfeit products would be equivalent (to the rigorously tested legitimate Advantage and Frontline products.)"

The only way to determine whether a product is legitimate or counterfeit is to open the package. The EPA has posted detailed information, including photos of legitimate www.epa.gov/pesticides/factsheets/ products, at petproduct.htm. Veterinarians and consumers concerned product's authenticity can also www.nofleas.com for information about Advantage or www.FRONTLINE.com/epa to find out more about Merial's products.

Among other things, counterfeit products might be missing package inserts bearing directions for use required under U.S. law. Moreover, the counterfeit Frontline products are not packaged in required child-resistant packaging. Consumers cannot be assured that the counterfeiters inserted the appropriate size applicator for the animal pictured or otherwise indicated on the retail carton.

The differences between the legitimate and counterfeit products are most pronounced on the inside applicator package. Legitimate U.S. Frontline products include the following features:

- lot number on the outer package matches the lot number of the applicator package insert and/or the individual applicator
- product is in child-resistant packaging
- instruction leaflet is included
- individual applicator has a label that includes the registrant's name, Merial, product name, EPA registration number, net contents in fluid ounces, and percentage of active ingredients
- all text is in English
- applicator label for the dog products includes the poundage of the dog on which the product is to be used

The only way to determine a legitimate Advantage product from a counterfeit is by examining the product tubes inside the retail carton. Legitimate Advantage products contain tubes that are printed in English. The most obvious sign of a counterfeit is product tubes printed in a foreign language, most likely French or German.

In addition, legitimate Advantage product tubes include the EPA registration number, the word "WARNING," and a child hazard warning.

Legitimate product tubes for Advantage also include a statement referring to the main labeling directions for use and the manufacturer's name, Bayer. Product tubes should also contain an active ingredient statement that agrees with the active ingredient statement on the retail carton.

friend who might be interested in assisting.

Cindy would like to have the next Instructors' Workshop on July 15, when we do not have any classes due to the fair. She would like to have pizza, pop and dessert at someone's house. Barb Misch made a motion to allow Cindy to spend a maximum of \$85 for the food and drink at the Instructor's Workshop. Penny Brcich seconded the motion. The motion was approved by all, without any opposed or abstentions.

PA Systems - Barb Misch reported about she had not placed an order for any PA systems. Barb did the investigation and discovered the Apollo PA-7 unit appears to satisfy our needs. The unit is not wireless, the microphone is wired to the speaker and the speaker can be hung anywhere on a person's body. The Apollo unit has a 30 day return policy to allow the instructors to evaluate the unit and possibly return it if the unit does not meet our needs. Penny volunteered to do the actual ordering. Taffy Wille also volunteered to check on eBay for prices.

Penny also asked whether she could get a set of keys for the training building to allow her to also be able to open the building. Cheryl Hettinger stated that she would check with Denny at the fairgrounds about getting another set of keys for her.

Taffy Wille (Trial Secretary) announced that the wording regarding refunds in this year's obedience trial premium list will match Agility Trial premium list "Entry fees will not be returned after the closing date for any reason other than the following exceptions. Ill or injured dogs may have their entry fee returned, less the \$3.00 AKC Recording Fee, after delivering a signed statement from a veterinarian to the Trial Secretary no later than 8:00 a.m. the day of the trial. No refund for bitches in season."

Taffy reported that according to AKC rules, we can have any type of refund policy that we want as long as we submit the appropriate Recording Fee to AKC. Helen stated that Suzan Scott reported that she has only had a couple of requests for refunds in past five years. Peggy stated that if your dog has a known injury, you should be cautious about submitting entries. More discussion ensued regarding whether the wording currently used for the Obedience Trial's refund policy was fair and just for exhibitors and the club or should it be modified to match the Agility Trial's policy wording. Following the discussion regarding the wording for the Obedience Trial's refund policy, Carolyn made a motion that we continue to use the current wording which states 'Entry fees will not be returned after the closing date or when classes close, whichever comes first, for any reason. Entry fees will not be refunded for bitches in season." The motion was seconded by Barb

Misch. The motion was passed with the following tally:

Taffy also stated that although the Opening Date field had previously been available for completion in the on-line event application, AKC has since eliminated the use of the Opening Date. AKC states that any entries received must be accepted at any time. Taffy did receive and return two entries prior to the originally scheduled opening date. She will attempt to contact those individuals.

New obedience trial rules were approved during the AKC April Board meeting. The following is a partial list of the updated rules. All of these rules are effective October 1, 2004. For a complete list, see

http://www.akc.org/dic/events/obedience/ on the AKC website.

When a dog earns a title, it may be moved to the next class even after the closing date has passed, as long as the class is open and available. The change must occur at least 30 minutes prior to the trial start.

The following trial ribbons <u>must</u> have the trial's date on the ribbon: High In Trial, High Combined and the placement ribbons for regular classes. The ribbons received for Qualifying scores <u>may</u> have the dates but are not required.

The High Combined trophy can be handed out as soon as the classes have finished rather than waiting until the trial has completed.

The judge's program must list a cellular phone number of someone present on the trial grounds. The board suggested that the Trial Chair's phone

be used as the contact number.

The stewards assisting in the Utility scent exercise may put the scented article out. The judge is not required to place the article in the pile.

Exhibitors can now add the number of UDX titles received after the dog's name. For example, when the dog has earned a total of 40 UDX legs, the dog can be listed as "Fido, UDX-4"

The club may offer a warm-up ring in the building. However, the ring's location must not be disruptive and the ring usage must be monitored.

Sandy Davis (Waggin' Tales Editor) stated that she has noticed a problem with the timing of the Waggin' Tales distribution and the request for volunteers to work at the correction clinics. She wanted to remind chairpeople to please be cognizant of the timing.

Sandy also reported that she will be on vacation from July 7th until July 18th. Therefore, it was agreed that the deadline for the July Waggin' Tales will be changed to June 30, NOT July 4th as originally announced.

Amy Ford (Treasurer) was not in attendance, but sent the following report. She will be in China from June 16th until June 27th. Therefore, any requests for checks should be forwarded to Amy, as soon as possible. However, if an emergency check must be written while she is away, contact Carolyn Pearson who also has authority to sign FVDTC checks.

Sue MacPherson (Membership Chairperson) reported that a mishap prevented the membership renewal forms from being published in the May Waggin' Tales. The membership renewal forms will be available as a link on the club's website and in the June Waggin' Tales.

Barb Misch (Public Education Coordinator) reported that the WOOF-line has been updated. Barb also reported that Petsmart is also offering CGC tests. Barb stated that in-spite of a little confusion on the lack of a park district permit obtained by the school, a fun time was had at multi-faceted demonstration at the Simmons School in Aurora. Barb was contacted with less than two weeks notice to provide a demonstration for the sixth and seventh graders at Simmons School. Barb extended thanks to many wonderful volunteers. Because of their efforts, she was able to demonstrate agility, obedience, flyball and other activities at 11:00 a.m., 11:45 a.m., and 12:30 p.m. Following the demonstrations, many pieces of information were passed out.

Barb expressed frustration and anger about a situation that happened to her during her walk prior the meeting, and also on other occasions. She has once again encountered an unleashed dog, which is illegal in Batavia. According to the Batavia ordinances, dogs must be contained by a fenced yard, leashed or tied. Barb proposed the following three plans to remind local dog owners that they have rights as well as responsibilities.

Barb stated that her husband, Ken suggested that the club draft a letter to each town asking them to remind the dog owners about local leash ordinances. Sandy Davis stated that while she understands Barb's frustration, based on her knowledge of how city government operates, she suggested that we ask to have the letter published in the city newsletter. Cheryl Hettinger asked whether we should contact someone directly in the city to provide a dog program. Sandy Davis stated that she knows that Geneva has an ordinance ticket, but does not know if Batavia has such an entity.

Barb also suggested that we perhaps we could ask the Animal Control Department include information in the rabies reminders. However, most of the rabies information is now handled electronically.

Another idea that Barb presented was to get a copy of the local ordinances and pass them out to the beginners students. However, the consensus was that the dog owners in our classes probably were not the ones violating the laws.

Barb presented the following ideas to participate in the Responsible Dog Ownership week, which begins September 13th. The locations that were suggested were local libraries (Taffy suggested that the Elburn library would be large enough), the Geneva chamber meeting room, etc. With the exception of the CGC test, the location should be the same each night for consistency.

Monday, 09/13 - Meet the Breed Tuesday, 09/14 - How to Pick a Puppy Wednesday, 09/15 - Basic First Aid (to be presented by a vet)

Thursday, 09/16 - CGC Test

Friday, 09/17 - Dog Safety Presentation Saturday, 09/18 - Pass out club information to the tri-city area

Barb suggested that we could host an open house at training on September 23rd.

It was also suggested that for future participation in this event, perhaps we could do everything on one day. Taffy Wille stated the Republican newspaper has a reporter that writes a lot of dog-related stories that should be contacted to publicize these events. Taffy also suggested that we might combine some of the events, such as hosting "Meet the Breed" and the Open House if volunteers are difficult to obtain.

Helen Castellano (Agility Chairperson) reported that AKC has FINALLY approved the Agility Trial. Premium lists are available on the club's website with an opening date is July 14th. Helen stated that the Agility Trial committee is currently in need of a Hospitality Chairperson and a volunteer to hand out the ribbons at the trials.

Old Business

Dave Lewis reported that the club's Web Site has been fixed and moved a new ISP. This move was done to help prevent the many problems we were having with the website inaccessibility, etc. Dave also stated that a group e-mail address has been created for the entire board. Anyone wishing to send an e-mail message to the whole board can use boardmembers@fvdtc.org.

Job Description Updates (Dave Lewis) - The following Board members stated that the job descriptions were fine as is, and did not require any changes: Vera Nyberg, Peggy Sue Seehafer and Taffy Wille. Will Short provided updates for the Trial Chair's position.

Grievance Committee Process (Dave Lewis) - Due to the length of the meeting, this topic was deferred until the August 4th Board meeting.

New Business

2003 Obedience Trial Refund Issue: Will Short sent an e-mail to the board requesting a refund for an exhibitor from last year's obedience trial whose dog died unexpectedly. Will noted that CarDunAl refunded her entry fee but we did not, and that we should make allowances for situations such as this, even if it is not specifically addressed in the premium list.

Taffy Wille stated that the reason that this

situation was being readdressed at this time was Will Short's feeling that that we did the wrong thing not to issue a refund to the exhibitor. Taffy stated that according to the 2003 premium list, the decision was appropriate. Helen stated that although we feel bad about the loss of any dogs and can sympathize with the owner, the premium list explicitly states that we do not offer refunds for any reason.

Penny Brcich stated that as an exhibitor we are signing a contract when we complete and sign our entry forms. The entry forms state that by signing the form, "I (we) agree to abide by the rules...and by any additional rules and regulations appearing in the premium list for this event..." Peggy Seehafer agreed that we are not being heartless, however we need to remember that we are running the club as a business. Vera Nyberg stated that as exhibitors we often run into situations where things are out of our control and can only be defined as "Acts of God", such as the rain that cancelled a recent outdoor Agility Trial. Vera stated that the club sponsoring the trial did not give any refunds to the exhibitors.

When Dave Lewis asked whether we needed to propose a motion regarding this situation, we all agreed that we did not need to, because no policies or rules were going to be changed. We simply enforced a current rule that was previously addressed in the Trial Secretary's report.

A motion was made, seconded and approved to adjourn the meeting at 10:01 p.m.


