Meeting brought to order at 7:33 p.m. by Cheryl Hettinger. Dave Lewis was unable to attend due to a new teaching assignment. Vera Nyberg introduced the Midwest K-9 Emergency Response Team program. The three Midwest members, Ellen, Mary and Dave presented a wonderful program outside with dogs demonstrating how the dogs work for different types of tracks, such as tracking a missing person or searching for a cadaver. NO we did not have a cadaver, but we did have an item that is used to train the cadaver search dogs.

Carolyn Pearson (Secretary). The May Meeting minutes were approved as published. Several items of correspondence were read.

Cheryl Hettinger (First Vice-President) extended a big thank you to the thirteen people who helped clean the mats on August 28th. Because of the amount of people we were done in two hours. Carolyn said that a huge thanks should also go to Cheryl for providing everyone with great food and great fun. Sue MacPherson (Membership Chairperson) read a list of nine applicants as published in recent Waggin' Tales newsletters. Taffy Wille made a motion to accept the list as published and read. Francene seconded the motion. The motion was approved by all without any discussion. Three new members were present at the meeting. WELCOME to all new members!

Barb Misch (Public Education Coordinator) thanked Rick Cox, Trudi Kimm and Carolyn Pearson who helped out at Critters Pet Store on Saturday, August 28th for an obedience demonstration. Barb believes that we generated some interest and will see some of the folks we met at training. The obedience demonstration followed a drug searching demonstration by the St. Charles and South Elgin Police Departments K-9 dogs.

Barb stated that the WOOF line is updated and included information about the Responsible Dog Ownership (RDO) activities. Barb thanked Dave who put the Responsible Dog Ownership activities information on our web site. Barb reported that the publicity for our events is going well. Anne Stuessy, who was not officially a member until tonight, sent out the first press release earlier this week, so watch for us in your local papers. Event information was also sent the vet's offices with some tweaking of the list that usually receive our club information. Barb also reported that her friend at the 95.9 the River radio station said that he will attempt to

get some radio station items for us to give away, in addition to promoting our events on the radio station.

The preparations for the RDO appearance at the Batavia Public Library on Sunday, September 12<sup>th</sup> are going well. The following programs will be presented.

- \* At 2:00 p.m., the Dog Safety program with Priscilla Pisarski with Abby.
- \* At 2:30 p.m., an obedience demonstration with Cindee and (hopefully) Edward Ehrhart with Payton and Millie. Barb is hoping that other children see Edward, so they will be encouraged to start training a dog.
- \* At 3:00 p.m., a presentation by Sue MacPherson on items to have in a canine first aid kit. Barb asked Sue to provide a list of the first aid kit items so she can make copies of the list.

Barb also reported that there are still a LOT of openings for the CGC test. The 8:00 p.m. test will be canceled if more entries are not received. If the 8:00 p.m. test is cancelled for the September test, we will consider hosting just one test per testing night, with a 7:00 p.m. start.

Barb stated that she is in need of volunteers to be part of the "Welcome Waggin'" at our Open House on September 23rd between 7:00 p.m. and 9:00 p.m. She said that one-hour time commitments would be wonderful. The volunteers would probably be asked about general club information and probably asked about classes. She is planning on having balloons, cookies and other items to make the event festive. Cheryl Hettinger stated that she has the FVDTC nametags. Cheryl also volunteered to be a Welcome Waggin' representative between 7:00 p.m. and 8:00 p.m. Priscilla Pisarski also volunteered to be a Welcome Waggin' representative between 8:00 p.m. and 9:00 p.m. Helen Castellano suggested that the nametags include the club members' job title, to help direct the person looking for more information to the correct person.

Francene Andresen (Tracking Test Secretary) Francene reported that plans for the September 19<sup>th</sup> Tracking Test are going well. The judges are Ted Hoesel and Orrin Eldred. Francene stated that she needs volunteers to be a cross tracklayer on Saturday, the 18th and Sunday, the 19<sup>th</sup>. Cheryl Hettinger stated that she would help, following confirmation of her schedule. Francene stated that cross-trackers would need to be at Burnidge Forest

Preserve at approximately 9 am on Saturday and very early on Sunday. Priscilla also volunteered to help. Francene reported that the tests usually conclude around 1:00 p.m. on Sunday.

Francene also stated that she needs help on Sunday to driving trackers and dogs to the tracks, etc. As of today, there are six entries for the four TD tracks, and thirteen entries for the four TDX tracks. Francene reported that next year she would investigate the possibility of adding more tracks. She will seek the opinions of current and past judges. Francene stated that there is a definite need for more tracking tests in this area, particularly the TDX tests.

Francene extended a huge thank you to Ingrid and Hermann Hamburger who made 110 new much lighter tracking flags. We will start using the new flags immediately, but keep the old ones in case we need them. Ingrid stated that the new flags would be stored at her house.

Helen Castellano (Agility Trial Chairperson) reported that the entries were closed. This year we received 773 total entries, which is 59 less than last year. Will Short stated that he needs help with set-up, which starts at 4:30 p.m. on Friday, September 10<sup>th</sup> and continues until the set-up is done or until it is dark. This year the rings will be fully gated without any open areas to distract the dogs. Anyone else who can help at any time during the weekend should contact Cathy Fleury at 847-464-5909 or Jacquie Kramer at 630-365-1802. Experience is not required; on the job training is provided!

Helen reported on the electronic timers topic. Helen is recommending that we do not rent the electronic timers this year for several reasons, including the following:

- \* Agility Ability's contract is non-negotiable and included a "free entry" clause which we feel violates AKC regulations.
- \* We would be responsible for replacing the equipment if it is damaged or the cost of the repairs, even though we are not setting up or operating the equipment. We just provide the readers.
- \* The entries were down from last year.

Helen reported that she would investigate more options for next year's trial. When asked about the reasons why the electronic timers are important, Helen stated that high-level competitors need the



#### Board Meeting Highlights August 4, 2004

Meeting brought to order at 7:42 p.m.

Carolyn Pearson (Secretary). June Meeting minutes were approved as published without change. A request for a donation from the AKC Health Foundation was read. Peggy Sue Seehafer made a motion to send a \$50.00 to the AKC Health Foundation. Barb Misch seconded the motion. The motion was approved by all members present.

Cheryl Hettinger (First Vice-President) reported that the mat-cleaning event is scheduled for 8:30 a.m. on Saturday, August 28<sup>th</sup>. In addition to needed volunteers, she also needs power washers and dryers. We discussed the types of dryers that will work. Cheryl reported that in the past, we have unsuccessfully used leaf-blowers. Peggy Sue volunteered to bring her horse drier. Cheryl stated that we would need at least two more driers. Carolyn will check with some other club members who might have a similar type of drier. Cheryl also stated that if we have enough volunteers, it should take approximately four to five hours. All volunteers are welcome - even if all you can help for an hour, please come to help.

Vera Nyberg (Second Vice-President) stated that she had compiled a list of ideas of possible membership meeting programs that were discussed at the last instructors meeting. Those ideas included discussing AKC regulations, a panel discussion, a discussion with Dr. P. Meiser about vaccination protocols or perhaps about latest canine research. Barb Misch asked whether we could get a canine CPR demonstration. After a brief discussion about the ideas, it was decided that Helen will contact Dr. Meiser about doing a vaccination protocol discussion at the March 2005 Membership Meeting and a CPR demonstration at an unspecified 2005 membership meeting. Carolyn will contact Ronnie Bizer about discussing the information she learned at a recent AKC Judges seminar at the October or November Membership Meeting.

Carolyn will also check with Trudi Kimm about hosting a CERF clinic in March 2005. After a brief discussion, it was decided that the club would once again host two Health Clinics, although we will try to get them both scheduled for March 2005. Sue MacPherson will check the Amber Leaf's doctor's preference for a date and Helen will discuss a date with Dr. Meiser.

Cindy Pakenas (Director of Training) stated that she asked all instructors to anonymously provide a list of Instructor Guidelines to her. At the instructors meeting, Vera read all of the submissions and then took the notes from the discussions. Cindy Pakenas presented a condensed list for

the Board to review and asked that the list not be distributed outside of the meeting at this time. Once that list has been finalized with the board member's comments, Cindy will ask the instructors for a final review and approval. Cindy stated that the goal of the Instructors Guidelines was to provide the instructors a list of guidelines that could be used now and in the future.

Cindy Pakenas asked for advice about a bite situation that recently occurred. Cindy reported that a two-year intact male Rottweiler, bit a Great Dane, leaving four punctures wounds. Cindy received several suggestions for resolving this situation.

Will Short (Obedience Trial Chairperson) reported that the Trial committee will meet at 7:00 p.m. on Wednesday, September  $1^{st}$  at the Extension Center. Tentative meetings are also scheduled for October  $6^{th}$  and November  $3^{rd}$ . The October and November meetings will only be held if the Trial Committee deems them necessary. Will Short stated that these meetings are a new directive by AKC.

Taffy Wille (Obedience Trial Secretary) was not in attendance, but sent the following report.

Limits for the classes were successfully increased to 72 for Novice, 64 for Open A, 64 for Open B, 56 for Utility A, and 56 for Utility B.

This year the premium will be available online or by request. This will substantially cut the mailing list down. This should save on postage, however the copy cost was about the same for 550 as for 800, because we did not receive a price break for quantity.

Contract for the fairgrounds has been received. The check must be signed prior to Taffy submitting it. Thanks to Jean Munger for advising that the fair had not sent out the contracts yet.

Sandy Davis (Waggin' Tales Editor) was not in attendance but sent her report that the next Waggin' Tales deadline is Sunday, August  $8^{th}$ .

Amy Ford (Treasurer) was not in attendance but provided cash balance. Amy asked for guidance regarding she should look into getting more CDs for the extra interest earned or not, depending on the status of the land purchase process. It was decided to keep the cash on hand while searching for land



Fort Dodge Animal Health, of Overland Park, Kansas, at FDA's request, has agreed to immediately cease production and recall its heartworm medication ProHeart®6 from the market until the FDA's concerns about adverse reaction reports associated with the product can be resolved. FDA is requesting that the firm continue to conduct research to determine the cause of related adverse reactions and develop a strategy to help prevent such problems in the future before the product is marketed again. The FDA will convene an independent scientific advisory committee to thoroughly evaluate all available data. ProHeart®6 is an approved injectable sustained-release heartworm prevention product for dogs. Heartworm disease is a serious and potentially fatal condition of dogs, cats, and other species of mammals. The parasite that causes heartworm disease is transmitted through the bite of a mosquito. FDA is also advising veterinarians to avoid administering this product to dogs until further notice. Pet owners should consult their veterinarians regarding their pet's health care needs. Since the product was approved in June 2001, Fort Dodge Animal Health has cooperated with FDA to investigate numerous adverse event reports. As a result, Fort Dodge has voluntarily changed the label to include post approval safety information including rare reports of death and a caution to practitioners that dogs should have a negative test for heartworm before administration. Despite these label changes, FDA is still receiving unexplained adverse event reports, some of them severe. FDA's concern is based on voluntary self-reporting to FDA by veterinarians and owners whose dogs have suffered adverse drug experiences (ADEs) to ProHeart®6 (which contains the drug moxidectin) as well as the mandatory reporting of adverse events by Fort Dodge Animal Health. Fort Dodge Animal Health has agreed to recall any product that has already been distributed to veterinarians. As of August 4, 2004, FDA's Center for Veterinary Medicine (CVM) had received 5,552 adverse event reports for ProHeart®6. The actual number of adverse events is likely even higher because studies show that only a fraction of actual ADEs are reported. The Agency has observed an increase in the number of cases associated with liver and bleeding abnormalities followed in some cases by death.

## KONG STUFFING TECHNIQUES

I received a flyer from Barb Misch a few months ago regarding Kongs and different recipes that you can use for stuffing. If you find your dog needs some stimulation or hates being alone without you for a long period of time, then try a Kong. REMEMBER - Always clean the Kong after use. Your Kong is also Dishwasher safe

Step One - Start with a clean, appropriate size Kong Toy.

Set Two - (TANTALIZER) Place freeze dried liver, peanut butter, cheese or other tantalizing item into the little hole on top.

Step Three - (DESSERT) Fill approximately one-third of the cavity with doggie treats such as biscuits, marrow bites, etc.

Step Four - (MAIN COURSE) Fill the last two-thirds with canned food or food roll mixed with food nuggets.

Step Five - (APPETIZER) Leave a nice tidbit sticking out of the opening. The "easy pickins" will provide an immediate pay off and entice your dog to "get serious" about the job.



It is important for dogs to succeed at their work. Make it easy to remove the Kong stuffing at first. As they become more experienced, you may want to make their job more challenging - here's how:

- 1. Pack stuffing tighter
- 2. Wedge biscuits inside the cavity using the inside rim of the opening to secure them.
- 3. FREEZE IT! Very Popular! Try various combinations of canned food, gravy, noodles, rice and mashed potatoes mixed with food nuggets and freeze. KONGSICLES are a favorite with many hot dogs! Put a dab of peanut butter in the small end of the Kong to plug it. Turn it upside down in a cup. Fill it full of water, chicken broth or fruit juice and freeze. Cool doggies! Kongsicles are recommended for outdoor use.
- 4. CHEESE IT! Mix cheese pieces or cheese spread with food nuggets and microwave until cheese melts. Let it cool to a safe temperature. NOTE - Use a cup to contain the Kong when freezing or microwaving.

# ILLINOIS: Dog disease puts a halt to adoptions Chicago shelter quarantines strays

Faced with an outbreak of canine distemper, Chicago Animal Care and Control has begun quarantining strays and has adopted a 30-day moratorium on providing dogs to would-be pet owners, officials said Friday. The department's shelter has seen 76 cases of the disease since April, an enormous spike from last year when there were no distemper cases, said spokeswoman Melanie Sobel. The moratorium began Thursday. The department has formed a task force, including veterinarians and experts from Loyola University Medical Center in Maywood and Brookfield Zoo, in an attempt to understand the outbreak of a disease that kills about 50 percent of the dogs it infects.

"We're trying to figure out where this is coming from and how we're going to handle it," Sobel said. "But for the moment, we cannot adopt out animals that could potentially be carriers of this virus."

Canine distemper is an airborne virus that can be spread by pet dogs and wildlife such as raccoons, ferrets, coyotes and other carnivores, and there is no cure, officials said. Animals that survive often suffer permanent brain damage and injuries. Younger dogs and puppies are the most susceptible to infection, according to the American Veterinary Medical Association. Among puppies, the death rate from distemper often reaches 80 percent, the association's Web site states. Animal Care and Control's shelter, 2741 S. Western Ave., receives 26,000 animals a year--14,000 of them dogs--and is required by law to accept all dogs that are brought in, Sobel said. This makes it difficult to quarantine canines for a disease that has a two-to-three week incubation period. Strays, which have the greatest risk of contracting distemper, will be quarantined at the shelter, and an auditorium will be adapted to hold some of them, said Nikki Proutsos, the department's executive director.

But when owners show up to dump an apparently healthy dog, the shelter will ask them to take it to another shelter. If they refuse, the dog will be placed in a 30-foot van and driven to a cooperating shelter or foster home. But it won't be allowed in the center, where it might be exposed to the disease. Otherwise, the shelter would be overwhelmed.

"If we're not going to adopt out for the next month, we want to have an opportunity for these animals to be placed," Proutsos said.

The moratorium on adoptions will lead to more euthanizations, though the number will depend on how many dogs are brought in and how many are placed elsewhere, Sobel said. Symptoms of distemper include a liquid discharge from the eyes, fever, coughing, lethargy, reduced appetite, vomiting and diarrhea. In later stages, it can cause seizures or paralysis and eventually death.

Animals that show signs of distemper will be euthanized, Proutsos said.

The scope of distemper outbreaks can be large, said John Lednicky, an assistant professor of pathology at Loyola University Chicago Stritch School of Medicine. In a statement released by Animal Care and Control, Lednicky said 10,000 Caspian seals died of the disease in 2000. "Since there is no cure for distemper, veterinarians can only alleviate a sick animal's suffering," he said.

The shelter will continue to adopt out cats and rabbits, which are not susceptible to canine distemper.

During the discussion, a concern was raised about the possibility of an equipment malfunction. If the equipment fails, would we still be required to pay the entire amount, if the equipment is unusable for the entire day? Another concern dealt with the requirement of one free entry per day. It was felt that this contract requirement is a violation of AKC rules for event entries.

Will Short made a motion to spend a maximum of \$360.00 to lease the electronic timers. Vera Nyberg seconded the motion. During another brief discussion, Helen clarified that she would negotiate with Agility Ability to address our concerns. The motion was approved by all.

#### **Old Business**

Land Purchase Status - Carolyn reported that she is awaiting a new contract from Dennis Halfpenny to be signed and resent to the sellers. The new contract is necessary to modify all of the dates.

Peggy Sue Seehafer made a motion that the club member who has the work credits, but not combined with the co-owner, applies for the award. Will Short seconded the motion. The motion was approved by 7, opposed by 1 with no abstentions.

A motion was made, seconded and approved to adjourn the meeting at 10:35 p.m.

#### **AKC Canine Good Citizen Test Items:**

- 1. Accepting a friendly stranger: Evaluator greets Handler.
- 2. Sitting politely for petting: Evaluator pets dog, dog must show no signs of shyness or resentment.
- 3. Appearance & grooming: Evaluator inspects dog, combs or brushes lightly, examines ears and each front foot.
- 4. Out for a walk: Handler takes dog for a short walk including right turn, left turn, about turn and stop.
- 5. Walking through a crowd: dog and Handler walk close to several people; dog may show casual interest but not jump up.
- 6. Sit & down on command/Staying in place: Handler shows dog can do a sit and a down, then chooses either position, leaves dog and goes to the end of a 20 ft. line and returns immediately.
- 7. Coming when called: with dog still on 20 ft. line, handler walks out 10 ft. and calls the dog.
- 8. Reaction to another dog: two handlers and dogs approach, shake hands, exchange pleasantries, move on; dogs can show casual interest to either the Handler or the other dog.
- 9. Reaction to distractions: distractions are presented; dog may not panic or show aggression.
- 10. Supervised Separation: Handler goes out of sight for 3 minutes. Dog is held on 6ft. lead by Evaluator's assistant. The dog may not display any signs of stress.

#### **IMPORTANT NOTES:**

- 1. Treats and toys are not allowed, but verbal praise and petting is encouraged.
- 2. <u>Acceptable Collars</u> for the test: leather buckle, nylon buckle, slip chain, or martingale (pinch/prong, head halters and Gentle Leader are unacceptable)
- 3. <u>Acceptable Leads:</u> leather or nylon, up to 6 feet (flexi, chain and any line longer than 6 feet is not allowed).
- 4. You may wish to bring your dog's own brush to the evaluation. You are also allowed to lift your dog's paws for the evaluator in item 3.
- 5. Exercise your dog just prior to the test and between exercises if necessary. A dog that eliminates during the test is dismissed.
- 6. As the handler, you can really only test one dog at a time. If you want to test more than one dog, please sign up for more than one testing time.


No dog ever "fails" this test, however some items may require further training. A dog that shows signs of aggression may be dismissed at the Evaluator's discretion.
