Meeting brought to order at 7:40 p.m.

continue until the end of February. Barb Misch stated that beginning in February, a table would also be set up to accept reservations and checks for the annual dinner.

Cindy also reported that she would like to host a Rally class at 6:00 p.m. and will need a Primary Instructor and Assistants. The date for the next instructors meeting is Thursday, February 24, since we have classes on Tuesday, February 22 that week. The location is still to be determined. Barb reported that that Elburn Library requires a 30-day notice prior to the event and only allows pre-approved organizations. Cindy will also check other local libraries. Dave suggested the North Aurora Activity Center.

Cindy announced that she would like to initiate the use of a feedback survey for the advanced classes. This would be similar to the Beginner's class survey sheet. Cindy stated that the idea would be discussed at the next Instructors' meeting. Her initial thoughts were that it would be a one-page questionnaire to be published in the Waggin' Tales newsletter on a quarterly basis. All club members would be able to complete and return the sheets at training.

Since John and Barb Semenek are currently receiving applications for session 2, once the 7:00 and 8:00 p.m. classes are filled, they will check with the students if they would prefer the 6:00 p.m. or the 9:00 p.m. class. Cindy asked Carolyn to update the Beginner's class application to include the 6:00 p.m. time.

Cindy also stated that she and Priscilla would begin rotating assistant instructors to offer them opportunities in other levels of classes.

Cindy addressed the lack of a policy about allowing non-members to assist in teaching classes. The situation has occurred in the past and was dealt with on an individual basis. However, she would like to have a club policy set-up to address the issue. During the brief discussion, it was suggested that we investigate whether club's current insurance policy has any restrictions about coverage. Dave stated that he would ask Amy Ford to check with our insurance policy about that question. Dean Connolly asked whether other club members would be denied the opportunity to assist if we allowed non-club members to perform the role, this would prevent club members from earning work credits. Taffy asked about the other perks that the instructors receive, such as reimbursement for seminar expenses, reduced membership fees, and preferred ring time for the Utility run-throughs. It was decided that without the insurance information, no policy could be created. This item will be placed on the April 6th Board meeting agenda.

Sandy Davis (Waggin' Tales Editor) was not present, Dave reminded everyone that the next deadline is Sunday, February 6th. Will Short stated that he is experiencing some trouble sending information to Sandy for publication in the newsletter. Dave suggested that Will send it to him and he will see that Sandy gets the information.

Positively Speaking--Part 2 by William Short

I recently had occasion to be involved in a discussion concerning the type of dog who would best benefit from a positive reinforcement/negative punishment training method as opposed to one that uses positive reinforcement/positive punishment method. It is my opinion and the opinion of those who train using the former that any dog can and will benefit from the use of a positive training method. Aversives chip away at your dog's confidence and trust in you as his protector and leader. If you use violence (even in small amounts) you are likely to encounter violence or to a lesser extent a poorer relationship with your dog and a decrease in his willingness to work for you. A happy dog is less likely to give in to stress in a ring situation as opposed to a dog who equates being in a ring with you as an unsafe place to be.

Anyone who tells you that in order to train your dog you need to use a firmer hand that also includes aversives has never trained or attempted to train a dog in a positive manner. So the next time your dog does something that you think that he shouldn't, it becomes your job to figure out why, help him to do it correctly, and to reward him for his efforts. Fight down that urge to give him just one jerk on his collar just to show him who really is boss.

I have also heard over the years that I have been training that handlers are worried that their dogs will embarrass them somehow. My reply is that you should never be embarrassed by your dog. Your dog will never do anything to embarrass you, but you can do plenty of things to embarrass him. You can, for instance, yell at him, blame him for the error, throw up your hands in exasperation, glare at him, search the sky for an answer to your prayer, etc. But your dog will never set out to "get you" in the ring or any place else by using revenge. If he errs, there are several reasons. I have written about these before and the post is in the archives of my Yahoo Group. I could cite many personal examples where I could say that I thought that one of my dogs purposely set out to embarrass me, and in each case I would be wrong. 




