## Prohibited Parking at Fairground

### Board Meeting Highlights April 6, 2005

Meeting brought to order at 7:40 p.m. Joe and Kathy Busch, Fundraising Chairs, attended the Board meeting. Kathy reported that she would like to make arrangements to have a Tastefully Simple representative present at training with products for sale. Any products sold at training will net the club 15% of the sale. Kathy also stated that she is investigating the possibility of having a Candlelight Bowl at the Wheaton Bowl for a fundraising event. The event would be a night of Pizza and Bowling. The cost to the club would be \$12.95 per person. Kathy suggested that we charge a fee of \$40.00 per couple. Another idea presented was the sale of clothing with sayings such as "My dog trains at FVDTC".

Peggy Sue Seehafer also mentioned that she is involved with fundraising projects for St. Charles, which includes snow globe sales and a raffle for vacation trips. Peggy offered to help Joe and Kathy get ideas for ways to have fundraising events. Additionally, Joe and Kathy reported that they will need help with coordinating events. Peggy stated that we need to be careful about how we go about fundraising, as the government may require the club to collect sales taxes. Taffy offered to help complete the tax forms, should we be required to submit them.

Dave also announced that Joe and Kathy were creating the job description for the Fundraising Chairs.

Cheryl Hettinger (Annual Dinner Co-Chair) reported that although 70 surveys were sent out to the individuals who attended this year's dinner, only a very small percentage of responses were returned. Cheryl stated that one of the biggest concerns that she had heard from past dinners was the length of time for the evening's events. With that in mind, Cheryl stated that they planned that the MC's would announce the handler's name and the dog's name, but not the dog's titles. Cheryl stated that she received many positive reactions on the night of the dinner and felt really well about it. However, she was extremely disappointed with the tone of the comments that were returned on the surveys. Although she realized that people are typically more willing to offer negative comments on a written survey, she felt that some of the comments bordered on personal attacks. One comment that was particularly hurtful and not necessarily constructive stated that the Annual Dinner Committee went out of their way to downplay the titles earned by club members. Other surveys mentioned that the main focus did not appear to be the awards given for the titles earned.

Cheryl stated that her goal was to make the dinner fun, to get club members to talk to each other, and to make everyone feel welcome. One of the committee's goals was to have one dinner to help minimize the divisiveness that the club is currently experiencing. Cheryl stated that she also tried to acknowledge all the volunteers who keep the club's activities functioning. Barb also stated that the committee welcomed the surveys that provided constructive criticism, but some of the comments were downright mean. Dean stated that the individuals, who provided the negative feedback, probably have not given it a second thought, and do not realize the impact they had on the committee members. He also said that it is impossible to please everyone, no matter how hard you try. Cheryl agreed that it is hard to satisfy the individual needs of the over 150 club members, although the committee tried their best.

Peggy Sue said that she thought that the committee did an outstanding job. Peggy Sue also stated that although constructive criticism is useful, too much negative feedback is destructive and can cause volunteers to quit working. She also apologized to Cheryl and the rest of the committee for the hurtful comments. Cindy Pakenas felt that the awards presentation should not have been so "flip" and casual but she thought that Priscilla's presentation of the Paws in Community award to Tom Stephenson was appropriate.

Taffy stated that perhaps the dinner's evolution over the past few years was perceived as a downplaying of the awards significance to the event.

During the discussion of things to do differently for next year's dinner, the following ideas were shared.

Include on the award's application a location to add information whether the title was "special" in anyway. For example, this was the first XYZ title earned by a Basenji in AKC history.

Read the title earned for each dog. Perhaps include the explanations of each title on a laminated table tent card.

Cheryl announced that she is unsure at this time whether she would volunteer to be the Annual Dinner's Chair for next year's dinner. She will let the Board know by the May Membership meeting.

### Open class: 8-9 p.m. Current Instructor: Rick Cox

Are you interested in going further with your training—maybe gaining a title for your dog? Check out our Open Class.

Open class is intended for dogs and handlers that plan to enter AKC, UKC, and/or CKC open obedience trials. In

order to be eligible for this class the dog and handler must either have earned their CD (Companion Dog) title or be actively pursuing that title. Handlers must have good control of their dogs as all exercises in the Open ring are accomplished without the use of a lead. Dogs must be in good physical condition, as they will be jumping obstacles during training and exhibition.

The goal of this class is that the dog and handler earn a CDX (Companion Dog Excellent) title. In doing so they must be able to successfully complete the following exercises:

Figure eight exercise off lead

- Heel off lead
- Retrieve on flat
- Drop on recallRetrieve over high jump
- Broad jump
- 3 minute out-of-sight sit
- 5 minute out-of-sight down

Individual elements of each exercise is taught and perfected until they can be combined to earn the CDX title. Individual and group instruction is required to teach all of the exercises. We use positive reinforcement teaching the exercises including the use of food and toys. Some elements of Open can be intimidating to the dog so we also spend time working to keep a positive attitude with the dog.

Open class is ongoing; students enter when they are qualified and finish when they earn their title. Registration is completed by consulting with the instructor.

### Saving Dogs from High Kill Shelters You can make a difference!

The Humane Society of the U.S. says that 3 to 4 million (yes, million) shelter dogs are euthanized each year. Every 9 seconds another dog is put down. Staggering numbers. (Every Nine Seconds is also the name of a campaign the Humane Society runs, <u>www.hsus.org</u>) Bringing a dog into foster care, providing proper health care, rehabilitation when needed and the love every dog deserves is a tall order. But the rewards are

well worth the efforts. When we look into the eyes of these abandoned and abused animals, it is often very difficult to understand how they could have been neglected and unloved. But it happens every day.

SO WHAT CAN YOU DO TO HELP? There are several quality local rescue organizations, but today I'd like to introduce you to Rover Rescue. The success rate of Rover's foster program has been phenomenal. Since September of 2003, Rover Rescue, (<u>www.roverrescue.org</u>) a 501-C3 nonprofit rescue organization has saved 608 dogs from being euthanized. 597 of those 608 have been adopted and are now living the good life with loving families. The rest are currently in quality foster homes. 99% of those sweet pooches have come from high-kill shelters and the others were owner surrenders.

There are many different ways that you can help Rover Rescue continue it's noble work of placing neglected, abused and abandoned dogs with loving adoptive homes.

- Foster Care: Fostering even one dog can make a big difference. Many people say, "oh it would break my heart to see them go", or "I'd get too attached", but the truth of the matter is that when you see a dog who comes to your home frightened and confused and then watch him blossom under your shower of affection and go to a new home with people who love him, and will care for him properly you will realize that you have had one of the most truly rewarding experiences of your life. Foster homes provide the love, Rover Rescue provides vet care, donated food and supplies. (Vet care includes, vaccinations, worming, spay/neuter...)
- **Transport**: Animal transport is a critical piece of the puzzle. Dogs are picked up mostly from high kill Indiana shelters (listed at <u>www.sisaveapet.com</u>) and brought back locally to be vet checked and then taken into foster care. Health certificates are provided for each dog.
- **Donations**: Monetary donations, food, toys, collars, leashes are all welcome and greatly appreciated.
- **Pet Dog Show:** Come have some fun with us and participate in Rover Rescue's pet dog show on May 14th. There are many fun and silly categories available. More info at Rover's website or talk to me at training. It'll be FUN and great support for Rover Rescue.

Please take a few moments to consider what you can do to save the life of a dog who needs our help. You can be a part of something wonderful and rewarding. You CAN make a difference!

You can find more information about Rover Rescue at <u>www.roverrescue.org</u> or you can talk to me on any FVDTC training night. I am at training from approximately 5:30 until around 9:15 or so.

I just can't keep BRAGS... quiet another minute, and therefore, although very few of our members are active in tracking, I want to share my great news. On March 20, 2005, the Medallion Rottweiler Club hosted its spring Variable Surface Tracking Test. Fortunately for me, after all the Rotties who wanted to run had been drawn, there was room for ONE non-Rot. Reggie, my Rottie colored Collie (Black, Tan and Sable) made the draw and ran at the DuPage County Police Center. Happily, Reggie passed a difficult VST track, running it a in a comfortable twenty-five minutes, to be the only Collie who has succeeded up to this time. For those of you not familiar with tracking, the VST is THE ultimate level tracking event. In order to be considered a Champion Tracker, dogs must have earned the TD, and TDX titles previously. They are required to work surfaces devoid of vegetation for at least 1/2 the track. These tracks go between buildings, over parking lots, and in between rows of parked vehicles. Length of the three hour minimum track is between 600 and 800 yards, and four dissimilar articles, plastic, leather, metal and fabric must be presented to the judges at the completion of the run. REGGIE did this, with me along for the ride.

I still can't believe all that work finally paid off.— Sylvia Schultz

## This page is yours to keep, and to help you prepare for the test! <u>AKC Canine Good Citizen Test Items:</u>

- 1. Accepting a friendly stranger: Evaluator greets Handler.
- 2. Sitting politely for petting: Evaluator pets dog, dog must show no signs of shyness or resentment.
- 3. Appearance & grooming: Evaluator inspects dog, combs or brushes lightly, examines ears and each front foot.
- 4. Out for a walk: Handler takes dog for a short walk including right turn, left turn, about turn and stop.
- 5. Walking through a crowd: dog and Handler walk close to several people; dog may show casual interest but not jump up.
- 6. Sit & down on command/Staying in place: Handler shows dog can do a sit and a down, then chooses either position, leaves dog and goes to the end of a 20 ft. line and returns immediately.
- 7. Coming when called: with dog still on 20 ft. line, handler walks out 10 ft. and calls the dog.
- 8. Reaction to another dog: two handlers and dogs approach, shake hands, exchange pleasantries, move on; dogs can show casual interest to either the Handler or the other dog.
- 9. Reaction to distractions: distractions are presented; dog may not panic or show aggression.
- 10. Supervised Separation: Handler goes out of sight for 3 minutes. Dog is held on 6ft. lead by Evaluator's assistant. The dog may not display any signs of stress.

### **IMPORTANT NOTES:**

- 1. 1. Treats and toys are not allowed, but verbal praise and petting is encouraged.
- 2. <u>Acceptable Collars</u> for the test: leather buckle, nylon buckle, slip chain, or martingale (pinch/prong, head halters and Gentle Leader are unacceptable)
- 3. <u>Acceptable Leads</u>: leather or nylon, up to 6 feet (flexi, chain and any line longer than 6 feet is not allowed).
- 4. You may wish to bring your dog's own brush to the evaluation. You are also allowed to lift your dog's paws for the evaluator in item 3-simply tell them you'd like to do so.
- 5. Exercise your dog just prior to the test and between exercises if necessary. A dog that eliminates during the test is dismissed.

As the handler, you can really only test one dog at a time. If you want to test more than one dog, please sign up for more than one testing time/date.

### No dog ever "fails" this test, however some items may require further training.

## A dog that shows signs of aggression may be dismissed at the Evaluator's discretion. For further information about the Canine Good Citizen Test, visit www.AKC.org.

Please show up 10-15 minutes prior to your testing time, as the test will begin promptly. You must be ready to go at your indicated time! If for some reason you find you are unable to attend your confirmed test time, please contact Barb Misch at 630-761-0823 early as possible. It is very likely that others would like to take your place.

She noted that with recent changes in committee chairs there has been a drop of information being put into the newsletter.

Taffy Wille (Obedience Trial Secretary) reported that approval for the obedience trial has been received. Taffy stated that the next step would be to mail premium lists, probably in the beginning of August. Taffy also stated that she is still looking for someone who wants to learn the trial secretary job.

Francene Andresen (Tracking Test Chairperson) reported that the Tracking test is approved for September 25<sup>th</sup>. Paul German and Donna Kircher are the judges. Plan are being formulated to meet with the volunteers with the following goals.

• To introduce newcomers to the tracking event and to each other.

- To establish areas of interest within the group to divide the workload.
- To clearly identify individual's roles and answer any questions regarding those roles.
- To set goals for specific tasks required for the tracking weekend.
- To plan for several fundraisers specific to tracking to try to offset expenses for the test, if possible.

Additionally, the committee will be securing experienced tracklayers in the next few months.

Barb Misch (Public Education Coordinator) stated that the next CGC Test is scheduled for Thursday, May 12th. The 6:00 p.m. evaluator is 99% certain to be Sandi Stephenson. Barb also stated that she is still searching for an 8:00 p.m. Evaluator. If one cannot be found, only one group will be done. Sign up information will be included in the next Waggin' Tales and will be posted at the club as soon as the evaluators are confirmed. Barb also reported that she will need a volunteer to assist her during the evening to check in the participants, to provide the group distractions and to help with the supervised separation exercise.

Barb also reported that the club would participate in the Rover Rescue Pet Dog Show on Saturday, May 14th from 10:00 a.m. until 2:00 p.m., at the Turner's Club in Aurora. The show provides one table and two chairs and Barb will bring the red tablecloth. Barb also asked whether we have a sign to use at the show. Barb will also bring the literature from the AKC, the club brochures and the club calendars. She plans to explain the classes we conduct and the CGC Test. However, she would like to get one or more volunteers to discuss Rally, Obedience, Agility and Tracking to join her at the event. She would like to have one extra person each hour, for a total of four volunteers.

Helen Castellano (Agility Trial Chairperson) reported that the September 17th and 18th Agility Trials have received AKC approval. The trials will be held outdoors at Creekwood Meadows in Plano. The opening date is July 13, 2005 with a closing date of August 24, 2005. The entry fee is \$20.00 for the first dog and \$10.00 for the second entry of the same dog. The judges are Karen Winter and Kurt Matushek. The entry limit is 450 runs per day.

Peggy Sue Seehafer (Director at Large) reported that the Animal Shelter would not be built at the Peck and Keslinger site. The county is putting the shelter in Sugar Grove. The training classes, we had hoped to provide there, will not happen.

### Welcome Wagon Brochures

Priscilla shared the information regarding her discussion with Marci Dillon from the Welcome Wagon. Marci verified with her supervisor that if we provide club brochures, she would include them with the Welcome Wagon packets at no additional cost to us, other than the cost to copy the brochures. It is our hope to take advantage of the busy Welcome Wagon schedule to increase the number of students for our classes to increase the amount of money we are able to put away for the possible purchase of our own training building.

Priscilla will share this information with Margi Stuessy, Publicity Chairperson, so she can contact Marci Dillon from Welcome Wagon.

## Policy About Non-Members Being Instructors or Assistant Instructors

During the February 2, 2005 Board meeting, Cindy Pakenas addressed the lack of a policy about allowing non-members to assist in teaching classes. The situation has occurred in the past and was dealt with on an individual basis. However, she would like to have a club policy set up to address the issue. Amy Ford discovered that according to our insurance agent, there is no problem by allowing non-members to be instructors, unless we pay them. If non-club members are paid to instruct, the purchase of a Workers Compensation Policy should be considered. This policy is approximately between \$800.00 and \$900.00 annually. Taffy stated that if we paid anyone to instruct, those individuals would be considered independent contractors. However the Board's consensus was that the club would not pay instructors.

Cindy asked the Board members to provide her any suggestions for the policy. Cindy reported that to be a certified APDT Pet Dog Trainer, at a minimum, an individual must instruct a class, take a certification test and pay a fee of approximately \$300.00. It was suggested that if a non-club member were interested in assisting, that his or her name be placed on a call list to be contacted when needed. Taffy reminded the Board that Assistant Instructors do have some authority and are still representatives of our club.

Additionally, Cindy stated that she would like input from instructors about this policy. Francene recommended, and Cindy agreed, that Cindy would provide a starting point for this policy to be presented at a future Board meeting. Dean Connolly made a motion that primary and assistant instructors must be club members. Priscilla Pisarski seconded the motion. There was no further discussion. The motion was approved by all Board members present.

### Paws in Community Award

Barb Misch made a motion to table the discussion of this agenda item until the June Board Meeting. Peggy Sue Seehafer seconded the motion. The motion was approved by all Board members present.

### **Trial Budgets**

During the February 2, 2005 Board meeting, Helen Castellano made a motion that each Trial Chairperson, Agility, Tracking and Obedience, prepare a budget for this year's trials to be submitted at the April Board meeting for approval by the Board.

The following chairs provided budgets for the 2005 events.

Helen Castellano (Agility Trial Chairperson) provided a budget for the Board members to review. Helen proposed a budget with an estimated revenue of \$12,000.00, and estimated expense of \$6,970.00, for a net profit of \$5,030.00. Helen responded that we would not be renting the electronic timers when Cindy posed the question. Helen also stated that last year's Hospitality expenses were too high, and would be lowered this year. Barb Misch made a motion to accept the Agility Trial budget as presented. Francene Andresen seconded the motion. The motion was approved by all Board members present.

Francene Andresen (Tracking Test Chairperson) provided a budget for the Board members to review. Francene proposed a budget with an estimated revenue of \$610.00, and estimated expense of \$576.00, for a net profit of \$44.00. Dave stated that the profit shown on the Tracking budget, should be \$34.00 not \$44.00 as shown. It was also agreed that the \$50.00 amount for fundraising revenue could be increased. Helen Castellano made a motion to accept the Tracking Test budget as amended. Peggy Sue Seehafer seconded the motion. The motion was approved by all Board members present.

Although Will Short (Obedience Trial Chairperson) was not in attendance, he had provided a budget to Dave following the February Board meeting, that Dave provided for the Board members. Will proposed a budget with an estimated revenue of \$7,540.00, and estimated expense of \$8,075.00, for a net loss of \$535.00. Several Board members expressed concern that the budget included an expense of \$700.00 to collect an estimated revenue of \$600.00. Barb Misch suggested that Will

recommend to the committee that collections/requests for donations should begin at this time. Helen also reminded the Board that we must be careful about how we handle raffles and the income earned, relative to any laws that St. Charles may have regarding raffles. Cindy stated that she knows that other clubs buy raffle items. It was also suggested that the Raffle committee also accept cash to purchase additional items for the raffle. Additionally, the Raffle committee should be told that they have to right to reject items that are not in excellent condition, such as used chew toys. Following the discussion, it was requested that the expense to purchase items to raffle be removed from the proposed budget.

Taffy suggested, because four of the five judges are incurring more substantial travel expenses, that the judges' expenses be increased from \$1600.00 to \$2000.00.

During the discussion of the Awards/Trophies expenses and revenues, Helen explained that the past Trophy committee eliminated the option of offering trophies purchased by the committee, when a club member donated cash, the trophy winner now gets the donated cash. Brenda Rivera, Trophy Committee Co-Chair and Board meeting guest stated that the 2005 Trophy Committee wants to offer cash instead of trophies. Brenda stated that the committee wants to try something different this year because they believe that a lot of people competing in advanced classes would rather receive money than trophies. Brenda also stated that she was not aware that the club had purchased the items last year from Peggy Sue Seehafer to use at last year's trial and for future trials. However, Brenda stated that even with the new knowledge of the existence of the trophies, she does not believe that the committee will change their plans. Taffy believes that the trophies should be used as originally proposed last year.

Peggy Sue Seehafer thought that the proposed budget should account for the possibility that the fairground's rent would increase by 10%. Taffy stated that last year's catalog sales were minimal. Taffy also stated that Will's other expenses shown on the budget seemed reasonable in her opinion.

Taffy made a motion that we return the budget to Will with the board's suggested changes, that Will make appropriate adjustments and that he resubmit it to the Board for approval immediately following the May Membership meeting. Barb Misch seconded the motion. Without further discussion, the motion passed with ten votes for approval and one vote against and no abstentions.

### Lifetime Members and Membership Renewal Forms

During the February 2, 2005 Board meeting, Sue MacPherson asked the Board to consider whether the club should <u>require</u> all lifetime members to submit membership renewal applications

every year. After much discussion on this topic, Dean Connolly made a motion to table the discussion of the noncompliance until next Board meeting. Will Short seconded the motion. All Board members approved the motion. All members present agreed that this item should remain tabled.

### 6:00 pm Beginner Class Follow-Up

Following Cindy Pakenas's announcement that a 6:00 pm Beginner class would be held during the 2<sup>nd</sup> and 3<sup>rd</sup> session, several members requested that the board reconsider hosting a class in that timeslot. During the March Membership meeting, Dave asked that all comments regarding the classes be sent to him for review by the Board at the April meeting.

E-mail messages were received from five club members asking the Board to reconsider hosting a 6:00 p.m. Beginner's class. Additionally one club member stated that according to her observations, with the exception of the 7:00 p.m to 8:00 p.m. timeframe, there was always one available practice ring between 6:00 pm. and 9:00 p.m., for two separate training nights. However, Cindy stated that this observation was inaccurate because she needed to ask a person using the utility ring to defer the ring usage to Cindy.

Cindy Pakenas read a petition brought to the Board meeting by Brenda Rivera. The entire petition was several pages long, however the main statement was "We the undersigned members of Fox Valley Dog Training Club respectfully request that the board and officers of Fox Valley DTC uphold the club's bylaws and AKC's club guidelines by maintaining no fewer than 2 "free-training" novice rings, in addition to the open ring and two utility rings, between the hours of 5:30 and 7 p.m. on training nights".

In addition to Brenda, Colleen Kent, Loretta Lazarra, Marian Lazarra, Cris Mazza, Jan Schomer, and Suzan Scott were guests at the Board meeting. Cindy stated that she supports the petition because she feels very strongly that the needs of the members must also be recognized. She stated that the club needs to discuss their goals and where the future will lead us. Peggy Sue requested clarification from Cindy about the fact that Cindy originally had requested the ring space for the additional 6:00 p.m. class, and now she supports the requests as presented in the petition. Cindy stated that she supports the request that the club will not host additional classes during the 5:30 p.m. to 7:00 p.m. timeframe. Cindy also stated that she could see potential problems occurring if we progress to more than just one extra Beginner's class. The petition is asking for a moratorium on adding any more classes. Cindy reported that the 4-H classes are considering going to an earlier time next year, perhaps starting classes at 5:15 p.m.

Brenda confirmed that the current 6:00 p.m. Beginner's class was ok, but that no additional classes should be added during (Continued on page 13)

that timeframe. Brenda responded that were no additional items to be addressed from the petition, when asked by Taffy. Jan Schomer stated that as a titling club member, she is being pushed aside by the needs of the Puppy and Beginner's class students. She also stated that since she does not belittle the club members who do not seek titles, she should receive the same courtesy from those club members. She does not see any reason why both the competitive trainers and the recreational trainers cannot happily co-exist in the same training building.

Carolyn reminded those present that the 6:00 p.m. class was introduced with a trial period set of two sessions. Peggy stated that the Board members were considering other options to raise revenue to try to achieve the goal of attaining our own training building. Brenda suggested that perhaps decisions such as adding classes, therefore reducing practice ring space, should have been addressed to the membership prior to their introduction. Taffy stated that she always encourages the students in her Puppy classes to come and observe the activities at the correction clinics, to learn some of the goals that any dog owner can achieve.

Brenda also addressed the recent situation of an instructor that was overheard making disparaging comments about those people and dogs who compete in the conformation and the obedience rings. Brenda stated that unfortunately, that was not the only time that similar comments were made by the instructor. It was suggested that the person hearing that type of comment should address the issue immediately. However, Brenda stated that she did not feel that it was her responsibility to police other club members.

Dave stated that this divisiveness will cause, or already has caused, good people to get frustrated and either stop volunteering or to leave the club entirely. Although he would like to solve the problems by sending the "naughty children" to their rooms, unfortunately he cannot, because we are all adults. As adults, we should know that EVERY club member contributes to the club in some way – either by volunteering to work, actively competing with their dog in obedience, actively competing in the conformation ring, or actively working on building a better relationship with the canine community members in our houses. We should all actively work on supporting each other's decisions, regardless of what they are.

Dave then stated that he would like to halt the present discussion so that the remaining items on the agenda could be addressed without staying till late in the night. He also thanked the guests present for their written and verbal comments.

New Business

#### Work Credit Description

Dave submitted a proposal for the rewording of the work credit descriptions to match the way credits are actually awarded. Dave stated that Jan Schomer has reviewed and approved these suggested changes. Helen suggested that "1/2 day" be replaced with "Work 1/2 day" and "full day" be replaced with "work full day" in each case where the text occurs. The proposed changes were approved by the Board as amended.

#### Pup & People Pool Party

Carolyn asked for the opinion of the Board members regarding the possibility of renting the West Chicago outdoor pool on September 10th for a pup/people picnic. The Board approved this event.

### No Parking Signs

Barb Misch and Cheryl Hettinger have agreed to create signs reminding anyone using the training building not to park in the Fire Lane. When we have two lines of cars on either side of the driveway, it would be impossible for a fire truck to pull in, and get set-up should we ever have a situation that requires emergency assistance.

### Instructor Comments

Dean asked to return to the conversation earlier about the negative comments made by an instructor. He indicated that we must be proactive in preventing this from recurring or continuing. He suggested that the Board might consider censuring the instructor. The Board members agreed that the DOT has the right to remove instructors that are not representing the club well.



Helen stated that the instructor started the conversation by encouraging people to go work at a large show because it is fun. However, the comments that followed were less than complimentary about conformation competitors and their dogs. Cindy stated that she would not feel comfortable doing that, but still would like to distribute to the students, a survey designed specifically for the advanced classes.

A motion was made, seconded and approved to adjourn the meeting at 10:12 p.m.
