Membership Meeting Highlights January 07, 2009

Meeting brought to order at 7:42 p.m.

Carolyn Pearson (Secretary). The November Meeting minutes were approved as published. Terri Byerly asked Board members and committee chairs to send any reports to Carolyn. Due to Carolyn's lack of a voice, Taffy read one item of correspondence regarding an organization offering to teach a pet first aid and CPR. Terri mentioned that the pet first aid and CPR class offered by the local American Red Cross is a fantastic class and encouraged club members to take the class. Although the class has been offered exclusively to club members in the past, Terri stated that she would not organize another class unless a significant number of club members were interested. Sandi Stephenson, Joan Mazat and Ingrid Hamburger all stated that they were interested.

Sandi Stephenson (Director of Training) stated that Nancy Pederson provided the following information for the Beginner classes starting on January 8th.

Sandi reported that Nancy Hofmeister will assist Kristen Anderson for the 8:00 p.m. Beginner's class. Sandi stated that she has been seeking an assistant for Ed Herdes for the 9:00 p.m. Beginner's class. Additionally, Sandi stated that when training is switched to a Tuesday night, Ericka Koehn and Sandy Davis cannot instruct. Sandi also reminded the instructors that the slip collars will no longer be provided to the students taking the Beginner's classes.

Joan Mazat (Co-Assistant Director of Training) reported that current attendance in the 8:00 p.m. Open class is down.

Terri Byerly asked whether the club should consider implementing the AKC STAR Puppy program. Terri stated that the STAR program is a cross between the CGC program and puppy class. Terri will provide the new D.O.T. with the information she has and the D.O.T. can decide whether or not to move forward with it.

Rick Cox (Obedience Trial Chairperson) thanked all members who made the 2008 Obedience and Rally Trial a success. The final financial tally indicates that the Fall Trial left Fox Valley Dog Training Club with a loss of \$447.83. He stated that he does have some ideas that may help change the financial outcome for the 2009 Trial.

The 2009 Obedience and Rally Judges are under contract. Additionally Judges have been assigned for the 2010 Trial with the contracts to be sent one year prior to the trial. The 2010 Judging Panel consists of more local judges so that there will not be as much travel expense as in 2008.

He stated that he would be willing to work with the 2009 Trial Chair. He also stated that assembling the Trial Committee might be a bit of a challenge this year due to the number of members from last year who stated that they would not be interested in the same position next year.

New Business

2009 Calendar

Terri explained that this year again, due to the St. Peter's Barn Sale, there will not be training on September 17th. To make up for this change, there will be two nights of training the week of November 1st. There will be a Regular Training night on November 3rd and a Correction Clinic on November 5th. This Correction Clinic will be the last one before the 2009 FVDTC Obedience Trial.

Tracking Committee Fundraiser

Cheryl Hettinger announced that she is donating a tub to the Tracking Committee to use as an item to host a fundraising raffle. The rules for the raffle will be announced.

Lifetime Members

Peggy Sue Seehafer asked for the policy of lifetime non-training members who are training their dogs. It was decided that the policy will be published in the January Waggin' Tales as a reminder to all club members. Terri stated that the club members who are not paying their training membership or a guest training fee should be spoken to first by Sue MacPherson, and if necessary by the Director of Training. Peggy Sue stated that she has witnessed one club member. Sue MacPherson stated that she knew of another club member who was not paying a guest training fee.

AKC Rule Changes

Rick Cox stated that AKC has changed the jump heights, the lowest board on the high jump has been reduced from 8" to 4". It was agreed that we need to review the high jumps prior to the Obedience Trial. More information is available in Chapter 4, Section 11 of the AKC Obedience Regulations (effective January 1, 2009). Dogs eligible for the 4 inch jump height must be less than 7 1/2 inches at the withers or less than 10 inches at the withers if listed in the "Three-Quarters Jump Height Table".

There are several changes in the AKC Regulations that became effective on January 1, 2009. There are even more changes that will take effect in 2010 and 2011. In discussion with some experienced handlers there has been some confusion about the changes. Rick said that AKC has documented the information quite well and it is available at http://www.akc.org/news/index.cfm?article_id=3633 and he would highly recommend this site for our members. There is also information about some new titling classes as well.

Assistant Director of Training (ADOT) Appointment

Joan Mazat appointed Sandi Stephenson, who accepted the nomination at the meeting, to the Assistant Director of Training (ADOT) position. The ADOT appointment was unanimously ratified by the members present at the meeting.

A motion was made, seconded and approved to adjourn the meeting at 8:45 p.m.
