MEMBERSHIP MEETING HIGHLIGHTS - NOVEMBER 3, 2010

Meeting brought to order at 7:43 p.m.

Carolyn Pearson (Secretary). The October Meeting minutes were approved with the following correction.

- Original statement: Ingrid Hamburger (Tracking Test Chairperson) reported that they had a wonderful tracking test, thanks to all the wonderful volunteers and the perfect weather! Ingrid reported that all four of the Tracking Test exhibitors went home with their TX titles and the passing rate for the Tracking Excellent Test was 75%.
- Corrected statement: Ingrid Hamburger (Tracking Test Chairperson) reported that they had a wonderful tracking test, thanks to all the wonderful volunteers and the perfect weather! Ingrid reported that all four of the Tracking Test exhibitors went home with their TD titles and the passing rate for the Tracking Excellent Test was 75%.

Several items of correspondence were read.

Dana Weller (Treasurer) distributed the year-to-date Income/Expense Report for the members review. Taffy asked about the obedience trial for the expense of the building – the fairgrounds is NOT charging us for set-up time.

Class Registrar, Nancy Pederson, reported that the session which began on October 28th was very successful. The following is the number of students in each of the classes.

Nancy also reported that she is currently accepting applications for the 8:00 p.m. Puppy class which starts on December 9th and the Puppy and Beginner's classes which start in January, 2011.

Nancy reminded club members that Fox Valley Dog Training Club

does have a Facebook page and she submits updates to it regularly. She encouraged other club members to utilize the site to post their news as well.

Barb Moore (Obedience Trial Chairperson) was not in attendance, however she sent the following report: The Obedience Trial Committee members met on Friday, October 29th and provided the following status updates. The majority of the details has been completed or are near completion, thanks to the experienced and dedicated members of the committee.

- Nancy Einwich (Obedience Trial Secretary) reported that she continues to process the entries received. She also stated that the total number of entries were down from previous years.
- Ed Herdes described how the rings would be laid out and stressed again the need for more volunteers for Sunday's trial. Volunteers would be welcome at the fairgrounds on Saturday at 6:00 p.m. for the set-up and on Sunday at approximately 3:00 p.m. for the clean-up. We also briefly discussed how we can encourage more club members to volunteer, however the topic was tabled for another time.
- Kent Hildebrand brought the updated ring table centerpieces that were beautifully created by Vivienne Hildebrand and her sister-in-law.

Additionally, Ed reported that the fairground's refrigerator would be available to us as of Thursday. Marian Lazzara stated that she would be in the kitchen starting at 6:00 a.m. on Sunday to prepare the food and allow access for any booth vendors who needed to set-up.

Carolyn reported that she had the sign-up sheet at the meeting from Cathy Fleury for anyone wishing to volunteer to steward, as still needed stewards.

Nancy Einwich (Obedience Trial Secretary) reported that the entry confirmations would be sent out via e-mail on Thursday. She reported that there were 125 dogs entered for the Obedience Trial with a total of 162 entries, and 52 dogs entered

for the Rally Trial with a total of 72 entries.

Sue MacPherson (Membership Chairperson) stated that there were three applications to be voted on this meeting which were published in the October Waggin' Tales. She stated that the last name listed for Elaine and Justin should have been "Patanella", not "Read". Taffy Wille made a motion to accept the list as corrected. Francene Andresen seconded the motion. The list was accepted by all members present, with no one opposed or abstaining. Welcome to all new members and especially to Willy Santiago who was present at the meeting!

Ingrid Hamburger (Tracking Test Chairperson) reported that planning for the 2011 Tracking Tests has not yet begun.

Cheryl Hettinger (Annual Dinner Chairperson) reported that "we will have a dinner" and "it will include food". She stated that with the feedback received from the recent Annual Dinner attendees, she is seeking a larger establishment. She is looking at the "sister" restaurant, which is located in Geneva, of the Old Towne Pub and Eatery restaurant. Currently there are two possible dates for the dinner, April 9 or April 16.

Jill Hansrote (CGC Test Coordinator) reported that our next CGC Test will be conducted on December 28th (in conjunction with the club's Christmas party). She is still confirming the evaluator for the test.

Barb Misch (Graduation Chairperson) was not in attendance, however she sent the following report: She will continue printing the graduation certificates at the mid-point of a class session rather than waiting until the end. The process was successful, thanks to the instructors for their help!

Ingrid Hamburger (Match Steward Chairperson) reported that she is very concerned with the difficulty she is having getting stewards for the November match, especially in light of the upcoming trial. She stated that we also had trouble for the October match.

David Lewis (Waggin' Tales Editor) reported that the next Waggin' Tales deadline was Sunday, November 21st to allow for inclusion of any trial news.

Vicki Wilder stated that the event was well attended on Saturday when she was there. Loretta stated that it was less busy on Sunday when she attended. With the information presented at the meeting, participation in a future event may be considered.


