I WILL MISS MY TUCK ...

A lthough some of you already know, I wanted to let you know that my dog Tucker, (Tuckmans Forrest Gump CD RE). crossed over the Rainbow Bridge on Tuesday, May 31st. He died of spenic hemangiosarcoma at the age of 6 years old. Tuck's life started rough, a 6 month old rescue dog who was emaciated when I got him in April 2005. He earned his CGC at Fox Valley in the fall of 2005 and then became a therapy dog the following year. He earned his first title, CD, in DeKalb in 2007 and his last title, RE, at Fox Valley in November 2010. He had started his Graduate Novice title with one leg earned in December 2010. Tucker earned a "First" ranking from the AKC Irish Red and White parent club last fall in Rally Obedience and was the poster dog for what one can do with a rescued Irish Red and White Setter.

Tucker was my demonstration dog in my Advance Beginner Classes and often enjoyed being handled by others during class. He also loved going into Marietta's Open Class as well as meeting everyone at the Club. His last night at class, May 26th, he was full of life, had a good training night coming off of a recovery of spleen surgery 6 weeks earlier and even enjoyed a romp with Carolyn's boys.

My friend from Canada sent me the following Irish poem when learning about Tucker's passing that I'd like to share.

I will miss my Tuck.....

A TENDER HETERODOXY

I dreamed one night I came Somehow to Heaven, and there Transfigured shapes like flame Moved effortless in air.

All silent were the Blest, Calmly their haloes shone, When through them all there pressed One spirit whirling on.

He like a comet seemed, But wild and glad and free, And all through Heaven, I dreamed, Rushed madly up to me

Back from his haloed head A flaming tail streamed far, This way and that it sped And waved from star to star.

And, as I saw it shot Like Searchlights through the sky, I knew my dog had got To Heaven as well as I.

In response to Terri's question (which she had previously received from Marietta Huber), no one present at the meeting could remember the club hosting a garage sale as a fundraiser.

In response to Terri's query whether the club should send a letter to the AKC regarding the lack of knowledge about the newest titling classes by judges. Several club members stated that they were personally involved or witnessed judges who were completely unprepared to judge the classes, such as Beginner Novice and Graduate Novice, they were hired to judge. It was the consensus of the members present at the meeting that as a club, we can simply not hire those judges. However, individual exhibitors (especially those personally involved) should contact AKC with their experiences and

concerns. It was suggested that a document with suggested 'talking points' be provided to club members wishing to contact AKC.

Terri Byerly also asked club members present to consider providing trophy sponsorship for the 4-H Dog Show in June.

Terri Byerly reminded club members that there have been recent attempts by the State of Illinois to sponsor bills that are not in the best interest of dog owners, and that we should be watchful. For example, Illinois Bill HB1080 would eliminate the current law that states "vicious dogs 'shall not be classified in a manner that is specific as to breed', and municipalities may not pass any breed-specific regulations or ordinances." If the bill is passed, Illinois (which is currently one of only eleven states that specifically prohibit breed-specific laws) would allow specific breeds to be declared as "vicious" and allow municipalities to enact breed-specific laws. Terri encouraged club members to keep informed about this type of legislation by visiting the following websites and by sharing with other club members any other Websites, etc. that can provide current and accurate information.

BOARD MEETING HIGHLIGHTS - APRIL 19, 2011

Meeting brought to order at 7:49 p.m.

Carolyn Pearson (Secretary). Several items of correspondence were read.

Ed Herdes (First Vice-President) mentioned that during recent conversation, his contacts at the Kane County Fairgrounds were asking whether we would be using the fairgrounds only on Sunday for the annual obedience trial.

Joan Mazat (Director of Training) stated that she was planning to host an instructors' meeting for current primary and assistant instructors at some time in the near future. The topics of conversation at the meeting would be a discussion of instructors' guidelines, how we can encourage other club members to become involved as instructors and incentives for our instructors.

Joan presented the following list of guidelines that she is planning to share at the instructors' meeting. She reported that this list was created as a result of her concern for the safety of trainers, dogs and instructors training at FVDTC. She stated that she was concerned that although we do have an expected level of risk due to the very nature of dogs, we should take care to review policies to make sure that we are avoiding unnecessary risks.

- Instructor's Dogs in the Ring While Instructing Students with Dogs Present
- Instructors to Students Ratio in Drop-In Classes
- Dogs Playing in the Ring Other than Puppy Class
- Dealing with Reactive Dogs

New Business

Terri Byerly addressed the possibility of modifying the current policy of offering individuals the opportunity to submit a membership application following the completion of the beginner's class to offering membership following the completion of a puppy class. Jill stated that as a new member, she would have submitted her membership application after the puppy class. Topics discussed during the discussion included the following.

- Would the club member be eligible to attend advanced level classes immediately following the completion of the puppy class, or would they be required to attend a beginner's class?
- How would the change impact the club's finances, due to the reduction in income from the non-member beginner's classes when those individuals pay the member fee rate? Currently, the building rental is covered by the fees collected by puppy and beginners class students.

Carolyn stated that the building lease expires on December 31, 2011. Therefore, the future amount of rent expenses are unknown at this time. Once we are aware of the amount, it may be necessary to increase the class fees for 2012.

There were many different ideas of how this policy modification could be tracked and processed. It was suggested that we offer puppy students the opportunity to submit a membership application at the same time as they apply for the beginner's class. The last date of the beginner's class would determine the membership date and the amount of dues (when prorated) that would become effective following the completion of the beginners' class. The discussion ended with the consensus that more financial information must be reviewed.

A motion was made, seconded and approved to adjourn the meeting at 9:45 p.m.

BOARD MEETING HIGHLIGHTS - JUNE 10, 2011

Meeting brought to order at 7:42 p.m.

Carolyn Pearson (Secretary). Several items of correspondence were read.

Ed Herdes (First Vice-President) reported that due to the age (purchased in 1996) and condition of the mats used for training every week, he has begun obtaining quotes for their replacement. Due to the limitation of our storage cabinet, the mats must be the 3 feet wide. Ed stated that both J & J Dog Supplies and Max 200 can supply the 3 foot wide mats, which are 105 feet long. To mat the training building, the club's order would be 22 rolls. The purchase date of new mats has not been determined at this time.

- J & J stated that the cost is \$485.00 per roll when purchasing between 21 and 30 rolls. Shipping is not included in the price.
- Max 200 stated that their minimum order for the mats is 30 rolls. The cost is \$489.00 per roll. Shipping is not included in the price.

The majority of the mats we are currently using and the mats that are in the outside shed will be available for sale by club members and others. The brown mats in the outside shed are the mats that we currently use for the Rally ring during the November trial and are available for other to rent. Those mats will be the first ones to be sold. A portion of the green mats that are currently used for training will replace the brown mats for the Rally ring and rental. The remaining green mats that are not needed by the club will be available for sale, once the brown mats have been sold. Any club members who would be interested in purchasing any of the older mats should contact Ed Herdes at training or via e-mail at vp1@fvdtc.org. Terri Byerly and Vicki Wilders both said that they were interested in purchasing mats.

Joan Mazat (Director of Training) stated that she is planning to host an instructors' meeting some time soon. She stated that Sandi Stephenson has offered the use of her house. The primary topic would be Training Policies.

- Terri Byerly addressed the class that was currently being taught at 7:00 p.m., which previously was used to host the R+ Advanced Beginner's class taught by Will Short. Recently, the format was changed to offer a Rally class with an Instructed Run-through format. Terri stated that currently the following individuals are involved in this class.
 - Will Short collects the names of the individuals wanting to do a run-through.
 - Joyce Conway does the actual run-through as the "judge".

If the Rally class is to be a permanent change, this will require changes to multiple documentation (e.g. information table binder and Website to name just a couple) and Will Short will be asked to provide that information.


