#### CONGRATULATIONS TO OUR NEWLY ELECTED VOLUNTEERS From Francene Andrersen

realized that perhaps I should set the record straight, even though the elections are over.

I wanted to write and congratulate everyone & to thank all of the Fox Valley volunteers for their service to the club. You don't always get recognition for the work that you do, but there are a lot of people who do support you & appreciate the efforts of your labor. Recently, I've been asked quite a few times why I had run for office. It seemed that some people had the wrong idea as to why I threw my hat in the ring & I

Since the late 1990's I've been a member of FV I observed a club started in the 1950's & considered to be "special" & looked up to by people in the canine community move to being a club that has in many ways stagnated & lost a lot of its appeal to a number of people. I see other newer clubs being much more progressive than us with much less. I see us losing our edge in the community & have been trying to understand why this is happening. Why are other clubs doing so much & how do they accomplish this? I don't have the answers but perhaps we need to reassess ourselves as a club. Perhaps we need to update our thinking about who we are & where we want to take our club in this century.

One of the most glaring observations I made came when I agreed to be on the nominating committee. I noticed just how many volunteers we **don't** have in our club. It occurred to me that we have only a handful of people doing the majority of work. Think about it. How many people do you know volunteering right now? How many of those people are doing more than one position within the club? Have you ever given this any serious thought?

In a moments time I thought about 3 people doing multiple jobs within the club: Carolyn, Terri, & Will. Carolyn, our Secretary (which is a huge job all by itself) is also an instructor, hostess for our Obedience Trial, & coordinated our club's judges with Car-Dun-Al's judges, & does a number of other things. Terri, our President (a big responsibility) is an instructor & manages all of our 4H activities (another big responsibility), she is a match judge, etc. Will is an instructor, a match judge, last year's Trial Chair (and this year's Trial Chair), etc. These are the folks I thought of first & I know there are a few more such as Ed & Ingrid & Cheryl & Nancy...

While I was on the nominating committee, and we were asking others to run for office, I began thinking about what was told to me by people & things I was noticing & I began assessing my own role within the club.

The realization of how much work our leaders are doing & how easily our club could get into trouble prompted me to take action. When so few people do so much of the work, if one person is no longer able to do their jobs, there will be enormous gaps to try & fill. It is difficult to fill 1 job but to fill 2 or 3 large jobs can be really tough. And if more than one person were to leave the club for some reason or another, it could be a disaster. Just look at the slate from the election if you don't think it would be a problem. All but 1 position had only 1 person running for the office.

I chose the Trial Chair position strictly on the basis that it is a big job & I thought I would be able to do the job well. I have had experience with trials. I also know that the paperwork cannot be completed in a timely manner if AKC does not know who the Trial Chair & Secretary will be. It is part of the form that you have to fill out for a trial. If no one is the Trial Chair then there is no Trial & if there is no Trial then paperwork doesn't need to be filed. I did not see it as a Board or Club problem that we were not going to have a Trial last year & that the paperwork was not sent in a timely manner. I viewed this as a membership problem & members not stepping up to the plate to do the work needed to be done.

All of us knew that we did not have a Trial Chair. There are a lot of members in this club who are capable of stepping up & chose not to do so. Therefore, it is not fair to point fingers at others if we ourselves are not willing to put forth the effort. Credit needs to be given to the people who do step up in times of need within the club.

Will had not run for the Trial Chair position during elections but was kind enough to step up to the plate last year when it was obvious that no one else was going to do so. I did not know that he was truly interested in the position since he hadn't run for it last year. I don't see Will much and we don't talk much so I had no idea how he felt.

Carolyn, too, needs to be given a lot of credit for getting the paperwork into AKC once the Trial Chair was finalized & for getting other things coordinated to ensure the Trial proceeded.

For me, this was not a campaign issue or a competition. As I see it, if more people want to volunteer & share in handling the big jobs & they have the ability to do so, then they should be accepted at face value.

Will was already doing a couple of big jobs so I thought I was being helpful & being a team player. I was trying to meet a need that I was observing. That too few people are doing too many big jobs & not enough other people are volunteering to help. My focus was on the bigger picture of what I could do to help the club. I am already a member of several committees but not in the leadership role & I also volunteer in areas of need at different times. I was just trying to **step up to the plate** to do a job that I felt I could do well & I was trying to encourage others to do the same.

The bottom line is: A few volunteers doing many jobs & making all the decisions results in overload, less time & energy to try new things, increased frustration & resistance to changes, fewer new ideas, less creativity & satisfaction, & increased dissatisfaction. The Club becomes less desirable to join, decreases its status within the community & decreases the desire to volunteer resulting in fewer people doing all the work – & the cycle continues. On the flip side: Volunteers equal to the number of positions, & assistant volunteers to help in areas of need, results in more equality of decisions toward membership needs, decreased overload & frustration, increased acceptance of positive changes & energy to promote & explore new things, increased flow of new ideas & creativity, increased satisfaction & decreased dissatisfaction. The Club becomes a magnet for others to join, increases its status within the community & volunteerism resulting in more people doing lighter workloads – & the cycle continues.

It is my sincere hope & wish for more people to volunteer. And, for volunteers to be welcomed with the warmth, respect & the admiration that they most profoundly deserve to receive. After all, they are giving of themselves something very precious. They are giving us their time & energy.

We all have those days. You know them. You're focusing on too many things at once, and suddenly you barely know your own name. Or, that dog you've been working so hard to train goes off and does something totally







#### Waggin<sup>®</sup> Tales <u>Membership Meeting Highlights</u> January 18, 2012

Meeting brought to order at 8:03 p.m.

Carolyn Pearson (Secretary). The November Meeting minutes were approved as published. Several items of correspondence were read. Brenda Rivera asked about the comment that Peggy Sue Seehafer made at the November membership meeting. Peggy Sue suggested that perhaps we should not host events when there are not enough volunteers. She also suggested that perhaps we should streamline the club by redoing our priorities. It was explained that we were just tossing out ideas about the club and how to improve it. In response to Joyce Conway's question, it was stated that there were no events which were more difficult than others. Getting club members to volunteer was not always easy to do. Terri stated that a good example was the Waggin' Tales editor. New club member, David Thornell, has volunteered to take over as the Waggin' Tales Editor from Dave Lewis. Dave volunteered in the recent past to make sure that the Waggin' Tales continued to be published as other editors stepped down.

### IT'S AWARDS TIME 2011!!

It is the policy of FVDTC to give awards for AKC, CKC and UKC titles earned at trials, tests or shows each year. Below is a list of the awards that are offered and a copy of the forms we will be using this year. Each form must contain all the information for eligibility. Please submit one handler form and a separate form for each dog.

To receive a club award, you must have a total of 10 work credits for the year and be listed as a Regular Training Member in the Roster. If for some reason you have not met **ALL** your requirements and can justify the reason, your eligibility will be reviewed by the Board of Directors.

<u>A member's dog is limited to receiving one AKC award per level of titles received.</u> For example, if your dog earns a CD and an RA, you may pick only one award at Level 2. The exception to this is anyone who receives a title at the highest level in the same year (OTCH and a MACH).

Awards are given for titles earned in 2011 (i.e., a dog may have earned two "legs" toward a title prior to 2011, but if the third "leg" was earned in 2011, the title is earned in 2011). However, all scores for any of the "Special Club Awards" must have been earned in 2011.

Members whose dog(s) earned a Canine Good Citizen (CGC) certificate AND have completed at least 10 work credits are eligible to receive a Certificate of Accomplishment.

Any award that states "Personalized" will be engraved with the dog's name, title and year. PLEASE NOTE: All items by C. Rodeback require a photo of your dog to be submitted with your forms. All items by B. McGuffey require an article of clothing (50% to 100% cotton and washed at least once) and a photo of your dog to be submitted with your award forms. All submitted pictures **MUST** be <u>clear</u>, <u>close-up</u> photos for best reproduction. Our artists need time to work on these, so please be considerate and get everything in as early as possible.

Front and Finish is now offering the "Front and Finish Excellent (FFX) Obedience Platinum Award". The requirements are that the obedience title must be completed in three trials with scores of 195 or better. If you are eligible for this award, **you must also submit the FFX Application with the rest of your forms**. For more information about this and other

### SPECIAL CLUB AWARDS

**ALL** scores for special awards must have been earned in the current year and must have been earned at AKC trials, unless otherwise specified.

**NOVICE A - HIGH QUALIFYING AVERAGE AWARD** - must submit a minimum of 3 scores.

**NOVICE B - HIGH QUALIFYING AVERAGE AWARD** - must submit a minimum of 3 scores.

**OPEN - HIGH QUALIFYING AVERAGE AWARD** - must submit a minimum of 3 scores.

UTILITY - HIGH QUALIFYING AVERAGE AWARD - must submit a minimum of 3 scores.

**RALLY NOVICE A - HIGH QUALIFYING AVERAGE AWARD** - must submit a minimum of 3 scores from Rally Novice A class.

**NOTE:** ALL qualifying AND non-qualifying scores must be submitted if you are applying for one of the following special awards that refer to an "average" score. If you do not know your NQ score, list it as 165. Remember, obedience is a sport guided by the principles of good sportsmanship. Each of you is on the "honor system" in submitting your scores.

**DOROTHY DIMOND MEMORIAL TROPHY** - given to the member whose dog was trained and shown by the member and receives the highest average score in regular classes in at least three AKC trials. All scores must be included. NQ's, unless higher, will be 165.

**DEBBIE ORR MEMORIAL AWARD** - goes to the member whose dog or dogs earned the most AKC titles or international equivalents during the year. For this award, AKC, UKC and CKC titles are counted.

**HEATHER MEMORIAL AWARD** - offered by Nancy Gillum, in memory of Briarwood's Heather Miss AM/CAN CD. It is given to the handler whose dog earned the 3 highest scores in Novice A at AKC trials.

**FOUNDERS AWARD** - offered by Fox Valley Dog Training Club, Inc. in memory of the founders of FVDTC. It is given to the handler whose dog earned the 3 highest scores in regular classes at AKC trials.

**ED KNEIP AWARD** - offered by Fox Valley Dog Training Club, Inc. in memory of Ed Kneip. It is given to the handler whose dog earned the highest combined score in Open B <u>and</u> Utility A or B at same AKC trial.

**KANOSAK KENNEL AWARD** - given to the handler whose dog earned the 3 highest Utility A scores at AKC trials with at least **KANOSAK KENNEL AWARD** 5 scores being submitted.

**TUCKER MEMORIAL AWARD** - offered by Sandy Davis, in memory of Tuckmans Forrest Gump CD, RE, THD. It is given to the handler whose dog earned their first AKC Rally Advanced Excellent (RAE1) title, in the same calendar year. All scores, including NQs, must be submitted. NQs will be counted as 0. Scores will be used to calculate the highest average score as a tie-breaker, when needed.

**SALLY COMPTON OUTSTANDING SERVICE TO THE CLUB AWARD** - given to a club member to acknowledge them and their contributions to the club. This award is especially significant because it offers you the opportunity to nominate a fellow club member for their efforts.

## THE ABOVE SPECIAL AWARDS WILL BE KEPT FOR ONE YEAR BY THE WINNER AND REPLACED WITH A PLAQUE.

3. Handouts describing the new signs and the rule changes will be available.


