### MEMBERSHIP MEETING HIGHLIGHTS - MARCH 20, 2013

Meeting brought to order at 7:48 p.m.

Carolyn Pearson (Secretary). The January 16 Meeting minutes were approved as published. No club members present at the meeting had responded positively in response to Carolyn's question whether any club member at the meeting had responded to the recent Constant Contact message regarding changes to the Illinois laws that impact the dog community. John said eight of the 90 subscribers had read the message. Donna stated that several items in the first aid kit needed to be replenished.

**Wendy Waddick (Second Vice-President)** was not at the meeting, but Donna reported that Wendy was in the process of scheduling programs for future membership meetings.

**Dana Weller (Treasurer)** was not at the meeting, but reported that the 2012 taxes are in progress.

**Terri Byerly (Director of Training)** reported that the recent instructors' meeting was fantastic! There was a lot of great input at the meeting and positive feedback after the meeting. THANK YOU to everyone who attended and participated in the discussions!

She stated that there is a new need for a conformation instructor; the volunteer must have some conformation handling experience. In lieu of a regular weekly instructor, there will be an ad-hoc rotation of instructors without a pre-arranged schedule. Additionally, Terri reminded club members that they can work themselves.

Terri stated that the new Beginner 2 class was filled within approximately 24 hours of announcing it! Reports of the first night of this new class were very positive!

Terri announced that the following should be added to the club's Roles and Responsibilities.

- Instructors must find their own substitute for any absences. A contact list to use has been provided to all current instructors.
- Instructors must sign in each night of training to enable work credits to be accurately recorded.
- Instructors' dogs must not be loose in a ring. When not being used for a demonstration, they must either be in a crate, held on leash outside the ring by a fellow handler or in a vehicle weather permitting (this is a reminder of an existing rule).
- In order to receive work credits for that session, instructors must be at a minimum of five classes taught.

In response to Terri question for the projected completion date for the "members only" area of the web site to be secure, Dave Lewis stated that a brief demonstration will be available during the May Membership meeting. The "members only" area will be secured to allow only members access.

Terri reported that unless there are more positive responses by March 28th, the upcoming workshop "Teaching is not the Same as Training" scheduled for April 14th might be canceled. She asked that anyone who is interested in attending this workshop, to contact her at dot@fvdtc.org, as soon as possible.

Terri also reported that there was a recent dog-on-dog incident at training. She stated that she has discussed the situation with both parties. Terri reminded all trainers that everyone is allowed/entitled/expected to protect your dog. However, once the dogs are separated, each handler should attend to their own

dog, and not "punish" the other dog. All club members have a responsibility to be aware of any potential incident. Terri stated that as DOT, she was not inclined to create broad and hard fast rules for incidents which occur, it was much better to address each incident on a case-by-case basis.

Terri reminded club members that dogs wearing an orange scarf should be afforded their space. Additionally, Barb Misch, who is making a new batch of the scarves, will now include an 'orange ribbon' that can be attached to the dog's leash. She also asked that instructors periodically remind students the reason that dogs are wearing the scarves and/or the leash ribbons.

Donna thanked the DOT and ADOT for all their hard work.

**Sue MacPherson (Membership Chairperson)** read the names of eleven new applicants which were published in recent Waggin' Tales. None of the applicants were present at the meeting. Sue made a motion to accept the list as read. Joyce Conway seconded the motion. The list was accepted by all members present, with no one opposed or abstaining. Welcome to all new members!

**Ingrid Hamburger (Tracking Test Chairperson)** reported that the Tracking Test is now listed on the AKC website. Ingrid stated that although the TDX entry fee information is listed on the AKC website, she must contact them to have the TD entry fee information included.

**Barb Runkle (Public Education Coordinator)** was not at the meeting, but reported that she is organizing a raffle at the Agility Trial with the proceeds going to the Tracking Test. She is still in need of donations.

**Cathy Fleury (Agility Trial Chairperson)** was not at the meeting, but reported that she needs volunteers for the upcoming Agility Trials.

Cheryl Hettinger (Annual Dinner Chairperson) reported that plans for the Bone-Anza themed dinner is on schedule. She asked that everyone wishing to attend to PLEASE send in your RSVP and money to her or Candy Ellis. Currently, there is low attendance. She stated that if an RSVP is not received by April 4th, the committee will not be able to order food for you. PLEASE - PLEASE - PLEASE reserve your spot TODAY!

Cheryl stated that the site's deposit has been sent and the caterer has been confirmed. Cheryl also reported that raffle donations are starting to pour in. Any donated item that is not necessary for a dinner attendee will be given to the Agility Trial's raffle. She reminded everyone to acknowledge the vendors who donate to the raffle.

**David Thornell (Waggin' Tales Editor)** thanked Dave Lewis for doing several of the past issues of the Waggin' Tales while his computer was out of commission. Additionally, he thanked Donna for helping obtain the software.

  - Donna thanked Ed Herdes for contacting the fairgrounds about getting the handicapped signs and reminded the club members to adhere to them.

- Dave Lewis reported that he is currently working on a password-secured Members' Only page for the updated website. The first phase of this page will enable members to update their own roster information, such as address changes, changing or adding breeds. Additionally the page will enable club members to record their work events for work credits and awards eligibility. Donna thanked Dave for the great job and his hard work. Additionally, Peggy Sue Seehafer stated that when the question was presented in the past, the Board made a financial decision. After more discussion, John Senne made a motion to address the request with more analysis and research by a separate committee. The motion was seconded. The motion

Meeting brought to order at 7:35 p.m.

**Carolyn Pearson (Secretary).** The February Meeting minutes were approved as published. One item of correspondence was read

**Ed Herdes (First Vice-President)** asked whether the invoice presented by Brian Ruppert for the work on the external shed included the painting. Carolyn stated that she would check with Dana Weller to review the invoice. If it was not included, Dave Lewis stated that his son Joshua would be available during the summer to paint it. Ed stated that he would also be able to paint when the weather permits.

Wendy Waddick (Second Vice-President) was not in attendance, but sent the following report. **Chairperson)** question about the fact that the members voted on at the January Membership meeting were NOT published as originally stated at the meeting, it was determined that because this was simply a mistake and not purposely done, the voting in process was still valid.

**Barb Runkle (Public Education Coordinator)** stated that the raffle held during the recent Agility Trials were very successful. Thanks to everyone who donated items and volunteered to help, the raffle raised \$344.00 to be used for the September Tracking Test expenses.

Will Short (Obedience Trial Chairperson) reported that Jim

Ham has agreed to judge the Beginner's Utility class for our 2013 trial.

Ingrid Hamburger (Tracking Test Chairperson) thanked Barb Runkle for the \$344.00 earned during the agility trials' raffles. Ingrid stated that more trophies will need to be ordered for next year's test. She will get the contact information from the awards committee for the business currently used.

**Cathy Fleury (Agility Trial Chairperson)** was not at the meeting, but reported that the Spring Agility Trials were a success as they received many compliments. In spite of the fact that it was Easter weekend, the trial was full with a wait list for both days. She stated that an order will be placed prior to the Fall Agility Trials for First Place and New Title ribbons

She thanked all of the Agility Trial committee members and the club members who volunteered at the trial. She stated that she is continually amazed at how quickly the set up and tear down happens. She also extended a special thank you to Donna Bihner for all of her help with the Worker Sign up. Cathy reported that she is in the process of providing the report and paperwork to Dana.

**Dave Lewis (Director at Large)** reported that his attempts to create a function to calculate the membership dues are more difficult than anticipated. He has included the information from the current membership database.

 In response for clarification, Terri stated that the area in front of each of the orange dividers are to be considered the handicapped parking spaces. That is typically where the fairgrounds have placed the signs.

#### **New Business**

 Donna sought feedback from the Board members regarding an e-mail from the Anderson Animal Shelter suggesting a 'partnership' between the club and the shelter. Carolyn stated that although there have been

- club members involved with the shelter in the past; we have not had any official relationship. Donna stated that she will contact them to find out more details for their proposal.
- Health Certificate Form Update Terri Byerly asked whether there was a policy in place to enable class students or club members to identify that their dog has been vaccinated or titered for parvovirus and distemper. Following the discussion, it was agreed that Carolyn will update the health certificate form with the 'titer question'. Once the form has been updated, she will send it to Nancy Pederson (class registrar).
- Aggressive Dog Discussion After much discussion, the Board's concensus was that any type of aggressive

- dog incident must be dealt with on a case by case. In many situations of aggression, it is not clearcut as to which dog initiated the physical contact.
- In response to Donna's request for Board member feedback regarding the resurrected policy of instructor's dogs in the rings, many of the Board members stated that as long as the dog was being used for demonstration, this was appropriate. Additionally, Terri stated that she would include the 'xpen' to the list of acceptable containment methods. However, if the dog does not remain in the x-pen, a crate would be required. Other Board members stated that there has not been a problem with instructor's dogs and therefore the policy was unnecessary.


A motion was made, seconded and approved to adjourn the meeting at 9:10 p.m.
