Note from the President:

Greetings Fellow Club Members!

Summer is more than half over, can you believe it? These days with temperatures over 90 degrees it makes me wish for winter – well, not quite, but almost. I am so grateful for the AC in the building on these hot days. To check if the AC will be turned on at training, visit our Facebook page (Fox Valley Dog Training Club) or the club web site www.fvdtc.org after 2pm on training days. Our policy states: "85 degrees in St. Charles by 2pm"--then we turn it on.

We are now well into our new fiscal year and hopefully you have sent in your membership renewal. Only renewing for six months was a bit confusing and thankfully we won't have to do that again. However in six months we renew for 2014 and this time our new work credit change will come into effect.

SO – have you earned your three credits yet? Remember, in accordance with the new rule your dues will stay exactly the same IF you earn three credits. If not, the dues will double (for members that pay no dues there is no change). If you joined in 2013 we ask that you earn just one credit to keep your dues the same for 2014. For all additional years it moves to three credits.

Also, for those who are working toward title awards, remember, your 3 dues work credits also go towards the 10 work credits required for title awards.

There are so many ways to earn these credits. One can even come from attending a membership meeting (upcoming meetings in Sept, Oct & Nov). We have three trials coming up (tracking, agility & obedience). There are many jobs at the trial and things that someone can do in preparation for the trial. Reach out to any of the chairpersons to help. Steward at a correction clinic and even earn a free run-thru in addition to a work credit.

To find ways to help look at the *Help Wanted* section of the newsletter, reach out to a committee member, or check out the work credit sheet. I've added both of these to this newsletter and you can also find them on the web site. We have no interest in seeing anyone's dues increase, the goal is to get a little more help from all of our members. Feel free to ask me if you are confused and need clarification with identifying ways to help. But please don't wait until November/December to start thinking about these credits! **NOW IS THE TIME!**

Membership tracking is quite a job and poor Sue MacPherson has to go through the work twice this year. This is a ton of paper to process and people to track. On top of that she is now working the information table from 6-7 on training nights and then volunteered to take on the publicity chair job when I begged for help. Whew – we are very lucky to have her as part of our club!

See you at training and please reach out if I can help you figure out how to earn those credits!

AWARD REQUIREMENTS

Effective January 1, 2012

To receive a club award, you must:

- have a minimum of 10 work credits for the year **and**
- be listed as a Regular or Lifetime Training Member in the roster

Each available "job" in the club has been assigned the following work credits:

ONE credit:

- Attend a membership meeting
- Steward one Kane County Fair 4-H Dog Show
- Steward one Correction Clinic
- Serve on a Committee for one year
- Work the Information Table/Front Desk for one night
- Work 1/2 day at the Obedience Trial
- Work 1/2 day at the Agility Trial
- "Substitute" as an Instructor or an Assistant on 4 nights
- Work at Mat Cleaning

TWO credits:

- Judge one Kane County Fair 4-H Dog Show
- Judge one Correction Clinic (OR the monetary compensation – NOT both)
- Evaluator for one CGC Test Serve
- Chairperson on a Committee for one year
- Serve as Kane County 4-H Coordinator for one year
- Serve as Kane County 4-H Dog Projects Superintendent for one year
- Assistant Instructor for Kane County 4-H Class for one year
- Assistant Instructor for Advanced Classes for one quarter
- Assistant Instructor for Puppy or Beginner Class for one session
- Serve as a Board Member for one year
- Work Full day at the Tracking Test
- Work Full day at the Obedience Trial
- Work Full day at the Agility Trial

THREE credits:

- Primary Instructor for 4-H Class for one year
- Primary Instructor for Advanced Classes for one quarter
- Primary Instructor for Conformation Class for one quarter
- Primary Instructor for Puppy or Beginner Class for one session
- Serve as Puppy/Beginner Class coordinator for one year

Work credits for other services to the club may be awarded by the Board on a per-event basis

RING CHANGES AHEAD!

Starting August 8th we will be using the ring layout below. The big change is that we will NOT be switching around the rings at the start of each session. After much discussion it was decided that the pros of leaving it the same out weighed the cons.

One of the major pros is that the puppy and beginner classes are right at the beginning of the aisle (much less scary for the little ones). You will note that we are also expanding the Rally time to 1.5 hours and moving the 8pm Adv Beginner class to 8:30 and giving it two rings of space. TDI Announcement

Greetings to FVDTC members and students:

FVDTC is planning to have a Therapy Dog International Evaluation on September 24th on our match night.

As you may know TDI is a non-profit organization of volunteers. Their primary objective is to provide qualified handlers and their Therapy Dogs to visit facilities and institutions where Therapy Dogs are needed.

TDI membership includes both purebred and mixed breed dogs. All dogs and handlers must be tested by a Certified TDI Evaluator, and pass a test of 13 different exercises.

Your potential therapy dog must be at least one year old, have the training level of a CGC (Canine Good Citizen) but not necessarily the CGC title. All dogs must have proof of a current Rabies certificate, which you will need for the evaluation. Your dog will be tested on a buckle collar or a training harness (both non-corrective) and a 6 foot leash. The fee for taking the test will be \$10.00/team (handler & dog).

We are planning on having a mini-seminar for anyone that is interested in learning about the Therapy Dog International testing guidelines. We hope to have a date for that sometime in August. We will post that information on the website and on Facebook.

We can only test 8 dogs. We are offering this to our club members and students on a first come first serve basis. If we have any openings as we get closer to the testing date we will open it up for the general public.

Membership Meeting Highlights May 15, 2013

Meeting brought to order at 7:30 p.m.

Carolyn Pearson (Secretary) apologized that the March Meeting minutes were NOT available for approval. Several items of correspondence were read.

Ed Herdes (First Vice-President) reported that Carolyn verified with Brian Ruppert that painting the exterior of the external equipment shed was not included in the original job. Ed stated that he would make the arrangements for the shed to be painted.

Dana Weller (Treasurer) was not in attendance due to the arrival of Declan Christopher on April 30th, however she did send the club's income/expense report through April. Additionally, she reported that Ingrid Weihe reported to her that due to some unexpected events, she requested an extension with IRS to file the club's tax returns. The tax returns will be filed by month end.

Terri Byerly (Director of Training) stated that the 4-H show offered by FVDTC is modeled using AKC regulations. Terri stated that previously the 4-H program promoted the students based on their age. She stated that she would like to incorporate Rally, as other 4-H clubs are doing. The 4-H show begins at 6:15 p.m. on June 26th and includes Showmanship (i.e. conformation) and Obedience.

Sue MacPherson (Membership Chairperson) read the names of six applicants which were published in recent Waggin' Tales. None of the applicants were present at the meeting. Sue made a motion to accept the list as read. Barb Misch seconded the motion. The list was accepted by all members present, with no one opposed or abstaining. Welcome to all new members!

Cheryl Hettinger (Annual Dinner Chairperson) stated that she will not be the Dinner Chair for next year's event and is seeking a new volunteer. Cheryl reported that volunteers for the dinner committee should include individuals who have some computer skills, who have artistic creativity. Cheryl stated that now would be a good time to revamp the dinner format. Cheryl also stated that club members should probably expect the cost of the dinner would increase.

Peggy Sue Seehafer reported that Fisherman's Inn is opening up again.

Willie Santiago (CGC Test Coordinator) reported that the next CGC Test is scheduled for Thursday, June 20th. Willie thanked John Senne and Terri Byerly for helping with the organization and communication for the test. He plans to rotate the local evaluators and their assignment dates. He stated that no tests have been scheduled beyond the June 20th test.

Barb Misch (Graduation Chairperson) reported that "all is well".

Marian Lazzara / Pat Senne / Sandi Stephenson (Match Co-Chairs). It was reported that everything is set for the May Correction Clinic.

Ingrid Hamburger (Match Steward Chairperson) reported that three stewards were still needed for the May 16th Correction Clinic.

Following a brief discussion about the responsibility for the position, Sue MacPherson volunteered to be the Publicity Chair.

Barb Misch (Scholarship) reported that the evaluations of the submitted applications will occur during the latter part of July. Last year, the evaluators took approximately one hour to review the applications. Barb stated that she would like to get the scholarship information out to more locations, such as college or scholarship fairs, and would welcome contact information from club members for local events. In response to Peggy Sue Seehafer's suggestion that Barb contact the Fox Valley Wildlife Center (FVWC), Barb stated that last year one of the evaluators was a representative from the FVWC. Additionally, she planned to speak to the 4-H participants shortly after 6:00 p.m. on May 23rd to encourage eligible 4-H students to submit an application.

David Thornell (Waggin' Tales Editor) was not in attendance, however Terri reported that the next deadline is the May 20th and submissions to be published should be sent to his direct e-mail address.

Monthly Dollar Bucket

...and the winner of \$9.00 is Nancy Pederson as drawn by club member, Nancy Einwich. The remaining \$10.00 is donated to the Tracking Test fundraising effort, and was accepted by Ingrid at the meeting. (It was the night of the Nancys.....)

Old Business

- **Awards Review**

Donna stated that the review of the present awards structure is ongoing. Once the committee has a list of recommendations, they will be presented.

- **Web Site Redesign**

Dave Lewis provided a demonstration of the password-secured Members' Only page prior to the start of tonight's meeting.

- **Contact Lists**

Donna stated that Cheryl Hettinger is collecting information looking for recommended pet sitters, dog walkers, boarding services and doggie day care facilities. The creation of this list is in response to questions that she receives at the information table from club members. This list should not be considered an endorsement by the FVDTC, rather as a service to club members from other club members.

Additionally, Terri Byerly volunteered to collect and compile a list of behaviorists based on club member recommendations. Once compiled, she will send the list to Donna Bihner. Peggy Sue Seehafer stated that she would not necessarily limit the contacts to only local individuals, as the individual that she would recommend is in Wisconsin and well worth the time necessary to drive.

- **Membership Dues Change**

Donna reminded that club members that we are in the process of changing the membership dates and the fee structure. In order to encourage our club members to offer a little more volunteerism, those club members who earn three work credits during 2013, will pay the same annual dues for 2014 as they do currently. Those who do not earn three work credits will pay \$180.00 for their 2014 dues. In response to Steve Timm's question, Donna stated that a list of the available volunteer opportunities published in each Waggin' Tales and a list of the work credits associated to the opportunities on the club's website on the Member's Only web page.

Peggy Sue Seehafer made a motion to accept the Proposed Membership Dues, as presented in the April, 2013 Waggin' Tales. Cheryl Hettinger seconded the motion. The motion was accepted by members present, with two opposed and no one abstaining.

New Business

- **Formatting of Waggin' Tales Items**

Francene Andresen expressed concern that the formatting of an item published in the April Waggin' Tales was too similar to a 'business card', rather than an informational news item. It was agreed that items, in the future, would be carefully reviewed to avoid the impression that we are providing free advertising for local businesses.

- **Places for Therapy Dogs to Visit**

In response to Cheryl Hettinger's question, Wendy Waddick volunteered to create and maintain a list of places that need and/or want therapy dogs. It was agreed that the club would be providing a valuable service to the local dog owner's community by hosting a therapy dog testing test and should pursue doing so.

A motion was made, seconded and approved to adjourn the meeting at 9:08 p.m.

Board Meeting Highlights June 19, 2013

Meeting brought to order at 7:32 p.m.

Carolyn Pearson (Secretary) the April Meeting minutes were approved as read.

Ed Herdes (First Vice-President) reported that the external equipment shed has been painted. Donna and Carolyn stated that "it looks great!" Terri also said that it looked great! Ed stated that he still plans to review the equipment that remains in the shed to determine what is excess and can be offered for sale. Will Short stated that the following equipment was required to host our annual obedience and rally trials.

- 3 bar jumps,
- 4 broad jumps,
- 6 high jumps

Wendy Waddick (Second Vice-President) reported that she is still confirming future membership meeting program speakers. Possible speakers are Bill McGuffy, who does the airbrush painted awards; a speaker to discuss the properties and uses of essential oils; a veterinarian to discuss first aid for dogs.

Additionally, Wendy stated that she has not been contacted by the TDI evaluator she contacted to possibly set a date. Wendy also stated that the evaluator for Pet Partners (formerly Delta Society) stated that she can evaluate three or four dogs in an hour and is available to perform the test at 6:00 p.m. or at 9:00 p.m. when ring space is available. Additionally, she would be willing to schedule multiple dates if there are more than four teams signed up for the test.

Dana Weller (Treasurer) was not in attendance, but provided the income and expense report as of June 15, 2013 for distribution at the meeting.

Terri Byerly (Director of Training) was not in attendance but sent the following report. There is a need for an Assistant instructor for 6:00 p.m. Beginners class which begins on August 8th. The 4-H show is scheduled for Wednesday, June 26th. Nancy Pederson reported that the club's website and the Facebook page was updated to announce that the 6:00 p.m. Beginner's class will resume. Additionally, Nancy stated that she already has students signed up for the 6:00 p.m. and 7:00 p.m. Beginner's classes which begin on August 8th.

Additionally, Terri stated that more instructors are needed for the Conformation ring. Currently the following instructors rotating in the ring: Penny Brcich, Terri Byerly, Will Short, Sandi Stephenson and Jan Winters.

Terri reported that she was working with Carolyn to get the rings and classes identified on the layouts.

Will Short (Obedience Trial Chairperson) reported that he has received verbal confirmations from the 2014 and the 2015 Judges for the Pre-Novice, Pre-Open and Pre-Utility class assignments.

Old Business

- **Web Site Redesign**

Dave Lewis was not in attendance, but sent the following report: The Member's Only page to enable club members to update their member information, such as phone numbers, e-mail address, or dog breeds is just about done. Once that is complete, he will work on the reports, which he feels are pretty straightforward.

- **Awards Review**

Donna presented a list of the recommendations that the Awards Review committee provided. The committee members were: Donna Bihner, Cathy Fleury, Ingrid Hamburger and Will Short. This ad-hoc committee was convened as a result of a motion made during the March 20th Membership Meeting. The committee reviewed the current awards offered and the list of AKC titles that can now be earned. Previously, the Champion Tracker (CT) was not offered as a separate award due to the fact that it was a prefix title assigned by AKC after the dog has earned all three tracking titles (TD, TDX and VST). However, now the CT will be added to list of awards at "AKC Level 6" on the awards application. The club member will then choose between that level or the level of the third tracking title earned (either the TDX, Level 4, or the VST, Level 5).

Additionally, the cost of the awards will be reviewed and adjusted to even out the cost of the awards. It was recommended that we offer the Full Body Airbrushed portrait at only Level 6 (not Level 5), offer the Dog Head Airbrushed at Level 5 (not Level 4) and attempt to determine whether a different and less costly airbrushed option can be offered at Level 4.

It was also clarified that for titles which can be earned multiple times, (i.e. the UDX) and is followed by a number (i.e. UDX2, UDX3) the club member could submit an award application for the dog's new title.

The Awards Committee is currently reviewing these changes and exploring the addition of other awards to the current list.

- **Handicapped Parking**

To eliminate any ambiguity about where the handicapped parking is, Sue will make signs to post at training that state "Handicapped Parking is Between the Two Signs". The consensus of the Board was that although the "signs in a bucket" are moveable, they rarely do move away from the orange blockades. Ed stated that this was to ensure that the signs remained upright during high winds.

New Business

- **9:00 p.m. Beginner's Class**

The elimination of the 9:00 p.m. Beginner's Class was brought up. It was confirmed with Ed (the usual 9:00 p.m. instructor) that he was still willing and able to instruct during that time and that he would have assistants. During the discussion, the following guidelines were suggested to help Nancy Pederson (class registrar) determine whether the class would be conducted.

- There must be a minimum of five students.
- The deadline to CANCEL the class would be prior to Week 2, since Week 1 is only discussion.
- On initial contact, potential 9:00 p.m. students would be notified that the class could possibly be cancelled if the minimum number of 5 is not met. However they would have the following options: move to another Beginner's class that had a spot open due to a cancellation (if available) or wait until the next session starts and get first dibs on the time.
- During the week that the class is scheduled to begin, Nancy will again notify the potential students of the number of students signed up and whether the class is at risk for cancellation.

- **Mats**

In response to Donna's request, Ed stated that he would review the readiness of the mats on the day of training, to verify that they are flat enough not to cause a hazard to students, club members and dogs.

A motion was made, seconded and approved to adjourn the meeting at 8:35 p.m.

***Board Meeting Highlights July
18, 2013***

Meeting brought to order at 7:37 p.m.

Carolyn Pearson (Secretary). The April Meeting minutes were approved as published.

Ed Herdes (First Vice-President) stated that according to the fairgrounds there are plans to modify the current parking lot. The current plan is to pave the grassy area in front of the door, and possibly install permanently identified handicapped parking.

Wendy Waddick (Second Vice-President) reported that Jan Winters is currently working with a TDI evaluator to perform a test at an upcoming correction clinic. After discussing the pros and cons of hosting the test on one of the remaining correction clinic nights, it was decided that the test should be scheduled for the correction clinic on Tuesday, September 24th.

Additionally, Wendy continues to work with an evaluator from Pet Partners to schedule a date for their test. She also announced that anyone who is interested in becoming a Pet Partners therapy dog must complete an online test prior to their test.

Dana Weller (Treasurer) reported that Ingrid Weihe has recently filed the taxes. Dana also distributed the most current financial report for review.

Terri Byerly (Director of Training) reported that she and several others reviewed the current ring set-up and the session-by-session rotation of the classes. As result, the ring set-up has been revised and there will no longer be classes moved around each session. It was hoped that this would alleviate confusion by our students and club members. The revised ring set-up was discussed, modified and finalized by the Board members.

Terri also reported that instructors will no longer need to sign in when teaching. It was originally thought to be used by the Statistician for record keeping, but was not effective due to the lack of regular participation by the instructors.

Will Short (Obedience Trial Chairperson) reported that he has signed contracts for all judges for the 2015 Obedience and Rally Trials and one contract for the 2016 trials. Also discussed the possibility of using the signmeup.com web site to allow stewards for the trials to sign-up to work. Cathy Fleury stated that based on her experience using it for the Agility trials, it is an easy tool to use. Donna stated that she paid the \$3.00 fee to enable the club to eliminate the various online advertisements from displaying.

Ingrid Hamburger (Tracking Test Chairperson) reported that she bought a supply of new plaques for those exhibitors who earn their TD titles at our annual Tracking Test.

Cathy Fleury (Agility Trial Chairperson) reported that she will confirm that the recently mailed order for ribbons sent to Kathy Jenkins has been received and processed. The order included ribbons for the next Agility Trial as well as for the

Obedience and Rally trials. Cathy stated that although she placed the order for the Obedience and Rally trials, the remainder of the process will be handled by Brenda Rivera.

In response to Will's question about the running order for the September 14th and 15th trials, she stated that issues which occurred at the Spring Agility Trial should not occur in the future. **Old Business**

- **Awards Review**

Donna stated that the review of the present award continues. The Awards Committee continues to explore the addition of other awards to the current list.

- **Web Site Redesign**

Dave stated that he has the majority of the Member's Only web page completed, and ready for testing. The membership specific information will be tested by Sue MacPherson, so "we're waiting on Sue"..... 😊

- **Anderson Animal Shelter Collaboration**

The Anderson Animal Shelter has sent a letter to the club seeking a possible partnership with us. Terri and Donna will contact the shelter for more information to be discussed at the August 21st FVDTC Board meeting.

New Business

- **A/C Policy Revision**

Donna stated that a slight revision to the a/c policy was made. Previously the time of day was designated as Noon, it has been modified to be at 2:00 p.m.

When the temperature on the day of training is 85 degrees or more at 2:00 p.m. in St. Charles, the President, the DOT or another designated Board Member would contact the Kane County Fairgrounds to turn on the air conditioning.

- **Work Credits and Membership Dues**

Donna stated that she was approached by a club member who was concerned about their physical ability to perform the three work credits necessary to maintain a \$90.00 membership due fee. After much discussion, the Board reached a consensus that the 3-credit requirement is reasonable for anybody active enough to be training. Attending a membership meeting achieves 1 credit, and many other activities require little or no physical effort. Anyone with a concern about how they might be able to volunteer is encouraged to contact any of the committee chairs to learn of those opportunities. For example, each ring must have a Table Steward at our Correction Clinics. That position does not require much movement and can be performed without strenuous activity. The consensus of the Board was that all club members were valuable volunteers and any limitations can be addressed.

A motion was made, seconded and approved to adjourn the meeting at 8:58 p.m.

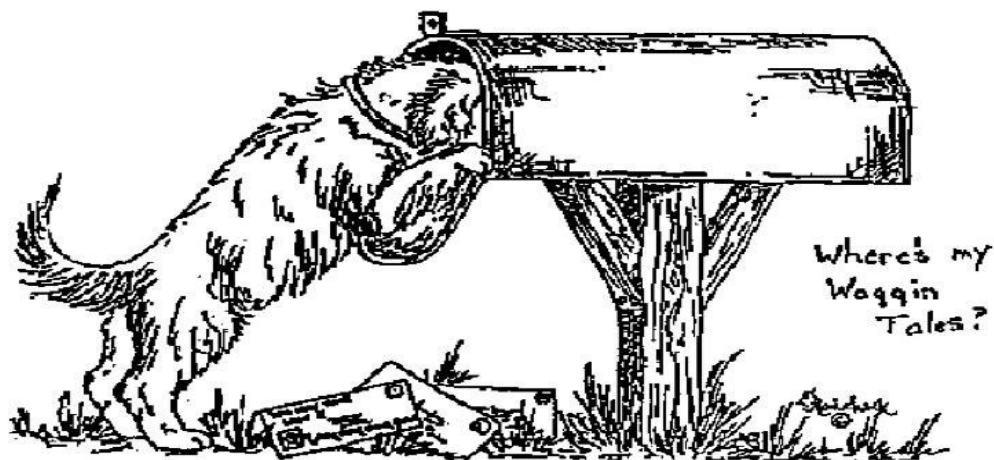
