So after that big description - and just to entice you – here are a few pictures of awards given out this year. I hope it inspires you to both volunteer and to earn those titles!






Award recipients have many items from which to choose. There are seven levels of awards based on the levels of titles awarded by AKC.

#### Membership Meeting Highlights May 14, 2014

Meeting brought to order at 7:54 p.m. following the interesting presentation by Dominick and Sandy Davero, from Country Financial, about the Trupanion pet insurance.

Carolyn Pearson (Secretary). The March Meeting minutes were approved as published. Several items of correspondence were read.

Wendy Waddick (Second Vice-President) stated that she currently has the following programs scheduled for our remaining 2014 membership meetings.

- Ask a Judge The concept would be to have a panel of our own FV judges representing the various
  performance events (Obedience, Conformation, Rally and Agility) available to answer club members questions.
  Wendy stated that this program is currently scheduled for the September 17th Membership Meeting.
- Canine Eyes The specific topic for the October 15<sup>th</sup> Membership Meeting is still to be determined.

Will Short (Director of Training) reported that he needs conformation instructors for the following dates in June: 5<sup>th</sup>, 12<sup>th</sup>.and 26<sup>th</sup>.

Additionally, Donna announced that we will be hosting two conformation mini-workshops at the training building. The first one is scheduled for June 19<sup>th</sup> (the night of the June Sanctioned Match/Correction Clinic) and again on August 21<sup>st</sup>. The working seminars are being conducted by Cheryl Petersen, UKC conformation judge and retired AKC conformation judge for \$30.00 per person. They are scheduled to be start at 7:30 p.m. and end at 9:00 p.m. and are limited to a maximum of 15 working teams. It was reported that AKC is accepting applications for the four new therapy dog titles will be accepted beginning June 1st, with titles awarded beginning July 1st. The following are the five levels of titles available.

- o AKC Therapy Dog Novice (ThDN) Awarded after 10 visits
- AKC Therapy Dog (ThD) Awarded after 50 visits (currently awarded)
- o AKC Therapy Dog Advanced (ThDA) Awarded after 100 visits
- AKC Therapy Dog Excellent (ThDX) Awarded after 200 visits
- AKC Therapy Dog Novice (ThDD) Awarded after 400 visits

Cheryl Hettinger reported that she will schedule a couple of dates in the near future for club member who are interested in volunteering to work at the front table to learn the job. A motion was made, seconded and approved to adjourn the meeting at 8:50 p.m.


### **HUMANEWATCH.ORG**

According to their information, only 1% of the HSUS budget goes to local shelters. According to its 2011 tax return, HSUS only shared about one-quarter of one percent (0.24%) of its <u>total</u> budget as grants to support pet sheltering that year. According to their records, the state of Illinois receives 0.0051% of the HSUS budget, that is between \$5,001 and \$10,000.
