I have received several requests for Registered Therapy Dog Teams.

The first request is for Therapy Dog Teams to visit in a senior residential center located in St Charles. Halina is a small senior residential home that is looking for registered Therapy Dog Teams to visit the seniors that reside there, they have two locations in the St Charles area.

The second request is from a Reading Specialist in the District 301 school system.

We need Therapy Dog Teams for their "Reading With Rover Program". This is a great program where children with reading difficulties come and read to a dog, which is a non-judgmental reading partner. This helps children get excited about reading and has shown to improve their reading skills and enjoyment of reading.

All teams MUST be registered Therapy Dog Teams, no exceptions. You will need to provide proof of current vaccines and registration with a Therapy Dog organization such as TDI or Pet Partners. We need 4 Teams to cover each school that will be participating in this Read program.

This is a pilot program within this district and will start with one school this January and expand to three additional schools in the Spring. The first school will be Country Trails in Elgin, which will take place in January during morning school hours. The other schools that will join this program are Lily Lake, Prairie View and Howard B Thomas.

### MEMBERSHIP MEETING HIGHLIGHTS - OCTOBER 15, 2014

Meeting brought to order at 7:44 p.m. Donna thanked Wendy Waddick for organizing the VERY informative "Ask the Judge" program and also Rick Cox and Loretta Lazzara for imparting such excellent information. Additionally, everyone who competed in AKC Obedience trials was encouraged to review and provide feedback to the AKC for the proposed changes. In response to Rick's statement about the lack of ease of locating the feedback website, Dave Lewis stated that he would put the link on the club's website.

**Carolyn Pearson (Secretary)**. The September Meeting minutes were approved as published. Several items of correspondence were read.

Wendy Waddick (Second Vice-President) reported that the upcoming program on November 19th will be Dr. Annora Gaerig, DVM from Eye Care for Animals in St Charles discussing eye health for dogs.

Will Short (Director of Training) reported that there are four students currently enrolled in the Junior Beginner's class, with a possibility of two more. Will stated that regardless of how many students were enrolled, the class will be held. It was reported that a student may participate at the 4-H show, if they take the Junior Beginner's class but do not participate in the 4-H class.

It was reported that the 6:00 p.m., 7:00 p.m. and 8:00 p.m. Beginner's classes were full. There were four students signed up for the 9:00 p.m. Beginner's class, with more than two weeks left before the October 30th start date. There were currently three students enrolled in the 7:00 p.m. Puppy class.

## MEMBERSHIP MEETING HIGHLIGHTS - NOVEMBER 19, 2014

Meeting brought to order at 7:55 p.m. following a VERY informative program by Dr. Annora Gaerig, DVM from Eye Care for Animals in St Charles discussing eye health for dogs.

Carolyn Pearson (Secretary) reported that the October meeting minutes could not be approved because they were not yet published in the Waggin' Tales. They will be published in the November Waggin' Tales for review/approval at the January membership meeting.

Ed Herdes (First Vice-President) thanked everyone for helping at the trial.

**Donna thanked Wendy Waddick (Second Vice-President)** for the fantastic final 2014 program.

**Dana Weller (Treasurer)** was not in attendance, however Donna reported that Dana will work on the final numbers for the year once the monies from the Obedience trial have been received.

Will Short (Director of Training) announced that a new Advanced Puppy class will begin in 2015, with Penny Brcich as the primary instructor. Additionally, Will is seeking at least one Assistance Instructor, preferably two, for the 8:00 p.m. class. The class goal is to enable the puppy students to continue, without going into the Beginner class and repeating many of the same exercises/concepts that they learned in their Puppy class. At the completion of this class, it is expected that those students will be able to start in an Advanced Beginner class. Students for this eight-week class must register with the Nancy Pederson, Class Registrar.

Cindy Pakenas (Obedience Trial Chairperson) was not in attendance, but reported that the FVDTC's 64thand 65th Obedience Trials and 8th and 9th Rally Trials are now history. Cindy thanked Donna Bihner and Nancy Pederson for preserving these memories and posting them on Facebook. She encouraged everyone to take a look and enjoy! She acknowledged the hard work of the committee chairs: Cathy Fleury, Loretta Lazzara, Ed Herdes, Barb Misch, Nancy Pederson, Vicki Wilder, Jan Winters, Carolyn Pearson, Pat Senne, Brenda Rivera, Penny Brcich, Mary Bradley and Bob Olson, trial secretary, nothing would have happened. The running of the November 15th and 16th trials would not have happened without the many members who volunteered. Behind the scenes, but always there, both during the weeks before the trial and that weekend was Cheryl Hettinger. Providing the national anthem and boombox was Marian Lazzara. Cindy offered a special thank you to Carolyn Pearson and Will Short for answering her many questions and always being there.

On Saturday, there were 112 dogs in the obedience trial and 42 dogs in the rally trial, with 141 obedience entries and 56 rally entries, for a total of 197 entries. On Sunday, there were 112 dogs in the obedience trial and 39 dogs in the rally trial, with 142 obedience entries and 50 rally entries for a total of 192 entries. With a significant number of entries absent, the classes ran quickly with the Novice Optional Titling and Utility A classes finishing last. Our judges: Diane Propst, Randy Capsel, Donna Darland, Rick Cox, and Sandy Forneris ran efficient, exhibitor-friendly rings.

Congratulations to Wendy Kraska and Sally Boeke who were the winners of the Workers Raffle.

All of us enjoyed the delicious food prepared by Barbara Palm and the members who generously donated desserts. Cindy

stated that she felt privileged to have been a part of this endeavor which so many of you made happen.

Donna also extended a huge thank you to all volunteers who worked and to Cindy for a great job of coordination. Donna stated that throughout the weekend, she received many compliments about the setting, the relaxed atmosphere and cheering and encouragement offered to the exhibitors.

Additionally special thanks goes to 'tailor' Dave Waddick for stitching a fabric covering for the "window which must remain open". In the past, the window was covered by paper that often rattled in the wind. Wendy stated that she took the covering home, but would bring it back to put in one of the Obedience Trial storage containers for future shows.

Candy Ellis stated that she heard many compliments for offering free coffee and sweets to all exhibitors.

Carolyn stated Cindy has already begun plans for the 2015 obedience trial. One of the ideas being discussed is to offer the exhibitors the opportunity to rent ring time following the trial on Saturday. Volunteers will be needed to coordinate the event as well as be there during that time. Details must be worked out and will be communicated. Another possible change is to which Utility class will be in which ring. It was suggested that the Utility B ring be in the ring on the east side of the building and the Utility A ring be on the west side of the building.

**Sue MacPherson (Membership Chairperson)** read a list of eight applicants who were published in the Waggin' Tales. One of the applicants, Jennifer Cornele, was present at the meeting. Sue MacPherson made motion to accept the list as published and read. Will Short seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to all new members!!!!

**Ingrid Hamburger (Tracking Test Chairperson)** reported that judges for the 2015 Tracking Tests have been confirmed. She stated that it was a little more challenging due to the test being scheduled for Labor Day weekend.

David Lewis (Director at Large) reported that for the last 30 days, the web site has had 4,087 page views distributed over 1,157 sessions. Which means that individuals visited the web site on 1,157 separate occasions, and — on the average — viewed between 3 and 4 pages each time. Approximately half of the time, the club was found by using a search engine like Google, Bing, or Yahoo, using terms such as "Fox Valley Dog Training Club" or "FVDTC". However, that does indicate that more generic "dog training" searches are not as effective in locating our web site.

Additionally, Facebook has been active. There were 1,200 people "engaged", which means that 1,200 people "liked", commented, shared or clicked on posts or pictures. As expected, there was a huge spike during the trials last weekend.

Dave also stated that unfortunately we have not been as successful at engaging our own membership in the "Members Only" area of the web site. Presently, only 59 out of 263 current members have created a userid and logged in. Instructions for creating a userid and password were published in the October Waggin' Tales. If after attempting to follow the instructions, there are still problems, PLEASE contact Dave Lewis at

woofmaster@FVDTC.ORG. The information on the Member's Only page is secured and very informative for members.

**Candy Ellis (Annual Dinner Chairperson)** reported that the Annual Dinner committee will meet in January or early February.

**Pat Senne (Match Co-Chair)** reported that the final match for the 2014 was held on November 13th. Donna volunteered to send out reminders in the future to individuals who have volunteered to help. Pat stated that she and the committee will draft a brief form letter for Donna to use.

**David Lewis (Waggin' Tales Editor)** reported that the next deadline is either November 20th or November 23rd (depending on who you ask).


