2015 Obedience/Rally Trials

The weekend of November 14th & 15th brings Fox Valley Dog Training Club's 65th & 66th obedience trials and the 10th & 11th rally trials to life! The premium is available both online on the website and in hard copy in the red box at training. Holly Cass and Wendy Waddick have worked hard to provide new awards ribbons. REALLY special are the new title ribbons. Vicki Wilder and Jan Winters are furiously at work procuring raffle items. Please support our trials by donating to the raffle; announcements about where to bring donated items will be on Facebook, Constant Contact, and our website. Donna Bihner has set up an online volunteer sign-up which includes stewards, kitchen workers, and set-up and clean-up. This will be one of your last opportunities to earn work credits for the year.

New this year is an opportunity to get in some extra practice after the trial on Saturday. Exhibitors may sign-up to train in one ring for 8 minutes for a fee of \$10. Ring sign-up begins at 10:00am on Saturday morning at the front table. Exhibitors must sign-up in person and pay at that time. Each exhibitor may use the ring of their choice once for each dog entered in the trial. An open ring, utility A or B ring, and a novice ring will be available. Entries will close when a total of 18 dogs per ring has been reached.

Also new this year will be an opportunity to take a selfie of you and your dog on Sunday. You may choose to have a friend photograph you as well. There will be a backdrop set up where the raffle tables were on Saturday. Since judging will be going at this time, please do not use flashes, squeaky toys, etc. which might distract dogs working in the rings.

Volunteers and judges will be enjoying delicious snacks and lunch. Sue MacPherson will be in charge of supplying us with these tasty delights. She still needs volunteers to assist her in this endeavor. Working in the kitchen is an all day work credit commitment. Donations of desserts would be very much appreciated. Desserts may be dropped off in the kitchen on Friday evening between 6:30 - 7:30pm and Saturday or Sunday morning.

Your support and efforts are necessary to make these trials a success. As always your time and effort are very much appreciated. Please join us and enjoy a day with the dogs and their people.

Membership Meeting Minutes

September 16, 2015

Meeting brought to order at 7:50 p.m. following a program by Dr. Kimberly Hsu, from Eye Care for Animals, as a follow-up to the program presented on November 19, 2014, by Dr. Annora Sheehan Gaerig.

Carolyn Pearson (Secretary). The July 15th Meeting minutes were approved as published. Several items of correspondence were read.

Ed Herdes (First Vice-President) reported that volunteers and equipment are needed for the annual mat cleaning event scheduled for MONDAY, September 28th. The equipment needed are leaf blowers, fans and ESPECIALLY power washers. Anyone wishing to volunteer should contact Ed at training or vp1@fvdtc.org. Volunteers who work during the entire event can earn 2 work credits.

Wendy Waddick (Second Vice-President) reported that the next and final 2015 program will be our very own Loretta Lazzara providing information about the new AKC obedience rules which will go into effect on December 1st.

Phil Nuger (Treasurer) was not in attendance, however he provided the income statement as of August 31, the account balances as of September 15th, and the estimated income and expenses for the March and September 2015 Agility trials. There are some deposits, refunds and other expenses which have not been fully accounted or reconciled and the income statement does not include the July and August Puppy and Beginner class registration, tracking test and correction clinic monies.

Will Short (Director of Training) thanked ALL past and present primary and assistant instructors for their hard work. Will also stated that he is seeking volunteers to instruct the Conformation class for November and December. Will reported he is currently verifying instructors for the final 2015 session of Puppy and Beginner classes.

Will stated that when not training your dog, they should be kept safe by either crating them or putting them back in your vehicle. Will reminded all trainers that they should keep their dogs close and be watchful of other dogs who attempt to get in your dogs' space. For example, if your dog is being approached by another dog that does not appear to be under handler control, use the opportunity to kindly educate the person about dog to dog interactions. Carolyn stated that using a pleasant tone of voice will likely get your point across better than a harsh one. As a club, we are attempting to educate all dog owners how to make our dogs a positive addition to the community, rather than a dog that isn't welcome anywhere.

Cindy Pakenas (Obedience Trial Chairperson) reported that the premium list is available and ready for distribution. She asked that any club member who visits other local training facilities to bring some premiums lists with them. Carolyn stated that club member, Donna Stahelin, recently passed away, therefore should be included in the "Trial Dedicated in Memory of...." portion of the catalog.

Unfortunately, the four TDX teams took the brunt of the heat and were not successful. Sadly, two of the four teams made it to the last corner and then went off track. Ingrid extended a "big, big Thank You" to all of the helpers: Judges, track layers, cross track walkers, drivers, hostess and everyone else involved. As always everyone involved did a great job! Additionally, Ingrid offered a special "Thank You" to all of the entrants and their dogs. Although everyone would have enjoyed a cooler day, in tracking you never know what we will get weather-wise.

Barb Runkle (Public Education Coordinator) reported that she still needs volunteers to participate at the Chicagoland Pet Show at the fairgrounds on November 7th and 8th. Anyone wishing to volunteer can contact her at training or at education@fvdtc.org.

Cathy Fleury (Agility Trial Chairperson) was not in attendance, however she did report that the Fall Agility Trial was a success! There were no major issues or complaints.
