## **Board Meeting Highlights** - December 09, 2015

Meeting brought to order at 7:45 p.m. by Wendy Waddick. President, Donna Bihner, is recovering from recent surgery.

**Carolyn Pearson (Secretary)**. The October 21st Meeting minutes were approved as published.

**Ed Herdes (First Vice-President)** stated that the main doors to the training building are scheduled to be replaced this week. Unless otherwise told by the fairgrounds, he is assuming that our keys will continue to function.

**Phil Nuger (Treasurer)** presented the year-to-date income comparison statement for review. Phil reported that our Beginner's class income is approximately \$5,000.00 less than the end of last year. Phil also reported that our Puppy class income is approximately \$1,000.00 less than the end of last year. However, there is still an unknown amount of income to be recorded for some of those classes. At this time we are showing a decrease of approximately \$12,000 in our accounts.

Phil reported that he did look into the functionality of QuickBooks on-line, and recommended that the club begin using the "simple start" version. According to Phil's review, there would be some work to convert the club's Quicken based files to QuickBooks, however, it is not considered prohibitive. Additionally, Phil will review the Zoho application and provide a side-by-side comparison to the Board.

In response to Carolyn's question about whether the club will continue to offer the Junior Beginner class in 2016, Will Short (Director of Training) stated that it will continue to be offered in Sessions 1, 4 and 5. However at this time, there are no students signed up for Session 1. Additionally, Nancy Pederson reported that we haven't had any interest the last two sessions of 2015.

**Barb Runkle (Public Education Coordinator)** was in attendance, and reported that our participation in the Chicago Pet Show was very successful and generated a lot of interest in the club. Barb stated that next year the event will be on November 12 and 13th and she

will again need to use ten mats for our demonstrations. She thanked the following individuals for all of their assistance.

**Cindy Pakenas (Obedience Trial Chairperson)** was in attendance and offered thanks to EVERYONE who worked so hard to put on the 2015 Obedience and Rally trials! She also stated that using the on-line signup for stewards this year worked very well.

**Cathy Fleury (Agility Trial Chairperson)** was unable to attend, and did not send a report. Additionally, Will asked whether the on-line sign-up for the Agility trials could be opened up to club members prior to announcing it to the general public. Cindy Pakenas stated that she had no problems signing up to work at the Fall 2015 trial, after the sign-up was opened up to the general public. Carolyn stated that she would contact Cathy to determine whether that is already the current process of the Agility Trial committee.

**Dave Lewis (Director at Large)** reported that the new on-line Work Credit tracking process for club members is now available in the Members Only section of the website. He stated that there are some minor updates that need to be made to the look of the page. The formal rollout will be announced following more testing and review.

The next priority of web site functionality upgrades is to be determined; the options are to provide on-line awards submission or on-line class registration. Dave stated that he has not had a chance to review the functionality offered by DogBizPro software for on-line class registration.

• Obedience Trial Jumps – Ingrid Hamburger

reported that several participants in the Obedience trial expressed concern about the condition of the jumps. However, she was unable to provide specific details about which jumps had issues. During the discussion, it was determined that the peg that had been previously replaced (from the steel one provided, to a fiberglass), should be looked at and possibly replaced with another metal one. Ed Herdes and Carolyn confirmed that the remaining jumps were in very good condition and did not require replacement. Although, it was agreed that they could probably be repainted.  "Fun" Classes - Sue MacPherson stated that she recently heard about a class in Elgin to teach "tricks" to dogs. She suggested that it might be something to look into as a way of increasing revenue, such as hosting other types of classes, such as "tricks", nose work or dance. The classes would be something that community members might consider fun. Dave stated that he will put a survey question on our website to assist in determining whether there is interest.

A motion was made, seconded and approved to adjourn the meeting at 9:07 p.m.
