Membership Meeting Highlights - September 20, 2017

Meeting brought to order at 7:45 p.m.

Carolyn Pearson (Secretary). The July Meeting minutes were approved as published. Several items of correspondence were read.

Ed Herdes (First Vice-President) reminded everyone that volunteers are always needed and welcome for the annual Mat Cleaning, which is scheduled for this

Saturday, starting at 8:30 a.m.! Wendy thanked Ed for the all the work he has done recently re-painting all of the jumps, the ring gates and the stanchions.

Will Short (Director of Training) reported that all classes until year end (registered and drop-in, including conformation) have instructors scheduled.

Nancy Pederson was not in attendance, but reported

that we have held quite a few successful short term workshops this year including: Tricks, CGC Prep, How to Get Started in Rally, Introduction to the new Rally signs and classes.

Most of the Rally workshops have been free to members to encourage newer handlers to exhibit in Rally at trials. Other workshops have charged fees. The type of workshop determines the fee charged.

Nancy also reported that when a new workshop is scheduled, it is announced as a posting on our Facebook page and on the Home Page of our web site, and through flyers available at training.

She asked that members who have an idea for a future workshop topic should contact her (workshops@fvdtc.org or at training) or Will Short to share their ideas.

Additionally, Wendy thanked Loretta Lazzara for hosting the New Signs in Rally workshop on September 19th. Wendy stated that she has received a lot positive feedback.

As a result of Candy Ellis' (Co-Assistant Director of Training) question about dog safety when the large overhead door is open, it was agreed that we would put ring gates in front of the opening, to prevent any dog from exiting the building.

Additionally, two dogs earned their TDX titles. Our judges were Lois Leidahl-Marsh and Eibhlin Glennon, who worked very hard to plot all the tracks. Ingrid stated that she cannot thank our helpers enough for their hard work and included tracklayers, cross track layers, and drivers who moved everyone to and from their tracks. Ingrid thanked everyone who helped during the two very long days; with some starting at 7:30 a.m. on Saturday and not leaving until 6:00 p.m. Sunday, workers arrived at 5:45 a.m. and left around 2:00 p.m. There was an extensive construction site in the Forest Preserve that needed to be avoided which complicated things quite a bit.

Viv Hildebrand, Tracking Test Hostess, was a great help again. Sylvia Schultz prepared extremely tasty pulled pork that was accompanied by salads, deserts, fruits and refreshments to keep everyone nourished. As she did last year, Barb Palm provided a very special breakfast on Saturday and Sunday.
