I want to start this month's note by thanking everyone that helped at our recent Canine Good Citizen Test. Thank you Terri Vaira, our CGC judge this month. She did a great job, making sure things ran smoothly with the large group of teams that participated. Also, thank you to Cris Ballenger who organizes all our CGC Tests. Cris also had a great group of volunteers who helped this month.

There were 13 teams that tested and 10 passed. Congratulations to all our new CGC Teams and thank you to all who helped!

As we get closer to the end of Summer, and the beginning of Fall, it starts to get busy with events at FVDTC. The first event will be our annual Tracking Test, which will take place on September 9th at Burnidge Forest Preserve in Elgin. For more information, contact our Tracking Chair, Ingrid Hamburger. Soon after the Tracking Test comes our Fall Agility Trials, which will be held on September 15th & 16th at Car-Dun-Al in Huntley. Cathy Fleury is our Agility Chair. The premium list and worker signup will be available soon.

Next comes our OFA Eye Exam, on the evening of October 4<sup>th</sup>, at the fairgrounds during regular training. The exam will be performed by Dr Denise M. Lindley of Animal Eye Consultants. This is the 3rd year Dr. Lindley has offered these exams. This is a fantastic opportunity to get your dog's annual eye exam at a greatly reduced price of only \$35 per dog. You must reserve your spot ahead of time, so please don't delay. Send your payment to me, with checks made payable to FVDTC, to reserve your spot. The earlier you get your payment to me the better chance you have of getting the time slot you want. I also need to make sure we have enough dogs that want to participate to ensure we can still hold this event. So, please don't delay if you want a spot!

We will be offering something new at FVDTC. On Tuesday October 9th , we will be doing a special blood

draw clinic to test for Taurine Deficiencies. This deficiency can cause Taurine-Deficiency Dilated Cardiomyopathy, which is a serious heart disorder.

Golden Retrievers have been hit especially hard by this, but it can affect other breeds, too. The blood samples will be sent overnight to UC Davis, which is studying Taurine Deficiencies in dogs. The cost of the test is set by UC

Davis at \$76 per dog. There will also be a small cost for the blood draw itself, most likely about \$10 and, of course, the overnight shipping will cost, too. We will have a veterinarian doing the blood draws. More information on this clinic will be available soon; check our website for full details soon. Plus, If any dog does test deficient for Taurine it can then take advantage of our Heart Clinic and have a full echocardiogram to make sure there are no problems with your dogs heart due to this deficiency. Our Heart Clinic will be held in conjunction with our Fall Obedience and Rally Trial on November 17th. Signup for our Heart Clinic is now available, please contact Nancy Lee for more information and to sign up. The cost is \$250 per dog.

One last thing: don't forget about completing this year's Work Credits, please don't wait till the end of the year. Candy doesn't need that many people helping her at the Christmas Party! You only need 3 Work Credits to get your annual dues reduced by half and you need only 10 work credits to be eligible for a volunteer or new title award. If you are unsure how you can volunteer contact any Committee Chair.

# **FVDTC Heart Clinic**

Fox Valley Dog Training Club is hosting a heart clinic in conjunction with our fall obedience and rally trials.

DR. HEIDI KELLIHAN DVM, DACVIM a Clinical Associate Professor of Cardiology, Board Certified Cardiologist at the University of Wisconsin -Madison will be performing the exams.

Dr. Kellihan will be offering the following heart exams:

- AN AUSCULTATIONS EXAM ALONG WITH A DOPPLER ECHOCARDIOGRAM, which is an Ultrasound of your dog's heart
- · AUSCULTATIONS EXAM, which is listening to your dogs heart

WHEN: In conjunction with our trial on Saturday November 17, 2018 from 8:00 am through 3:00 pm

WHERE: At our trial site at the Kane County Fairgrounds

**COSTS:** Echocardiogram exam, which includes an auscultation exam \$250.00 per dog Auscultation exam only \$50.00 per dog. This is a great opportunity at a greatly reduced costs!

## **Board Meeting Highlights - August 15, 2018**

Meeting brought to order at 7:43 p.m.

**Carolyn Pearson (Secretary)**. The June Meeting minutes were not available for approval. Several items of correspondence were read.

**Ed Herdes (First Vice-President)** reported that there are no weekends available at the fairgrounds to schedule our annual mat cleaning. Ed stated that he will consult with the fairgrounds to determine a date (probably on a Monday) and will announce it when able. Additionally, in response to Carolyn's question, he will ask the fairgrounds whether the southwest doors are scheduled to be replaced. Those doors are in ring that the Open A / Utility A classes are held.

**Peggy Sue Seehafer (Second Vice-President)** reported that the speaker for the November meeting will be Dr. Jennifer Wahlund with Peaceful Endings for Pets, an in-home euthanasia service.

**Phil Nuger (Treasurer)** was not in attendance, however he reported that the club is a couple of thousand dollars ahead of last year's pace, notwithstanding some delayed expense reimbursement requests. Additionally, the Morgan Stanley account as of July 31st showed an approximately \$5,000 increase in value over 2017, which has not been booked or realized this year in the financials. Additionally, he submitted the Statement of Activity Comparison, between 2018 and 2017, and the Statement of Financial Position, all as of August 15th.

Will Short (Director of Training) reported that all remaining 2018 slots for the Conformation run-through have been filled. Will also stated that he would like to replace the signup whiteboards at the Beginner Novice/Novice, Open and Utility rings with a clipboard with paper and pen for each ring. Carolyn and Ed stated that they will both look to see whether there are any not-currently-used clipboards available in the club's supply of equipment.

Will stated that he was advised by a former club member that several local rescue organizations do not recommend FVDTC to their adopters because "we all use pinch collars." He assured the individual that the club's instructors do not "force" students to use pinch collars. Pat Senne (Advanced Puppy class instructor) and Carolyn Pearson (Advanced Beginner's class instructor) both stated that they have never, nor will they ever, force a handler to use a pinch collar. assured Will that none of the other instructors would do that either. However, the instructors do offer a discussion of types of collars, which includes pinch collars, on the first night of classes. After more discussion of collars, Peggy volunteered to create a "collar board" that Puppy and Beginner class instructors can use during their class' first night talk to demonstrate different types of training collars and harnesses. Several Board members asked Ed to make copies for them of the article that he has, which discusses different types of collars and harnesses.

#### Old Business

Mats and Equipment

Peggy Seehafer described the different ideas she had about gaining more storage space at the fairgrounds for the equipment that we use weekly. The Board discussed those ideas and other options that can be presented to the fairgrounds for more storage for us. Wendy stated that during her discussion with the fairgrounds regarding that topic, she was told that the club cannot get anymore floor space in the building, as we already have the existing cabinet and the external shed. The discussions will continue to determine how best to solve the storage problem.

#### **New Business**

Taurine Blood Draw Clinic

Wendy Waddick stated that she recently received a message from Donna Bihner regarding hosting a "Taurine Blood Draw Clinic" to participate in a UC Davis study of a possible link between low taurine and the dilated cardiomyopathy (DCM) heart condition in dogs, especially in Golden Retrievers. Taurine is a type of amino acid found throughout the body. It is particularly concentrated in the brain, eyes, heart and muscles, and unlike most other amino acids, it is not used to build proteins in the body. The FDA research is looking into grain free diets and this issue. If the blood test shows a lowlevel of taurine, it is recommended that dogs receive further heart testing, such as during the FVDTC's heart clinic.

A proposal was made to offer a group blood draw and send the blood to UC Davis to participate in the research. The blood would have to be drawn by a veterinarian or veterinary technician and shipped overnight to California. The cost would be \$79.00 plus the cost of the blood draw plus shipping (determined by the number of dogs participating). In order to get the blood to UC Davis during a weekday, it was suggested that the clinic should be conducted on a Tuesday at training. It was recommended that we set a minimum number of dogs in order to host the event and include all dogs, not just Golden Retrievers. Sue MacPherson stated that she will ask one of the doctors at Amberleaf Animal Hospital to do the draw on October 9th. Sue also volunteered to look more into the study, determine how the blood samples are to be shipped to UC Davis and whether any type of paperwork is required to accompany the samples.

A motion was made, seconded and approved to adjourn the meeting at 9:30 p.m.
