I hope everyone has had a fantastic Summer. Fall will be upon us shortly, and that means our annual Obedience & Rally Trials will be here soon. Stay tuned and check our website for the signup list to volunteer to steward. We need lots of stewards to keep things running smoothly. It's also a great way to earn your work credits. Speaking of work credits, we are now getting closer to the end of the year - as hard as that is to believe - so it's time to make sure you have a plan to earn your credits. Remember, you need only 3 work credits to have a 50% reduction of your annual dues and 10 work credits to be eligible for one of our great volunteer, or new title awards. There will be lots of opportunities to earn your work credits at our Fall Obedience & Rally Trials so please consider helping out your club!

I want to give a big thank you to Ingrid Hamburger for all her work on our recent Tracking Trial. Ingrid has been organizing our Tracking Trial for many years now. We really appreciate all her efforts! Thank you also to Kent Hildebrand who helped Ingrid a great deal at the trial and to all the other volunteers that helped in so many ways. We appreciate all your efforts!

I would also really like to thank Cheryl Hettinger and Gayle Wede for volunteering to taking over the Awards Committee position from Donna Bihner and Nancy Pederson. There is a lot of work that goes into this important job and we are so thankful that you both have volunteered!

This is the last chance to sign up for the OFA eye clinic that will be held during regular training night on October 4th starting at 5:00 pm. This is a great opportunity to get your dog's eyes examined at a greatly reduced cost. This is a thorough exam that can detect any issues that may be going on with your dog's eye health that you may not even be aware is occurring. Each year Dr Lindley has found some eye issues in the dogs she has examined during our annual eye clinics. She has discovered everything from cataracts to eye cancer during these exams. The cost is \$35 per dog, and you must prepay to reserve your spot. Time is running out to sign up. Send your payment to me, with checks made payable to FVDTC. I will work to ensure you get a time spot that doesn't interfere with any classes you're attending. See the flyer in this newsletter for more information.

We are also offering 2 more clinics this Fall. The first is a blood draw clinic on October 9th at the fairgrounds during regular training. This clinic is to test for a possible Taurine deficiency your dog may have as a result of eating a grain free diet. The blood samples will be sent overnight to UC Davis. If your dog then tests positive for a Taurine Deficiency it is advised to get an echocardiogram done. We are offering a Heart Clinic in conjunction with our Fall Obedience & Rally Trial. The Heart Clinic is on Saturday, November 17th. The cost is \$250 for an echocardiogram or \$50 to have a Auscultation exam, which is just listening to your dogs heart. Both exams will be performed by Board Certified Veterinarian Cardiologist, Dr Heidi Kellihan. To reserve your spot in this clinic contact Nancy Lee. Volunteers needed to represent FVDTC with your dog for a Home for Dogs Adoption event in Naperville. You will be manning a table and talking to the public about all we offer at FVDTC plus doing a few small demos. This is a great way to earn work credits and represent your club at a fun event. ## **FVDTC Heart Clinic**

Fox Valley Dog Training Club is hosting a heart clinic in conjunction with our fall obedience and rally trials.

DR. HEIDI KELLIHAN DVM, DACVIM a Clinical Associate Professor of Cardiology, Board Certified Cardiologist at the University of Wisconsin -Madison will be performing the exams.

Dr. Kellihan will be offering the following heart exams:

- AN AUSCULTATIONS EXAM ALONG WITH A DOPPLER ECHOCARDIOGRAM, which is an Ultrasound of your dog's heart
- · AUSCULTATIONS EXAM, which is listening to your dogs heart

WHEN: In conjunction with our trial on Saturday November 17, 2018 from 8:00 am through 3:00 pm

WHERE: At our trial site at the Kane County Fairgrounds

**COSTS:** Echocardiogram exam, which includes an auscultation exam \$250.00 per dog Auscultation exam only \$50.00 per dog. This is a great opportunity at a greatly reduced costs!

\* EXAMS MUST BE PRE-PAID BEFORE THE DATE OF THE TRIAL \*

To reserve your spot for either exam, send your pre-registration payment, with checks made payable to Heidi Kellihan DVM, DACVIM. Nancy will set up the time schedule for the exams once the judging schedule is out; she will do her best to work around your ring times. ## William Short, Director of Training

Will Short, the man in black, has been Director of Training for about 4 years. Will heard about FVDTC through his wife, Shirley, who had a student at the time that told her about the club. They have been members since the mid 80's.

Will heard about the position for Director of Training from Donna Bihner, who was President of the club then. Donna appointed Will to be the head of the Nominating Committee. It was his job to encourage people to volunteer for the open positions. When it came time to fill the Director of Training position, he sent e-mails and spoke with other members. No one was interested in taking the job. After Will spoke with Terri Vaira, she suggested that he "take one for the team". So far it has been fun for him.

Will's job as Director of Training is to make sure there are enough instructors and assistants for every class each session. He is also responsible for what is happening each week. Will said, "I have been very lucky because I believe we have a very fine group working with the students and their dogs every week. Without their help and volunteer time, we would not work well at all." He has also been an instructor for FV since the late 80's. He has taught all levels of training, except for puppy class. Will taught Advanced Beginners for a number of years and is now currently instructor for Rally.

So what interested Will in training? He had a Golden Retriever, Woolie, who got into Shirley's grade book

and mangled it. She demanded that Woolie go to FV

for training. Will disagreed, said he didn't need training. Well he lost and shortly after they had two Golden Retriever's at FV for obedience training. His Golden Retriever, Curry Bear, earned his CDX.



Over the years, Will

has trained his dogs in obedience, field work, conformation, agility and rally. When he first started, he mainly focused on obedience. Once he got the Flat Coats, he focused on conformation and field work. When Shirley became interested in agility, Will wasn't interested. But he went to the classes with her and soon he joined the fun with his first FCR, Phantom. Shortly after he added Rally to his roster when it became an AKC event.

Will and Shirley started their lives with Golden Retrievers, and then came the Flat Coated Retrievers. In 1990 Judy Anderson had a litter of FCR and asked Will to come over and look at them and help socialize them. She encouraged him to take a puppy, but the Shorts already had 3 Golden Retrievers. So they went home, measured his vehicle to see if they could fit

another crate. So, Drifter, their first Flat Coated Retriever, came along. Will said, "Shirley and I consider ourselves to be extremely lucky to have discovered this breed. It was pure luck and very good luck that it happened. I cannot imagine having any other breed of dog. In my mind, they are the most special breed that I have ever known."

Will has placed many titles on his dogs over the years. He has multiple titles in obedience with AKC and CKC. AKC Championships on several of their FCR's and a couple of field titles. Several AKC rally titles and many agility titles starting with Phantom through Walker D Plank having 32 agility titles. Jack Sparrow earned his AKC MACH. Will's first FCR earned a CKC FCRSC BISS and AKC BIS.

They have always come up with interesting names for their dogs. They needed a kennel name and theme. Their call name has always been a part of their registered name. Will said that some of the names came easily, some could take up to 5 - 6 weeks. He started the Pirates of the Caribbean theme names with Jack Sparrow. Then William Turner and Walker D Plank.

Will is a retired teacher. He started his career as a teacher at Elgin State Hospital, then worked at a day care center and then teaching emotionally disturbed children in U-46 in Elgin. From there moved on to regular elementary schools teaching 4th, 5th and 6th grades. Most of his spare time is taken by his dogs. He does agility classes 3 days a week, trains at FV weekly and currently is showing in agility on many weekends. This fall he is looking forward to doing several agility trials in different venues with Walker, and the occasional conformation show with Rodeo Joe.

So why the "man in black"? His black wardrobe started shortly after he got Jack Sparrow in 2006. Having black dog's he always worried about their being in the sun for too long because of their black coats absorbing heat quickly. So he decided that if they were going to wear black then he would also. Will said, "I currently have no other colors in my closet than black. And it is really easy to match my clothes."

Meeting brought to order at 7:41 p.m.

**Carolyn Pearson (Secretary).** The July Meeting minutes were approved as published. One item of correspondence from AKC was read.

**Ed Herdes (First Vice-President)** reported that Mat Cleaning is scheduled for Monday, September 24th at 9:00 a.m.-ish until approximately 1:00 p.m.-ish. **Peggy Sue Seehafer (Second Vice-President)** was not in attendance, but she reported that Dr. Jennifer Wahlund will be our guest speaker at the

November 7th Membership Meeting. She will be speaking about her training, her huge successes with her dogs and tell us about all the different events in which she competes. Additionally, she will discuss her work with Peaceful Endings. The program will start promptly at 7:00 p.m.

#### Coming in November

Guest speaker Dr. Jennifer Wahlund will visit our November membership meeting to talk to us about a variety of topics. The membership meeting is at the Kane County Extension Center Building at 535 Randall Road, St. Charles, (just south of the Kane County Fairgrounds). Be there at 7pm!

**Phil Nuger (Treasurer)** was not in attendance and did not have a financial report to send. He reported that the next significant update will occur after the upcoming Agility Trial.

**Will Short (Director of Training)** reported that Barb Misch has submitted the paperwork to become a CGC Evaluator which enables her to be an instructor/evaluator for the Socialization, Training, Activity and Responsible (S.T.A.R.) Puppy program. She would teach a S.T.A.R. puppy class at 7:00 p.m. with a limit of 10 students. When reminded that we pay our rent with the fees collected from our Puppy, Advanced Puppy and Beginner's classes, Will stated that he would speak to Barb regarding the cost of the class.

**Nancy Pederson (Workshop Coordinator)** Nancy was not in attendance, but reported that we are currently finishing a RALLY NOVICE FOR NEWBIES Workshop. The workshop consisted of three nights of reviewing signs numbers 1 through 42, ring procedure, ring etiquette and what to do on the day of a trial. That was then followed by three nights of run-throughs conducted as "mock trials". This workshop was offered free to members.

We are currently working on a "How to Get Started Showing in Obedience or Rally" workshop to be presented by Loretta Lazzara. This will not be a working workshop. Loretta will be sharing information and tips for newbies. More information will be available as plans become finalized.

**Pat Senne (Obedience Trial Chairperson)** reported that the premium lists are available on our website, on our Facebook page and at training. Additionally, volunteers are bringing copies to CarDunAl, Glenbard and Kanosak.

**Sue MacPherson (Membership Chairperson)** read a list of seven new applicants who were published in the Waggin' Tales. Will Short made a motion to accept the list as published and read. Collette Ainsly-Treonis seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to all new members, none were present at the meeting.

**Ingrid Hamburger (Tracking Test Chairperson)** was not attendance, but reported that last weekend's Tracking Tests went very well; the weather was great and she did not hear any complaints about the judges. Ingrid reported that Kent Hildebrand did a great job as the Tracking Test Secretary and is willing to fill that role next year. She reported that three of the four teams attempting the TD test passed, including former member, Marilyn Blenz. Ingrid also stated that only one of the four TDX tests passed. She also reported that they received 10 entries for the TD test and 11 entries for the TDX test.

Wendy stated that we would put together a Constant Contact seeking volunteers for the "Homes for Dogs" event and mat cleaning.

**Cathy Fleury (Agility Trial Chairperson)** was not in attendance and did not send a report. Will stated that he would like to recommend that we host our Agility Trial at "The Farm" on Burlington Road in Campton Hills rather than at the Car Dun AI Dog Training facility. He stated that "The Farm's" floor is new turf, the parking is nicer, the lighting is better and there are no neighbors complaining about noise. Pat Senne stated that the crate space is very tight compared to Car Dun AI.

Pat Senne also stated that she was very disappointed when she discovered that by the time it was announced that the worker sign-up was ready, a majority of the positions had already been taken, and many of them were by non-club members. Several other club members confirmed that they had experienced the same thing. Due to our work credit requirements, the consensus of the meeting attendees was that club members should be able to sign-up several days before the list is opened up to non-club members. Carolyn Pearson and Wendy Waddick stated that they would talk to Cathy Fleury about that issue.

**Candy Ellis (Annual Dinner Chairperson)** stated that they are attempting to determine a theme for the dinner. She also reported that she keeping an eye out for anyone earning a boner.

We have enough FVDTC ribbons and AKC forms and ribbons for the next test. An updated registration form will be created and submitted for the web site and the training table in January, 2019.

Cris stated that she appreciated having enough chairs for everyone and having the use of Ring 8 for the evaluation, to enable CGC teams to give their dogs quick access to the outside for potty and stress breaks during the 2-1/2 hours of the test.

**Carla Tsoris (Graduation Chairperson)** stated that she currently has enough Graduation Certificates for this session (ending the end of October) and, if the number of students graduating during the last session are the same as last year, then there should be enough certificates for the rest of the year. Dave Lewis, Wendy Waddick and Carolyn Pearson will meet very shortly to determine the new wording and bring the design back to the Board for approval.

**Sandi Stephenson (Match Chairperson)** Sandi reported that following volunteers are judging during the September 20th fun match. She thanked the volunteers for contributing their time and effort to make our matches a success. Sandi also reminded all volunteers to arrive not later than 6:30 p.m. to ensure that all workers are able to get their run-through, especially due to the quickly approaching local show season. Hopefully, we will see the entry numbers go up.
